#### 4. MESSAGE FROM THE PRESIDENT

The Speaker conveyed the following Message -

"Honourable Members, pursuant to the provisions of Standing Order No. 42(1) of the National Assembly Standing Orders, I wish to report to the House that I have received a Message from His Excellency the President seeking the National Assembly's approval of Justice (Rtd.) Paul Kihara Kariuki for appointment as the Attorney-General, in exercise of powers vested in him under Article 156(2) of the Constitution.

Section 8 of the Public Appointments (Parliamentary Approval) Act provides that the relevant Committee of the House will consider the suitability or otherwise of the nominee and table its report for consideration by the House within fourteen (14) days from the date the notification of nomination is conveyed to the House. Further, the Act requires that the public be given seven (7) days notification to submit their views regarding the suitability or otherwise of the nominee proposed for appointment to an office requiring Parliamentary approval.

In this regard, and in accordance with the provisions of Article 259(5)(a) of the Constitution as read together with section 5 of the said Act, the seven (7) days' notification to the public shall start running on the day following the day when the notice is published in the dailies.

Honourable Members, it is advisable that the relevant Committee expeditiously proceeds to notify the nominee and the public, commence the approval hearing after the seven day notification period, and table a Report on or before Tuesday, 27th March, 2018 to enable the House to consider the matter within the statutory timelines. This Message, together with the Curriculum Vitae of the nominee therefore, stands committed to the Committee on Appointments for consideration. Thank you".

#### 7. STATEMENT PURSUANT TO STANDING ORDER 52(h)

Pursuant to Standing Order 52(h), the Member for Murang'a County (Hon. Sabina Chege) made Statement regarding privilege relating to privacy and security of Members of Parliament;

Thereupon, the Member informed the House that several Members have over the past few weeks fallen victims to a fraud of scam through con individuals who have been registering mobile numbers in the Members' names and thereafter using those numbers to solicit for funds from unsuspecting Members. The Hon. Member called on the Inspector General of police to ensure investigations on the matter are expedited.

The Speaker referred the matter to the Departmental Committee of Administration and National Security and directed that the Committee invites the Inspector General of Police, Director of Criminal Investigations, the Director-General of the Communications Authority of Kenya and local telecommunications service providers.

The Committee was directed to report to the House within seven (7) days.

Raising in his place on a Point of Order under Standing Order 259 as read together with Standing Order 20 and Article 108 of the Constitution, the Leader of the Majority Party brought to the attention of the Speaker the fact that the Member for Mavoko (Hon. And the Member having refused to vacate the seat as directed on three occasions, the Speaker, pursuant to Standing Order 107, ordered that the Member withdraws from the precincts of the Assembly for the remainder of the Sitting for disorderly conduct.

Thereupon, the Member withdrew from the Chamber.
