4. COMMUNICATIONS FROM THE CHAIR

The Speaker conveyed the following Communications -

(i) <u>Communication from the Chair on the Registration of Members in the</u> <u>Biometric System</u>

"Honourable Members,

I wish to welcome you back from the long recess and hope you are refreshed and rejuvenated for busy second part of the Second Session. I do know that even during the recess Members were busy in their respective Committees considering the Budget Estimates for 2018/19 and indeed, the various Bills, including the two voluminous Statute Law Miscellaneous Amendment Bills, 2018. As we resume this part of the Session, may I remind Members about my Communication made just before the recess, asking all Members to register in the new Chamber Biometric System. The registration is for purposes of recording Chamber attendance and speaking in the House.

Honourable Members, I am informed that, as at 1.30 p.m today, Tuesday, June 5, 2018, a total of **235 Members** had registered and have been issued with new chamber cards. From the foregoing, I will allow Members who have not registered in the Biometric System to use the Manual Register for purposes of recording Chamber attendance. However, from Tuesday next week, that is June 12, 2018, we will **discontinue** the use of the Manual register.

Honourable Members, I therefore urge all those Members who are yet to register in the Biometrics System to do so as a matter of urgency. This can be done at the entrance of the Chamber during working hours when the House is not sitting. **I thank you!"**

(ii) <u>Guide on the Procedure for Consideration of Budget Estimates and Committee</u> of Supply

"Honourable Members,

Now that the House has passed the procedural motion limiting speaking time during General Debate and Committee of Supply on the Estimates I wish to guide the House on the way forward regarding the debate and introduction of any amendments to the Estimates.

Honourable Members, First, may I request all Chairpersons of Departmental Committees to be present tomorrow morning during the moving and debate on the Estimates that were tabled this afternoon. This is because, as the procedural motion indicates, the respective Chairpersons will be required to be the next to speak after the question is proposed, in the Order the Committees appear in the Second Schedule to the Standing Orders. The debate will continue for three days. This first stage of the process is similar to second reading of a Bill.

Secondly, **Honourable Members,** may I remind the House that, amendments to the Annual Estimates may be considered at the second stage, which is the Committee of Supply. However, I must caution the House that any amendments proposed to the Estimates will be subjected to the provisions of Article 114 of the Constitution, regarding motions with a "money bill" effect. As such, proposed amendments must be presented to the Budget & Appropriations Committee which will guide the House on how to proceed in keeping with the provisions of Article 114. Further, the same deadline of twenty four hours required for submission of amendments to Motions and Bills will apply to any amendments to the Estimates. Members should also note that, pursuant to the provisions of Standing Order 30(2) as read together with Standing Order 237, the House may be required to sit for longer hours during Committee of Supply.

I therefore urge Honourable Members to acquaint themselves with the relevant provisions of the Standing Orders, so as to familiarize themselves with the process. I thank you!"

5. **PETITIONS**

The Speaker conveyed the following petition-

"Honourable Members, Standing Order 225(2)(b) requires that the Speaker reports to the House any Petition other than those presented through a Member. I therefore wish to convey to the House that my office has received a Petition signed by one Mr. Njoroge Waweru of P. O. Box 287, Kikuyu.

Honourable Members, the Petitioner avers that there have been numerous challenges facing the higher education sector in the country ranging from administration, recruitment of Vice Chancellors, appointment of University council members, academic programs and facilities, Research output and Publications among other aspects.

Honourable Members, the Petitioner further contends that these challenges have far much affected the access and realization of higher education in the country. Further, he is concerned that if the challenges are not addressed, they would lead to collapse of public universities and in the long run jeopardise Kenya's higher education system.

Honourable Members, the Petitioner therefore prays that the National Assembly: -

(i) deliberates on the crisis facing higher education institutions and forms a commission of inquiry to investigate among other things, the administration of universities, criteria for recruiting Vice Chancellors and other administrators,

appointment of University Council Members, formation of regulatory framework to oversight universities and management of resources; and

(ii) makes any other order or direction that it deems fit in the circumstances of this matter.

Honourable Members, Pursuant to the provisions of Standing Order 227, this Petition therefore stands committed to the Departmental Committee on Education and Research for consideration. The Committee is requested to consider the Petition and report its findings within sixty days in accordance with Standing Order 227(2).

I am aware that the Statute Law Miscellaneous Amendments) Bill (National Assembly Bill No. 12 of 2018) now before the various Departmental Committees, makes specific proposals regarding appointment of Vice Chancellors of Universities. The Committee is encouraged to hear the Petitioner as it considers the provisions and is at liberty to incorporate his prayers in their proposed amendments on the Bill. I thank you!"
