#### 3. **COMMUNICATION FROM THE CHAIR**

The Speaker issued the following communications from the Chair: -

# a) Historic Sitting of the Senate in Uasin Gishu County Assembly, held on September 24th -28th, 2018 In Eldoret

"Honourable Senators,

I welcome you all to Uasin Gishu County for this auspicious sitting of The Senate. I also want to thank the leadership of Uasin Gishu County Government, both the Executive and the Assembly, led by His Excellency, Governor Jackson Mandago and the Assembly Speaker, Rt. Hon. David Kiplagat for the warm welcome since our arrival and for facilitating these sittings.

I wish to convey our deep appreciation to the Leadership and Members of the County Assembly for hosting us and for accepting to adjourn their sittings to allow the Senate to use your Chambers for this first-ever Sitting of the Senate outside the capital city.

The 3<sup>rd</sup> Senate of the Republic of Kenya and the Uasin Gishu County are jointly making history which will remain engrained in the annals of Kenya's parliamentary history.

Our sincere gratitude also goes to the great people of Uasin Gishu County "the home of champions" for the friendly welcome and the hospitality extended to us. I also thank the leadership of neighbouring Counties for embracing this noble idea and joining us for this auspicious sitting.

#### Honourable Senators,

One of the most fundamental provisions of the 2010 Constitution is the devolved system of government which aims at bringing services closer to the people as a means of accelerating development and enhancing the collective responsibility. A core creation of this Constitution is the Senate whose main function is, interalia, to represent the counties, and serve to protect the interests of the counties and their governments.

In recognition of the above and in an effort to institute steps towards its actualization, the Senate Business Committee on 13<sup>th</sup> March, 2018 resolved that a sitting of the Senate be held away from its traditional premises in Nairobi, in Uasin Gishu County in September, 2018 as an innovative way of enhancing interaction between the national and county levels of government.

These inaugural Senate sittings constitute one of the noble and innovative ways of enhancing interactions between the National and County Governments which are distinct and interdependent. In this manner, we bring The Senate closer to the people both symbolically and functionally.

# 5. NOTICE OF MOTION - COMMENDING ELIUD KIPCHOGE FOR BREAKING THE WORLD MARATHON RECORD

(The Senate Majority Leader)

**COGNIZANT THAT** Eliud Kipchoge broke the world marathon record held by a fellow Kenyan athlete Dennis Kimetto during the 2018 Berlin Marathon held on Sunday, 16<sup>th</sup> September, 2018;

**AWARE THAT** Kenya has earned international respect in athletics over the years courtesy of such hard work and stellar performance by our athletes in both

on and off the field events which has brought us together as a country and encouraged cohesion in line with our National Anthem;

**FURTHER AWARE THAT** athletics has created significant economic opportunities and infrastructure in the Rift Valley creating thousands of jobs for many would be jobless youth, thus engaging them in a productive and meaningful manner for purposes of nation building;

**FURTHER AWARE THAT** the youth are a critical component of the Big 4 agenda by the government and that development of athletics will lead to more productivity by a significant population of the youth who constitute a formidable part of the demographic structure of the country;

**COGNIZANT THAT** more support from the government is needed to fight the doping menace that has bedevilled our athletes and to encourage and motivate young and upcoming athletes to strive for excellence untainted by the vice;

**NOTING THAT** performances by our sportsmen and women are indeed commendable and deserve special recognition, the Senate now commends Mr. Eliud Kipchoge for his excellent performance in the Marathon and specifically for breaking the world marathon record and urges the national government to-

- a) Set aside additional funds to improve sports facilities;
- b) Establish a conducive environment in the country by giving incentives to investors in the sports sector;
- c) Provide psychosocial support to active and former athletes including a pension scheme; and
- d) Create a fund to cushion athletes who are forced to early retirement due to illness, injury or other circumstances.

### 6. STATEMENT PURSUANT TO STANDING ORDER NO. 48 (1)

Nominated Senator (Sen. Naomi Shiyonga, MP) sought a statement from the Standing Committee on Finance and Budget, on behalf of Nominated Senator (Sen. Beatrice Kwamboka, MP), regarding the implementation status of the Commission on Revenue Allocation Circular Reference CRA/FA/01vol 11 (22) on County Government Recurrent Expenditure Ceilings for Financial year 2018/19.

The Chairperson of the Standing Committee on Finance and Budget issued a response, in which he informed the Senate that, during passage of the County Allocation of Revenue Act (2018), the county governments budget ceilings on recurrent expenditure was enhanced from Kshs.28.8 billion to Kshs.31 billion.

This increase was informed by a number of factors, among them, the computation of operation costs based on inflation and not the increase in equitable share of revenue, the factoring in of plenary sitting allowances for Members of County Assembly, and the computation of staff salaries based on actual numbers as opposed to optimal staffing levels.

Sen. Shiyonga informed the House that the Chairperson had not responded to the statement sought, which was with regard to differential treatment of Nominated Members of County Assembly vis-à-vis their elected counterparts, in facilitation to perform their duties.

Whereupon, the Deputy Speaker directed that the Standing Committee on Finance and Budget do proceed to consider the request for statement in the manner provided for under the revised Standing Orders.
