5. STATEMENTS PURSUANT TO STANDING ORDER NO. 51 (1)

i. The Chairperson, Standing Committee on Labour and Social Welfare issued a Statement regarding the Committee's study visits to Mombasa, Kwale and Kilifi Counties from 29th October, 2018 to 2nd November, 2018.

In his statement, the Chairperson informed the Senate that the County Governments' Workers Unions, County Assemblies and County Governments' Executive Committee members raised several issues, including non-recognition of trade unions, uncertainty on employees' retirement pension schemes and unavailability of specialized personnel in the counties for pension management.

The Chairperson requested the Senate to support the Committee in ensuring that County Governments recognize trade unions for purposes of collective bargaining, expediting the enactment of the County Governments' Retirement Scheme Bill (Senate Bills No. 6 of 2018) and developing a legal framework through which counties could share scarce and specialized personnel in pension management.

ii. The Chairperson, Standing Committee on Labour and Social Welfare issued a Statement regarding the preferences and reservations in public procurement and assets disposal provided for under Section 157 of the Public Procurement and Assets Disposal Act.

In his statement, the Chairperson highlighted that the Act establishes the Public Procurement Regulatory Authority that is mandated to, among other things, monitor the implementation of the preference and reservation schemes by procuring entities. He informed the House that all procuring entities at the National and County levels were mandated to make reports after every six months to the Authority on the number of businesses owned by youth, women and persons with disability whose goods and services had been procured by procuring entities.

The Chairperson stated that the Authority was required to report to Parliament and the relevant County Assembly and requested that the Committee on National Cohesion, Equal Opportunity and Regional Integration makes an inquiry on the preferences and reservations in public procurement and provide a report to the Senate.
