The Speaker conveyed the following Petition -

## Introduction of a Private Bill entitled the Mau Mau Liberation, Movement Bill

"Honourable Members,

Standing Order 225 (2) (b) requires that the Speaker reports to the House any Petition other than those presented through a Member. I therefore wish to convey to the House that my office is in receipt of a Petition from members of the Mau Mau War Veterans Association seeking for leave of the House for the introduction of a Private Bill.

You may wish to note that this Petition is not an ordinary one as the Petitioners are asking for leave of the House to introduce a Private Bill aimed at providing for the recognition of the role of *Mau Mau Liberation Struggle Movement*. The draft legislation attached to the Petition is proposing to among other things, to acknowledge in law, the role of the *Movement* in the fight for Kenya's independence and to provide for the documentation of the history and activities of the *Movement* for posterity. The Petition does comply with the provisions of SO 159 (1) which states that "No private Bill shall be introduced unless a Petition for the same, headed by the short title of the Bill, and signed by the parties, being promoters of the Bill, or some of them, has been previously presented to the House with a copy of the Bill annexed"

Hounorable Members, you all appreciate that the Mau Mau Veterans played a key role in the liberation of this country from colonialism. Therefore it would be appropriate to recognise and appreciate their efforts in the fight for the Country's independence.

Pursuant to the provisions of Standing Order 227, this Petition now stands committed to the Departmental Committee on Sports, Culture and Tourism for consideration. The Committee is advised to prioritize the Petition, accord hearing to the Petitioners and assist

the House to determine whether the prayers by the Petitioners would properly be addressed by way of a Private Bill in terms Part Twenty (XX) of the Standing Orders. Should the Committee find that a Private Bill is the appropriate way to address the prayers, the Committee should, upon tabling the Report move a Motion asking the House to grant leave for the introduction of a Private Bill on the subject. Thank you".

## Guide on submission of the 2019 Budget Policy Statement

**Honourable Members,** Following the tabling of the 2019 Budget Policy Statement, 2019 Medium Term Debt Management Strategy Paper and draft Division of Revenue and County Allocation of Revenue Bills, I wish to inform the House that the said documents have been submitted pursuant to the Public Finance Management Act, 2012 and the Standing Orders.

The Budget and Appropriation committee is expected to submit its report within 7 days thereafter. This is to allow the House to consider the BPS within the 14 days limit set by section 25(7) of the PFM Act 2012 and Standing Order 232. The House is guided accordingly.
