THAT, aware, that the National Youth Service (NYS) is a Government Department established by an Act of Parliament (Cap 208 Laws of Kenya) in 1964 whose vision is to catalyze a transformative youth empowerment in Kenya; further aware that NYS currently targets to recruit twenty six thousand(26,000) youths annually with laid down procedure and the vacancies in each intake allocated in every county and gender; cognizant of the fact that the recruits undergo intense six (6) months training in paramilitary skills, national reconstruction programmes, disaster response, impacting sense of responsibility, values of discipline, respect to authority among other skills and values; deeply concerned that after successful completion of the training, the graduate youths are discharged to seek jobs which often are not readily available; further cognizant of the budget allocated for recruitment and training of servicemen and women to serve in various disciplined forces in Kenya; this House urges the Government to consider through all the disciplined forces to give first priority in recruitment of their servicemen and women to all willing NYS graduates which will significantly reduce their recruitment cost, training period and subsequently training cost and in addition create jobs for these skilled youths.
