## Conveyance of a Petition on proposed amendments of the Engineers Act, 2011 to the Engineers Ration in the country

"Honourable Members,

Pursuant to the provisions of Standing Order 225(2) (b), I wish to convey to the House that my office is in receipt of a Petition by one Dr. Ferdinand Chirure Nyongesa. The Petitioner is praying that the National Assembly repeals various sections of the Engineers Act, 2011 with a view to enhancing industrial take-off and realization of Vision 2030 through increasing the number of Engineers in the Manufacturing Sector.

The Petitioner avers that in a recent report by the World Bank titled "Expanding Tertiary Education for Well-paid Jobs: Competitiveness and shared Prosperity in Kenya", Kenya has been warned that it may not have the requisite number of engineering professionals to catapult it to Vision 2030, since only 2000 out of the expected targeted number of Engineers are registered in the Country.

Honourable Members, the Petitioner therefore prays that the National Assembly amends the Engineers Act, 2011 to enable registration of adequate supply of Scientists and Engineers to the labour market who will drive the development agenda for the benefit of the citizens.

Honourable Members, pursuant to the provisions of Standing Order 227, this Petition therefore, stands committed to the Departmental Committee on Education and Research for consideration. The Committee is requested to consider drafting a legislation to address the Petitioner's prayers.

- iv. The status of equipment and other hospital facilities including their suitability; and
- v. Staffing matters in the Hospital."
