# 12. PUBLIC PRONOUNCEMENT OF THE BUDGET HIGHLIGHTS AND REVENUE RAISING MEASURES FOR THE NATIONAL GOVERNMENT FOR THE FINANCIAL YEAR 2019/2020

The Speaker made the following Communication and thereupon invited the Cabinet Secretary for the National Treasury to make Public Pronouncement of the Budget Highlights and Revenue-raising Measures for the National Government for the financial year 2019/2020:-

### "Honourable Members,

As you are aware, yesterday, Wednesday, June 12, 2019, this House passed the Report of the Budget & Appropriations Committee on the Budget Estimates for the National Government for the 2019/2020 financial year. This process will be finalized once the House concludes with the Committee of Supply, which will allocate funds to various Votes and programmes for the respective three arms of National Government. As part of the process, a public pronouncement of the policy highlights contained in the Budget, along with the proposed Ways and Means of supporting it, ought to be made by the Cabinet Secretary for the National Treasury.

### Honourable Members,

Now therefore, pursuant to the provisions of Section 40 of the Public Finance Management Act, 2012 and Standing Orders 25A & 244C of the National Assembly Standing Orders, I will now interrupt the business of the House to allow the Cabinet Secretary for the National Treasury, Mr. Henry K. Rotich, EGH, to make a public pronouncement on the *Budget Policy Highlights and Revenue Raising Measures for the National Government* for the Financial Year 2019/2020 and the Medium Term.

### Honourable Members,

In accordance with the Standing Orders, I have also designated a suitable place in the Chamber for that purpose, to the right of the Speaker's seat and adjacent to the public servants' benches, to enable the Cabinet Secretary for the National Treasury discharge his obligation in compliance with the provisions of section 40(1) of the Public Finance Management Act.

Cabinet Secretary, you may now proceed."

Thereupon, the Cabinet Secretary for the National Treasury made the public pronouncement of the budget highlights and revenue raising measures for the National Government for the Financial Year 2019/2020, and submitted the following documents to the Speaker of the National Assembly:

- 8) Estimates of Revenue, Grants and Loans for FY 2019/2020
- 9) 2019 Medium Term Debt Management Strategy

- 10) Statistical Annex to the Budget Statement for the FY 2019/2020; and
- 11) The Public Finance Management (Biashara Kenya Fund) Regulations, 2019
