9. STATEMENTS

(i) The Member for Bomet County (Hon. Joyce Korir, MP) sought a statement pursuant to Standing Order 44(2) (c) regarding the passing on of a class six pupil named Jackline Chepngeno, aged 14 years from Kabiangek Primary School in Konoin, Bomet County who allegedly committed suicide following embarrassment suffered as a result of shaming by a teacher as a result of experiencing monthly menses. The Honourable

Speaker directed the Departmental Committee on Education and Research to look into the matter and report on the same by Thursday, September 19, 2019.

- (ii) The Member for Kitui Central (Hon. Makali Mulu, MP) sought guidance from the Speaker regarding the status the National Government Constituencies Development Fund (Amendment) Bill, 2019 which he had sponsored. The Bill was read a First Time on 24th April, 2019 and since then, the National Government Constituencies Development Fund Committee had not made progress in the consideration the Bill. The Speaker referred to the Departmental Committee on Finance and National Planning so as to avoid further delays in processing of the Bill.
- (iii) The Member for Marakwet East (Hon. Kangogo Bowen, MP) sought guidance from the Speaker regarding the status of the Kenya Uwezo Fund Bill, 2019, which he had sponsored. He claimed that the Departmental Committee on Finance and National Planning had taken over two years to consider the same and as a result, the Bill could not proceed for the Second Reading. Upon confirming the status of the Bill from the official record, that is, the Bills Tracker, the Speaker informed the House that the Bill was read a First Time on 3rd July 2019 and ordered the Member to withdraw and apologize for misleading the House on the status of the Bill. The Member then proceeded to withdraw and apologize accordingly.

- (3) The vice-chairperson of the Board shall be elected by the Trustees from among their number.
- (4) The chairperson and vice- chairperson shall be of the opposite gender.
- (5) The Cabinet Secretary shall ensure that not more than two thirds of the members of the Board are of the same gender.
- (6) The Cabinet Secretary shall appoint the persons nominated under subsection (2) by notice in the gazette.
- (7) The procedure for nomination and appointment of Trustees under subsection (2) shall be as prescribed in the regulations.
