5. **NOTICES OF MOTION**

The following Notices of Motion were given-

(i) Establishment of a Widows' Fund

THAT, aware that Kenya has an estimated eight (8) million widows, with the number said to be steadily increasing; concerned that most widows face numerous challenges including losing their source of income and security, economic hardships, social discrimination, degrading treatment, physical and mental abuse; cognizant that the said challenges could be mitigated through providing widows with alternative sources of income that would afford them a level of liberty and dignity in their lives upon the death of their spouses; appreciating the efforts by the Government in empowering widows economically through various programmes that provide opportunities for capacity building and skills training for widows; further appreciating that the government has established the National Government Affirmative Action Fund (NGAFF), Women Enterprise Fund (WEF), Uwezo Fund and Youth Enterprise Development Fund which provide loans and financing to the targeted groups; this House urges the Government to classify widows as a disadvantaged group and establishes a Widows' Fund for the sole purpose of economically empowering widows.

(ii) Approval of Revised Debt Ceiling for the National Government

THAT, this House adopts the Report of the Committee on Delegated Legislation on its consideration of the Public Finance Management (National Government)(Amendment) Regulations, 2019, laid on the Table of the House on Wednesday, October 09, 2019, and pursuant to the provisions of section 205(4) of the Public Finance Management Act, 2012, section 18 of the Statutory Instruments Act, 2013 and Standing Order 210 (4)(b) <u>approves</u> the amendments to the Public Finance Management (National Government) Regulations, 2015 (principal Regulations) as effected through <u>Legal Notice No. 155 of 26th September</u>, 2019, as follows-

- (a) in regulation 26(1), sub paragraph (c) by deleting the words "50 percent of Gross Domestic Product (GDP) in net present value terms" and substituting therefor the words "nine trillion shillings"; and,
- (b) in regulation 196, paragraph (1) by deleting the words "net present value of the total public debt that is" and substituting therefor the words "set limit".
