THAT, this House **adopts** the Report of the Committee of Powers and Privileges on the Inquiry into Alleged Leakage and Misuse of Official Information contrary to the Leadership and Integrity Act, 2012, laid on the Table of the House on Wednesday, November 20, 2019, and pursuant to the provisions of section 17(3) (b) of the Parliamentary Powers and Privileges Act, 2017, **resolves** to reprimand the Hon. Fatuma Gedi for conducting herself in a manner that –

- (i) reflected adversely on the dignity and integrity of the National Assembly and its Members; and
- (ii) is contrary to the best interests of the National Assembly and its Members in contravention of section 16(e) of the Parliamentary Powers and Privileges Act, 2017.
