He is in Parliament on the invitation of the CPA Kenya Branch to carry out a self-assessment exercise on the CPA Recommended Benchmarks for Democratic Legislatures. The CPA Recommended Benchmarks for Democratic Legislatures were first published in 2006, and comprise of 87 indicators for excellence in Commonwealth parliamentary and legislative practice.
