- (i) When will the outstanding arrears owed to sugarcane farmers who delivered cane to Sony Sugar factory be paid including other suppliers for the goods and services rendered to the factory?
- (ii) When will the Management of the Company pay workers and employees considering that they have not been paid for over six (6) months?
- (iii) What measures has the Ministry put in place to ensure that plant maintenance is carried out regularly on the said factory?
- (iv) Could the Ministry consider upgrading all governmentowned sugar factories in the country with modern technology and equipment for efficient and effective operations that will cut on maintenance costs and increase production?
