CHAIRPERSON'S FOREWORD

Pursuant to section 20(1) of the NG-CDF Act No. 30 of 2015 and section 5 of the Public Appointments (Parliamentary Approval) Act, No. 33 of 2011 the Cabinet Secretary for National Treasury and Planning, Hon.(Amb) Ukur Yatani, EGH nominated Mr. Yusuf Mbuno for the position of the Chief Executive Officer of the Board. The nomination of Mr. Yusuf Mbuno was conveyed to the Speaker of the National Assembly through a letter Ref. No. TNTP/SDP/4/52 dated 24th March, 2020 (*Annex 1*). The nominee's Curriculum Vitae and other testimonials were attached.

On Thursday, 26 March, 2020(*Annex 2*) and pursuant to section 20 of the National Government Constituencies Development Fund Act, 2015, the Speaker of the National Assembly conveyed message from Cabinet Secretary, National Treasury & Planning communicating the name of the nominee for approval by the National Assembly pursuant to section 4 of the Public Appointments (Parliamentary Approval) Act, 2011 and section 20(1) (d) of the NG-CDF Act, 2015 and Standing Order 45(1), the name of the nominee was referred to the select Committee on National Government Constituencies Development Fund for the necessary approval hearings vetting and reporting to the House within fourteen (14) days.

In compliance with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011, the Clerk of the National Assembly placed an advertisement in the print media on Thursday, 16th April, 2020, (Annex 2) inviting the public to submit memoranda by way of written statements on oath (affidavit) on the suitability of the nominee in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011. The memoranda were to be received by Wednesday 22nd April, 2020 at 5.00 pm. By close of the submission deadline, the Clerk of the National Assembly had received a total number of 3 submissions.

Pursuant to Article 118 of the Constitution, section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011 and Standing Order 45(3), the Clerk of the National Assembly on Thursday, 16th April, 2020, notified the public in the print media the exercise the select Committee on NG-CDF to undertake the approval hearing of the nominee on Thursday, 23rd April 2020 at 10.00am in County Hall mini-chamber (*Annex 3*).

The nominee Mr. Yusuf Mbuno appeared before the committee on Thursday, 23rd April 2020 at 10.00am for approval hearing in accordance with the provisions of the Constitution, the Public Appointments (Parliamentary Approval) Act, 2011, the National Government Constituencies Development Fund Act, 2015 and the National Assembly Standing Orders. The purpose of this hearing was to assess the suitability of the nominee for appointment to the position of Chief Executive Officer of the National Government Constituencies Development Fund Board.

I take this opportunity to thank all Members of the Committee for their dedication to duty. I also wish to thank the offices of the Speaker and the Clerk of the National Assembly for according the Committee the necessary logistical support during the vetting exercise.

Further, the Committee wishes to thank all members of public who submitted memoranda to be considered during the approval hearings.

EXECUTIVE SUMMARY

Pursuant to the provisions of Section 20 of the National Government Constituencies Development Fund Act, 2015, the Cabinet Secretary for the National Treasury & Planning, Hon.(Amb) Ukur Yatani, EGH nominated Mr. Yusuf Mbuno, on 24th March, 2020 for the position of the Chief Executive Officer of the National Government Constituencies Development Fund Board and forwarded his name to the National Assembly for approval.

The Speaker subsequently issued conveyed the message to the House on 26th March, 2020 on receipt of the name from the Cabinet Secretary, National Treasury and Planning and committed the nominee to the Select Committee on National Government Constituencies Development Fund for approval.

The Committee subsequently commenced the approval exercise in accordance with the provisions of the Constitution, the Public Appointments (Parliamentary Approval) Act, 2011, the National Government Constituencies Development Fund Act (No. 30 of 2015) and the National Assembly Standing Orders.

On 16th April, 2020, the Committee, pursuant to section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011 invited the interested members of the any representation by written statements on oath (affidavit) with supporting evidence on the suitability of the nominee. On 16th, 2020, the general public was notified of the appointment, pursuant to Article 118 of the Constitution and Section 6(4) of Public Appointments (Parliamentary Approval) Act, 2011 and the date of the approval hearing scheduled for Thursday, 23rd April, 2020 in Mini-Chamber, First Floor County Hall, and Parliament Buildings starting at 10.00a.m. The members of the public were required to submit their memoranda by close of business at 5 pm on Wednesday, 22nd April, 2020.

The nominee was also required to submit clearance certificates from the following agencies: the Ethics and Anti-Corruption Commission, the Kenya Revenue Authority, the Higher Education Loans Board, and the Directorate of Criminal Investigation.

By close of the submission deadline, the Committee had received a total number of 3 submissions, 1 in support of the nominee and 2 contesting the nomination of Mr. Yusuf Mbuno, but only the contesting submissions met the threshold of memoranda for consideration by the committee as required by provisions of the Public Appointments (Parliamentary Approval) Act, 2011.

The Committee undertook the approval hearing on Thursday 23rd April, 2020, in compliance with the Constitution, the Public Appointments (Parliamentary Approval) Act, 2011, National Governments Constituencies Development Fund Act, 2015 and the National Assembly Standing Orders.

Having conducted the approval hearing for the nominee pursuant to section 20(1) of the Constituencies Development Fund Act, 2015, sections 3 and 5 of the Public Appointments (Parliamentary Approval) Act, 2011 the Committee recommends that the House **approves** the nomination of Mr Yusuf Mbuno for appointment as the Chief Executive Officer of the Constituencies Development Fund Board, by the Cabinet Secretary for Treasury &Planning, Hon(Amb.) Ukur Yatani, EGH.

1.0 PREFACE

1.1 Establishment and mandate of the committee

- 1. The Select Committee on National Government Constituencies Development Fund is a statutory committee established in accordance with the provisions of section 50 of the NG-CDF Act of 2015 and its functions include:
 - a) To oversee the implementation of this Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary, propose any amendments to this Act with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;
 - b) To oversee the policy framework and legislative matters that may arise in relation to the Fund;
 - c) To continually review the frame set out for the efficient delivery of development programmes financed through the Fund;
 - d) To consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act; and
 - e) To carry out any other functions relevant to the work of the Fund.

2.0 INTRODUCTION

2.1 Establishment of the position of the Chief Executive Officer of the NG-CDF Board

- 4. Section 20 of the NGCDF Act provides for the position of the Chief Executive Officer of the Board. It states as follows-
 - 20.(1) There shall be a Chief Executive Officer of the Board who shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly.
 - (2) No person shall be appointed under this section unless such person-
 - (a) has a degree in finance, accounting, engineering, economics, community development, law or a related field from a recognized university;
 - (b) has at least ten years' working experience in the relevant field; and
 - (c) has served in a senior management position for a minimum period of five years.
 - (3) The Chief Executive Officer shall subject to the directions of the Board be responsible for the day to day management of the affairs and staff of the Board.
 - (4) The Chief Executive Officer shall serve for a period of three years renewable once.

2.2 Approval and appointment procedure of the Chief Executive Officer, NG-CDF Board

5. The procedure for recruitment of the Chief Executive Officer of the NGC-DF Board is provided for under the Section 20 (1) of the NG-CDF Act. It states-

(1) There shall be a chief executive officer of the Board who shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly.

2.3 Notification of nomination

6. On Thursday 26th March, 2020 and pursuant to section 20 of the National Government Constituencies Development Act, 2015, the Speaker of the National Assembly read the message from Cabinet Secretary, National Treasury & Planning communicating the name of the nominee for approval by the National Assembly.

2.4 Committal to the Committee

7. Pursuant to section 4 of the Public Appointments (Parliamentary Approval) Act, 2011 and section 20(1) (d) of the NG-CDF Act, 2015 the name of the nominee was referred to the select

Committee on National Government Constituencies Development Fund for the necessary vetting and reporting to the House within fourteen (14) days.

2.5 Notification to the public

- 8. In compliance with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011, the Clerk of the National Assembly placed an advertisement in the print media on Thursday, 16th April, 2020, (Annex 3) inviting the public to submit memoranda by way of written statements on oath (affidavit) on the suitability of the nominee in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011. The advert required members of the public to present their submissions by close of business on Wednesday 22ndApril, 2020 at 5.00 pm. By close of the submission deadline, the Committee had received a total of 3 submissions, 1 in support of the nominee and 2 contesting the nomination of Mr. Yusuf Mbuno, but only the 2 submissions contesting the nomination of the candidate met the threshold of memoranda for consideration by the committee as required by provisions of the Public Appointments (Parliamentary Approval) Act, 2011.
- 9. Pursuant to Article 118 of the Constitution, section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011 and Standing Order 45(3), the Clerk of the National Assembly on Thursday, 16th April, 2020, notified the public in the print media that the select Committee on NG-CDF will undertake the approval hearing of the nominee on Thursday, 23rd April, 2020 at 10.00am in the Mini-Chamber, First Floor County Hall in Parliament Buildings (*Annex 3*).

2.6 Clearance Requirements

- 10. On 15th April, 2020, the Clerk of the National Assembly wrote to the Ethics and Anti-Corruption Commission (EACC), Kenya Revenue Authority (KRA), Directorate of Criminal Investigations (DCI), the Higher Education Loans Board (HELB) and the Office of the Registrar of Political Parties (ORPP) (Annexure 5) requesting for reports with respect to the nominee on the following issues:
 - (i) ethics and integrity;
 - (ii) tax compliance;
 - (iii)criminal records;

- (iv) Higher education loan repayments; and
- (v) political party affiliations.
- 11. With regard to the Ethics and Integrity, the Ethics and Ant-corruption Commission vide a letter Ref. No. EACC.7/10/5 VOL.XIII (60) and dated 20th April, 2020 (*Annex 5*) confirmed that the Commission has not undertaken any investigations in relation to the nominee on any matter where the nominee has been found culpable.
- 12. With regards to matters on tax obligation, the KRA confirmed vide a letter Ref. No. KRA/5/1002/5/ (2092) and dated 16th April, 2020 (Annex 5) that the nominee was tax compliant.
- 13. The Nominee presented a police clearance certificate Ref. No. PCC-AAALZKM2 and dated 30th September 2019 valid for one Year, (30th September 2020) (Annex 5)
- 14. The Nominee presented a letter from the Higher Education Loans Board confirmed vide a letter Ref. No. HELB/REC/21/CERT 150/3334 dated 2nd October 2013 (Annex 5), confirming the nominee to have been a beneficiary of the Loans Board but has since fully repaid the loan and was given a clearance certificate 2648.
- 15. On the issue of party affiliation, the office of the Registrar of political parties vide a letter dated 16th April, 2020, REF NO: RPP/ORG/34 Vol. IV (19), Ref. No. (*Annexure 5*) confirmed that the nominee is not an official of a registered political party.

2.7 Issues for consideration during the approval hearing

- 16. The Committee took into consideration section 7 of the Public Appointments (Parliamentary Approval) Act, 2011 which provides the issues for consideration by the relevant House in relation to any nomination. These are:
 - a) the procedure used to arrive at the nominee;
 - b) any constitutional or statutory requirements relating to the office in question; and
 - c) the suitability of the nominee for appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.
- 17. Section 6 (7) of the Act provides further guidance which places focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

2.7.1 Procedure for Nomination

- 18. The procedure of nomination of the Chief Executive Officer of the NGC-DF Board is provided for under the Section 20(1) of the NG-CDF Act. It states-
 - 20.(1) There shall be a chief executive officer of the Board who shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly.
- 19. Section 15 (2) of the NG-CDF Act further provides that in nominating or approving the appointment of a person as a member of the Board under sub-section (1), the Cabinet Secretary and the National Assembly shall take into account gender equity and the regional diversities of the people of Kenya.
- 20. Further, Regulations 4(2) of the NGCDF Regulations, 2016 requires the NGCDF Board to forward to the Cabinet Secretary three names of selected candidates, from among whom the Cabinet Secretary nominates one and notifies the National Assembly on the same.
- 21. Regulation 4 of the National Government Constituencies Development Regulations outlines the procedures for appointment of a chief executive officer. It states-
 - "4. (1) The Board shall, in recruiting the chief executive officer of the Board under Section 20(1) of the Act, ensure that the recruitment is carried out in a transparent and competitive manner.
 - (2) The Board shall finalise the recruitment of the chief executive officer of the Board within sixty days from date of the close of the application period, and shall forward three names of the selected candidates to the Cabinet Secretary for consideration.
 - (3) The Cabinet Secretary shall, within twenty one days after receiving the names of the selected candidates from the Board, forward the name of one of the selected candidates to the National Assembly for approval.

- (4) The National Assembly shall, within twenty-one days of receipt of the name of the selected candidate from the Cabinet Secretary, under paragraph (3) consider the nomination, and may approve or reject the nomination.
- (5) Where the National Assembly approves the nomination under paragraph (4), the Speaker of the National Assembly shall forward the name of the approved person to the Cabinet Secretary for appointment.
- (6) The Cabinet Secretary shall, within fourteen days of the approval by the National Assembly, by notice in the Gazette, appoint the person approved by the National Assembly as the chief executive officer of the Board.
- (7) Where the National Assembly rejects the person nominated by the Cabinet Secretary, the Speaker of the National Assembly shall, within three days of the decision, communicate the decision of the National Assembly to the Cabinet Secretary and request the Cabinet Secretary to submit a fresh nomination.
- (8) The Cabinet Secretary shall submit to the National Assembly a name from the list initially forwarded by the Board within seven days of receipt of the communication from the Speaker.
- (9) Where the National Assembly rejects the names of all the persons nominated by the Cabinet Secretary the provisions of paragraph (2) shall apply."

2.7.2 Constitutional and other Statutory Requirements

- 22. The Constitution in addition gives guidelines on how to appoint persons to public office which include -
 - (a)Two-third Gender Rule
 - Article 27 (8) of the Constitution provides that the State shall take legislative and other measures to implement the principle that not more than two-thirds of the members of elective or appointive bodies shall be of the same gender
 - (b) Leadership and Integrity
- 23. The Committee, in determining the suitability of the nominee, was also guided by the provisions on leadership and integrity as outlined under Chapter Six of the Constitution. In

particular, Article 73 (2) provides that the guiding principles of leadership and integrity include

- (i) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
- (ii) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices;
- (iii) selfless service based solely on the public interest, demonstrated by
 - (a) honesty in the execution of public duties; and
 - (b) the declaration of any personal interest that may conflict with public duties;
 - (c) accountability to the public for decisions and actions; and
 - (d) discipline and commitment in service to the people.
- 24. Article 77(5) requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties. This provision further prohibits a State Officer who has been removed from office under it from holding any other State Office.
- 25. Article 77(1) prohibits a full time State Officer from participating in any other gainful employment.
- 26. Article 77(2) prohibits an appointed State officer from holding office in a political party. Article 78 disqualifies persons who are not Kenyan Citizens from appointment as State Officers. Further, a State Officer is barred from holding dual citizenship.
- 27. In addition, the Committee considered section 10 of the Leadership and Integrity Act, 2012 in particular which provides that
 - A State officer shall, to the best of their ability—
 - (i) carry out the duties of the office efficiently and honestly;
 - (ii) carry out the duties in a transparent and accountable manner;
 - (iii)keep accurate records and documents relating to the functions of the office; and
 - (iv)report truthfully on all matters of the organization which they represent.

2.8 Submission of Memoranda

28. By close of the submission deadline, the Committee had received a total number of 3 submissions (annex 7), one in support of the nominee while 2 submissions contesting his nomination but only the 2 submissions contesting his nomination met the threshold of a memoranda for consideration by the committee as required by provisions of the Public Appointments (Parliamentary Approval) Act, 2011. The memoranda received were as follows-

2.8.1 Public Memorandum by concerned Citizen Kenya by Kennedy O. Ondiek 7th April, 2020

- 29. Mr. Ondiek supports the appointment of Mr. Yusuf Mbuno on the following grounds: THAT—
 - (a) Section 20(1) of the Ng-CDF Act requires that the CEO of the NG-CDF Board be recruited competitively and three names be forwarded to the Cabinet Secretary for appointment after National Assembly approval;
 - (b) The NG-CDF Board conducted its interviews and the Ag. CEO Mr. Yusuf Mbuno was ranked first followed by Prof. Mohamed Abdille with Mr. Jackton Omulo Akello coming in third. This shows that, apart from goodwill, the nominee performed above par in the interviews and has run, in the interim, the functions of the Board per excellence;
 - (c) The nominee has dutifully acted in the same capacity not extending to the requisite dates of the term, without the required payment, carried out the function diligently;
 - (d) The laws of fairness and justice be adorned to the nominee and be allowed to serve as the substantive CEO for the National Government Constituency Development Board;
 - (e) It is important to note that the memorandum presented above does not meet the threshold as espoused in section 6(9) of the Public Appointments (parliamentary Approval) Act; and
 - (f) The memorandum is not a sworn statement on oath.

2.8.2 Affidavit by Tolbert Manyange, 18th April, 2020

- 30. Mr. Manyange opposed the appointment of Mr. Yusuf Mbuno based on the following grounds: THAT—
 - (a) The recruitment by the NG-CDF Board and the recommendation made to the Cabinet Secretary for appointment with the approval of Parliament of the nominee for the post of CEO, does not meet the required leadership and integrity values set out in the Kenya Constitution;
 - (b) There is a requirement that there shall be a Chief Executive Officer of the Board who shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly;
 - (c) In sharp contrast to Section 20 of the NG-CDF Act, the members of the National Assembly showed open biasness in favour of one candidate and hostility towards the other candidates;
 - (d) It is evident that the members of parliament openly showed their biasness in favour of the candidature of the nominee against any other nominees which is inconsistent with the Constitution and the NG-CDF Act;
- (e) If the nominee is appointed for the position, his allegiance will only be to the National Assembly and not the people of Kenya, the tax payers or other arms of the Government. His appointment will greatly affect the delivery of services and negatively affect people and institutions that will depend on the CEO's integrity;
- (f) The selection will not be competitive because the members of National Assembly have a close working relationship with the said nominee;
- (g) The nominee has already served in the same position for almost eight and a half years in an acting capacity. The maximum period of service for the CEO for NG-CDF is six years. In this case, if the nominee is appointed, it will be a gross violation of the spirit of the Act. Essentially, the nominee will have served for a record of twelve years and a possible term of fourteen years;

- (h) The appointment of the nominee will be inconsistent with the guiding principles of leadership and integrity under chapter six of the Constitution Article 73 (2) (a) which requires selection on the basis of personal integrity, competence and suitability;
- (i) The nominee has further been mentioned in fraudulent withdrawals and questionable expenditures from time to time during his term as CEO of NG-CDF Board. In 30th June, 2016, he was cited by the Auditor General for the loss and failure to account for Kshs. 332,000 a withdrawal solely attributed to him because his signature is the main one in bank operations in line with section 13 (3) of the NG-CDF Act; and

31. The memorandum met the threshold stipulated in section 6 (9) of the Public Appointments (parliamentary Approval) Act;

2.8.3 Affidavit by Sam Kinyua, 20th April, 2020

- 32. Mr. Kinyua opposed the appointment of Mr. Yusuf Mbuno based on the following grounds: THAT—
 - (a) Article 259 (3) (b) of the Constitution of Kenya provides that " any reference to a state officer or other public office or officer, or a person holding such an office, includes a reference to the person acting in or otherwise performing the functions of the office at any particular time";
 - (b) The nominee's intended appointment is in violation of Article 259 (3) (b) for the following reasons—
 - (i) The law provides under section 20 (4) of the NG-CDF act that the holder of the office shall serve for three years;
 - (ii) The nominee has been acting since 2011 and remained eight years consecutively contrary to the law;
 - (iii) The nominee has served beyond the stipulated period and has illegally extended beyond the maximum two years;

- (iv) If appointed, the nominee will have served twice above the time limit by an extension of eight years taking into consideration his term begin afresh;
- (c) Section 20 (3) and 13(3) of the NG-CDF Act provides that the CEO shall be responsible for the day to day management affairs of the Board and signing instructions shall be such that the signature of the CEO is mandatory on all payments cheques and/ or instruments intended for the release of money from the fund. The above functions are duties that the nominee has been discharging for the last eight and a half years;
- (d) As per Article 259 of the Constitution, the nominee has served not only for the stipulated time but has also exceeded it by two years;
- (e) the nominee has served the Board for the past eight years and has influence on the board and will not competitively be selected due to his influence;
- (f) the nominee has had his time at the fund having served for the past eight years as opposed to the maximum of six years prescribed by section 20 (4) of the NG-CDF Act;
- (g) there is a grave concern as to why the nominee has stayed in the same office for so long. This matter has been raised severally in parliament and is also subject to litigation in the High Court;
- (h) there are other persons who have served in the same position and have moved on to other roles. Agnes Odhiambo and Wycliff Oparanya; and
- (i) if the nominee is appointed to this position, this act would be prejudicial to the competitive process; and
- 33. The memorandum met the threshold stipulated in section 6 (9) of the Public Appointments (parliamentary Approval) Act.

2.9 Written response by the Nominee to the Memoranda

- 34. The nominee put in a reply to the admissible statements. (annex 8)
- 35. The nominee in his written response to Statement by Sam Kinyua, submitted: THAT,
 - (a) He is the Chief Manager-Programs and is serving as the Acting Chief Executive Officer of the National Government Constituencies Development Fund Board;
 - (b) The memorandum is scandalous and frivolous with the sole aim of causing mayhem and disrupt a constitutional process that was initiated legally and performed within the confines of the laws of Kenya as regards to due process;
 - (c) main issue in the affidavit is with the alleged ambiguities of legislation and his fitness to be appointed as the Chief Executive Officer of the NG-CDF Board. The move to oppose the appointment is not made in good faith, considering that the appointment has been made with strict adherence and compliance with the existing laws;
 - (d) Section 20(1) of the NG-CDF Act establishes the office of the chief executive officer of the NG-CDF Board and the process of recruitment. The section provides that the NG-CDF Board CEO "shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly." Section 20(4) provides that the CEO recruited as per the provisions of the section shall serve for a period of three years, renewable once. Accordingly, the later provision sets a term limit for the CEO to a maximum of six years.
 - (e) He has <u>NEVER been recruited</u> as CEO of the NG-CDF Board as per the dictates of Section 20(1) of the NG-CDF Act. All along, he has been serving in an acting capacity. A person serving in an acting capacity is not subject to term limits associated with that office. Only a substantive holder of an office is subject to term limits of an office. There is **NO** law that stops a person serving in an acting capacity from applying to be considered for appointment as a substantive holder of that same office;

- (f) the rational for appointing someone to hold an office in an acting capacity is simply to ensure the smooth running of an office and to avoid a vacuum that would cripple service delivery. The most important thing to note is that a person holds office in an acting capacity while he/she awaits the relevant authorities to nominate and appoint a substantive holder of that office. Similarly, he has been serving as the Acting CEO of the NG-CDF Board awaiting the relevant authorities to appoint a substantive holder. he cannot be blamed for the length of time that he has served in an acting capacity. Further, there is no law that automatically changed his status from acting CEO of NG-CDF to a substantive CEO as claimed;
- (g) An employee is supposed to hold office as per the terms and conditions of the engagement contract. The letter of appointment appointing him to serve as the CEO of the NG-CDF Board in an acting capacity clearly stated that he was appointed to hold office until such a time when the office was to be filled substantially. Accordingly, the term and conditions of the letter of appointment stipulate the term limit, which is "until such a time when the position is filed by a substantive holder." The terms exclude the application of section 20(4) of the NG-CDF Act, which only applies to a substantive holder of the office. Additionally, the fact that he served the office in an acting capacity does not by itself stop or exclude him from applying to be considered for appointment as a substantive holder of the office. It is clear that the Petitioners in this case misread and misinterpreted the law;
- (h) Section 2 of the Public Service Commission Act, 2017 defines "acting appointment" to mean temporary conferment upon a public officer, by the Commission or the relevant appointing authority, the power to perform duties of a public office other than the office the officer is substantively appointed to hold, while the public officer continues to hold the substantive appointment. Accordingly, the mere fact that he performed the roles of a NG-CDF Board CEO does not mean he automatically became a substantive holder of that office. An acting officer

- performs similar roles that a substantive holder of that office would have performed, but on temporary terms.
- (i) the law allows him to apply and be considered for appointment to the position of the CEO NG-CDF Board. This is in consideration that he has never been appointed to the office according to the laws. Where the Petitioners feel aggrieved by the current laws that allow his appointment, then they should challenge the constitutionality of those laws or request an amendment;
- (j) The Petitioners have misapprehended paragraph C.14(1)-(9) of the Human Resource Policies and Procedure Manual for the Public Service Commission. The paragraph deals with allowances paid to an officer serving in an acting capacity and nothing further;
- (k) the Board is an independent body and he cannot by any means whatsoever influence its decision in the recruitment process. The petitioners are speculating without any form of evidence to prove influence in any decision of the Board.
- (1) comparing the office of the NG-CDF Board CEO to that of other constitutional bodies as the Petitioners have alluded is a clear indication that the Petitioners are misguided. The office of the NG-CDF Board CEO is established under the NG-CDF Act and the terms of service and stipulated therein. The other referenced bodies are established under different Acts of Parliament, which also specify the terms of office. A comparison of the offices cannot be afforded as the laws stipulate different terms for different offices based on the unique needs and demands of each office. Furthermore, the officers mentioned were substantive holders of the respective offices, unlike in this case where he has been serving in an acting capacity awaiting a competitive recruitment process as provided under Section 20(1) of the NG-CDF Act;
- (m) the Petitioners correctly acknowledge that the matters elicited in their affidavit are subject to an on-going litigation in the High Court. Accordingly, any further hearing of this affidavit is in violation of our Sub Judice laws as well as Standing Order No. 89 of The National Assembly Standing Orders as adopted by the

National Assembly on 9th January, 2013 during the Fourth Session of the Tenth Parliament. The Standing Order prohibits members from referring to any particular matter which is *Sub Judice*. A matter shall be considered to be *sub judice* when it refers to active criminal or civil proceedings and the discussion of such matter is likely to prejudice its fair determination. To avoid violating the *Sub Judice* Rule, the best action is for the Petitioners to apply to be added as interested parties in the on-going High Court Petition.

- 36. The nominee in his written response to Statement by Tolbert Manyange submitted: THAT-
 - (a) There is no alleged contravention of the provisions of the law quoted therein on his part. The petitioners are merely throwing around sections of the law without explaining how they support their opposition to his appointment. It is an uncontroverted fact that he meets all the qualifications for appointment as Chief Executive Officer of the NG-CDF Board as stipulated under Section 20 of the National Government Constituency's Development Fund Act. Additionally, there is no proof that he has acted in violation of the provisions of Chapter 6 of the Constitution of Kenya;
 - (b) the Petitioners acknowledge the fact that the NG-CDF Board followed due process of recruiting the Chief Executive Officer of the NG-CDF Board through a competitive process as required by Section 20 of the National Government Constituency's Development Fund Act, which process commenced with advertisement in local dailies;
 - (c) After the advertisement, people applied for the position and the NG-CDF Board shortlisted 7 candidates who had met the qualification for appointment under Section 20 of the National Government Constituency's Development Fund Act, whereby he happened to be among the shortlisted candidates;
 - (d) the assertions made by the Petitioners therein are baseless, full of rumors and conjecture. The Petitioners are merely shouting unsubstantiated allegations

- without proving how he failed to meet the requirements of Chapter 6 of the Constitution on Leadership and Integrity;
- (e) the Petitioners DO NOT understand the recruitment process of the Chief Executive Officer of the NG-CDF Board. It is quite lucid that the Petitioners DO NOT understand the role of the NG-CDF Board and the role of Parliament in the recruitment process of the Chief Executive Officer of the NG-CDF Board. This Petition is clearly based on a misapprehension of the law and it should, therefore, be treated with the contempt it deserves;
- (f) the role of recruiting the Chief Executive Officer of the NG-CDF Board lies squarely on the on the NG-CDF Board and not Parliament. Section 20(1) of the National Government Constituency's Development Fund Act provides that "There shall be a chief executive officer of the Board who shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly. The role of the National Assembly in the recruitment process of the Chief Executive Officer of the NG-CDF Board is merely to approve the appointment made by the Cabinet Secretary;
- (g) the allegations of bias in the National Assembly in his favor are unfounded considering that during the interviews conducted by the NG-CDF Board, he emerged the top candidate among the 7 shortlisted candidates where he led with a score of 93%. The second candidate, Prof. Abdille scored 73.3% while the 3rd candidate, Mr. Jacton Omulo Akelo, scored 66.35%. The essence of recruitment through a competitive process is to select the best candidate to take a position. It beats logic for the Petitioners to fantasize that the National Assembly should have approved the appointment of a candidate who scored 66.35% or even 73.3% when he had floored them during the interviews by scoring a whopping 93%;
- (h) that it is not his responsibility to direct parliamentarians how to treat persons who appear before them. The purpose of vetting by parliament is to ensure that the most qualified and morally fit candidate ascends to a given position. Based on his score during the interview with the NG-CDF Board, he was the most qualified

- candidate. Further, the Petitioners have not raised any issues about his moral fitness to hold the office. Accordingly, their claim of biasness in the National Assembly is baseless. The issues raised by the Petitioners clearly indicate that they favored the candidature of Prof. Abdille and/or Mr. Jacton Omulo and they are trying to lobby for their appointment through this Petition;
- (i) his allegiance is to the people of Kenya whom he is constitutionally mandated to serve. He further stated that for the years he has served in the office of the Chief Executive Officer of the NG-CDF Board in an acting capacity, he has never been accused of favoritism. The Petitioners have not adduced any evidence to show his history of favoring others and there is no evidence to suggest that he is likely to favor MPs simply because the National Assembly approved his appointment;
- (j) The National Government Constituency's Development Fund Act clearly stipulates the roles of the Chief Executive Officer of the NG-CDF Board. Section 20(3) of the Act provides that "The chief executive officer shall subject to the directions of the Board be responsible for the day to day management of the affairs and staff of the Board." However, just like any other agencies in the Executive Arm of Government, the Board is subject to the oversight role of Parliament. Section 18(3) of the Act requires the NG-CDF Board to refer policy issues to the Cabinet Secretary. Accordingly, my office will be subject to oversight by parliament and the NG-CDF Board;
- (k) With regards to him serving the same position eight and a half years, has never served as a substantive holder of the office of the Chief Executive Officer of the NG-CDF Board. He only served in an acting capacity. The There are no specifications as to the exact term limit for an acting CEO of the NG-CDF Board. A substantive holder of the office is appointed by the NG-CDF Board through a competitive process. He has never gone through such recruitment before. Accordingly, he qualifies to be appointed as the substantive holder of the office after serving in an acting capacity;

- (I) On the allegations of fraudulent withdrawals from the NG-CDF Board Account they are a misrepresentation of the contents of the Auditor General's Report. The payment in the Bank not captured in the cashbook as stated in the Auditor General's report are as a result of cybercrime by external fraudsters alien to the Board. Some were arrested by the Banking Fraud Investigation Unit and charged in court. The case is still on-going and the officers of the Board are key witnesses; and
- (m) His appointment to the office of the CEO of the NG-CDF Board was done in accordance with the law and through a competitive recruitment process.

3.0 APPROVAL HEARINGS

- 37. Having received the name of the nominee, the Committee commenced the approval process in accordance with the Constitution, the Public Appointments (Parliamentary Approval Act) (No.33 of 2011) and Section 15 of the NG-CDF Act of 2015.
- 38. Committee held two meetings: The approval hearing meeting on Thursday 23rd April, 2020 and a meeting on 28th April, 2020 to draft, consider and adopt its report.
- 39. In carrying out the vetting exercise, the Committee was guided by the Constitution, the Public Appointments (Parliamentary Approval) Act (No. 33 of 2011), the National Government Constituencies Development Fund Act of 2015, and the National Assembly Standing Orders.
- 40. The Committee also considered the following in vetting the nominee: -
 - (i) Academic qualifications;
 - (ii) Employment record and work experience;
 - (iii) Professional association;
 - (iv) Public office, political activities and affiliations;
 - (v) Potential conflict of interest;
 - (vi) Suitability to the position;
 - (vii) Integrity; and
 - (viii) Expectations and key priorities.

3.1 Vetting of Mr. Yusuf Mbuno

41. The nominee, Mr. Yusuf Mbuno, appeared before the Committee on Thursday, 23rd April, 2020 at 10.00 am and was vetted pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approval) Act, 2011, the National Government Constituencies Development Act, 2015 and the Standing Orders of the National Assembly. The Committee took note of his submissions-

Citizenship, Date and Place of Birth

42. He is Kenyan, male citizen, identity card Number 8456646, born in 1966 in Makueni County.

Academic and Professional Qualifications

43. He is a holder of a Master's Degree in Economics from University of Nairobi. He earned his Bachelor degree in Economics from the University of Nairobi. Mr Yusuf Mbuno passed a Kenya Advanced Certificate of Education from Kenyatta High School and Kenya Certificate of Education from Joana Chase Secondary School.

Work and Professional Experience

44. He is currently the Acting Chief Executive Officer of the National Government Constituencies Development Fund Board; He substantively holds the position of National Programme Coordinator, NGCDF. Previously, he was head of Planning and Monitoring Unit in the Ministry of Lands as well as Principal Economists in the Department of Development in Kilifi District. He has over 28 years' experience in the public service having served from the year 1991 to 2020, of which 16 years were in a senior management position.

Honors and Awards

- 45.Mr. Yusuf Mbuno stated that he had received various awards among them -
 - (i) GOK scholarship for undergraduate studies-UoN.
 - (ii) GOK M.A scholarship- UoN.

Professional Associations

46. The nominee stated that he is a member of the Economist Society of Kenya

Other Activities and Membership

47. The nominee is a member of the Board of Management, Joanna Chase Secondary School and a member of the Board of Management of Kyaani Secondary school.

Published Writing

- 48. The nominee submitted that he has authored the following publications -
 - (i) Factors determining childhood immunization in the Coast Province of Kenya, 2006-UoN
 - (ii) District Planning Handbook, Minisytry of Planning -2006
 - (i) Kilifi District Development Plan, 2002-2008
 - (ii) NGCDF Board strategic plan 2016/2017-2020/2021

Political Activities and Affiliations

49. The nominee had no record of political activities and affiliations to any political party.

Potential Conflict of Interest

50. He had not shown any immediate associations that are likely to present potential conflict of interest when he assumes the position.

Sources of Income and Net-worth

51. The nominee's estimated financial net worth was at Ksh. 58,000,000 (Fifty eight Million only).
His sources of income included: Salary and Sacco dividends earnings.

Integrity

- 52. The nominee stated that he had not been dismissed or otherwise removed from office for contravening the provisions of Article 75 of the Constitution. He has also not been adversely associated with practices that depict bias, favouritism or nepotism in the discharge of public duties.
- 53. He pointed out that he has fully complied with the tax obligations to the State for the financial year immediately preceding his nomination for the appointment.
- 54. The nominee further submitted that he has not been charged in court of law in the last three years or been adversely been mentioned in an investigatory report of Parliament or any other Commission of inquiry in the last three years. He had ever appeared in court only for a minor traffic offense which was discharged.

General Questions and Sector specific questions to the Nominee

55. In order to assess his overall suitability on the position, the Committee examined the nominee on general and specific thematic areas which the nominee responded to as follows: -

The Values and Principles under Article 10 and 232 of the Constitution.

- 56. He submitted that as the acting CEO of NGCDF he was guided by the principles and values provided under article 10 and 232 of the Constitution. These values have been incorporated in all working documents of the Board such as the manuals, strategic plan as well as the daily operations of the Board. The Board is guided by patriotism, transparency and accountability and responsiveness. The transparency of the projects are public and every constituency is held accountable for the use of funds, where each constituency submit a separate financial statement to the Auditor General.
- 57. He also averred that selection and recruitment of human resource has been guided by meritocracy. The Board has developed human resources guidelines that incorporated values and principles under article 232 of the Constitution.

Handling of complaints related to Funds Account Managers

- 58. The Nominee informed the Committee that he handled complaint related to Managers as follows-
 - Held a meeting where all the Managers were invited for meeting with the parliamentary committee to respond to issues that were either political in nature or were difficult for the Board to resolve.
 - ii. Monitored the daily attendance of duties of the Managers with the help of the Constituency Committees
 - iii. Took seriously complaints raised by Members about the Managers. The managers were required to institute corrective measures once the complaint has been conclusively discussed. In cases where a Manager had persistently not performed as required the Board, then disciplinary action had been taken in line with the Human Resources guidelines, some action leading to termination of contract.
 - iv. The Board was considering further measures to ensure the availability of the Managers

in their workstations

Work experience and relevance to the position

59. The Nominee informed the Committee that he had cumulative work experience of 28 years in the public Service, 16 of which were in a senior management position of job group P and above. He joined the Public Service in 1991 as an economist and rose through the ranks to the highest position in the scheme of service of that position to Chief Economist. He also held other position such as the Head, central planning and Monitoring Unit, ministry of lands and the National Programme Coordinator, NGCDF. He is currently the Acting CEO of NGCDF overseeing all the budgeting, financial management, strategy development, procurement, and human resource, accounting, administration, accounting and related matters. He has held this position from 2011 to date.

Vision 2030 and the Big Four Agenda

60. The nominee stated that vision 2030 is the nation's development blue print. All public institutions including the Board are expected to implement their projects and programmes in line with the vision's goals and aspirations. He stated that the vision is implemented through a series of 5 year's medium term projects. He averred that in relation to the Big four agenda, the Board implements projects through a five year strategic plan supporting the key areas under the Big Four Agenda such as bursary for students to invest in critical technical competencies to drive the manufacturing sector, engagement with NHIF to provide social protection to members of the community among other important projects that contribute to food security.

Leadership and integrity

61. The nominee submitted that leadership and integrity values in the constitution are operationalized through the leadership and integrity Act. He averred as a public servant he understood the position his position in trust for the public. They (Board) have put deterrent measures in place to reduce cases of corruption, where necessary they have also invited investigatory authorities to come in either to investigate any reported malpractices or create awareness as well as initiated restoration mechanisms through the Assets Recovery Agency. The board have also invested in capacity building of its personnel and oversees a performance contracting regime. They have also involved the public in reporting corruption cases through the

Board's website and automated their system. The board therefore provides the kind of leadership envisaged in the constitution.

55. Relationship between the Board and Members of Parliament

62. The nominee submitted his engagement with members of parliament began when he was a District Development Officer (DDO). It was during this period that the CDF fund was initiated. During his time in the Board he had ensured clear communication lines with the Members of parliament and ensured that his staffers had the necessary set of skill to receive and attend to the members needs in relation to the fund. He also informed the Committee that the Board was always open to the Members and specific engagements have taken place between the Members of the Select Committee and the Board.

4.0 COMMITTEE OBSERVATIONS

63. The Committee made the following observations having considered the nominees' curriculum vitae, filled questionnaire pursuant to the Schedule to the Public Appointments (Parliamentary Approval) Act No. 33 of 2011 and the oral submissions during the approval hearings:

- (1) The nominee is a Kenyan citizen born in Makueni County;
- (2) He has 28 years of experience, having been in the public service since the year 1991, of which 16 years were in senior management positions of job group P and above.
- (3) He holds a Masters of Arts degree in Economics, and a Bachelor of Arts degree in Economics from the University of Nairobi which are related degrees for the purposes of section 20 (2)(a) of NGCDF Act 2015;
- (4) The EACC, KRA, DCI, ORPP, and HELB had sent clearance letters with respect to the nominee;
- (5) The nominee has not been charged in a court of law in the last three years;
- (6) As stipulated in Article 75(1) of the Constitution, he has not shown the possibility of potential conflict of interest.
- (7) He satisfies the requirements of Article 77(1) of the Constitution in that, he does not intend to participate in any other gainful employment if appointed as the Chief Executive Officer of the National Government Constituencies Development Board;
- (8) The nominee does not hold office in any political party and therefore meets the requirements of Article 77(2) of the Constitution;
- (9) The nominee has not been dismissed from a public office;
- (10) The nominee exhibited knowledge of the workings of the public service and displayed profound knowledge in the operation of the NG-CDF fund.

5.0 COMMITTEE RECOMMENDATION

64. The Committee having considered the suitability, capacity and integrity of the nominee following the vetting process, and taking into account its observations, and pursuant to Section 8(2) of the Public Appointments (Parliamentary Approval) Act, 2011, the National Government Constituency Development Act 2015, the Committee hereby recommends that the National Assembly **APPROVES** the nomination of Mr. Yusuf Mbuno for appointment to the position of the Chief Executive Officer of the National Government Constituencies Development Fund Board.

REPLYING AFFIDAVIT TO THE PETITION AND THE PETITIONER'S SUPPORTING AFFIDAVIT

- I, YUSUF MBUNO, a resident of Nairobi and of Post Office Box 9876-00200 NAIROBI do hereby make oath and state as follows:
 - THAT I am the Chief Manager-Programs and serving as the Acting Chief Executive
 Officer of the National Government Constituencies Development Fund Board (hereinafter
 "the NG-CDF Board").
 - 2. THAT I am also the person nominated by the Cabinet Secretary in charge of the National Treasury and Planning for appointment as the Chief Executive Officer of the NG-CDF Board and the subject of a Petition dated 18th April, 2020 filed by one Tolbert Manyange and five other petitioners, seeking to challenge my nomination for appointment to the



- position of the Chief Executive Officer of NG-CDF Board. That I am well versed with the facts elicited in the said Petition and, therefore, competent to swear this Affidavit.
- 3. THAT the Petition is scandalous and frivolous with the sole aim of causing mayhem and disrupt a constitutional process that was initiated legally and performed within the confines of the laws of Kenya as regards to due process.
- 4. THAT in response to paragraphs 1 and 2 of the Petition and paragraphs 2 and 3 of the Petitioner's Supporting Affidavit, I would like to state that there is no alleged contravention of the provisions of the law quoted therein on my part. The petitioners are merely throwing around sections of the law without explaining how they support their opposition to my appointment. It is an uncontroverted fact that I meet all the qualifications for appointment as the Chief Executive Officer of the NG-CDF Board as stipulated under Section 20 of the National Government Constituency's Development Fund Act. Additionally, there is no any prove that I have acted in violation of the provisions of Chapter 6 of the Constitution of Kenya.
- 5. THAT in response to paragraph 3 of the Petition and Paragraph 4 of the Petitioner's Supporting Affidavit, I would like to respond that it is true that the NG-CDF Board placed an advertisement in local dailies on the 17th day of December, 2019 inviting qualified candidates to apply for the position of the Chief Executive Officer of the NG-CDF Board.
- 6. THAT in further response to paragraphs 3 and 5 of the Petition and Paragraphs 4 and 6 of the Petitioner's Supporting Affidavit, it is clear that the Petitioners acknowledge the fact that the NG-CDF Board followed due process of recruiting the Chief Executive Officer of the NG-CDF Board through a competitive process as required by Section 20 of the National Government Constituency's Development Fund Act, which process commenced with advertisement in local dailies.
- 7. THAT after the advertisement, people applied for the position and the NG-CDF Board shortlisted 7 candidates who had met the qualification for appointment under Section 20 of the National Government Constituency's Development Fund Act, whereby I happened



to be among the shortlisted candidates. Annexed and Marked "YM1" is a list of the shortlisted candidates.


- 8. THAT in response to paragraph 4 of the Petition and paragraph 5 of the Petitioner's Supporting Affidavit, I would like to reiterate the contents of paragraph 4 of this Supporting Affidavit and further state that the assertions made by the Petitioners therein are baseless, full of rumors and conjecture. The Petitioners are merely shouting unsubstantiated allegations without proving how I fail to meet the requirements of Chapter 6 of the Constitution on Leadership and Integrity.
- 9. THAT in response to paragraphs 6 and 7 of the Petition and Paragraphs 7 and 8 of the Petitioner's Supporting Affidavit, I would like to state that it is clear the Petitioners DO NOT understand the recruitment process of the Chief Executive Officer of the NG-CDF Board. It is quite lucid that the Petitioners DO NOT understand the role of the NG-CDF Board and the role of Parliament in the recruitment process of the Chief Executive Officer of the NG-CDF Board. This Petition is clearly based on a misapprehension of the law and it should, therefore, be treated with the contempt it deserves.
- 10. <u>THAT</u> in further response to paragraphs 6 and 7 of the Petition and paragraphs 7 and 8 of the Petitioner's Supporting Affidavit, I would like to state that the role of recruiting the Chief Executive Officer of the NG-CDF Board lies squarely on the on the NG-CDF Board and not Parliament. Section 20(1) of the National Government Constituency's Development Fund Act provides that "There shall be a chief executive officer of the Board who shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly."
- 11. <u>THAT</u> the role of the National Assembly in the recruitment process of the Chief Executive Officer of the NG-CDF Board is merely to approve the appointment made by the Cabinet Secretary.
- 12. THAT the allegations of bias in the National Assembly in my favor are unfounded considering that during the interviews conducted by the NG-CDF Board, I emerged the

top candidate among the 7 shortlisted candidates where I led with a score of 93%. The second candidate, Prof. Abdille scored 73.3% while the 3rd candidate, Mr. Jacton Omulo Akelo, scored 66.35%. It is a matter of common sense that the essence of recruitment through a competitive process is to select the best candidate to take a position. It beats logic for the Petitioners to fantasize that the National Assembly should have approved the appointment of a candidate who scored 66.35% or even 73.3% when I had floored them during the interviews by scoring a whopping 93%.

- 13. THAT without prejudice to the foregoing, I would like to state that it is not my responsibility to direct parliamentarians how to treat persons who appear before them. The purpose of vetting by parliament is to ensure that the most qualified and morally fit candidate ascends to a given position. Based on my score during the interview with the NG-CDF Board, I was the most qualified candidate. Further, the Petitioners have not raised any issues about my moral fitness to hold the office. Accordingly, their claim of biasness in the National Assembly is baseless. The issues raised by the Petitioners clearly indicate that they favored the candidature of Prof. Abdille and/or Mr. Jacton Omulo and they are trying to lobby for their appointment through this Petition.
- 14. THAT in response to paragraphs 8, 9, 10, and 11 of the Petition as well as paragraphs 9, 10, 11, and 12 of the Petitioner's Supporting Affidavit, I would like to state that my only allegiance is to the people of Kenya whom I am constitutionally mandated to serve. Further, I would like to state that for the years I have served in the office of the Chief Executive Officer of the NG-CDF Board in an acting capacity, I have never been accused of favoritism. The Petitioners have not adduced any evidence to show my history of favoring others. There is no evidence to suggest that I am likely to favor MPs simply because the National Assembly Approved my appointment. My predecessors went through the same process of vetting and I am made to wonder why the Petitioners believe I should not go though the same.
- 15. THAT in further reply to paragraphs 8, 9, 10, and 11 of the Petition and paragraphs 9, 10, 11, and 12 of the Petitioner's Supporting Affidavit, I would like to state that the National Government Constituency's Development Fund Act clearly stipulates the roles of the Chief Executive Officer of the NG-CDF Board. Section 20(3) of the Act provides that "The

chief executive officer shall subject to the directions of the Board. be responsible for the day to day management of the affairs and staff of the Board." However, just like any other agencies in the Executive Arm of Government, the Board is subject to the oversight role of Parliament. Section 18(3) of the Act requires the NG-CDF Board to refer policy issues to the Cabinet Secretary. Accordingly, my office will be subject to oversight by parliament and the NG-CDF Board.

- 16. THAT in response to paragraphs 12 and 13 of the Petition and paragraphs 13 and 14 of the Petitioner's Supporting Affidavit, I would like to state that I have never served as a substantive holder of the office of the Chief Executive Officer of the NG-CDF Board. I have only served in an acting capacity. The There are no specifications as to the exact term limit for an acting CEO of the NG-CDF Board. A substantive holder of the office is appointed by the NG-CDF Board through a competitive process. I have never gone through such a recruitment before. Accordingly, I qualify to be appointed as the substantive holder of the office after serving in an acting capacity.
- 17. THAT in response to paragraphs 17 and 18 of the Petition and paragraphs 17, 18, 19, and 20 of the Petitioner's Supporting Affidavit, the allegations of fraudulent withdrawals from the NG-CDF Board Account are a misrepresentation of the contents of the Auditor General's Report. The payment in the Bank not captured in the cashbook as stated in the Auditor General's report are as a result of cybercrime by external fraudsters alien to the Board. Some were arrested by the Banking Fraud Investigation Unit and charged in court. The case is still on-going and the officers of the Board are key witnesses.
- 18. THAT in further reply to paragraph 19 of the Petitioner's Supporting Affidavit, I would like to state that my appointment to the office of the CEO of the NG-CDF Board was done in accordance with the law, through a competitive recruitment process.
- 19. <u>THAT</u> in light of the foregoing, the orders and declarations sought by the petitioner are untenable as the entire application and petition are premised on falsehood, misrepresentation, and misinterpretation of the law.



20. THAT what is deponed herein is true to the best of my knowledge, information, and belief.

REPLYING AFFIDAVIT TO THE PETITION AND THE PETITIONER'S SUPPORTING AFFIDAVIT

- I, YUSUF MBUNO, a resident of Nairobi and of Post Office Box 9876-00200 NAIROBI do hereby make oath and state as follows:
 - THAT I am the Chief Manager-Programs and serving as the Acting Chief Executive Officer of the National Government Constituencies Development Fund Board (hereinafter "the NG-CDF Board").
 - 2. THAT I am also the person nominated by the Cabinet Secretary in charge of the National Treasury and Planning for appointment as the Chief Executive Officer of the NG-CDF Board and the subject of a Petition dated 20th April, 2020 filed by one Sam Kinyua and four other petitioners, seeking to challenge my nomination for appointment to the

position of the Chief Executive Officer of NG-CDF Board. That I am well versed with the facts elicited in the said Petition and, therefore, competent to swear this Affidavit.

- THAT the Petition is scandalous and frivolous with the sole aim of causing mayhem and disrupt a constitutional process that was initiated legally and performed within the confines of the laws of Kenya as regards to due process.
- 4. THAT in response to paragraphs 1 and 2 of the Petition and paragraphs 3 and 4 of the Petitioner's Supporting Affidavit, I would like to state that the Petitioner's main issue is with the alleged ambiguities is our legislation and not my fitness to be appointed as the Chief Executive Officer of the NG-CDF Board. If the Petitioners want an amendment to our laws, they should follow the correct procedure. The Petitioners' move to oppose my appointment is not made in good faith, considering that my appointment has been made with strict adherence and compliance with the existing laws.
- 5. THAT in further response to paragraphs 1 and 2 of the Petition and paragraphs 3 and 4 of the Petitioner's Supporting Affidavit, I would like to state that Section 20(1) of the NG-CDF Act establishes the office of the chief executive officer of the NG-CDF Board and the process of his recruitment. The section provides that the NG-CDF Board CEO "shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly." Section 20(4) provides that the CEO recruited as per the provisions of the section shall serve for a period of three years, renewable once. Accordingly, the later provision sets a term limit for the CEO to a maximum of six years.
- 6. THAT in addition to the foregoing answers to paragraphs 1 and 2 of the Petition and paragraphs 3 and 4 of the Petitioner's Supporting Affidavit, I would like to inform this Honorable house that I have NEVER been recruited as CEO of the NG-CDF Board as per the dictates of Section 20(1) of the NG-CDF Act. All along, I have been serving in an acting capacity. A person serving in an acting capacity is not subject to term limits associated with that office. Only a substantive holder of an office is subject to term limits of an office. There is NO law that I know of which stops a person serving in an acting

capacity from applying to be considered for appointment as a substantive holder of that same office.

- 7. THAT the rational for appointing someone to hold an office in an acting capacity is simply to ensure the smooth running of an office and to avoid a vacuum that would cripple service delivery. The most important thing to note is that a person holds office in an acting capacity while he/she awaits the relevant authorities to nominate and appoint a substantive holder of that office. Similarly, I have been serving as the Acting CEO of the NG-CDF Board awaiting the relevant authorities to appoint a substantive holder. I cannot be blamed for the length of time I have served in an acting capacity. Further, there is no law that automatically changed my status from acting CEO of NG-CDF to a substantive CEO as the Petitioners claim. The office of the CEO NG-CDF Board is established under the NG-CDF Act and any appointment to that office should be made according to that Act.
- 8. THAT in any case, an employee is supposed to hold office as per the terms and conditions of the engagement contract. The letter of appointment appointing me serve to serve as the CEO of the NG-CDF Board in an acting capacity clearly stated that I was appointed to hold office until such a time when the office was to be filled substantially. Accordingly, the term and conditions of the letter of appointment stipulate the term limit, which is "until such a time when the position is filed by a substantive holder." The terms exclude the application of section 20(4) of the NG-CDF Act, which only applies to a substantive holder of the office. Additionally, the fact that I served the office in an acting capacity does not by itself stop or exclude me from applying to be considered for appointment as a substantive holder of the office. It is clear that the Petitioners misread and misinterpreted our laws.
- 9. THAT in response to paragraphs 4 and 5 of the Petition and Paragraphs 6 and 7 of the Petitioner's Supporting Affidavit, I would like to reiterate the contents of paragraphs 4, 5, 6, 7, and 8 of this Reply Affidavit and further accentuate that the Petitioners have clearly misconstrued our laws.
- 10. <u>THAT</u> the claims made in paragraphs 6, 7, and 8 of the Petition and paragraphs 8, 9, and 10 of the Petitioner's Supporting Affidavit are a classic demonstration that the Petitioners

are clueless and have a shallow understanding about the roles one performs while serving in an acting capacity. Section 2 of the Public Service Commission Act, 2017 defines "acting appointment" to mean temporary conferment upon a public officer, by the Commission or the relevant appointing authority, the power to perform duties of a public office other than the office the officer is substantively appointed to hold, while the public officer continues to hold the substantive appointment. Accordingly, the mere fact that I performed the roles of a NG-CDF Board CEO does not mean I automatically became a substantive holder of that office. An acting officer performs similar roles that a substantive holder of that office would have performed, but on temporary terms.

- 11. THAT in response to paragraphs 9, 10, 11, and 12 of the Petition and paragraphs 11, 12, 13 and 14 of the Petitioner's Supporting Affidavit, I would like to reiterate the contents of paragraphs 4, 5, 6, 7, and 8 of this Reply Affidavit and further states that the law allows me to apply and be considered for appointment to the position of the CEO NG-CDF Board. This is in consideration that I have never been appointed to the office according to our laws. If the Petitioners feel aggrieved by the laws that allow my appointment, then they should challenge the constitutionality of those laws or request their amendment. Such requests should be formally tabled to Parliament for consideration and not by way of challenging my appointment.
- 12. THAT the Petitioners' claims contained in paragraph 13 of the Petition is a clear misapprehension of paragraph C.14(1)-(9) of the Human Resource Policies and Procedure Manual for the Public Service Commission. The paragraph deals with allowances paid to an officer serving in an acting capacity and nothing further.
- 13. THAT in response to paragraphs 14, 15, and 16 of the Petition and paragraphs 15, 16, 17, and 18 of the Petitioner's Supporting Affidavit, I would like to reiterate the contents of paragraphs 4, 5, 6, 7, and 8 of this Replying Affidavit and further state the Board is an independent body and I cannot by any means whatsoever influence its decision in the recruitment process. The petitioners are merely speculating without any form of evidence to prove I could possibly influence the decision of the Board. It is appalling that the



Petitioners could table a petition of this magnitude to this Honorable House based on pure speculations and outright misapprehension of our laws.

- 14. <u>THAT</u> paragraphs 17 and 18 of the Petition and paragraphs 18 and 19 of the Petitioners' Supporting Affidavit are based on a fallacious interpretation of our laws and I urge this Honorable House to treat them with the contempt they deserve.
- 15. THAT comparing the office of the NG-CDF Board CEO to that of other constitutional bodies as the Petitioners have done in paragraph 19 of the Petition and paragraph 20 of the Supporting Affidavit is a clear indication that the Petitioners are misguided. The office of the NG-CDF Board CEO is established under the NG-CDF Act and the terms of service and stipulated therein. The other referenced bodies are established under different Acts of Parliament, which also specify the terms of office. A comparison of the offices cannot be afforded as the laws stipulate different terms for different offices based on the unique needs and demands of each office. Furthermore, the officers mentioned were substantive holders of the respective offices, unlike in my case where I have been serving in an acting capacity awaiting a competitive recruitment process as provided under Section 20(1) of the NG-CDF Act.
- 16. THAT in paragraphs 21 and 22 of the Petition and paragraph 22 and 23 of the Petitioner's Supporting Affidavit, the Petitioners correctly acknowledge that the matters elicited in their Petition are subject to an on-going litigation in the High Court. Accordingly, any further hearing of this Petition is in violation of our Sub Judice laws as well as Standing Order No. 89 of The National Assembly Standing Orders as adopted by the National Assembly on 9th January, 2013 during the Fourth Session of the Tenth Parliament. The Standing Order prohibits members from referring to any particular matter which is Sub Judice. A matter shall be considered to be sub judice when it refers to active criminal or civil proceedings and the discussion of such matter is likely to prejudice its fair determination. To avoid violating the Sub Judice Rule, the best action is for the Petitioners to apply to be added as interested parties in the on-going High Court Petition.



- 17. <u>THAT</u> the Petitioners' Petition is ill-founded with a dubious factual basis and a fallacious interpretation of both the constitution and the relevant statutory provisions.
- 18. <u>THAT</u> in light of the foregoing, the orders and declarations sought by the petitioner are untenable as the entire application and petition are premised on falsehood, misrepresentation, and misinterpretation of the law.
- 19. <u>THAT</u> what is deponed herein is true to the best of my knowledge, information, and belief.




We the undersigned deponents,

Citizens of Kenya, representing individuals listed herein below, wish in the interest of the republic, to lodge this petition concerning the appointment of the Chief Executive Officer of The Board of the National Government Constituency's Development Fund Board under section 20 of the National Government Constituency's Development Fund Act.

We bring the attention of the August House to the critical provisions of the law and constitution of Kenya that would otherwise be violated, if Mr Yusuf Mbuno was to be appointed;

- 1. THAT, under article 259 (3)(b) of the Constitution of Kenya, which is couched in mandatory terms - "...SHALL.." it is provided that; "any reference to a state or other public office or officer, or a person holding such an office, includes a reference to the person acting in or otherwise performing the functions of the office at any particular time."
- 2. THAT as it is, as far as Mr Yusuf Mbuno's (intended) appointment is concerned, it is in violation of article 259 (3)(b) of the unambigious provision of the Constitution for the reasons THAT;







- a) The law provides under the National Government Constituencies Development Fund Act, section 20 (4) <u>THAT</u> the holder of the office <u>shall</u> serve for three (3) years, <u>THAT</u> is renewable once.
- b) Mr. Yusuf Mbuno has stayed to act since 2011 and has remained for 8 years consecutively in acting capacity, contrary to the law.
- c) Thus, he has not only served beyond the normal term of three years <u>THAT</u> is renewable once -to 6 years, but he has illegally gone beyond the maximum term by two years.
- d) That if he were to be confirmed he will not only be serving not only twice above the time limit, but by an outrageous extention of 8 years assuming he is confirmed and then, he takes the position that his term is beginning afresh.
- e) In any case, in matters of employment, if one serves beyond six (6) months in given position, it's deemed that you have assumed the substantive role of that job.
- 3. <u>THAT</u> as stated, the period of service of the CEO both in the NGCD Fund act and the Constitution is couched in mandatory term "..SHALL..."
- 4. THAT we humbly submit that Mr Mbuno is not above the law nor is he exempted by the Constitution.
- 5. <u>THAT</u> Mr Mbuno is not supposed to be allowed to use technicalities to perpetuate mischief or violate the express statutory provisions and the Constitution.
- 6. <u>THAT</u> in the NGCD Fund Act, it is provided in Section 20, sub-section 3 that "..the CEO shall be responsible for the day to day management the affairs of the Board."
- 7. THAT it is also provided in Section 13(3) of the NGCD Fund Act that "the signing instructions shall be such that the signature of the CEO SHALL be mandatory on all payment cheques and/or instruments intended for actual release of money from the fund."
- 8. <u>THAT</u> the afore stated functions in our paragraph 6 & 7 is exactly the duties that Mr Mbuno has been discharging for the last 8 and a half years.
- 9. THAT as per article 259 of the Constitution which is also couched in mandatory terms "..SHALL.." Mr Mbuno has not only served the stipulated term, but has already exceeded it by two years.
- 10. THAT it is an understatement to state that there are queries about Mr Mbuno's tenure.
- 11. <u>THAT</u> in the event Mr mbuno submits that he has not been the CEO, then he wants to use a technicality contrary to the provisions of the new Constitution...... or in the alternative, he wants to benefit from an illegality.
- 12. THAT Mr Mbuno is estopped from further serving as the CEO to the fund.
- 13. <u>THAT</u> further Mr. Mbuno's tenure in office violates the spirit and intention of Human Resource Policies and Procedure Manual for the public service(May,2016). para.c14(1)-(9)
- 14. <u>THAT</u> Mr Mbuno had been seconded by the Ministry of Planning during the time that Hon. Wyclifff Oparanya served as Minister of planning eight (8) years ago and has acted in that role for the aforesaid period.
- 15. <u>THAT</u> I have reason to believe that Mr Mbuno has had his time at the fund having served if for the past eight (8) years as opposed to the maximum of six years prescribed by sub-section 4 of Section 20 of the Governing Act.



- i) <u>THAT</u> if he were to be confirmed he will not only be serving not only twice above the time limit, but by an outrageous extention of 8years –assuming he is confirmed and then, he takes the position that his term is beginning afresh.
- j) In any case, in matters of employment, if one serves beyond six (6) months in given position, it's deemed that you have assumed the substantive role of that job.
- 5. <u>THAT</u> as stated, the period of service of the CEO both in the NGCD Fund act and the Constition is couched in mandatory term "...SHALL..."
- 6. THAT we humbly submit that Mr Mbuno is not above the law nor is he exempted by the Constition.
- 7. <u>THAT</u> Mr Mbuno is not supposed to be allowed to use technicalities to perpetuate mischief or violate the express statues and the Constitution.
- 8. <u>THAT</u> in the NGCD Fund Act, it is provided in Section 20, sub-section 3 that "..the CEO shall be responsible for the day to day management the affairs of the Board."
- 9. THAT it is also provided in Section 13(3) of the NGCD Fund Act that "the signing instructions shall be such that the signature of the CEO SHALL be mandatory on all payment cheques and/or instruments intended for actual release of money from the fund."
- 10. <u>THAT</u> the afore stated functions in our paragraph 4 & 5 is exactly the duties that Mr Mbuno has been discharging for the last 8 and a half years.
- 11. THAT as per article 259 of the Constition which is also couched in mandatory terms "..SHALL.." Mr Mbuno has not only served the stipulated term, but has already exceeded it by two years.
- 12. THAT it is an understatement to state that there are queries about Mr Mbuno's tenure.
- 13. <u>THAT</u> in the event Mr mbuno submits that he has not been the CEO, then he wants to use a technicality contrary to te provisions of the new Constition..... or in the alternative, he wants to benefit from an illegality.
- 14. THAT Mr Mbuno is estopped from further serving as the CEO to the fund.
- 15. <u>THAT</u> Mr Mbuno had been seconded by the Ministry of Planning during the time that Hon. Wyclifff Oparanya served as Minister of planning eight (8) years ago and has acted in that role for the aforesaid period.
- 16. <u>THAT</u> I have reason to believe that Mr Mbuno has had his time at the fund having served if for the past eight (8) years as opposed to the maximum of six years prescribed by sub-section 4 of Section 20 of the Governing Act.
- 17. <u>THAT</u> further, Mr Mbuno having been the acting head of the fund for the past eight years and having worked together with the Fund Board for the aforesaid Perioud of time has influence on the board and will not be competitively selected due to his influence.
- 18. <u>THAT</u> I sincerely believe that apart from the violation of the Constition, Section 20 (4) subsection one cannot and will not be complied with it if the said Mr Mbuno were to be allowed to present himself for selection to head the fund for that he now commands in the influence GMV the board and staff he has been working with the past eight years.
- 19. <u>THAT</u> I believe the best thing for for Mr Mbuno is to step down in view of his aforesaid past stint at the fund so that competitiveness can be seen to having been applied in the recruitment to



head the Fund, Mr Mbuno should have therefore done the honourable thing by not offering himself for recruitment to head the fund as the Chief Executive Office.

- 20. <u>THAT</u> it is noted that he has remained in one position for unusually long period of time and that in the said period others holding constitional office have either retired or moved on to other roles;
 - d) Mrs Agnes Odhiambo who was the previous CEO of the same body went on to serve as the Controler of budget and has retired having served her time
 - e) Hon. Wycliff Oparanya having served as Minister in Kibaki's government, is serving his second term as governor of Kakamega.
- 21. THAT there is grave concern as to why Mr Mbuno has stuck in the same office for so long and this is a matter that has i) been raised in parliament severally as per hansard for. May 1919
- 22. THAT the same concern has also been subject of litigation in the High Court of Kenya see...
- 23. <u>THAT</u> there are now good grounds to question exactly as to how and why Mr Mbuno has retained his position illegally.
- 24. <u>THAT</u> be as it may, the Hon. CS. Finance, cannot breath life into Mr Yusuf Mbuno, for the latter having served beyond (6) years. In case he wants to continue serving the government, he ought to be redeployed but in the alternative, he retires and seek his terminal benefits.
- 25. <u>THAT</u> there are precedents in that if one serves for a period that covers the term limit, you are re-deployed by the appointing authourity. that was the case with a previous officer who was once holding the post of CEO to NGCD Fund Act.
- 26. <u>THAT</u> it is evident that the framers of the constitution never intended that out of technicality or for whatever reason, CEO to the fund should never hold the office in perpetuity.
- 27. <u>THAT</u> further if Mr. Yusuf Mbuno is appointed to this position it will have been prejudicial to the competitive process.
- 28. <u>THAT</u> if the Mr. Yusuf Mbuno is to be appointed, the working of the body will be premised on a wrong LEGAL foundation.
- 29. THAT now annexed and marked:

- 2. <u>THAT Mr.</u> Yusuf Mbuno's fails the test of the job requirements and is unqualified to serve as far as the law and articles 259 (1) read with sub-section (3)(b) of the Constitution is concerned.
- 3. <u>THAT</u> the intended appointment of Mr. Yusuf Mbuno as CEO of National Government Constituency's Development Fund Board will violate the principles and values enshrined in Articles 6,10 and 73 of the Constitution.

Thus, his appointment will greatly affect the delivery of services and negatively affect people and institutions that will greatly depend on the CEO's integrity -which unfortunately he doesn't possess.
- 9. <u>THAT</u>, with the MPs' open biasness and hostility towards other candidates, if Mr. Yusuf Mbuno is appointed to this position it will be prejudicial to other applicants who meet the integrity criteria.

That for the foregoing reasons the selection will not also be competitive more so when it comes to vetting by members of the National Assembly who have a close working relationship with the said Mr Mbuno. He has been the one responsible for disbursing to them for their Constituency Development funds.
- 11. That the said Members of the National Assembly will have the last say in the selection if the individual to head the Fund and due to their familiarity with Mr Mbuno, it is not foreseeable that they will act fairly as against the other candidate (s) who maybe equally qualified for selection or recruitment.
- 12. THAT further, Mr Yusuf Mbuno has already served in the same position for almost 8 & half years in an acting capacity. The maximum period of service for the CEO for NG-CDF is 6 (six) years. In the event Mr Yusuf Mbuno is given the seat of being the CEO's position, it will be a gross violation of the spirit of the Act of the NG-CDF act that provided for a term of three (3) years that is renewed once. Essentially Mr Yusuf Mbuno will be serving a for a record 12 years and a possible term of 14 years.
- 13. THAT the same will bring serious questions concerning whose interest Mr Mbuno is serving and erode public confidence as to whether their funds are properly managed.

- 14. THAT the appointment of Mr. Yusuf Mbuno will be inconsistent with the guiding principles of Leadership and Integrity under Chapter six of the Constitution Article 73(2a) which requires selection on the basis of personal integrity, competence and suitability. In contrast, Mr Mbuno's appointment will be based on the patronage, favouritism and biasness by the MPs.
- **15.** THAT if he were to be appointed, the appointment would impact negatively the National Government's nine (9) point agenda and make Government's Vision 2030 an illusion.

THAT the National Assembly, in approving a CEO for National Government Constituency's Development Fund Board appointment, should ensure that the MPs follow the law and thus save the public from biasness, favouritism and/or patronage of any candidate. The MPs should therefore reject the nomination of Mr. Yusuf Mbuno by the Cabinet Secretary (National Treasury and Planning).
- 17. THAT further, there are queries on Mr Mbuno's management of funds during his tenure. He has adversely been mentioned in fraudulent withdrawals and questionable expenditures from time to time throughout his term as CEO of NG-CDF Board in that for instance;
 - a) He was cited by the Auditor General in the report for the year ending 30th of June,2016. Kshs.332,000.000 could not be properly accounted for. - 17. THAT further, and of grave concern is that Mr Mbuno has adversely been mentioned in fraudulent withdrawals and questionable expenditures from time to time during his term as CEO of NG-CDF Board in that for instance;
 - a) He was cited by the Auditor General in the report for the year ending 30th of June,2016, in the loss, failure to account for Kshs.332,000.000. The withdrawals is solely attributed to him since as per Sec 13(3) of the National Government Constituencies Act No.30, his signature is the main one in bank operations. He thus bears all responsibility for any culpability.
- 18. THAT thus considering the audit queries relating to his management of funds and the fact that he has exceeded the term ordinarily a CEO ought to serve, any further extension of his term will bring questions as to why is he being favoured and will totally erode the confidence of the public in the manner their funds are managed.
- 19. **THAT** the purported appointment of Mr. Yusuf Mbuno as CEO of National Government Constituency's Development Fund Board is contrary to the principles and values enshrined in articles 6, 10 and 73 of the Constitution.
- 20. THAT consequently Mr. Yusuf Mbuno is unfit for the position of CEO of National Government Constituency's Development Fund Board for the queries that has arisen concerning his management of the fund and the likely illegality of his term as CEO since it has extended beyond the six (6) year period.
- 21. THAT appointment of Mr Yusuf Mbuno will likely erode public confidence in the leadership and management of their constituency development fund for there will be appearance that the CEO is insulated from any consequences arising from conduct or illegality of his tenure.

- **22. THAT** there be a review of the other applicants who were short listed & met the job criteria.
- 23. THAT now annexed is
 - i) TM-1Audit queries by Auditor general for 30th, June, 2016.
 - ii) TM-2 Bundle of documents/Financial report -proving that Mr Yusuf Mbuno has been serving as CEO to NG-CDF at all material times.
- 24. THAT what is deponed herein is true to the best of my knowledge, information and belief.



- iv. Previously, he was head of Planning and Monitoring Unit in the Ministry of Lands as well as Principal Economists in the Department of Development in Kilifi District.
- v. He has over 28 years' experience in the public service having served from the year 1991 to 2020, of which 16 years were in a senior management position.

Also, he stated that he had received various awards among them -

- Government of Kenya Scholarship for undergraduate studies and Master of Arts at the University of Nairobi
- ii. He is a member of the Economists Society of Kenya

iii. A member of the Board of Management, Joanna Chase and Kyaani Secondary schools.
