# 5. NOTICE OF MOTION - ALTERATION OF THE SENATE CALENDAR (REGULAR SESSIONS) FOR THE FOURTH SESSION

THAT, pursuant to Standing Orders 28 and 29, and the Resolutions of the Senate made on  $27^{th}$  February, 2020 and on  $17^{th}$  March, 2020 regarding the Senate Calendar, the Senate now resolves to alter its Calendar further in respect of Part I

and Part II of the Calendar, to hold one sitting in each week on Tuesdays, beginning on Tuesday, 21st April, 2020 until Tuesday, 2nd June, 2020 and that the Senate Calendar (Regular Sessions) for the Fourth Session, 2020, be altered accordingly.

# 6. **STATEMENTS**

# (i) Pursuant to Standing Order 47(1)

a) The Senator for Siaya County (Sen. James Orengo, MP) made a statement on an issue of national concern, namely; the burial of Mr. James Oyugi Onyango a resident of Siaya County who reportedly died of COVID-19 disease.

Thereupon, the Senator informed the Senate that COVID-19 (Coronavirus) disease is a worldwide pandemic that has brought serious challenges to normal life and the public health system in Kenya. He said the measures the National Government has taken to contain the spread and impact of the pandemic in the country are commendable but the country has to prepare for the worst before things can get better.

The Senator further informed the Senate that in the midst of the fight against COVID-19, certain regrettable incidents have occurred which have generated public outcry.

He cited an incident at Simur Village, Ukwala Location, Ugenya Constituency in Siaya County, where on the night of 12<sup>th</sup>/13<sup>th</sup> April, 2020, James Oyugi Onyango who had reportedly died from COVID-19, was buried in the middle of the night in extremely gruesome circumstances.

The Senator stated that while the circumstances the country is in are appreciated, and cognisant of the Ministry of Health Guidelines on handling of bodies of persons who have died of COVID-19, the burial of James Oyugi's body elicits serious concerns that he wished the Ad-Hoc Committee on COVID-19 Situation in Kenya to look into and revert to the House with a response. The Senator requested that the Committee should-

- 1. State the cause of death of Mr. James Oyugi Onyango;
- 2. Explain the reason and justification for the burial of the deceased at night and in a shallow grave and without being placed in a coffin as the family had planned;
- 3. Explain why there was a complete disregard of the protocols laid out by the Ministry of Health concerning respect for the dignity of the dead, hours of burial and sensitivity to acceptable cultural practices and traditions; and
- 4. State why there was no consultation with the family and community before the burial.

The Speaker referred the Statement to the Ad-Hoc Committee on COVID-19 Situation in the Country for consideration pursuant to Standing Order 47 (3).

b) The Senator for Machakos County (Sen. Boniface Kabaka, MP) made a statement on an issue of county-wide concern, namely; plans by the county government of Machakos County to take a credit facility.

The Senator informed the House that through a letter dated 8<sup>th</sup> April, 2020 addressed to the Clerk of the County Assembly of Machakos, Mr. Mbiuki and copied to the Speaker of the County Assembly, the Governor of Machakos County Government, Dr. Alfred Mutua, sought the approval of the Assembly to borrow an amount of Ksh. 935, 600,000.

He said the letter to the Assembly invoked Article 212 (b) of the Constitution 2010 read together with Section 142 of the PFM Act, 2012 and Section 81 (d) of the County Governments Act.

The Senator informed the House that in the letter, the Machakos County Treasury has requested the County Assembly of Machakos to approve a short term cash flow management facility to address the following expenditure-

- 1. Emergency mitigation measures related to COVID-19 pandemic;
- 2. Salaries and extraneous allowances for health professionals and workers;
- 3. Salaries and allowances for members of the County Assembly; and
- 4. Salaries for county staff.

Consequently, the Senator requested that the Governor of Machakos County be required to, among others –

- 1. Explain why the Treasury has refused to release the annual equitable share for the County as presented in its budget;
- 2. Explain how he plans to repay the said huge loan facility with interest that will run to over Ksh. 1 billion Shillings and without interfering with the County Development Plans;
- 3. Explain why has not suspended non-essential expenditure to free more money that he requires before borrowing; and
- 4. State how own revenue funds of Ksh. 2.2 billion collected by the County Government have been spent.
