#### 6. STATEMENTS

### (a) Pursuant to Standing Order 47(1)

(i) Nominated Senator (Sen. (Dr.) Isaac Mwaura, MP) made a statement on an issue of National concern, namely, the effects of COVID-19 pandemic on Micro and Small Enterprises (MSEs).

In the Statement, the Senator stated that in the wake of the COVID-19 pandemic, Micro and Small Enterprises (MSEs) were staring at mass closure across the 47 counties that would lead to unprecedented increase in job losses and unemployment. He stated that MSEs were a critical sector of the economy that could not be ignored due to the fact that the sector provided jobs to millions who were not absorbed in the formal sector and observed that the devastating effects of the COVID-19 on business environment had hit the MSEs hard and breadwinners could no longer provide for their families. As a consequence, poverty levels were in the short term, expected to rise as COVID-19 persists.

As a way of rendering support the MSEs sector during this difficult time, the Senator called upon county governments to suspend the renewal of single business licences, charges for accessing open air markets as well as cess for agricultural produce for at least three months, or even waive them altogether for the remaining part of the year, particularly for any businesses with an annual turnover of less than a million Shillings.

The Senator appealed to the Standing Committee on Tourism, Trade and Industrialization to engage the Council of Governors (CoG) and the County Assemblies Forum (CAF) to ensure that the county governments provided appropriate reliefs to MSEs. He further suggested that the county assemblies consider taking legislative interventions to give legal effect to the specified relief measures.

(ii) The Senator for Nyamira County (Sen. Okong'o Mogeni, SC, MP) made a statement regarding the judgement of the Supreme Court Ref. No. 3 of 2019 on an Advisory Opinion sought by the County Government of Kakamega and 46 others.

The Senator informed the Senate that the Council of Governors had sought an Advisory Opinion from the Supreme Court on questions regarding the matter of Division of Revenue, the mandate of the Senate in the legislative process and questions on public finance in general. The Senator stated that the Supreme Court had delivered a precedent-setting judgment reinforcing the role of the Senate in division of revenue and in its role as the defender of the counties. Sen. Mogeni proceeded to apprise the House on the details of the arguments presented on behalf of the Speaker of the Senate and the general role of the Senate with regards to the Division of Revenue Bill and the Appropriation Bill.

The Senator further informed the Senate that the Supreme Court had upheld Parliament's legislative role by finding that the legislative authority of Parliament must be safeguarded by requiring that Parliament pay due regard to the recommendations of the Commission on Revenue Allocation but without being bound by the recommendations. He observed that Parliament was allowed to deviate from the recommendations of the Commission on Revenue Allocation, noting that not every deviation must be explained and that an explanation would only be required where there was a significant deviation from the proposals by the Commission on Revenue Allocation.

Sen. Mogeni noted that the Supreme Court had affirmed the position of the Senate that the National Assembly could not enact the Appropriation Act before the Division of Revenue Act and if the National Assembly does enact the Appropriation Act before there is a Division of Revenue Act, the resulting Act would be of doubtful constitutional validity. He concluded by reminding Senators that they must zealously guard and protect their role as a House of Parliament and to protect the county governments. He stated that challenges continue and that Senators had other legal proceedings in which the Senate seeks to defend its mandate. He called upon Senators to keep up the fight, and to appear in court when called upon to.

Other Senators commented and praised the Supreme Court for issuing a timely and judicious Advisory Opinion.
