3. <u>COMMUNICATION FROM THE CHAIR ON THE COMMENCEMENT OF</u> <u>PART IV OF THE FOURTH SESSION</u>

The Speaker issued the following communication-

"I take this opportunity to welcome you back to Part IV (Four) of the Fourth Session. This Part will run from today, 8th September, 2020 to 22nd October, 2020, pursuant to the Senate Calendar.

It is my hope that you have all kept well and safe during the three - week recess, reconnected with your constituents, families and friends; and that you are ready for the business of the Senate.

I urge that we redouble our efforts to enable us to consider and conclude all business that is before us including Bills, Motions, Petitions and Statements, critical among them being the determination of the third basis for revenue allocation among the county governments.

As you will recall, during the Special Sitting on Monday, 17th August, 2020, the House constituted an informal Committee to try to develop consensus on the issue of the formula. The informal Committee has been updating the Senate leadership on a regular basis including the Senate Business Committee. The Committee was informed that consultations were ongoing and that the prospects of achieving a win-win position are very promising. Consequently, following the Senate Business Committee meeting this morning, the Committee agreed as follows-

- 1. That, a consultative meeting be held between the informal Committee and the Senate leadership on Thursday, 10th September,2020;
- 2. That a *Kamukunji* be held on Monday, 14th September to apprise the entire membership on progress made and the outcome of the consultative engagement; and
- 3. That, the matter of the Report of the Committee on Finance and Budget on the Third Basis for Revenue Allocation Among the County Governments be listed on the Order Paper and disposed of on Tuesday, 15th September, 2020.

I look forward to your cooperation and commitment as we undertake this very solemn duty.

I thank you."

8. <u>NOTICE OF MOTION ON OPERATIONALIZATION OF EDUCATION</u> ASSESSMENT RESOURCE CENTRES (EARCs) IN COUNTIES

THAT, AWARE THAT Section 46 of the Basic Education Act, 2013 mandates the county education boards to provide for Education Assessment and Research Centres (EARCs), including a special needs service in identified clinics in the respective counties.

FURTHER AWARE, THAT the functions of the EARCs as provided by the Act include; the study of children with special education needs within the county; the giving of advice to parents and teachers as to appropriate methods of education for such children; in suitable cases, provision for the special education needs of such children in the identified clinics; and, the giving of advice to county education boards regarding the assessment of the needs of any child under special needs education for purposes of any of the provisions of the Basic Education Act, 2013.

NOTING THAT, given the critical role EARCs play in assessment, placement and early intervention of children with special needs, EARCs countrywide are currently in a dilapidated and dysfunctional state.

NOW THEREFORE, the Senate calls upon the county governments to operationalize Section 46 of the Basic Education Act, 2013 by:

- 1. Ensuring that EARCs in the respective counties are fully furnished and adequately staffed; and
- 2. Working in tandem with the National Government to develop a national policy on EARCs that will define the expected service delivery in accordance with internationally set standards and regulate the terms of employment for the staff.

9. STATEMENTS

a) Pursuant to Standing Order 47(1)

i. Nominated Senator (Dr.) Milgo issued a Statement on appointment of Sen. (Dr.) Getrude Musuruve, MP as co-chair of the International Parliamentary Network for Education.

Therefore, she informed the Senate that the International Parliamentary Network for Education seeks to realize goals of SDG 4 and that the appointment comes at an opportune time when the world is grappling with COVID-19.

She added that although education is meant to be a socio-economic equalizer for all children, with time, children with disability have been adversely affected as they have been most hit by the pandemic.

Further she noted that the achievement of the commitments in SDG 4 is at great risk and the Network should make concerted efforts and reforms towards achievement of these commitments. Sen. (Dr.) Musuruve, MP, is a Member of the Standing Committee on Education and her commitment to issues of learners with disabilities is encouraging as she has written and published books on sign language using her own resources.

Sen. (Dr.) Milgo also informed the senate that Sen. (Dr.) Musuruve, MP, was a Member of the National Council of Nomadic Education in Kenya, represents persons with disabilities in the Senate and was a teacher where she interacted with persons with disabilities. She possesses academic qualifications in special needs education and holds a master's degree in applied linguistics with a bias in sign language as well as a PhD in mass communication with a bias in media portrayal of persons with disabilities.

ii. Nominated Senator (Dr.) Getrude Musuruve issued a Statement regarding the alleged approval of the use of silicone vaginal ring to curb HIV infection in Kenya.

Thereupon, the Senator informed the Senate that a silicone vaginal ring containing the antiretroviral drug Dapivirine had been approved as a new method of HIV prevention for women. The European Medicines Agency (EMA) announced that it had adopted a positive scientific opinion for its use in low- and middle-income countries.

She further stated that Information in mainstream media, specifically, the Daily Nation of 26th July, 2020, stated that a study proved that the vaginal ring could reduce the risk of Type 1 HIV (HIV-1). The ring

had been developed by the International Partnership for Microbicides, a US non-profit organization. This US non-profit organization, however, has not revealed the methodology used, the participants of the study and the resultant outcome that informed their decision that the ring is best suited for HIV prevention for women in Sub Saharan Africa. Therefore, without verifiable empirical data, the study so far lacks the research thresholds of credibility and objectivity of the trial studies carried out in Malawi, South Africa, Uganda and Zimbabwe.

The Senator also stated that it is common knowledge that HIV-1 is also mostly prevalent in West Africa (at the rate of 7% compared to Uganda's 4.4%) and, as such, the developers of the ring needed to have included samples from that population.

In conclusion, she requested that the Senate engage the concerned Ministry in Kenya so that public participation is carried out before adopting the use of silicone vaginal ring to curb HIV infection in Kenya.

iii. Nominated Senator Abshiro Halake issued a statement concerning the imposition of Value Added Tax (VAT) on clean and renewable energy products in Kenya.

Thereupon, she informed the Senate that on 23rd June, 2020 the president assented to the Finance Bill, 2020 imposing a 14% VAT to the supply or the importation of the specialized equipment for the development and generation of solar, wind energy, including deep cycle batteries and hydro energy, as well as clean cook stoves.

She further stated that this taxation of clean energy or renewable energy will have far reaching consequences as it will not only increase the tax burden of the poor and the marginalized but also act as an impediment to the national development objectives as affordable universal access to clean energy is at the core of modern civilization and renewable energy sources are specifically designed to power and empower the poorest and most marginalized citizens of Kenya.

In conclusion, she recommended that the initial VAT exemptions on equipment used for the development and generation of the solar and wind energy be retained.
