#### a) Visiting delegation from Nairobi City County Assembly

#### b) Meeting of Senators with the Council of Governors

"Honourable Senators,

As you are aware, devolution is the cornerstone of our Constitution and hence we should make concerted effort to protect it and make it flourish. Resultantly, I cannot underscore the important and strategic role that the Senate has in this framework on devolution, as espoused in Article 96 of the Constitution. As a Senate therefore, we must shape and influence the discourse on devolution across all levels, and ensure that our counties are adequately resourced and that we judiciously oversight counties, to deliver services to "Wanjiku".

The Constitution of Kenya in Article 6(2) recognizes that governments at the national and county levels are distinct and inter-dependent and shall conduct their mutual relations on the basis of consultation and cooperation. Consequently, our linkage with devolved institutions is critical to enable us to deliver on our mandate on safeguarding counties and their governments.

Honourable Senators,

One such institution which we have continued to make effort to work with closely is the Council of Governors. As you may be aware, the Council of Governors recently elected its leadership and is now chaired by the Governor of Embu County, Hon. Martin Wambora.

This is to inform you that the Standing Committee on Devolution and Intergovernmental Relations has organized a meeting with the newly appointed leadership of the Council of Governors to discuss the "State of Devolution." The meeting is scheduled to take place in **the Senate Chamber**, **Main Parliament Buildings** on **Tuesday**, **2**<sup>nd</sup> **March**, **2021** at **9.00** am

5. **NOTICE OF MOTION** – (Chairperson, Standing Committee on Finance and Budget)

THAT, pursuant to Section 25 (7) of the Public Finance Management Act and Standing Order 180 (7) of the Senate, this House adopts the Report

of the Standing Committee on Finance and Budget on the 2021 Budget Policy Statement and Medium Term Debt Management Strategy, laid on the Table of the Senate today, Wednesday 24<sup>th</sup> February, 2021.

#### 6. **STATEMENTS**

#### a) Pursuant to Standing Order 47(1)

1) The Senator for Trans Nzoia County (Sen. Michael M. Mbito, MP) made a statement regarding investing in mental healthcare post – Covid – 19 pandemic.

Thereupon, the Senator drew the attention of House on how the economy has been devastated by the COVID-19 pandemic, noting that the journey to recovery will be a long and difficult one, particularly, for African economies and will be strongly dependent on the resilience and productivity of the workforce.

The Senator also noted that it was estimated that mental illnesses cost \$2.5 trillion globally in 2010 and this cost will rise to over \$6 trillion by 2030, most of which are indirect and are due to productivity losses associated with mental illness, including absenteeism and presenteeism at the work place.

The Senator further urged African governments to proceed with implementing the WHO Global Mental Health Action Plan (2013-2020), which has been endorsed by most African UN member states and which provides a road map for national investment in mental health. This would enable mental health to be included in national health insurance schemes as part of Universal Health Coverage (UHC). At the same time, there is need to consider stimulus packages and improvement of the regulatory environment to incentivize employers to protect and promote the mental health of their workforces.

2) The Senator for Vihiga County (Sen. George Khaniri, MP) made a Statement concerning alleged electrocution of wild animals, most recently within the Soysambu conservancy.

Thereupon, the Senator informed the House that three of the endangered distinct giraffe species, Rothschild's giraffe, were electrocuted in Soysambu Conservancy within Nakuru County as a result of low hanging power line is disheartening to say the least.

The Senator noted that it was not the first time that such an incident was happening and that in the last two years, at least 11 giraffes and dozens of birds have been electrocuted at the conservancy by sagging Kenya Power cables.

The Senator also informed the House that after the above report was aired in the media, there has been a reactionary response, particularly by the Kenya Power Company. The Senator urged caution on the part of Kenya Power, especially when live power lines had to pass through a wildlife habitat, hence posing a great danger to the animals.

The Senator further implored the Ministry of Tourism and Wildlife to strive to find solutions to the human-wildlife conflicts across the country and pay prompt compensation to affected residents in case of damage of property or injuries to humans by wild animals, while at the same time urging the Ministry of Interior and Coordination of National Government and the Kenya Wildlife Service to bring to an end the poaching menace.

Following contributions by Senators, the Speaker referred the matter to the Standing Committee on Land, Environment and Natural Resources and the Committee on Energy, pursuant to Standing Order 47 (3).

3) Nominated Senator (Sen. (Dr.) Alice Milgo) made a statement on the importance of encouraging girls to pursue courses in Science, Technology, Engineering and Mathematics (STEM).

Thereupon, the Senator informed the House that, according to a UNESCO report titled, "Cracking the Code: Girls and Women Education in STEM", only 35 per cent of STEM students in higher education globally are women and this was an issue of concern, as such careers are referred to as the jobs of the future, particularly in sub-Saharan Africa.

The Senator also noted that, according to the United Nations Institute of Statistics, less than 30 per cent of the world's researchers were women and that women in STEM fields published less, were paid less for their research, and did not progress as far as men in their careers.

The Senator further emphasized the importance of engaging with girls at primary and secondary school levels to raise the visibility of STEM subjects as a potential career trajectory, noting that one such collaboration is the DigiGirlz programme, which inspires high school girls to pursue STEM subjects by providing them with the opportunity to interact with Microsoft employees and receive computer and technology training.

4) The nominated Senator (Sen. (Dr.) Getrude Musuruve) made a statement on the annual International Mother Language Day celebrated on 21<sup>st</sup> of February every year

Thereupon, the Senator drew the attention of the House to the International Mother Language Day that is celebrated every year to promote linguistic and cultural diversity and multilingualism around the world.

The Senator also informed the House that the idea to celebrate International Mother Language Day first came from Bangladesh, after which the General

Conference of the United Nations Educational Scientific and Cultural Organization (UNESCO) decided to celebrate February 21st as International Mother Language Day from November, 1999 and UNESCO on 16 May, 2007, through a general resolution, called upon member states to promote the preservation and protection of all languages used by peoples of the world. The Senator noted that, in the same resolution, the General Assembly proclaimed 2008 as the International Year of Languages to promote unity in diversity and international understanding through multilingualism and multiculturalism.

The Senator, while encouraging universities and colleges to offer courses in vernacular languages, emphasized the need to encourage multilingualism, as a country, so that vernacular languages do not disappear, as well as the need to embrace new strategies of salvaging vernacular languages.
