#### TUESDAY, MARCH 30, 2021 AT 10.00 A.M.

- 1. The Senate assembled at Ten O'clock.
- 2. The proceedings were opened with prayer said by the Speaker.

#### 3. COMMUNICATIONS FROM THE CHAIR

The Speaker conveyed the following Communications from the Chair:-

a) On the call to Adjourn the Ordinary Sittings of the Houses of Parliament to Facilitate Containment of the Spread of the Covid-19 Global Pandemic

"Honorable Senators,

On Friday, 26<sup>th</sup> March, 2021, an extraordinary meeting of the three arms of government was convened at State House, Nairobi to receive reports on the status of the COVID-19 pandemic situation in the country from the National Emergency Response Committee on COVID-19. At the meeting, Parliament was one of the institutions identified that had recorded a high infection rate as per the data availed during the meeting.

As a mitigation measure, Parliament, both National Assembly and the Senate were urged to suspend their sittings until such a time that the rate of infection is brought under control. A number of other measures to contain the spread of the pandemic were deliberated upon and a resolution made on the way forward.

#### Honorable Senators,

Let me reiterate that from the figures given at the meeting, we are facing a grave situation that should be taken very seriously by everyone. For instance, as at yesterday, Monday, 29<sup>th</sup> March, 2021, the positivity rate hit a shocking 26.6%. What this means is that for every 100 people tested, over a quarter or more than 26 were found to be infected by the virus. The Cabinet Secretary for Health has raised the alarm that the health care system is at risk of being overwhelmed by the pandemic

leading to lack of basic supplies such as oxygen. Enough has been said about the dire situation of ICU beds. The decision to put sittings on hold is not unique or isolated to our country. Since the virus was declared a pandemic in March, 2020 parliaments in all regions of the globe have been affected and their sittings disrupted in one way or the other. For instance, as recent as February, 2021 the Parliament of Ghana was suspended for weeks after several members and staff tested positive for the virus.

Subsequent to the meeting, His Excellency the President of the Republic of Kenya, Uhuru Muigai Kenyatta, CGH, made a national address on the COVID-19 pandemic situation in Kenya. Among other measures instituted to contain the spread of the pandemic, the President, following consultation with the Leadership of Parliament and upon the advice of the National Security Council and the National Emergency Response Committee on COVID-19, called upon the National Assembly and the Senate to effect the above decision to suspend respective Ordinary Sittings in accordance with the respective House's Standing Orders.

#### Honorable Senators,

For the avoidance of doubt, Standing Order 28 (1) of the Senate states that "Except for the Session commencing immediately after a general election, regular Sessions of the Senate shall commence on the second Tuesday of February and terminate on the first Thursday of December." Standing Order 29 (1) provides for the determination of the Senate Calendar by the Senate. Additionally, Standing Order 29 (4) provides a mechanism for the Senate to alter its Calendar or the adjournment date by way of a Resolution.

Consequently, in the Supplementary Order Paper for today, at Order No. 10, the Senate Majority Leader will move a Motion whose effect will be to further alter the Senate Calendar for the Fifth Session, so as to adjourn today, Tuesday, 30<sup>th</sup> March, 2021 until Tuesday, 11<sup>th</sup> May, 2021, as one of the mitigating measures to minimize human contact and exposure and to contain the spread of the pandemic.

#### Honorable Senators,

In line with the measures instituted by His Excellency the President for the containment of the spread of the pandemic, I direct that all meetings of Select Committees of the Senate will only take place virtually pursuant to Standing Order 252A of the Senate. All physical meetings, including field and county visits, are hereby suspended until further notice.

There will be <u>NO</u> exception to this directive and any requests to hold inperson meetings will <u>NOT</u> be approved by the Speaker. I urge all Committees to fast track any business using the mechanism provided under Standing Order 252A, particularly Bills and Petitions.

I thank you."

# b) On the status of the Coffee Bill (Senate Bills No. 22 of 2020)

"Honourable Senators,

As you will recall, on 24th March, 2021, the Chairperson of the Standing Committee on Agriculture, Fisheries and Livestock sought to know whether the Senate Leadership had accepted to withdraw the Senate Bill in favour of a Coffee Bill drafted by the Ministry of Agriculture, Livestock, Fisheries and Cooperatives.

The Coffee Bill (Senate Bills No. 22 of 2020), sponsored by the Committee on Agriculture, Livestock and Fisheries, was published on 23rd October, 2020. In compliance with Article 110 (3) of the Constitution, I sought the concurrence of the Speaker of the National Assembly on 9th November, 2020. In addition, I wrote to the Speaker of the National Assembly severally reminding him of the various Bills that still await his concurrence including the Coffee Bill (Senate Bills No. 22 of 2020). The latest among these being a letter dated 15th March, 2021.

#### Honourable Senators,

I confirm that on 15th March, 2021 and 16th March, 2021, the Attorney General wrote letters reference number AG/LDD/442/1/46 to both the Leader of Majority in the Senate and the National Assembly forwarding a draft Coffee Bill, 2021 developed by the Ministry of Agriculture, Livestock, Fisheries and Cooperatives for further processing by the Houses of Parliament.

As evidence by my letter to the Speaker of the National Assembly dated 15th March, 2021 seeking his concurrence on the Coffee Bill, (Senate Bills No. 22 of 2020), neither I nor the Senate Business Committee, has approved the withdrawal of the Coffee Bill, 2020 published by the Committee on Agriculture, Fisheries and Livestock in favour of the Bill developed by the Ministry of Agriculture, Livestock, Fisheries and Cooperatives.

I am further informed that the National Assembly is yet to publish the Bill developed by the Ministry of Agriculture, Livestock, Fisheries and Cooperatives.

Honourable Senators,

We continue to actively pursue concurrence of the Speaker of the National Assembly on the Coffee Bill (Senate Bills No. 22 of 2020) and other Senate Bills already published. As an additional measure, I further direct that the Leader of Majority in the Senate write to his counterpart in the National Assembly informing the leader of —

- i) the publication of the Coffee Bill (Senate Bills No. 22 of 2020); and
- ii) the changes proposed by the Cabinet Secretary, Ministry of Agriculture, Livestock, Fisheries and Cooperatives.

I thank you."

## 4. MESSAGES FROM THE NATIONAL ASSEMBLY

# a) Passage of the Division of Revenue Bill (National Assembly Bill No. 7 Of 2021)

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 41 (3) and (4), I have received the following Message from the Speaker of the National Assembly regarding the passage, by the Assembly, of the Division of Revenue Bill (National Assembly Bill No. 7 of 2021) -

PURSUANT to the provisions of Standing Orders 41(1) and 142 of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly –

WHEREAS the Division of Revenue Bill (National Assembly Bill No. 7 of 2021) was published vide Kenya Gazette Supplement No. 22 of March 8, 2021 as a Bill proposing to provide for the equitable division of revenue raised nationally between the national and county governments as required by Article 218 of the Constitution in order to facilitate the proper functioning of National and county governments and to ensure continuity of county services.

AND WHEREAS the National Assembly considered the Bill in all stages and passed it on Tuesday, March 23, 2021 <u>without</u> amendments, in the form attached hereto;

NOW THEREFORE, in accordance with the provisions Article 110(4) of the Constitution and Standing Order 142 of the National Assembly Standing Orders, I hereby refer the said Bill to the Senate for consideration.

Honourable Senators,

Pursuant to Standing Order No. 157, which requires that a Bill which originates in the National Assembly be proceeded with by the Senate in the same manner as a Bill introduced in the Senate by way of First Reading in accordance with Standing Order No. 139, I now direct that the Bill be read a First Time today, Tuesday, 30th March, 2021.

I thank you."

# b) Passage of the Health (Amendment) Bill (National Assembly Bill No. 64 of 2019)

"Honourable Senators,

Vide a Message dated Thursday, 18<sup>th</sup> March, 2021, I received a Message from the National Assembly, pursuant to Standing Orders 41(1) and 142 of the National Assembly Standing Orders, on the passage of the Health (Amendment) Bill (National Assembly Bill No. 64 of 2019).

Honourable Senators,

You will recall that following the High Court ruling on 29th October, 2020, on Constitutional Petition No. 284 of 2019, implementation of the judgment by the Senate commenced. Notably, the High Court ordered that all Bills for which the concurrence process contemplated under Article 110(3) of the Constitution could not be demonstrated be ceased and that the said concurrence process be adhered to before introduction of such Bills in either House of Parliament.

Honourable Senators,

The Health (Amendment) Bill (National Assembly Bill No. 64 of 2019) was one such Bill, for which the concurrence process pursuant to Article 110(3) of the Constitution could not be demonstrated by the time the High Court gave its judgment. As such, the Bill ought to be aligned to Article 110(3) of the Constitution, following which the Bill will be read a First Time in the Senate.

In view of the foregoing, the Health (Amendment) Bill (National Assembly Bill No. 64 of 2019), as received from the National Assembly vide the Message dated Thursday, 18<sup>th</sup> March, 2021, will not be proceeded with in the Senate.

I thank you."

#### 13. STATEMENTS

# a) Pursuant to Standing Order 47 (1)

Nominated Senator, (Sen. (Arch) Sylvia Kasanga, MP) made a Statement concerning fees charged for issuance and filling of P3 forms.

The Senator informed the Senate that according to a recent survey by Trocaire East Africa and Legal Resources Foundation (LRF), P3 Forms were highly inaccessible and that this inaccessibility was stifling "access to justice" for poor litigants, especially survivors of violence, including Sexual and Gender Based Violence (SGBV) & domestic violence. She stated that the survey had further indicated an emerging trend in which "fees" were being charged for the "issuance" and "filling" of P3 Forms and that it had also noted that, "access to P3 Forms remains largely free in urban areas, while in the countryside, people pay to access the document".

The Senator posited that Article 48 of the Constitution of Kenya 2010 clarifies the centrality of the principle of "access to justice", in which, "if any fee is required, it shall be reasonable and shall not impede access to

justice". She stated that the P3 Form was an important "prosecutorial document" that ensured collection of witness statements, and assists in corroborating written evidence with forensic evidence.

She informed the House that, whilst civil society organizations in Kenya were advocating for enrichment of the document to include more comprehensive and vital information, the situation on the ground was that numerous victims had been impeded from accessing justice. Stating that the Embu High Court had ruled on April 4, 2019 to outlaw all fees charged on issuance and filling of P3 Forms, Sen. (Arch.) Kasanga said that the ruling was a relief to poor survivors of violence who previously abandoned their quest for justice because they couldn't afford these payments.

Sen. (Arch.) Kasanga concluded by urging the Speaker to commit the Statement to the Standing Committees on National Security, Defence and Foreign Relations and Labor and Social Welfare to interrogate and furnish the House with a tentative report on why P3 Forms were being paid for as well as the institutions culpable for the anomaly as well as to provide a mechanism that would help to enrich, and effectively process P3 Forms and encourage survivors of violence to report perpetrators.

Acceding to the request, the Temporary Speaker (Sen. (Dr.) Lelegwe Ltumbesi, MP) referred the Statement to the Standing Committee on National Security, Defense and Foreign Relations for consideration, pursuant to Standing Order No. 47(3).

# b) Pursuant to Standing Order 48 (1)

COVID - 19 vaccine (Astra Zeneca) and the status of the vaccination campaign in Kenya.

Mutula Kilonzo Junior, MP) sought a statement from the Standing Committee on Roads and Transportation concerning the status of loans granted by the Export Import Bank of China (China Exim) to the Government of Kenya, through the National Treasury, to finance construction of the Standard Gauge Railway (SGR).
- vi) The Senator for Makueni County, (Sen. Mutula Kilonzo Junior, MP) sought a statement from the Standing Committee on Energy concerning the increase in fuel prices imposed by the Energy and Petroleum Regulatory Authority (EPRA).
- vii) Nominated Senator (Sen. (Dr.) Getrude Musuruve, MP) sought a statement from the Standing Committee on Education concerning disbursement of higher education loans by the Higher Education Loans Board.
- viii) Nominated Senator (Sen. Petronila Were Lokorio, MP) sought a statement from the Standing Committee on Health concerning authorization of the use of Sputnik COVID-19 vaccine in Kenya.
- ix) The Senator for Kisumu County, (Sen. Fred Outa, MP) sought a statement from the Standing Committee on Finance and Budget regarding the status of pending payments to contractors and suppliers by the Kisumu County Government.
- x) Nominated Senator (Sen. Mercy Chebeni, MP) sought a statement from the Standing Committee on Land and Natural Resources regarding the forest blaze allegedly triggered by British Army troops at their training base at Nyati Barracks, Laikipia County.

## c) Pursuant to Standing Order 51(1)(a)

Sen. Ledama Olekina, MP, a Member of the Standing Committee on Health, made a Statement regarding the status of the COVID-19 pandemic situation in the country, on behalf of the Chairperson, Standing Committee on Health.

Thereupon, the Senator informed the Senate that according to the World Health Organization, as of 22<sup>nd</sup> March, 2021, there were 122,992,844 confirmed cases of COVID-19 globally and that 2,711,071 deaths had occurred due to the pandemic across the globe. In Africa, the World Health Organization reported that there were 3,006,474 confirmed cases and 76,241 deaths, while in Kenya, there were 120,910 confirmed cases, and 2,011 deaths. This represents almost double the number of

confirmed cases and deaths that had been reported in Kenya by November, 2020.

He also informed the Senate that according to the Ministry of Health, these figures were continuing to rise at an alarming rate. Indeed, with the current patient demand outstripping hospital bed capacity, there were fears that the country was in the midst of a third wave that was more deadly than the first two waves. In response to the escalating number of confirmed cases and deaths attributable to the COVID-19 pandemic, the Standing Committee on Health held a series of meetings with various health stakeholders that were aimed at getting a clearer understanding of the COVID-19 pandemic situation, and charting a way forward and that as a result of these meetings, the Committee had tabled its First and Second Progress Reports on the COVID-19 Pandemic Situation.

He further stated that the Committee was scheduled to conduct a series of county visits aimed at assessing the level of preparedness for the COVID-19 pandemic by counties. A comprehensive report on the same would likewise be tabled before the Senate in due course.

In conclusion, the Senator stated that even as we struggle to tackle the crisis of the COVID-19 pandemic, it was important that health workers avoid falling into the dangerous assumption that all cases arriving at the hospitals were as a result of COVID-19 infection. He appealed to the Ministry of Health to review all its treatment guidelines and protocols with a view towards ensuring that all patients received appropriate and proper treatment.

**CONCERNED**, that our children are losing their sense of identity due to the negative influences due to inadequate cultural identity catalyzed by globalization which has led to catastrophic consequences to the next generation as experienced in our country where a majority of young people are showing symptoms of feeling suicidal, anxious, feeling of hopelessness, anger, violence, feeling isolated, and paranoia;

**NOW THEREFORE**, the Senate urges the Cabinet Secretary, Ministry of Sports, Culture and Heritage to –

- a) Formulate cultural development policies and initiatives to inculcate stronger community values, safeguard Kenya's heritage, recognize local heroes and promote socio-cultural opportunities in the counties; and
- b) Formulate strategies to create an enabling environment for protection and promotion of diversity of cultural expressions in all counties.

**FURTHER CONCERNED**, that charging entry fees amount to double taxation as the motorists who would have paid the parking fees will still pay for the services they seek;

**NOW THEREFORE,** the Senate urges the Cabinet Secretary for Lands, Housing and Physical Planning together with the Council of Governors to come up with a policy framework to create an enabling environment for protection of motorists accessing essential services from paying exorbitant fees for parking.
