

#### Chairperson's Foreword

This report contains the proceedings of the Departmental Committee on Transport, Public Works and Housing on its consideration of the Petition by Messrs. John Dumas Gachara. The Petition was conveyed to the House by the Member for Nakuru West Constituency, Hon. Samuel Arama, on behalf of the Petitioner.

In processing the Petition, the Committee invited both the Petitioner and the Ministry so that they could submit their submissions to the Committee before a Report was compiled. The Petitioner and the Ministry officials appeared before the Committee on 18<sup>th</sup> November 2020. The Ministry's representatives were drawn from the State Department for Housing, State Department for Public Works, the National Construction Authority and the National Housing Corporation.

The Petitioner's prayer was that the National Assembly considers the issues raised in his Petition on Newbuild Construction Technology with a view to making recommendations to the relevant government agencies on the use of the said technology. He stated that since the year 2003, the technology has not been taken up by the government and that although the technology has been uploaded on the Ministry's website, the government was yet to compensate him according to the law.

The Committee however observed that the Ministry was in support of the Petitioner's work, and was willing to give the Petitioner a forum to showcase his innovation. It was for this reason that the Ministry uploaded the said technology on the Ministry's website to support and showcase the product. The Committee however concluded that neither the Committee nor the Ministry had powers to compel consumers to use the said technology. The Petitioner was therefore advised to showcase his product in the market and find innovative ways of attracting possible consumers even as the Ministry takes the necessary steps to support the growth of new and affordable technologies in the country.

The Committee wishes to sincerely thank the Offices of the Speaker and of the Clerk of the National Assembly for the necessary support extended to it in the execution of its mandate. I also take this opportunity to thank all Members of the Committee for their patience, sacrifice, endurance and commitment towards the production of this Report.

The Committee further wishes to record its appreciation for services rendered by the Committee Clerks and other technical staff of the National Assembly. Their efforts and input made the work of the Committee and production of this Report possible.

On behalf of the Departmental Committee on Transport, Public Works and Housing and pursuant to the provisions of Standing Order 199 (6), it is my pleasant privilege and honor to present to this House the Report of the Committee on its consideration of the Petition Regarding the Approval, Application and Use of Newbuild's Low-Cost Construction Technology.

#### 1.0 PREFACE

1. The Petition was tabled before the House and was committed to the Departmental Committee on Transport, Public Works and Housing for consideration pursuant to standing order 227. The Committee considered the Petition pursuant to the said Standing Order.

#### 1.1 Committee Mandate

- 2. The Departmental Committee on Transport, Public Works and Housing is established under Standing Order 216(1) whose mandate, pursuant to the Standing Order 216 (5), is as follows:
  - a. investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
  - b. study the programme and policy objectives of Ministries and departments and the effectiveness of the implementation;
  - c. study and review all legislation referred to it;
  - d. study, assess and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
  - e. investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House:
  - f. to vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (*Committee on Appointments*);
  - f (a). examine treaties, agreements and conventions;
  - g. examine treaties, agreements and conventions;
  - h. make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
  - i. make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
  - j. consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
  - k. examine any questions raised by Members on a matter within its mandate.
- 3. Further, the Second Schedule to the Standing Orders mandates the Committee to consider matters relating to the following subjects:
  - a) Transport;
  - b) Roads;
  - c) Public works;
  - d) Construction and maintenance of roads, rails and buildings;
  - e) Air and seaports; and
  - f) Housing.
- 4. In executing this mandate, the Committee oversees various State Departments, namely:
  - a) The State Department of Transport;
  - b) The State Department of Infrastructure;
  - c) The State Department of Housing and Urban Development;
  - d) The State Department of Public Works; and
  - e) The State Department of Shipping and Maritime Affairs.

#### 2.0 BACKGROUND OF THE PETITION

#### 2.1 The Petition

- 7. The Petition was presented to the National Assembly by Messrs. John Dumas Gachara. The conveyor of the Petition was the Hon. Samuel Arama, Member for Nakuru West Constituency. The Petitioner wished to draw the attention of the House to the following:
  - i. THAT, Article 43 of the Constitution guarantees every person the right to the highest attainable standard of health, which includes the right to accessible and adequate housing;
  - ii. **THAT,** provision of adequate, affordable and decent housing for low-income households is in short supply in the country;
  - iii. **THAT,** due to lack of quality shelter, a majority of people live in areas with no access to clean water and sanitation, unreliable and unhealthy energy sources, leading to increased exposure to diseases;
  - iv. THAT, the cost of production is the biggest challenge affecting the supply of housing and that the current housing deficit stands at 2 million houses with nearly 61% of urban households living in slums;
  - v. **THAT**, this deficit continues to rise due to fundamental constraints on both the demand and supply side and is exacerbated by an urbanization rate of 4.2%, equivalent to 0.5 million new city dwellers every year;
  - vi. **THAT**, the principle of progressive realization of socio-economic rights under the Constitution requires the government to take deliberate, concrete and targeted steps towards the achievement of these rights;
  - vii. **THAT,** to realize affordable housing, the Government of Kenya has set housing as one of the four core agendas it intends to address, with a projection of 500,000 new housing units every year;
  - viii. **THAT,** Newbuild Construction Technology is a Kenyan construction invention developed by the Petitioner and patented under African Regional Intellectual Property Organization on 9<sup>th</sup> Aug 2007 under certificate of grant of patent number 1765 awarded to New Build Ltd;
  - ix. THAT, the technology reduces the cost of production of houses by between 30-40% by employing the use of stones in the construction of the foundation, the floor slab and ring beams instead of the traditional cement, thereby reducing the cost of the foundation footing by 53.08%, the cost of the floor slab by 69.19% and the ring beams by 83.04%;
  - x. **THAT,** the technology is applicable whether the underlying base is soil or rock as it relieves considerable amount of pressure on the base and remains stable under varying weather conditions;

- xi. THAT, the application of the technology to only 25% of the government's target of 150,000 housing units in urban areas and to 60% of the 300,000 housing units in rural areas (estimates as per Sessional Paper No. 3) would save the country about Kshs. 54.3 billion per annum;
- xii. **THAT,** the Technology has been presented to the relevant authorities in the country, including the office of the President, the Ministry of Lands, Housing and Urban Development, the National Construction Authority and has not had any negative impacts on the critical economic activities;
- xiii. **THAT,** the Technology has been approved by the Ministry and has been uploaded on the Ministry's website and that training sessions on the application of the technology has been carried out to various industry players under the auspices of the National Construction Authority;
- xiv. **THAT**, the matters raised in this Petition are not pending before any court of law, constitutional or legal body.

#### The Prayer

8. The Petitioner's prayer was that the National Assembly, through the Departmental Committee on Transport, Public Works and Housing considers the issues raised in his Petition on Newbuild Construction Technology with a view to making recommendations to the relevant government agencies on the use of the said technology.

#### 3.0 CONSIDERATION OF THE PETITION BY THE COMMITTEE

- 9. The Committee held two sittings and deliberated on the Petition presented by the Petitioner.
- 10. On 10<sup>th</sup> November 2020, the Committee considered the Petition and resolved to invite the Petitioner to a meeting with the Committee. The meeting was scheduled for 18<sup>th</sup> November 2020. The Committee noted that the Petition by Mr. John Dumas Gachara as conveyed by Hon. Samuel Arama on 12<sup>th</sup> August 2020 was a replica of a Petition conveyed through Hon. David Ouma Ochieng, MP on 1<sup>st</sup> October 2019 and which the Committee already considered and made its report. The Committee further noted that during the consideration of the first Petition, the Petitioner did not appear before the Committee despite being invited twice.
- 11. In his oral submissions before the Committee, the Petitioner explained that the patent for his product (Newbuild Technology) was about to expire in a year. He explained that:
  - i. The technology was very good and prayed that Parliament legislated on this technology instead of holding it in abeyance. He stated that since the year 2003, the technology has not been taken up by government.
  - ii. The technology has been uploaded on the Ministry's website but the government has not paid compensation according to the law.
  - iii. The technology should be incorporated in the building code for it to be used. It was important to legalize the instruments of training by legislating the certificates issued.
- 12. The Committee considered the Petition pursuant to the provisions of the Standing Orders of the National Assembly and Petition to Parliament (Procedure) Act.
- 13. On 16<sup>th</sup> June 2021, the Committee prepared its report, and adopted the report in the same session which was held virtually.

## 3.1 Submissions by the Ministry of Transport, Infrastructure, Housing, Urban Development and Public Works

- 14. The State Department for Housing submitted that the technology is market driven. The Ministry affirmed that it assists innovators and Kenyans to showcase their innovations but they cannot force Kenyans or anyone to use a certain technology. The Department further explained that the new building code already embraces emerging technologies.
- 15. The Principal Secretary for Public Works explained that the reason the Ministry uploaded the technology on its website was for Kenyans to embrace it because the Ministry's appreciates all the efforts of innovators. It was a way of supporting the Petitioner by giving him the platform to showcase the technology. The Ministry explained that it will not be reasonable for the government to be forced to buy any particular technology, even as it tries to give platform to emerging technologies.
- 16. On issues raised in paragraph 1, 2, 3, 5, 6, 10, and 14 of the Petition, the Ministry agreed with the Petitioner because they were all factual. These include:
  - a. Article 43 of the Constitution guarantees every person the right to the highest attainable standard of health, which includes the right to accessible and adequate housing;

- b. The provision of adequate, affordable and decent housing for low-income households is in short supply in the country;
- c. Due to lack of quality shelter, a majority of people live in areas with no access to clean water and sanitation, unreliable and unhealthy energy sources, leading to increased exposure to diseases;
- d. Housing deficit continues to rise due to fundamental constraints on both the demand and supply side and is exacerbated by an urbanization rate of 4.2%, equivalent to 0.5 million new city dwellers every year;
- e. The principle of progressive realization of socio-economic rights under the Constitution requires the government to take deliberate, concrete and targeted steps towards the achievement of these rights;
- f. The technology is applicable whether the underlying base is soil or rock as it relieves considerable amount of pressure on the base and remains stable under varying weather conditions; and
- g. That the matters raised in this Petition are not pending before any court of law, constitutional or legal body.
- 17. The Ministry however made clarifications in light of paragraphs 4, 7, 8, 9, 11, 12 and paragraph 13 of the Petition.
- 18. In paragraph 4 of the Petition, the Petitioner asserted that the cost of production is the biggest challenge affecting the supply of housing and that the current housing deficit stands at 2 million houses with nearly 61% of urban households living in slums.
  - The Ministry submitted that the assertion that 61% of urban households live in slums was not accurate. According to the 2009 Population and Housing Census by the Kenya National Bureau of Statistics as stated in the National Slum Upgrading and Prevention Policy 2016, 40% of the urban population live in slum/informal settlements.
- 19. In paragraph 7 of the Petition, the Petitioner submitted that to realize affordable housing, the Government of Kenya has set housing as one of the four core agendas it intends to address, with a projection of 500,000 new housing units every year.
  - The Ministry submitted that the Affordable Housing Programme (AHP) was one of the pillars of the Big Four Agenda that commits to deliver 500,000 housing units in the period between 2017 and 2022 and not every year. The spirit of the programme is nevertheless to continue beyond 2022.
- 20. In paragraph 8 of the Petition, the Petitioner explained that Newbuild Construction Technology was a Kenyan construction invention developed by the Petitioner and patented under African Regional Intellectual Property Organization on 9<sup>th</sup> Aug 2007 under certificate of grant of patent number 1765 awarded to New Build Ltd.
  - The Ministry submitted that according to Kenya Industrial Property Institute (KIPI), this patent was registered in 2007 and expires in 2022. This was subject to annual renewal through payment of a fee. They noted that since 2016 the Petitioner has not paid for the renewal fees as required.
- 21. In paragraph 9 of the Petition, the Petitioner claimed that the technology reduces the cost of production of houses by between 30-40% by employing the use of stones in the construction of the foundation, the floor slab and ring beams instead of the traditional

cement, thereby reducing the cost of the foundation footing by 53.08%, the cost of the floor slab by 69.19% and the ring beams by 83.04%.

The Ministry submitted that according to Kenya Industrial Property Institute (KIPI), the Patent applies to only foundation footing and floor slab and does not include ring beam. An assessment was undertaken by the State Department for Housing and Urban Development at the Nakuru Appropriate Building Materials and Technology (ABMT) Center to understand the technology. The assessment established a cost reduction of 53.08% for the foundation footing and 69.19% for the floor slab.

22. In paragraph 11 of the Petition, the Petitioner claimed that the application of the technology to only 25% of the government's target of 150,000 housing units in urban areas and to 60% of the 300,000 housing units in rural areas (estimates as per Sessional Paper No. 3) would save the country about Kshs. 54.3 billion per annum.

The Ministry submitted that the figures given on the application of this technology were not based on verifiable statistical data. Besides, the State Department has no policy for awarding technology owners any monetary benefits. Technologies are expected to be demand driven in the market, with the government playing the facilitative role of promoting and disseminating them. The Ministry further submitted that matters of exploitation of patented inventions by the Government or by persons authorized by the Government are governed by The Industrial Property Act, 2001 (Revised Edition 2012) under the Ministry responsible for Industry in consultation with Kenya Industrial Property Institute (KIPI).

23. In paragraph 12 of the Petition, the Petitioner submitted that the Technology has been presented to the relevant authorities in the country, including the office of the President, the Ministry of Lands, Housing and Urban Development, the National Construction Authority and has not had any negative impacts on the critical economic activities.

The Ministry stated that the State Department through the ABMT unit receives and closely interrogates emerging housing technologies to assess if they could be classified as ABMT so as to promote and disseminate them to members of the public. It therefore received Newbuild Technology for the same objective.

24. In paragraph 13 of the Petition, the Petitioner claimed that the technology has been approved by the Ministry and has been uploaded on the Ministry's website and that training sessions on the application of the technology has been carried out to various industry players under the auspices of the National Construction Authority.

The Ministry submitted that in 2015, the State Department uploaded Newbuild technology on the website among other emerging technologies for the purpose of disseminating it to members of the public but this is not tantamount to approval. Approval and issuance of standards is undertaken by the Kenya Bureau of Standards (KEBS). The State Department's role is limited to ensuring emerging technologies meet the criteria of being ABMT. Technology owners are however required to ensure their technologies are approved and issued with standards by KEBS. To gain credibility and wider acceptance by the built environment professionals and consumers, it is advisable for the Petitioner to update the patent by paying the requisite fees and seek approval by KEBS.

The training component was not delivered through the Housing Directorate.

#### 3.2 Submissions by the National Construction Authority

- 25. The National Construction Authority was fully in concurrence with the Ministry's submissions and further noted that the National Construction Authority Act 2011 as currently enacted does not mandate the Authority to test any material or technology to be used during construction. Despite this, the Authority collaborates with other state agencies such as the materials department and Kenya Bureau of Standards to carry out testing.
- 26. In conclusion, it was stated that the Petitioner was known to the Ministry and that the Ministry and the National Construction Authority gave the Petitioner an opportunity to present his innovation but he never honoured the invitation. The NCA submitted that for instance, in a letter dated 7<sup>th</sup> October 2015, the NCA invited Mr. John Dumas Gachara (the Petitioner) to some of the planned year 2015/2016 contractors and artisans training seminars in different parts of the country so that the Petitioner could introduce, discuss and market his technology.

#### 4.0 COMMITTEE'S OBSERVATIONS

#### 27. The Committee observed that:

- i. The Newbuild Construction Technology was well known to the Ministry and that the Ministry was in support of the Petitioner's work, and was willing to give the Petitioner a forum to showcase his innovation;
- ii. The issues raised in the Petition were all addressed by the Ministry as submitted during the Committee sitting held on 18<sup>th</sup> November 2020;
- iii. The Ministry had shown remarkable commitment to embracing new technology and to give platform to innovators to showcase their products and to support them in every way possible;
- iv. The Petitioner had been given numerous opportunities by the National Construction Authority to showcase his innovation. The Ministry uploaded the Petitioner's proposal on its website as a way of supporting innovation within the country; and
- v. Neither the Committee nor the Ministry had powers to compel consumers to use the said technology.

#### 5.0 RECOMMENDATION

#### 28. The Committee recommends that:

The Petitioner showcases his product in the market and find innovative ways of attracting possible consumers. The Ministry to take all the necessary steps to support the growth of new and affordable technologies in the country including the Newbuild Low-Cost Housing Technology in line with the relevant laws and regulations.



# MEMORANDUM ON PETITION REGARDING THE APPROVAL APPLICATION AND USE OF NEWBUILD'S LOW COST CONSTRUCTION TECHNOLOGY

### 1.0 INTRODUCTION

The National Construction Authority (NCA) is a state corporation established by the National Construction Authority Act No.41 of 2011. The principle purpose of the Authority is to oversee the construction industry and coordinate its development.

The National Construction Authority is mandated under Section 5 (2)(h) of the National Construction Authority Act No. 41 of 2011 to encourage the standardisation and improvement of construction techniques and materials. Further, according to Section 5 (2) (j) of the Act, the Authority shall provide, promote, review and co-ordinate training programmes organized by public and private accredited training centers for skilled construction workers and construction site supervisors.

The "Big Four" agenda was launched in December 2017 by the Honorable President Uhuru Kenyatta and it identifies four priority initiatives namely: enhancing manufacturing, affordable housing, universal health coverage and food security and nutrition which are to be implemented over five years (2017 – 2022). The key purpose of the agenda is to transform standards of living and put Kenya on the path of becoming an upper middle-income nation by 2030. It aims to create employment, reduce cost of living, income inequality, poverty among others.

In regards to the construction industry, the Big Four Agenda plans to build 500,000 affordable homes in all major cities by 2022; reduce corporate tax for developers constructing at least 400 units per year; and increase the supply of affordable houses by partnering with the private sector to develop homes in serviced land.

### 2.0 TECHNOLOGIES SUB-COMMITTEE OF THE PROJECT IMPLEMENTATION UNIT (PIU)

In line with the Big Four agenda, the government established a Techniques/Technologies sub-committee of the Project Implementation Unit (PIU) initially domiciled at the Kenya Building Research Centre (KBRC). The Techniques/Technologies Sub-Committee of the Project Implementation Unit (PIU) was tasked with the planning of the Innovative Building Materials and Technology Exhibition.

The team advertised for Expressions of Interest with clear Technical Specifications that each of the 'would be' providers of alternative building solutions were expected to comply with (Annex 1). Upon opening of bids, twenty-four (24) firms had expressed interest, but only twenty (21) had met the established evaluation criteria (Annex 2). However, this duty was transferred to the National Construction Authority vide a MEMO dated 20<sup>th</sup>

June, 2018 from the Principal Secretary, State Department for Housing, Urban Development and Public Works.

Hence, the National Construction Authority was tasked to spearhead the realization of the Government's Agenda on Affordable Housing, through coordination of the Techniques/Technologies Sub-Committee of the Project Implementation Unit (PIU). This is one of the approaches geared at addressing the high building costs associated with building materials and technologies.

### 3.0 APPOINTMENT OF THE SPECIAL COMMITTEE

Consequently, the Executive Director -National Construction Authority appointed a team of nine (9) members on 27<sup>th</sup> June, 2018 to spearhead the completion of the exercise (Annex 3). The team was required to organize exhibition in a pre-identified site at the Agricultural Society of Kenya grounds in Jamhuri dubbed 'Affordable Housing Village'.

The Village affords an opportunity for innovators, manufacturers and suppliers to display their appropriate, innovative and sustainable materials and technologies ideal for use in the construction sector in Kenya.

The Executive Director –National Construction Authority further appointed a team of five experts from five different institutions to analyze the suitability of the exhibited technologies. These included:

- 1) Department of the Built Environment, University of Nairobi (UON)
- 2) The Kenya Green Building Society (KGBS)
- 3) Architectural Association of Kenya (AAK)
- 4) Material Testing and Research Department
- 5) Kenya Bureau of Standards (KEBS)

The appointed nominees were required to independently develop an evaluation criterion and thereafter carry out a qualitative and quantitative evaluation of the appropriateness of the said materials and technologies.

The Authority in partnership with the State Department of Housing hosted the 1st edition of the Affordable Housing Village Exhibition on 1st to 7th October 2018 at the ASK Show Grounds in Jamhuri. The exhibition was aimed at showcasing new and innovative materials and technologies in the construction industry to the public. The Affordable Housing Village attracted a total of 7 exhibitors who all showcased their different construction materials and technologies. These included;

- a) Bola Technologies
- b) Buildmart Solutions

- c) Hydraform/Sureblock Limited
- d) Koto Housing
- e) Ecobrains Limited
- f) National Housing Corporation (NHC)
- g) Ecosteel Africa

Further, the Authority hosted the 2<sup>nd</sup> edition of the Affordable Housing Village Exhibition at the Nairobi International Trade Fair from 30<sup>th</sup> September to 6<sup>th</sup> October 2019 at the ASK Show Grounds in Jamhuri. A further 2 No. companies exhibited giving a total of 9 No. companies exhibiting in the year 2019.

- a) Mineco Housing Limited
- b) Femo Works Engineering Limited

### 4.0 NEW BUILD'S LOW-COST CONSTRUCTION TECHNOLOGY

Newbuild Limited via letter REF: NL/NCA/0.06B dated 28th September 2015 requested the Authority to facilitate and support New Build's Technology Training and Transfer. In response, the Authority via letter REF: NCA 5/6/VOL1/26 dated 7th October 2015 proposed to support New Build Technology Training and Transfer by giving the company an opportunity to discuss the technology during the planned year 2015/2016 contractors and artisans training seminar (Annex 4).

Further, the State Department for Housing via letter REF: MLHUD/DH/HD/8/13/2/6 dated 15<sup>th</sup> September 2015 requested the Authority to collaborate with Newbuild Limited in the Authority's capacity building and training program for construction workers (Annex 5).

The State Department for Housing and Urban Development vide letter REF: MTIHUD/HUD/ADM/1/1/369 dated 1<sup>st</sup> November 2018 forwarded a letter detailing the patented technology by Newbuild and noted that Newbuild was seeking to collaborate in the Authority's capacity building and training program for construction workers (Annex 6). The Authority encouraged Newbuild Limited to construct a sample structure at the Nairobi show ground to showcase the technology.

The Authority received a letter REF:NL/NCA/0.06C dated 11<sup>th</sup> January 2019 on 14<sup>th</sup> January 2019 from Newbuild Limited requesting for support and facilitation to enable quick implementation of the patented technology (Annex 7).

In response, the Authority held a meeting with Newbuild Limited on 15<sup>th</sup> January 2019 at its headquarters in Nairobi (Annex 8). The agenda of the meeting was presentation of the Newbuild Construction Technology and discussion on the way forward in rolling out training and capacity building on


Newbuild Construction Technology in the construction industry. During the meeting, Newbuild Limited was advised for the second time to construct a sample structure at the Nairobi show ground to showcase the technology. However, the company did not exhibit their technology in the Affordable Housing Village Exhibition held from 30th September to 6th October 2019.

### 5.0 WAY FORWARD

- 1. The Authority is mandated under the Act to encourage the standardisation and improvement of construction techniques and materials. However, the National Construction Authority Act 2011 as currently enacted does not mandate the Authority to test any material or technology to be used during construction. Despite of this, the Authority collaborates with other state agencies such as the materials department and Kenya Bureau of Standards to carry out testing.
- 2. The Building Code, 1968 does not reflect an up-to-date scientific understanding of building technology or evolving societal expectations. In recognition of these limitations, the Building Code is currently undergoing review to address the inadequacies identified in the Code.
- 3. The standardisation and improvement of construction techniques and materials will be achieved through collaboration among various stakeholders including ministries, departments, state agencies, county governments and other public and private sectors.





### INNOVATIVE BUILDING MATERIALS AND TECHNOLOGY EXHIBITION HANDING OVER REPORT

The State Department for Housing, Urban Development and Public Works is charged with the responsibility of facilitating and coordinating the housing sector in Kenya. One of its key functions is to address the high building costs by promoting collaborative research, development and utilization of innovative building material and technologies. Towards this end, the State Department for Housing, Urban Development and Public Works is organizing an exhibition on Innovative Building Materials and Technologies to sensitize the public on affordable housing solutions. The exhibition is to be held at the ASK grounds at Jamhuri Park Nairobi.

Kenya Building Research Centre has been heading the Technology/Techniques subcommittee of the Programme Implementation Unit (PIU), and which was tasked with the planning for the Innovative Building Materials and Technology Exhibition, and gives reports during PIU meetings and/or as required.

This report details the status of the preparations towards planning for the exhibition.

- A request was sent by the State Department for Housing, Urban Development and Public Works, to the Agricultural Society of Kenya (ASK), requesting them for 5acres of land for purposes of holding the exhibition.
- 2. The ASK responded stating that in partnership with the Government of Kenya, they have developed an elaborate master plan for the redevelopment of Jamhuri park showground, aligned with Vision 2030. The State Department's request for allocation of land, was to be guided by the mixed land use and which was in its first phase of implementation.
- 3. Consultations were held with ASK upon which they agreed to allocate to the State Department, approximately lacre of land directly opposite the entrance to the main arena. ASK also gave their charges for the land as follows:
  - i. Off show exhibition

- -KShs. 1.0 million
- ii. Exhibition during Nairobi International Trade Fair
- -KShs. 1.5 million
- iii. Costs for electricity, water, exhibition grounds security services e.t.c. to be met by the State Department for Housing, Urban Development and Public Works.

- 4. The State Department placed advertisement notice with the Nation Media Group Limited and also in MyGov publication, for "Expression of Interest in Innovative Building Materials and Technology Exhibition. The EOI was initially to be opened on 19th April, 2018 but was later extended through an addendum placed in the local daily newspapers, to allow prospective exhibitors attend a "Pre-Bid Meeting"
- A "Pre-Bid Meeting" with the prospective exhibitors was held on 24th April, 2018 at the Kenya Building Research Centre Auditorium to respond to the interested exhibitors concerns, inquiries and queries.
- The Principal Secretary, State Department for Housing, Urban Development and Public Works appointed the Opening Committee, in line with the Public Procurement and Asset Disposal Act, 2015, to open the EOI.
- The Expression of Interest was opened at Ardhi House 6th Floor Conference Room on 3rd May, 2018 by the appointed Committee Members in the presence of applicants who chose to attend.
- An Evaluation Committee was similarly appointed by the Principal Secretary, State Department for Housing, Urban Development and Public Works in line with the Public Procurement and Asset Disposal Act, 2015.
- 9. The Evaluation Committee finalized their report and submitted to the Head of Supply Chain Management Services on 31st May, 2018 for onward submission, with the professional opinion, to the Principal Secretary as per the procurement requirements. The Head of Supply Chain Management Services gave his professional opinion and the Principal Secretary approved the evaluation report on 14th June, 2018.

#### PENDING TASKS

- a) The Technology/Techniques Sub-committee has held several meetings and developed a tentative programme and budget for the exhibition, with an initial proposal to hold the exhibition from 9th July, 2018 to 14th July, 2018. The programme to be reviewed, visaviz, the time required by the exhibitors to set-up and in liaison with ASK to avoid a clash with other activities they may have programmed.
- b) Consultations with ASK was initiated on 20th June, 2018 to ascertain the exact dates ideal for the exhibition. ASK indicated that the State Department should respond to their letter, accepting the offer they made for the grounds and indicating the period the grounds were required.
- c) An agreement is to be entered into between the State Department for Housing, Urban Development and Public Works on one part, and ASK on the other, for the use of their grounds. ASK has a standard form of agreement they use with other parties, however the State Department may develop a form of agreement and submit to them for their review and consideration.
- d) Payments to ASK for the grounds not yet made.

- e) Following approval of the evaluation report by the Principal Secretary, communication on the outcome of the process is to be sent to all parties who participated in the EOI.
- Agreement to be prepared and entered into between the State Department for Housing, Urban Development and Public Works on one part, and each of the successful exhibitors on the other part, for participation in the exhibition, subject to there being no appeals in accordance with the regulations.
- g) The design layout for the grounds to be prepared, clearly mapping out circulation areas and spaces where exhibitors are to set up.
- h) The grounds to be prepared for the exhibition, any overgrown grass and/or bushes cut, debris removed, circulation areas paved etc.
- Exhibition stand for the State Department for Housing, Urban Development and Public Works to be set up, including materials to be communicated and/or issued to the public. The entrance building to be renovated to make it presentable. This may be put to use by the State Department officers at the exhibition.
- j) Exhibitors to set up their exhibitions.
- k) Programme for activities during each day of the exhibition to be drawn. Guests lists to be prepared and invitations sent out.

### MIN No. TPWH 267/2020: PRELIMINARIES

The meeting was called to order at twenty minutes past two o'clock followed by a word of prayer. The Chairman informed the Honorable Members that the Committee was meeting the relevant Departments in the Ministry to consider two petitions and one legislative proposal.

The agenda of the meeting was therefore adopted after being proposed by Hon. Gideon Mulyungi, MP and seconded by the Hon. Ahmed Bashane, MP.

### MIN No. TPWH 268/2020: CONFIRMATION OF THE MINUTES OF THE PREVIOUS SITTING

Confirmation of minutes of the previous sittings was deferred to a later date.

# MIN NO. TPWH 269/2020: PRE-PUBLICATION SCRUTINY OF THE PROPOSED ENGINEERING TECHNOLOGY (AMENDMENT) BILL, 2020 BY HON. EVE OBARA, MP

The Committee noted that in attendance was Hon. Eve Obara, MP, who was also the sponsor of the proposed Engineering Technology (Amendment) Bill, 2020 (legislative proposal). In her submission, she explained that her proposal in Clause 2 was meant to expand the definition of engineers to include engineering technologists as the current Engineering Technology Act of 2016 limits the membership of the society to a fewer cadre. For instance, she explained that people who are doing crafts, certificates and diploma in different fields should be allowed to join the engineering board.

Members of the Committee concurred that it was important to have all cadres regulated by the Board, but equally important was to first determine on who really qualifies to be an engineer.

### Way Forward

The Committee and the Hon. Eve Obara resolved that another meeting be scheduled after two weeks to enable the Hon. Member more time to consult on her proposal before appearing before the Committee again.

# MIN NO. TPWH 270/2020: CONSIDERATION OF THE PETITION REGARDING THE APPROVAL, APPLICATION AND USE OF NEWBUILD'S LOW COST CONSTRUCTION TECHNOLOGY

The Committee noted that the petition by Mr. John Dumas Gachara as conveyed by Hon. Samuel Arama on 12<sup>th</sup> August 2020 was a replica of a petition conveyed through Hon. David Ouma Ochieng, MP on 1<sup>st</sup> October 2019 and which the Committee already considered and made its report. The Committee further noted that during the consideration of the first petition, the petitioner did not appear before the Committee despite being invited twice. In his defense, however, the petitioner explained that he received the invite late.

In his oral submissions before the Committee, the petitioner explained that the patent for his product (newbuild technology) was about to expire in a year. He explained that-

- 1. The technology was very good and prayed that Parliament legislates on his technology instead of leaving it hanging. He stated that since the year 2003, the technology has not been taken up by the government.
- 2. The technology has been uploaded on the Ministry's website but the government has not paid compensation according to the law.

3. The technology should be incorporated in the building code for it to be used. It was important to legalize the instruments of training by legislating the certificates issued.

In their submission, the State Department for Housing explained that technology is market driven. They explained that the Ministry assists innovators and Kenyans to showcase their innovations but they cannot force Kenyans or anyone to use a certain technology. The Department further explained that the new building code already embraces emerging technologies.

The Principal Secretary for Public Works explained that the reason the Ministry uploaded the technology on its website was for Kenyans to see it and embrace it because the Ministry's appreciates all the efforts of innovators. It was a way of supporting the petitioner by giving him the platform to showcase his technology. The Ministry explained that it will not be reasonable for the government to be forced to buy any particular technology, even as it tries to give platform to emerging technologies.

Way Forward

The Committee noted that the petitioner's oral submissions were not expressive of the prayers as submitted in writing through the petition. The Committee further noted that, whereas they appreciated the petitioner's efforts as an innovator, it was not possible for Parliament to force the Ministry to buy a particular technology and neither was it possible for Parliament to legislate on a private commercial venture like the newbuild technology. The Committee Chairperson thanked the petitioner for his time and efforts and explained that the Committee will later retreat to prepare its report.

### MIN NO. TPWH 271/2020:

CONSIDERATION OF THE PETITION REGARDING ECONIMIC VIABILITY OF PHASE 2B OF THE STANDARD GAUGE RAILWAY (SGR) BY THE NOMINATED MEMBER (HON. DAVID OLE SANKOK, MP?

The Petitioner, Hon. David ole Sankok, explained that the construction of the multibillion 52km Phase 2B SGR line from the Suswa dry port had stalled at Emurutoto Shopping Center, a very remote area with no roads and essential social amenities. He explained that the phase 2B SGR project could be more viable if the 12km stretch to Narok Town was completed to give it an economic catchment area of the Greater Lake Region.

The Principal Secretary for Transport explained that the project ended abruptly because of lack of funds but that the Ministry was looking for a way out.

The Petitioner was however not convinced, explaining that the same Ministry constructed another 30km stretch from the dry port to Longonot even when it ironically maintained it had no funds for the 12km from Emurutoto to Narok.

Way Forward

The Committee asked the Principal Secretary to bring a report in two weeks on the following:

- 1. Estimate cost of building the remaining 12km stretch from Emurutoto to Narok Town.
- 2. To submit a report on the scope of the phase 2B SGR project contract.
- 3. Possibility of using the RDLF to fund the 12km stretch.

The Committee will retreat to prepare its report after the said report is received from the Ministry, which was estimated to be after the December 2020 House recess.
