The following petition was conveyed by the Honourable Speaker:

#### REGARDING AMENDMENT OF THE ADVOCATES ACT CAP. 16 TO ALLOW ADMISSION OF LAW PRACTITIONERS FROM THE REPUBLICS OF RWANDA AND BURUNDI TO THE ROLL OF ADVOCATES IN KENYA

**Honorable Members,** pursuant to Standing Order 225(2)(b) requiring the Speaker to report to the House any Petition, other than those presented by a Member, I wish to report to the House that I have received a Petition from Mr. George Njenga Mwaniki and 12 others on behalf of law students, practicing advocates and Members of the East African Law Society in the Republics of Rwanda and Burundi.

**Honorable Members,** the Petitioners state that in 2012, the National Assembly, through enactment of the Statute Law (Miscellaneous Amendments) Act, 2012 amended sections 12 and 13 of the Advocates Act (Cap) 16 and included Rwanda and Burundi in the list of countries from which one is eligible for admission to the roll of advocates in Kenya. However, in its ruling on *Civil Appeal No. 96 of 2014 (Law Society of Kenya vs the Attorney General & 2 others)*, the Court of Appeal declared the Statute Law (Miscellaneous Amendment) Act, unconstitutional citing lack of public participation, thereby rendering lawyers who studied or are practicing advocates in Rwanda or Burundi ineligible for admission to the roll of advocates in Kenya.

**Honorable Members,** the Petitioners are content that, while the Hon. Chief Justice has continued to enroll practicing advocates from other Member-States of the East African Community (EAC) to the roll of Advocates of the High Court of Kenya, those from Rwanda and Burundi are excluded and discriminated against contrary to the spirit of EAC integration espoused in the EAC Treaty that Kenya duly ratified and domesticated. The petitioners are concerned that all efforts to have the matter resolved through the Law Society of Kenya, the Office of the Attorney General and the Minister in charge of the East African Community have not been fruitful.

**Honorable Members,** the petitioners are therefore praying that the National Assembly urgently amends the Advocates Act (Cap 16) with a view to reinstating the impugned provisions of sections 12 and 13 so as to provide for enrolment of legal practitioners from the Republics of Rwanda and Burundi to the roll of Advocates of the High Court of Kenya.

**Honourable Members,** having determined that the matters raised by the petitioners are well within the authority of this House, I order that pursuant to the provisions of Standing Order 227, this Petition be committed to the Departmental Committee on Justice and Legal Affairs. The Committee is required to consider the Petition and report its findings to the House and the Petitioners in accordance with Standing Order 227(2).
