LIMITATION OF DEBATE

The House resolved on Wednesday, February 10, 2021 as follows-

Limitation of Debate on Individual Members' Bills

Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of three hours and thirty minutes, with not more than thirty (30) minutes for the Mover, in moving and ten (10) minutes in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each; and that priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order

Limitation of Debate on Bills sponsored by Parties or Committees

II. THAT, each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and **THAT** priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in **THAT** order.



253/2021 The Member for Kimilili (Hon. Didmus Barasa, MP) to ask the Cabinet Secretary for Interior and Coordination of National Government: -

- (i) Could the Cabinet Secretary explain action taken against a Police Officer who caused an accident that resulted in the loss of lives of *Gilbert Wanjala Sirengo*, a motorcycle rider and his passenger, *Ms. Margaret Nabutua Ndicho* of Kimilili Constituency on 23rd June 2021 as he was driving a police vehicle Reg No. GKB 358T assigned to *Kimilili Police Station* while drunk?
- (ii) What steps has the Ministry taken to ensure that the families of the two victims are compensated for the loss of their loved ones?

The Member for Kasipul (Hon. Ong'ondo Were, MP) to ask the Cabinet Secretary for the Ministry of Transport, Infrastructure, Housing, Urban Development and Public Works: -
