

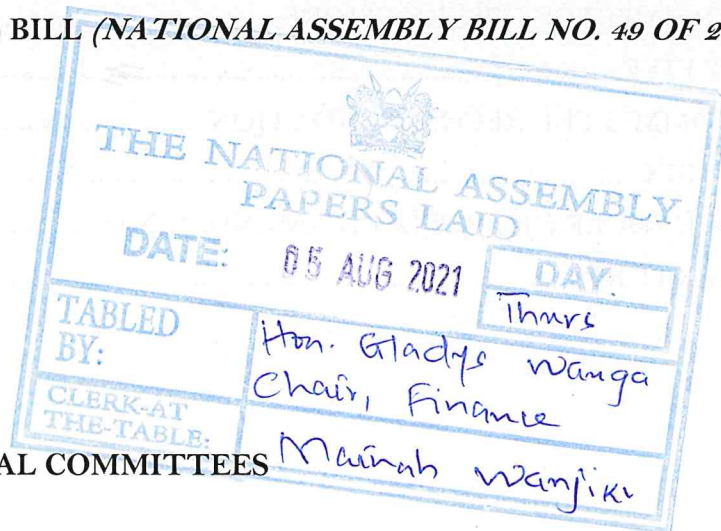

CHAIRPERSON'S FOREWORD

This report contains the proceedings of the Departmental Committee on Finance and National Planning on its consideration of the Public Procurement and Asset Disposal (Amendment) Bill (National Assembly Bill No. 49 of 2020) which was published on 10th December 2020.

The Bill went through the First Reading on 9th June 2021 and was thereafter committed to the Departmental Committee on Finance and National Planning pursuant to Standing Order 127.

The Bill has two (2) clauses and seeks to amend the Public Procurement and Asset Disposal Act, 2015 to enhance the amount of tenders where Kenya citizens are given exclusive preference from the sum of five hundred million shillings to twenty billion shillings. This is to protect the Kenyan traders from foreign competitors.

Following placement of adverts in the print media on 11th June 2021 requesting for comments on the Bill from members of the public and relevant stakeholders pursuant to Article 118(1)(b) of the Constitution and Standing Order 127(3), the Committee received two written memoranda from the National Treasury and Planning and the Institute of Certified Public Accountants of Kenya (ICPAK).

In order to extensively carry out public participation on the Bill, the Committee invited stakeholders vide letter REF: NA/DDC/F&NP/2021/30 dated 6th July 2021 for a stakeholder engagement meeting which was held on Wednesday, 15th July 2021 at Emara Ole Sereni Hotel where National Treasury and Planning attended the meeting.

The stakeholders were opposed to the amendment noting that the threshold set will inhibit the participation of private firms that usually contribute to the economy through the public private partnership framework. They also raised concerns on the capacity of citizen contractors and tenderers to adequately provide the necessary services that require specialized skills that the market space demands. Further, limiting participation of foreign tenderers may hinder technology transfer and building local capacity and locking out foreign contractors will negatively affect Kenya's participation as a key player in regional and international trade.

While considering the Bill, the Committee noted that the leap from five hundred million shillings to twenty billion shillings is astronomically huge. Further, very few Kenyan contractors can afford tenders worth twenty billion shillings. It is for the above reason that the Committee agreed with the stakeholders' concerns and resolved to delete the Bill in its entirety.

On behalf of the Departmental Committee on Finance and National Planning and pursuant to provisions of Standing Order 199(6), it is my pleasant privilege and honour to present to this House the Report of the Committee on its consideration of the Public Procurement and Asset Disposal (Amendment) (No. 3) Bill, 2020. The Committee is grateful to the Offices of the Speaker and Clerk of the National Assembly for the logistical and technical support accorded to it during its sittings. The Committee further wishes to thank Hon. Benjamin Gathiru, MP for sponsoring the Bill and all the stakeholders who participated in the consideration of the Bill. Finally, I wish to express my appreciation to the Honorable Members of the Committee and the Committee Secretariat who made useful contributions towards the preparation and production of this report.

It is my pleasure to report that the Committee has considered the with the Public Procurement and Asset Disposal (Amendment) (NO. 3) Bill (National Assembly Bill No. 49 of 2020) and have the honour to report back to the National Assembly recommendation that the Bill be deleted in its entirety.

1 PREFACE

1.1 ESTABLISHMENT OF THE COMMITTEE

1. The Departmental Committee on Finance & National Planning is one of the fifteen Departmental Committees of the National Assembly established under **Standing Order 216** whose mandates pursuant to the **Standing Order 216 (5)** are as follows:

- i. *To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;*

- x. *To examine any questions raised by Members on a matter within its mandate.*

PART TWO

2 OVERVIEW OF THE PUBLIC PROCUREMENT AND ASSET DISPOSAL (AMENDMENT) (NO. 3) BILL (NATIONAL ASSEMBLY BILL NO. 49 OF 2020)

2.1 INTRODUCTION

6. The main principle object the Public Procurement and Asset Disposal (Amendment) Bill (National Assembly Bill No. 49 of 2020) is to amend the Public Procurement and Asset Disposal Act, 2015 to enhance the amount for tenders where Kenyan citizens are given exclusive preference from the sum of five hundred million shillings to twenty billion shillings. This is to protect the Kenyan traders from foreign competitors.

2.2 ANALYSIS OF THE BILL

The Bill proposes the following amendments:

7. **Clauses 1** of the Bill provides for the short title.
8. **Clauses 2** of the Bill increases the amount for exclusive preference of tenderers for Kenyans from five hundred million shillings to twenty billion shillings.
9. The Bill does not limit any fundamental rights and freedoms as provided under the Constitution.
10. The Bill affects the functions of county governments and is therefore a Bill concerning county governments for purposes of the Standing Orders.
11. Enactment of this Bill shall not occasion additional expenditure of public funds to be provided for through the annual estimates.

PART THREE

3 PUBLIC PARTICIPATION/STAKEHOLDERS CONSULTATION

12. Following the call for memoranda from the public through the placement of adverts in the print media on 11th June, 2021 and vide a letter REF: NA/DDC/F&NP/2021/30 dated 6th July 2021 inviting stakeholders for a meeting, the Committee received memoranda from the following stakeholders:

- i. Institute of Certified Public Accountants of Kenya (ICPAK)
- ii. National Treasury and Planning

The stakeholders submitted as follows:-

3.1 THE INSTITUTE OF CERTIFIED PUBLIC ACCOUNTANTS OF KENYA (ICPAK)

The Chief Executive Officer for the Institute of Certified Public Accountants of Kenya, Mr. Edwin Makori submitted a memorandum **THAT —**

13. The increment margin of exclusive preference from five hundred million shillings to twenty billion shillings is too high. Whereas the threshold set will enhance eligibility of local firms and contractors in promoting the growth of the SME sector, it has the risk of completely excluding foreign firms from participating in procurement thus may inhibit foreign investment in Kenya.
14. In addition, they submitted that the threshold set will inhibit the participation of private firms that usually contribute to the economy through Public Private Partnership frameworks. They also raised concerns about the capacity of citizen contractors and tenderers to adequately provide the necessary services that require specialized skill that the market space demands.
15. They proposed that the Bill should be amended by reducing the threshold of exclusive preference from twenty billion to five billion shillings.

Committee's Observation

The Committee noted ICPAK's concerns and resolved to delete the proposed amendment.

3.2 NATIONAL TREASURY AND PLANNING

In a meeting with the Committee held on Wednesday, 14th July 2021, Hon. Nelson Gaichuhie, Chief Administrative Secretary, National Treasury, submitted that National Treasury did not submit the amendment because of the following reasons:

16. The amendment implies that the Cabinet Secretary shall set thresholds of above KSh. 20 billion for citizen contractors (firms wholly owned and controlled by Kenyan citizens). This will lock out local contractors (firms registered in Kenya with above 51% Kenyan shareholding) and foreign contractors (firms owned by foreign Nationals).
17. The proposed amendment will limit competition to citizen contractors hence loss of benefits that accrue from international competition which includes increased prices for projects. Further, there is inadequate capacity of citizen contractors to deliver quality complex projects in a timely manner.

18. If procurements of KSh. 20 billion are reserved for local contractors, foreign bidders and local contractors will be locked out leading to capital flight, decline in direct investments and relocation of businesses to other countries. Limiting participation of foreign tenderers may hinder technological transfer and building local capacity.
19. Additionally, locking out foreign contractors will negatively affect Kenya's participation as a key player in regional and international trade. Further, it may create room for laxity among citizen contractors due to poor quality of projects which will in the long run outweigh the intended benefits.
20. Arising from the above reasons, there is need to assess the existing thresholds and evaluate if citizen contractors have the requisite capacity to handle tenders of that amount and increase gradually through prescribing in the Regulations.
21. The threshold for exclusive preference given to citizen contractors is prescribed in Regulation 163 of the Public Procurement and Disposal Regulations 2020 as follows: (i) One billion shillings for procurements in respect of works, construction materials and other materials which are made in Kenya; and (ii) five hundred million shillings for procurements in respect of goods and services.

Committee's Observation

The Committee noted the concerns raised by National Treasury and Planning and deleted the proposed amendment.

PART FOUR

4 COMMITTEE OBSERVATIONS

In considering the Bill, the Committee observed the following:

22. The proposed amendment will raise the threshold for exclusive preference from five hundred million shillings to twenty billion shillings;
23. The leap from five hundred million shillings to twenty billion shillings is too huge i.e. 40 times more. The increase should be gradual; and
24. Very few Kenyan contractors have the capacity to execute tenders worth twenty billion shillings. This will therefore mean that tenders worth the amount will be reserved for the few Kenyans who can afford them.

PART FIVE

5 COMMITTEE RECOMMENDATION

25. The Committee having considered the Public Finance Management (Amendment) Bill (National Assembly Bill No. 39 of 2020) recommends to the House that the Bill be **deleted in its entirety**.

PART SIX

6 SCHEDULE OF PROPOSED AMENDMENTS

The Committee proposed the following amendments to be considered by the House in the Committee Stage:-

26. Clause 2: Delete

Justification

The move from five hundred million shillings is astronomically high. Additionally, very few Kenyans can execute contracts worth twenty billion shillings. This will mean that such tenders will only be reserved to a few contractors.

The meeting was called to order at 9.45 a.m. and a prayer was said. The Chairperson then called for introduction of those present before inviting the Governor, CBK to make their submissions.

Dr. Njoroge submitted as follows on the two Bills:

1. Digital lending has grown exponentially in Kenya over the last few years due to high mobile phone penetration, adoption of mobile-phone based financial services and ease of use and convenience.
2. Regulated digital lending has 3.9 million accounts with a loan value of KSh. 50.6 billion which is 1.6% of banking sector loan book as at the end of April 2021.
3. FinAccess Survey 2019 showed that usage of unregulated digital credit has grown from 0.6% (200,000) of Kenya's adult population in 2016 to 8.3% (2 million people) in 2019. There is growing uptake of unregulated digital credit but the number and size of the unregulated digital credit providers is uncertain.
4. The following issues have arisen from unregulated digital lending:
 - i. High indebtedness of borrowers;
 - ii. Lack of consumer protection safeguards due to lack of transparency in pricing, aggressive debt collection and personal data abuse;
 - iii. Financial integrity concerns like Anti-Money Laundering/Combating Financing of Terrorism;
 - iv. Misuse of Credit Reference Bureau (CRB) reporting for blackmailing borrowers; and
 - v. Uneven playing field-regulatory arbitrage.
5. Actions taken by CBK against unregulated digital lending:

- i. Warnings to the public through speeches, press conferences, public notices, dedicated page on CBK website on fraud safety and warned banks against dealing with fraudulent and unlicensed financial schemes;
 - ii. Carrying out of surveys like the National FinAccess Household Surveys conducted by CBK, KNBS and FSD done in 2016 and 2019 and the CBK Innovation Survey done in 2020;
 - iii. Withdrawal of approval as third party sources of information to CRBs
 - iv. Regulation: CBK hosted Global Alliance for Financial Inclusion Forum on Regulation of Digital Credit and drafted Digital Credit Policy and Regulations; and
 - v. Engagement: Afro-Asia Fintech Festival 2019 and 2020, related Africa Hackathons (Fintech) Competitions in 2019 and 2020 and subsequent engagements with Fintechs.
6. Central Bank of Kenya (Amendment) Bill, 2020:
- i. The scope is limited to mobile phones, excludes other digital channels;
 - ii. Too broad and applies to all entities including licensed institutions like banks, microfinance banks and sacco; and
 - iii. Recommended that it is shelved and Central Bank of Kenya (Amendment) Bill, 2021 progressed.
7. Central Bank of Kenya (Amendment) Bill, 2021:
- i. Seeks to empower CBK to regulate and supervise the conduct of digital lenders; and
 - ii. Seeks to address the issue of unregulated digital lending activities.

MEMBERS' DELIBERATIONS

1. Regarding the setting of the minimum liquidity rate and capital requirements for digital lenders, the meeting was informed that regulation on minimum liquidity and capital will be right sized for digital lenders.
2. Regarding the capping of interest rates for digital lenders, CBK will come up with regulations that will ensure that consumers are protected.
3. With regards to delays in issuance of licenses to digital lenders, the Governor stated that CBK does not sit on licensing requests. Requests take long to be approved because applicants fail to submit all the required information.
4. Regarding the renewal of licenses annually, the meeting was informed that licenses will be paid for annually but digital lenders will not be required to reapply for the licenses.
5. Regarding concerns that regulation of digital lenders will stifle innovation, the Governor informed the meeting that innovators should not be allowed to run amok and that the innovations should be consistent with the principles that are already set out. CBK does not intend to overregulate the industry. All they want is to protect consumers.
6. Regarding the over indebtedness of borrowers, the Governor noted that it is a very important issue that needs to be looked into. Information should be provided to the citizenry on their financial options.
7. Regarding listing of customers on the CRBs, CBK noted that that digital lenders should continue using CRBs in a balanced way. The data should be well protected.
8. On whether these laws will stop pyramid schemes, the Governor stated that the law will not stop pyramid schemes. CBK will however ensure that people are given the right information on investment.
9. Regarding collaboration with the Office of the Data Commissioner and Communications Authority, the Governor stated that this is very welcome as it will enhance consumer protection.

10. On the provision of dispute resolution in the legislation, the meeting was informed that this is not necessary because disputes rarely arise. The law should be clear to prevent disputes.
11. Regarding the extension of the period of compliance with the law, the Governor stated that 6 months after enactment of the law is sufficient. CBK will start working with digital lenders immediately so that the licensing is timely.
12. The Committee requested CBK to submit documentation on legal frameworks on digital lending for countries that they had benchmarked with.

Pursuant to Article 118(1) (b) of the Constitution and Standing Order 127(3) of the National Assembly Standing Orders, the Clerk of the National Assembly hereby invites members of the public and relevant stakeholders to submit memoranda on the aforementioned Bills, whose objects are as follows:

The Higher Education Loans Board (Amendment) Bill, 2020 (National Assembly Bill No. 37 of 2020) sponsored by Hon. Paul Mwirigi, MP, Igembe South Constituency, seeks to amend the Higher Education Loans Board Act in order to provide that a loanee shall commence the repayment of his or her loan once he or she secures employment. The amendment is meant to cushion unemployed graduates from being charged interest on the loan before they have secured employment.

The Pharmacy and Poisons (Amendment) Bill, 2021 (National Assembly Bill No. 1 of 2021) sponsored by Hon. Alfred Keter, MP, Nandi Hills Constituency, seeks to amend the Pharmacy and Poisons Act to prohibit the sale or dispensing of medicine without written prescription from a registered medical practitioner.

The Health (Amendment) Bill, 2021 (National Assembly Bill No. 14 of 2021) sponsored by Hon. Moses Mwambu Wekesa Mabonga, MP, Bumula Constituency, seeks to amend the Health Act No. 21 of 2017 to provide that the National government and county governments shall, in consultation through the existing inter-governmental relations mechanism establish regional cancer centers; to make it an offence for a person in-charge of a Public Health facility to demand or permit of payments of advance medical fees as pre-condition for the provision of medical services; to make it an offence for person in-charge of a Public Health facility to detain a body of deceased person as means of enforcing settlement of outstanding medical bills and to provide for regulation on levying of charges for the practice of conventional medical practice.

The National Electronic Single Window System Bill, 2021 (National Assembly Bill No. 15 of 2021) seeks to provide for the establishment and operationalization of the National Electronic Single Window System in order to facilitate trade, the establishment of the Kenya Trade Network Agency, to provide for electronic transactions, and for connected purposes.

The Coffee Bill, 2021 (National Assembly Bill No. 17 of 2021) seeks to provide for development, regulation and promotion of the Coffee Industry, provide for establishment, powers and functions of the Coffee Board of Kenya.

The Community Groups Registration Bill, 2021 (National Assembly Bill No. 20 of 2021) seeks to provide a regulatory framework for the registration and regulation of community groups and connected purposes.

The Kenya Roads (Amendment) Bill, 2021 (National Assembly Bill No. 13 of 2021) sponsored by Hon. David Pkosing, MP, Pokot South Constituency, seeks to amend the Kenya Roads Act (No. 2 of 2007) to align the Act with the provisions of the Constitution with regard to the auditing functions of the Office of the Auditor-General. The Act currently refers to the defunct office of the Controller of Budget and the Auditor-General. The Bill further seeks to amend the term of office of and the qualification for the Director-General of the Kenya Roads Board appointed under the Act.

The Computer Misuse and Cybercrimes (Amendment) Bill, 2021 (National Assembly Bill No. 11 of 2021) sponsored by Hon. Aden Bare Duale, MP, Garissa Township Constituency, seeks to amend the Computer Misuse and Cybercrimes Act, 2018 to provide for the prohibition against the sharing of pornography through the internet and prohibit use of electronic mediums to promote terrorism, extreme religious and cult activities.

Kenya Industrial Research and Development Institute Bill, 2021 (National Assembly Bill No. 44 of 2021) seeks to establish the Kenya Industrial Research and Development Institute, and for connected purposes. It further provides for the promotion of research, development, technology and innovation in industrial and allied technologies, and for initiation and support of industrial development.

The National Construction Authority (Amendment) Bill, 2020 (National Assembly Bill No. 45 of 2020) sponsored by Hon. David Gikaria, MP, Nakuru Town East Constituency, seeks to amend the National Construction Authority Act, No. 41 of 2011 to ensure women, youth and persons living with disabilities with start-up businesses who apply to be registered as contractors under category six, seven and eight are exempted from paying the prescribed fee. The amendment seeks to recognize women, youth and persons living with disabilities as marginalized groups and to cushion them from the burden of paying registration fees.

The Kenya Deposit Insurance (Amendment) Bill, 2020 (National Assembly Bill No. 43 of 2020) sponsored by Hon. Abdul Rahim Dawood, MP, Imenti North Constituency, seeks to amend section 28 of the Kenya Deposit Insurance Act, 2012 in order to increase the maximum amount a person with an account with an institution under liquidation is to be paid by the Kenya Deposit Insurance Corporation. It further seeks to delete the provision limiting the maximum amount a person is to be paid by the Corporation despite having different accounts.

The Public Procurement and Asset Disposal (Amendment) (No. 3) Bill, 2020 (National Assembly Bill No. 49 of 2020) sponsored by Hon. Benjamin Gathiru Mwangi, MP, Embakasi Central Constituency, seeks to amend the Public Procurement and Asset Disposal Act, 2015 to enhance the amount for tenders where Kenya citizens are given

exclusive preference from the sum of five hundred million shillings to twenty billion shillings. This is to protect the Kenyan traders from foreign competitors.

The Irrigation (Amendment) Bill, 2021 (National Assembly Bill No. 12 of 2021) seeks to amend the Act by expanding the administration of irrigation matters to include management and regulation of irrigation matters. The Bill further seeks to amend the Act to harmonize the provision of the Irrigation Act, Water Act and Water Resources Management Rules, 2007.

The Tax Appeals Tribunal (Amendment) Bill (National Assembly Bill No. 19 of 2021) seeks to amend the Tax Appeals Tribunal Act, 2013 to address the challenges affecting the performance of the Tax Appeals Tribunal to facilitate the expedition of tax disputes in the country.
