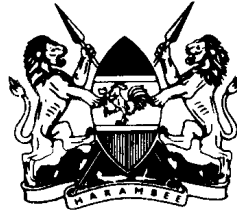

**LIMITATION OF DEBATE**

The House resolved on Wednesday, February 10, 2021 as follows-

Limitation of Debate on Bills sponsored by Parties or Committees

**THAT**, each speech in a debate on **Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party** shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and **THAT** priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in **THAT** order.

**109/2021      The Member for Loima (Hon. Jeremiah Lomurukai, MP) to ask the Cabinet Secretary for Devolution and the ASALs: -**

- (i) Could the Cabinet Secretary explain the plans the Ministry had put in place to ensure that there is constant and sufficient stock of food and relief items for purposes of emergencies such as droughts, famine and other calamities in the country, particularly in Turkana County?
- (ii) What action has the Ministry taken to distribute relief food across the six Sub-Counties in Turkana County to mitigate against the current dire situation in Turkana County where there is serious drought leading to loss of crops and livestock with *Loima, Turkana West, Turkana South and Turkana East Sub Counties* being the most affected?

- (iii) What specific steps is the Ministry taking to ensure timely achievement of the project's objective and mitigate potential risk of termination of the project?
