NOTICES

I. <u>THE IRRIGATION (AMENDMENT) BILL (NATIONAL</u> <u>ASSEMBLY BILL NO. 12 OF 2021)</u>

Notice is given that Chairperson of the Departmental Committee on Environment and Natural Resources intends to move the following amendments to the Irrigation (Amendment) Bill, 2021 at the Committee Stage—

CLAUSE 2

THAT, clause 2 of the Bill be amended in paragraph (c) by—

- (a) by deleting the proposed new definition of the expression "cabinet secretary"; and
- (b) by deleting the proposed new definition of the expression "monitoring and evaluation"

CLAUSE 4

THAT, clause 4 of the Bill be amended by inserting the following new paragraph immediately after paragraph (a) —

(aa) by deleting the word "projects" appearing in paragraph (g) and substituting therefor the word "schemes".

CLAUSE 6

THAT, clause 6 of the Bill be amended —

- (a) in paragraph (a)—
 - (i) in subparagraph (iii) by deleting the words "two persons appointed by the Cabinet Secretary out of four" appearing in the proposed new paragraph (h) and substituting therefor the words "one person appointed by the Cabinet Secretary out of three";
 - (ii) by deleting subparagraph (iv); and
- (b) by inserting the following new paragraph immediately after paragraph (a) —

(aa) in subsection (4) by deleting the words "or its equivalent in any field" appearing in paragraph (c) and substituting therefor the words "in water engineering, civil engineering, agriculture, irrigation or environmental studies."

CLAUSE 12

THAT, clause 12 of the Bill be amended by deleting the words "subject to mandatory approvals" and substituting therefor the words "subject to mandatory approvals in accordance with regulations"

CLAUSE 16

THAT, clause 16 of the Bill be amended in paragraph (a) by deleing the proposed new sub-paragraph (c) and substituting therefor the following new sub-paragraph—

"(c) be removed from office by the Cabinet Secretary if the member-

- (i) contravenes the provisions of Chapter six of the Constitution; or
- (ii) acts in contravention of codes, policies and procedures in the public service.

LIMITATION OF DEBATE

The House resolved on Wednesday, February 10, 2021 as follows-

Limitation of Debate on Bills sponsored by Parties or Committees

II. THAT, each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party shall be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and THAT priority in speaking shall be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in THAT order.

Limitation of Debate on Sessional Papers

III. THAT, each speech in a debate on any **Sessional Paper** shall be limited as follows:- A maximum of two and a half hours, with not more than twenty (20) minutes for the Mover in moving and five (5) minutes for any other Member speaking, **including** the Leader of the Majority Party and the Leader of the Minority Party and the Chairperson of the relevant Committee (if the Sessional Paper is not moved by the Chairperson of the relevant Committee), and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and **THAT** priority in speaking shall be accorded to the Leader of the Majority Party and the Leader of the Minority Party and the Leader of the Minority THAT order.

ORDINARY QUESTIONS

294/2021 The Member for Eldama Ravine (Hon. Moses Lessonet, MP) to ask the Cabinet Secretary for Energy:-

- (i) What measures has the Ministry put in place to ensure electricity power connection in Eldama Ravine Constituency particularly, to public institutions including schools and health facilities?
- (ii) Could the Cabinet Secretary explain why the following transformers in Eldama Ravine Constituency are either unoperational or not connected to any customer:- Transformers at *Sumbeiywet Village, Kabor Primary School,* Kenya Power Station at *Ipopor area near Kimamoi Trading Centre, Ngusero village, and Sogee area Kokwomoi Primary School?*
- (iii)Could the Cabinet Secretary explain why *Kapsoit* Primary school in Eldama Ravine Constituency is yet to be connected to electricity power over 10 years after installation of a transformer in the school?
- (iv)Why was the transformer at Lomunera Muserechi area in Eldama Ravine Constituency taken away by Kenya Power officers, and when will it be returned?

(i) Could the Chairperson provide the current staffing levels for teachers in both primary and secondary schools across the country in terms of the numbers in post vis-à-vis the authorized establishment in each county categorized for National, Extra County, County and Sub-County Schools for the case of Secondary Schools?

- (ii) Could the Chairperson provide a list of teachers recruited since 2017 to date for both primary and secondary schools and indicate their counties of birth?
- (iii)What is the justification for the new recruitment system which requires teachers to apply for jobs in several counties as opposed to the previous system which required applicants to do so in their counties of origin and which enabled distribution of recruitment opportunities to all geographical regions in the country?
- (iv)How many teachers were promoted from each county in the last promotion exercise in both primary and secondary schools and could the Chairperson provide a list of the said teachers?
