









Introduction

The National Government Constituencies Development Fund (NG-CDF) Act, 2015 as amended in 2016 section 50 establishes the National Assembly Select Committee (NASC) on the NG-CDF whose main functions include but not limited to;

- (a) Oversee the implementation of the Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary propose any amendments to this Act, in particular, with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;
- (b) Oversee the policy framework and legislative matters that may arise in relation to the Fund;
- (c) Continually review the framework set out for the efficient delivery of development programmes financed through the Fund;
- (d) Consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act;

Section 51(1) of the Act further stipulates that the Board shall, on a quarterly basis, submit a report to the National Assembly Select Committee detailing the following;

- a) A summary of the project proposals received from the constituencies in the preceding quarter and indicating the approval status of such projects;
- (b) A summary of the status of disbursements of funds to the constituencies for that preceding quarter;
- (c) A summary of the status of disbursements from the Treasury to the National Account;
- (d) Any restriction imposed on a constituency account in accordance with the Act.

It is based on the foregoing that the National Government Constituencies Development Fund (NG-CDF) Board is submitting its report for the first quarter of 2021/2022 Financial Year.

A. A summary of the project proposals received from the constituencies in the preceding quarter and indicating the approval status of such projects

The NG-CDF Board management issued a circular on submission of project proposals on 26th August 2021 guiding Constituency Committees on the process of preparation and online submission of Project Proposals for 2021/2022 Financial Year. The Constituency Committees were advised to submit their Project Proposals not later than 30th September, 2021.

Management has to date received Project Proposals from two hundred and fifty - six (256) constituencies, out of which thirty three (33) were considered by the Board in its meeting of 27th September 2021, two hundred and twenty three (223) are under review while thirty four (34) are yet to be received. *See details in Annex I.*

The Board has communicated to the respective Constituencies requiring them to provide written communication on the reasons for non-submission of Project Proposals within the set timeline.

C. Summary of the status of disbursements from the National Treasury to the National Account

(i) 2021/2022 Financial Year

The NG-CDF was allocated a total of Kshs. 41,714,800,000 for the 2021/2022 financial year. Subsequent to the allocation, the Board determined the financial ceiling for each constituency in consultation with the National Assembly Select Committee in line with Section 6 and 34 of the NGCDF Act. This paved way for the National Government Constituency Development Fund Committees (NGCDFCs) to embark on preparation of project proposals for the 2021/2022 financial year. The Board is in the process of receiving and considering proposals from the constituencies.

Section 39(2) provides that:

“The disbursement of funds to the constituency fund account shall be effected at the beginning of the first quarter of each financial year with an initial amount equivalent to twenty-five per centum of the annual allocation for the constituency and thereafter the constituency fund account shall be replenished in three equal instalments at the beginning of the second, third and fourth quarters of the financial year”.

Pursuant to the above section, the Board has received first quarter allocation amounting to Kshs.10.4287 billion from the National Treasury and Planning as tabulated here below:

(ii) Pending receipts from The National Treasury

Section 7 (2) of the NG-CDF Act 2015 as amended in 2016 provides that all funds allocated to a constituency shall be cumulative and shall be carried forward from one financial year to the next, including funds returned into the accounts in accordance with section 6(3) or funds which are not utilized for whatever reasons.

Section 40 of the Act further provides that the Board shall ensure that the list of projects forwarded to it by each constituency is, upon approval, funded in accordance with the Act.

The Fund has pending receipts amounting **Kshs.4.97319675 Billion** relating to financial Years 2011/2012, 2013/14 and 2014/15 as tabulated below.
