**THAT, WHEREAS** Kenya is a multi-ethnic and multi-racial country with rich and diverse cultural resources such as traditional medicine and foods, arts, craft, music, dances, dress among others;

**AWARE THAT,** the Constitution, in its preamble acknowledges the cultural diversity of the Kenyan people who are determined to live in peace and unity as one indivisible sovereign nation whilst, Article 11 of the Kenyan Constitution recognizes culture as the foundation of the nation;

**NOTING** that, while the Department of Culture under the Ministry of Sports, Culture and Heritage has been playing some of the key roles in promotion of cultural integration, formulation of policies and standards that will guide the development of culture, little information has been available to the Kenyan public;

**ACKNOWLEDGING,** that culture performs a significant role in the life of a child, the cultural background in which a child is brought up affects the totality of his or her life's activities;

**CONCERNED**, that our children are losing their sense of identity due to the negative influences due to inadequate cultural identity catalyzed by globalization which has led to catastrophic consequences to the next generation as experienced in our country where a majority of young people are showing symptoms of feeling suicidal, anxious, feeling of hopelessness, anger, violence, feeling isolated, and paranoia;

**NOW THEREFORE**, the Senate urges the Cabinet Secretary, Ministry of Sports, Culture and Heritage to –

- a) Formulate cultural development policies and initiatives to inculcate stronger community values, safeguard Kenya's heritage, recognize local heroes and promote socio-cultural opportunities in the counties; and
- b) Formulate strategies to create an enabling environment for protection and promotion of diversity of cultural expressions in all counties.

### 29. <u>MOTION - RECOGNIZING AND APPRECIATING THE ELDERLY BY</u> <u>COUNTY GOVERNMENTS</u>

(Sen. Rose Nyamunga, MP)

**THAT, AWARE** that in 2006, the National Government initiated the Older Persons Cash Transfer (OPCT) Programme, popularly known as *Pesa ya Wazee*, which is an unconditional cash transfer programme to destitute elderly persons above the age of 65 years to cater for their subsistence needs;

**NOTING THAT** the beneficiaries receive a monthly stipend of Kshs. 2,000, delivered every two months through appointed payment agents, and also entitled to medical insurance through the National Health Insurance Fund (NHIF);

**CONCERNED HOWEVER THAT** the programme's credibility is marred by issues of delayed payments to beneficiaries, difficulties in processing of payments through the stipulated agents and payments to unregistered persons;

**NOW THEREFORE**, the Senate recommends that the County Governments complement the efforts of the National Government and assist in resolving these challenges by:-

- 1. Developing legislation and policies to protect the elderly including ensuring all elderly persons in their counties are registered in the OPCT programme; and
- 2. Organise value addition mechanisms such as financial training to help the beneficiaries of the programme to efficiently utilise this allowance.

**NOTICE** is given that the Chairperson, Standing Committee on Land, Environment and Natural Resources, intends to move the following amendments to the Natural Resources (Benefit Sharing) Bill (Senate Bills No. 25 of 2020), at the Committee Stage—

### CLAUSE 10

**THAT** clause 10 of the Bill be amended—

(a) by inserting the following new sub clause immediately after sub clause (2)—

(3A) The members of the County Benefit Sharing Committee elected under subsection (2)(d) shall serve for one single term of five years.

(b) In sub clause (4) by deleting the expression "(2)(c)" appearing immediately after the words "elected under subsection" and substituting therefor the expression "(2)(d)".

### CLAUSE 12

**THAT** clause 12 of the Bill be amended in sub clause (2) by deleting the words "county and local community" appearing immediately after the word "Each".

(6) The local community benefit sharing forum shall ensure that the respective local community benefits from the exploitation of natural resources and shall, for this purpose—

- (a) collect and collate the views of the local community and represent the interests of the local community in the negotiations with the respective County Benefit Sharing Committee and in the implementation of a Benefit Sharing Agreement;
- (b) in consultation with the local community, identify local community projects to be supported by money allocated to the local community by the County Benefit Sharing Committee under this Act; and

**AWARE THAT**, the Kenya Mental Health Policy 2015-2030 is a commitment to pursuing policy measures and strategies for achieving optimal health status and capacity of each individual whose goal is attainment of the highest standard of mental health;

**FURTHER AWARE THAT**, Advocacy for mental health goals, promotion of mental well-being, prevention of mental disorders, treatment of mental disorders and rehabilitation helps mentally ill individuals achieve optimum social and psychological functioning;

**APPRECIATING THAT,** these services are offered in the three main public level 6 hospitals and a few private providers in major urban centres despite the rise in suicide cases in Kenya which is largely attributed to mental health issues;

**CONCERNED THAT,** many Kenyans view mental illness as a spiritual problem rather than a medical one, causing them to turn to religious leaders or traditional healers for a cure;

**NOTING THAT,** Traditional Health Practitioners (THPs) are often the first line of contact for mental illness in Kenya, because they are readily available and accessible in the community and form part of the Community's cultural belief system, thus communities prefer seeking treatment from THPS rather than health facilities because of dissatisfaction with treatment and services at the local health facilities;

**FURTHER NOTING THAT,** no specific policy guides this, although the 2015-2030 mental health policy encourages integration of THPs into mental healthcare and support community leaders to participate in referral of persons with mental illness for treatment;

**ACKNOWLEDGING THAT,** the Traditional Health Practitioners Act, 2014 makes provision for training, registration and licensing and provides for the establishment, powers and functions of THPs Council of Kenya;

**NOW THEREFORE,** the Senate urges the Cabinet Secretary, Ministry of Health together with the Council of Governors, to ensure that Traditional Health Practitioners services are integrated in the modern healthcare system in order to ensure effective treatment of mental illnesses by:

- i. engaging THPs to help treat mental health issues;
- ii. formulating policy that will guide the collaboration between the mainstream health professionals and traditional health practitioners; and
- iii. establishing facilities at the lowest administrative units to monitor and attend to mental health issues.
