There being no Member to second the motion, the provisions of Standing Order 57 applied.

In this regard, the Speaker issued the following Communication:

ON THE CONSIDERATION OF THE WILDLIFE CONSERVATION AND MANAGEMENT (AMENDMENT) BILL (SENATE BILL NO. 30 OF THE 2020)

"Honourable Members,

You will recall that on Wednesday, 16th February 2022 during the Afternoon Sitting, when the Order for Second Reading was read, the Chairperson of the Departmental Committee on Environment and Natural Resources, the Hon. Sophia Abdi, MP moved the motion that "The Wildlife Conservation and Management (Amendment) Bill (Senate Bill No. 30 of 2020) be read a Second time".

Honourable Members, in moving the Motion, the Chairperson expressed reservations on the Bill. In particular, the Chairperson claimed that the proposed Bill contains provisions that have money bill implications and that the Bill ought not to have originated from the Senate. She further indicated that following the public participation exercise undertaken, the Cabinet Secretary for Tourism and Wildlife submitted to the Committee that a more comprehensive Draft Bill from the Ministry to the Wildlife Conservation and Management. She indicated that the publication of the Bill is at an advanced stage and it was her considered view that the proposed Bill is a proposed piecemeal review of the Act. The Committee agreed with the Cabinet Secretary.

Honourable Members, the Chairperson also indicated that she was moving the motion, albeit reluctantly, since it is her obligation to move the Motion. At the end, she asked the Member for Laikipia North, the Hon. Sarah Korere, MP to second the Motion for Second Reading for the Bill. On her part, the Member declined to second the Motion. Consequently, the Speaker was not able to propose the Question by dint of Standing Order 57 which provides that-

"The question on any motion shall not be proposed unless it shall have been seconded and any motion that is not seconded shall be deemed to have been withdrawn, and shall not be moved again in the same Session."

Honourable Members, since this is a Bill originating from the Senate, I wish to invoke the provisions of Standing Order No. 1 and pause for a moment to find out whether there is any Member desirous in seconding the Motion for Second Reading for the Bill.

If any Member is so desirous, please proceed to do so now!

[No Member rose to second the Motion]

Honourable Members, in the absence of such a Member to second the Motion, then the provisions of Standing Order 57 (1) as stated above shall apply, the effect of which is that the Bill shall not proceed at Second Reading, but will instead be referred to a Mediation Committee.

Honourable Members, may I therefore request the Leader of the Majority Party to consult with the Leader of Minority Party and propose five (5) members to sit in the Mediation Committee so as to enable me communicate the decision of the House to the Senate, in line with the provisions of Articles 112 and 113 of the Constitution.

In the meantime, Honourable Members, The Wildlife Conservation and Management (Amendment) Bill (Senate Bill No. 30 of 2020) stands defeated and the provisions of Articles 112 and 113 of the Constitution apply. The House is accordingly guided. I thank you!"

35. Section 139 of the principal Act is amended in subsection (4) by deleting the words "any variation of a contract shall only be considered after twelve month from the date of signing the contract" and substituting therefor the words "a variation of a contract shall be considered at any time, in the case of a quantity variation but shall only be considered after twelve months from the date of signing of the contract, in the case of a price variation".

- Amendment **35.** The principal Act is amended in section 139–
 - (a) by deleting subsection (2) and substituting therefor the following new subsection-
 - "(2) An accounting officer of a procuring entity, on the recommendation of an evaluation committee or as prescribed in the signed Contract Agreement, may approve the request for—

- (a) use of prime costs;
- (b) use of contingencies;
- (c) reimbursable costs; and
- (d) use of provisional sums."
- (b) by inserting the following new subsection immediately after subsection (2)-
 - "(2A) Despite subsection (2), an accounting officer of a procuring entity, on the recommendation of an evaluation committee or as prescribed in the signed contract agreement, may approve the request for the extension of the contract period, which request shall be accompanied by a letter from the tenderer making justifications for such extension."
- (c) by deleting subsection (4) and inserting the following new subsection-
 - "(4) For the purposes of this section, any variation of a contract shall only be considered if the following are satisfied—
 - (a) the price variation from the original price is based on the prevailing consumer price index obtained from Kenya National Bureau of Statistics;
 - (b) the quantity variation for goods does not exceed fifteen per cent of the original contract quantity;
 - (c) the price or quantity variation is to be executed within the period of the contract;
 - (d) the cumulative value of all contract variations for goods do not result in an increment of the total contract price by more than twenty five per cent of the original contract price; and
 - (e) the cumulative value of professional services does not result in an increment of the total contract price by more than twenty five per cent of the original contract price.
- (d) by inserting the following new subsection immediately after subsection (6)–
 (7) The method for computing price variation shall be prescribed in regulations.
