ON MESSAGE FROM THE PRESIDENT ON NOMINATION OF PERSONS FOR APPOINTMENT TO THE POSITIONS OF AMBASSADORS, HIGH COMMISSIONERS AND PERMANENT REPRESENTATIVES

WHEREAS on 2nd February, 2022, the House resolved that- "upon receipt of any name of a person nominated for appointment to a state or public office from the President or any other office in the National Executive, the Speaker shall forthwith refer such Message to the relevant Committee for consideration, without having to recall the House".

FURTHER WHEREAS, Standing Order 42(2) requires the Speaker to cause the transmission of any Message received from the President at a time when the House is not in Session to every Member and later report such Message to the House at its next sitting;

IT IS THEREFORE NOTIFIED to all Members of the National Assembly that, on **4**th **May**, **2022**, I received a Message from H.E. the President regarding nomination of twenty two (22) persons to the Offices of Ambassadors, High Commissioners, and Permanent Representatives for approval for appointment to various diplomatic missions as representatives the Republic of Kenya. IT IS FURTHER NOTIFIED THAT in furtherance to the provisions of Article 132(2)(e) of the Constitution and sections 3 and 5 of the Public Appointments (Parliamentary Approval) Act (No.33 of 2011), H.E. the President now seeks the approval of the National Assembly of the said persons to the respective offices;

NOW THEREFORE, in keeping with the provisions of Standing Order 42(2) and the Resolution of the House of 2nd February 2022 –

- (a) upon resumption of the House on Tuesday, 10th May 2022, in accordance with its Calendar for Regular Sessions, I shall convey the Message from H.E the President to the assembled House;
- (b) the Message now stands referred to the Departmental Committee on Defence and Foreign Relations for the Committee to commence necessary vetting processes as contemplated under the Public Appointments (Parliamentary Approval) Act and Standing Order 45 (Committal of public appointments to Committees); and,
- (c) the Clerk is hereby required to transmit this Notification to all Members of the National Assembly and facilitate the Committee to expeditiously undertake the necessary approval hearings.
