CHAIRPERSON'S FOREWORD

Standing Order 200A (1) and (2) of the National Assembly Standing Orders provides that *"(1) A Committee which is unable to complete its work before the expiry of its term shall table an exit report to the Assembly detailing reasons for such inability; and (2) The report shall be available to the succeeding committee which may consider it in preparing its work plan"*.

The Exit Report is an important tool of gauging the Committee's performance in the Twelfth Parliament. It gives details of the business transacted by the Committee from November 2017 to June 2022 and offers a starting point for the succeeding Committee as it highlights the business pending before the Committee at the end of the Sixth Session.

The following business was referred to the Departmental Committee on Finance and National Planning in the Twelfth Parliament: eighty-one (81) Bills; thirty-four (34) Legislative Proposals; nineteen (19) Petitions; two (2) inquiries; sixty-three (63), eighteen (18) Statements; ten (10) vetting of nominees for approval for appointment to public office; and one (1) Agreement. The Committee executed most of the work referred to it despite the difficult times that Members had to work under particularly the COVID-19 Pandemic during which Members could not hold in-person meetings, among other challenges.

Through its work, the Committee was able to positively impact the country in several ways including increasing revenue collection by Kenya Revenue Authority through increased budgetary allocation which made it possible for the Authority to increase its surveillance hence identify tax cheats and evaders. For the first time in many years, KRA surpassed its revenue collection target in the Fiscal Year 2020/21. Additionally, the Committee ensured that the National Population and Housing Census for 2020 was successful by providing adequate funding for the activity and holding regular meetings with the Kenya National Bureau of Statistics (KNBS) to be apprised on the preparation for the Census. The Committee also prides itself in the success of the Africities Conference held in Kisumu County in May 2022.

It is therefore my pleasant duty and privilege, on behalf of the Departmental Committee on Finance and National Planning and pursuant to provisions of Standing Order 200A (1) to present to this House the Committee's Exit Report.

1 PREFACE

1.1 ESTABLISHMENT OF THE COMMITTEE

1. The Departmental Committee on Finance and National Planning is one of the fifteen Departmental Committees of the National Assembly established under **Standing Order 216** whose mandate pursuant to the **Standing Order 216 (5)** is as follows:

- i. To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;*
- ii. To study the programme and policy objectives of Ministries and departments and the effectiveness of their implementation;*
- iii. To study and review all the legislation referred to it;*
- iv. To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;*
- v. To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;*
- vi. To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No. 204 (Committee on appointments);*
- vii. To examine treaties, agreements and conventions;*
- viii. To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;*
- ix. To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and*
- x. To examine any questions raised by Members on a matter within its mandate.*

1.2 MANDATE OF THE COMMITTEE

2. In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider, public finance, monetary policies, public debt, financial institutions (excluding those in securities exchange), investment and divestiture policies, pricing policies, banking, insurance, population revenue policies including taxation and national planning and development.

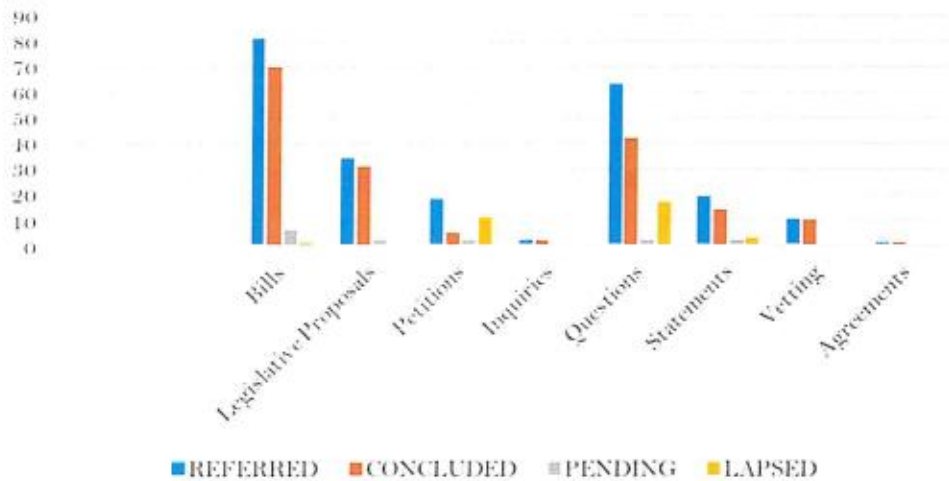

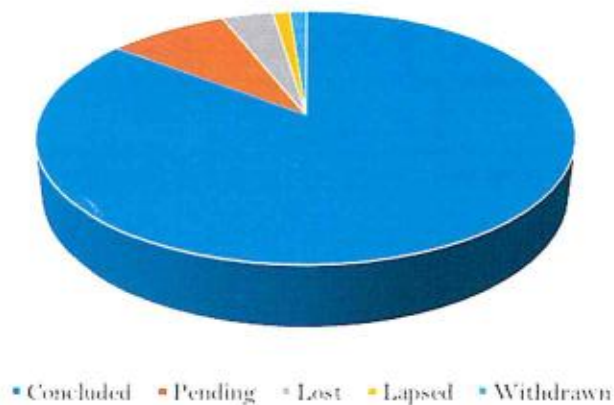

2.1 BILLS

11. One of the roles of the National Assembly is to enact legislation. Committees assist the House in the in-depth consideration of Bills by incorporating public participation in the legislative process as well as consider and make recommendations for approval of the Bills.
12. Eighty-two (82) Bills were committed to the Departmental Committee on Finance and National Planning. The Committee concluded consideration of seventy-one (71) Bills, six (6) Bills were pending before the Committee, three (3) were lost, one (1) lapsed and one (1) was withdrawn. 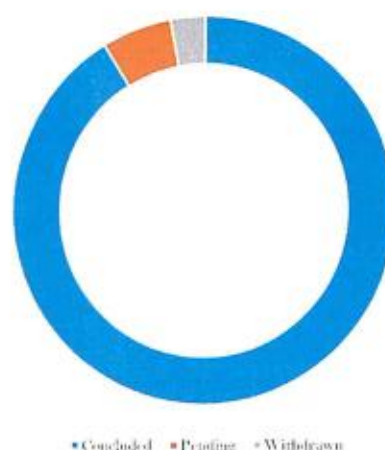

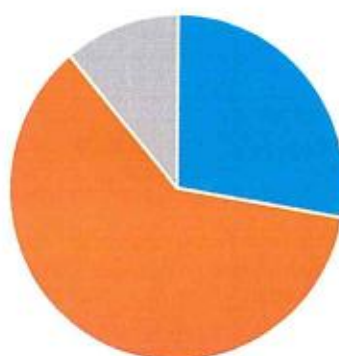

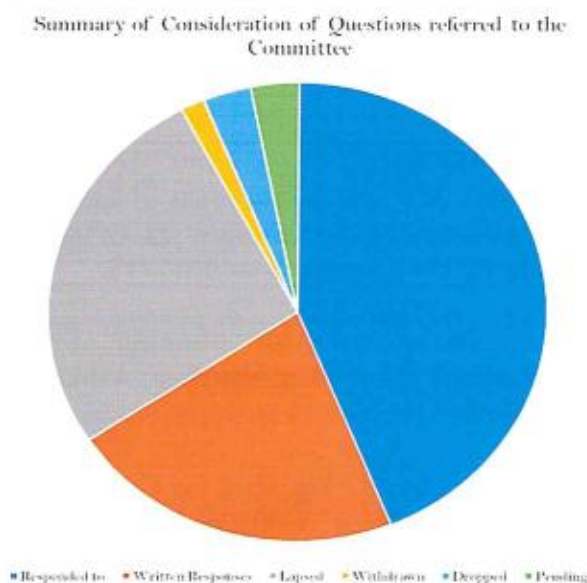
2.4 INQUIRIES

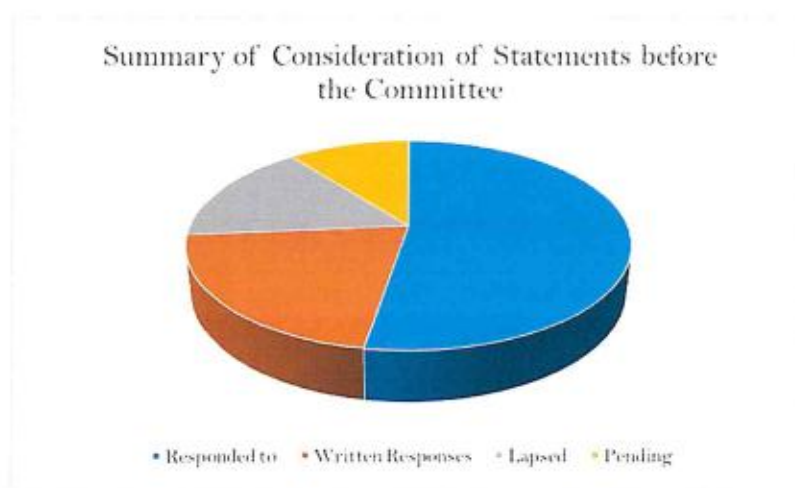

2.8 BUDGETARY REVIEW

30. The Committee in playing its budget making role reviewed budget documents i.e. budget policy statements for 2018, 2019, 2020, 2021 and 2022, budget estimates for FYs 2018/19, 2019/20, 2020/21, 2021/22 and 2022/23 and supplementary estimates that were submitted to the House for consideration during the period.

2.9 AGREEMENTS

31. During the period, the Committee considered an Agreement between the Republic of Kenya and the Republic of Mauritius on the avoidance of double taxation (Legal Notice No. 114 of 2020). The Agreement provided a legal framework for the elimination of double taxation of the residents of Kenya and Mauritius with respect to taxes on their income without creating opportunities for non-taxation or reduced taxation through tax evasion or avoidance.

PART THREE

3 ACHIEVEMENTS OF THE COMMITTEE

Some of the impacts that the Committee's work had to the country include:

35. Through the Committee's recommendations during the budget making process, funding was increased to the Kenya Revenue Authority to ensure that KRA leverages on advances in technology to identify new sources of taxation income, including bringing potential tax cheats under the tax net. Over the years, the revenue collector had not been getting requisite funding to improve on their revenue targets. It is for this reason therefore that the Committee supported increased funding to KRA to acquire scanners and other equipment meant to automate their services and increase ease of doing business. KRA has been reporting collection of surplus revenue for the last two financial years.
36. In a bid to diversify sources of Government revenue, the Committee has been pushing for divestiture of state owned enterprises. This made it possible for the National Treasury to recruit and appoint members of the Board of the Privatization Commission of Kenya a step that will make it possible for privatization of some parastatals hence reduce Government expenditure on parastatals that are funded by the Government and increase revenue through income tax and corporate tax.
37. At the onset of the COVID-19 pandemic in March 2020, the Committee through review of legislation and the budget recommended tax measures that were aimed at cushioning Kenyans from the adverse effects of the COVID-19 pandemic containment measures. This included reduction of VAT for basic commodities, reduction of PAYE, reduction of corporate tax among others.
38. The Committee considered an amendment to section 39A of the Public Finance Management Act, 2012 to provide for new timelines in the enactment of the annual finance bill. The reviewed timelines requiring that the finance bill is submitted and passed by Parliament for assent by 30th June every year were adopted by the House and signed into law. This has made it possible for the Budget Estimates to be passed together with the finance bill. Synchronizing timelines for approval of the finance bill, annual budget estimates and the appropriation bill to 30th June of every year has reduced the lodging of various litigations on tax measures and the use of the provisional collection of revenue and taxes order which has since been repealed.
39. The Committee ensured that the National Population and Housing Census that was carried out in 2020 was successful by recommending for adequate funding to Kenya National Bureau of Statistics (KNBS) for the exercise. The Committee also held regular meetings with KNBS to be apprised on the preparation for the census.
40. The Committee considered and tabled in the Public Private Partnerships Act, 2021 that provides for the participation of the private sector in the financing, construction, development, operation or maintenance of infrastructure or development projects through public private partnerships. This has fundamentally changed the manner to which government consider PPPs against the backdrop of dwindling public sector financing to government programs.
41. The committee through the review of the Public Finance Management Act, 2012 provided for the enhancement of the responsibilities of Parliamentary Budget Office (PBO) in section 10 to include

monitoring and evaluation of government expenditure as well as provide technical support to county assemblies in furtherance of their budgetary responsibility as provided for in the constitution of Kenya.

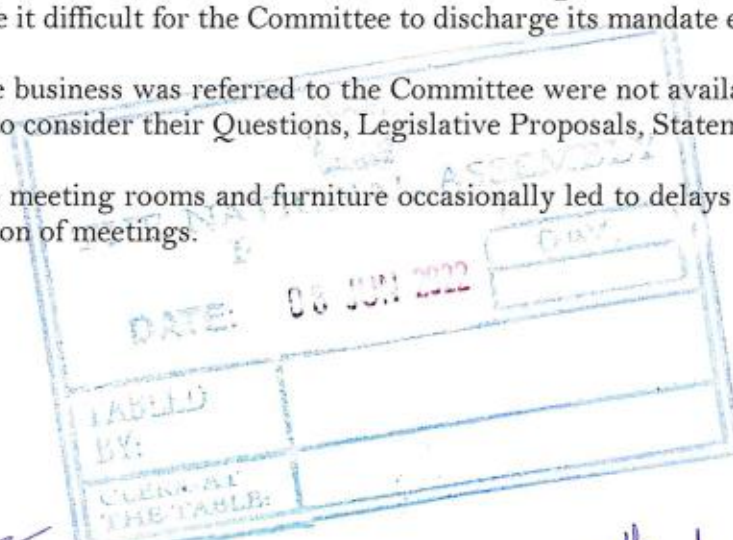
42. The Committee through the Finance Bill, 2022 reduced the Value Added Tax rate of liquefied petroleum gas from 16% to 8%. The Committee also rejected the proposal by National Treasury to remove the supply of maize (corn) flour, cassava flour, wheat or meslin flour and maize flour containing cassava flour from the list of zero-rated items as it would increase prices of the commodities. The above was aimed at reducing the cost of living which has been going up.

PART FOUR

4.0 REASONS THE COMMITTEE DID NOT CONCLUDE ITS WORK

The Committee experienced the following challenges which made it difficult for it to optimally discharge its mandate:

1. The COVID-19 pandemic affected the frequency of meetings and it made it difficult to meet stakeholders to prosecute matters before the Committee. This affected the Committee's efficiency in the execution of its mandate.
2. The Court Ruling on the Petition by the Senate regarding consideration of Bills between the two Houses of Parliament halted consideration of Bills in the National Assembly for a while. This increased the backlog of Bills in the Committee.
3. Unavailability of Government officials when invited for meetings to consider business before the Committee. This made it difficult for the Committee to discharge its mandate effectively.
4. Some Members whose business was referred to the Committee were not available when invited for Committee meetings to consider their Questions, Legislative Proposals, Statements or Petitions.
5. Inadequate committee meeting rooms and furniture occasionally led to delays in starting meetings and at times cancellation of meetings.
