CHAIRPERSON'S FOREWORD

I am pleased to present this report in conformity with the Standing Orders 200A, which requires the Committee to provide a report which shall be available to the succeeding Committee for preparation of its work plan. The report covers the period from 2017 to 2022 years which is the period under review.

The National Government Constituencies Development Fund (NG-CDF) has continued to enhance infrastructural and socio-economic development at the Constituency level in order to reduce poverty and inequalities across the Country.

Over the past 15 years, the fund has grown in leaps and bounds. Amendments to the NG-CDF Act have enhanced oversight over the Fund. During the period under review, the Committee facilitated amendments to the NGC-DF Act to align it with the Constitution of Kenya. To achieve this, the National Government has dedicated towards the Fund, a minimum of two and half per cent (2.5%) of its equitable share of annual revenue to fund projects identified by the community at Constituency level, within the framework of the Constitution. Through these interventions and many others, the Committee has ensured posterity of the Fund thereby enabling socio economic development in all 290 constituencies.

I am glad to note that the Fund has had tremendous impact towards improving the livelihoods of the citizens across the Country. These efforts therefore need to be scaled-up so as to benefit as many people as possible. Through numerous engagements with the NG-CDF Board, the Committee has ensured good leadership is in place and policy direction towards effective and efficient management of the Fund. The Committee is therefore committed to provide the necessary support to enable the NG-CDF Board realize its key strategic objectives as enshrined in the NG-CDF Board's strategic Plan 2016/2017-2020/2021 financial years.

Through efficient management of the Fund, various sectors have performed well particularly education through provision of bursaries and infrastructure development. It is therefore worth noting that the Fund has gone a long way to supplement government's effort towards access to education through infrastructure development resulting to increase in transition rate from

primary to secondary schools. Further, through bursary provision, there has been increased retention rate at secondary and tertiary levels of education.

In line with the NG-CDF Act, this House approves the budget ceilings for each constituency as submitted by the Board through the Committee. It is important to note that the Committee has continually ensured the compliance with Section 4(3) of the NG-CDF Act which requires that, *“the monies appropriated to the Fund in any financial year under subsection (1) (a) shall not be less than the amount appropriated to the Fund in the preceding financial year unless as otherwise allowed by this Act”*.

The Committee during its tenure has made tremendous achievements such as ensuring that the National Treasury has fully disbursed funds to the kitty for all the Financial Years as well as the Ksh.2.0 billion arrears for Previous Financial Years has been released by the National Treasury leaving a balance of Ksh.2.9 billion ; In collaboration with the Council of Governors’ an amicable solution was reached on the funding of incomplete projects that are devolved, the Council of Governors’ should seek for a conditional grant of Ksh.1.2 billion to complete the said projects; The Ajira digital platform driven by the Ministry of Information Communication and Technology to empower the youth access job opportunities, this was through a collaboration with the said Ministry and the fund constructed Digital Innovation Hubs in constituencies. The project was aimed at introducing young people to online digital work and provide the tools, training and mentorship needed for young people to work online and earn an income with dignity. This has contributed in achieving the country’s objective of a globally competitive knowledge-based middle – income economy in an increasingly digital world.

On matters legislation the Committee has considered 4 Bills that is; The NG-CDF (Amendment) Bill No.34 of 2021 by Hon. Tindi Mwale, MP, which proposed an increment of percentage from 2.5% to 5% of the National Shareable Revenue was concluded, the Bill underwent public participation and the Committee consulted with several Ministries and other stakeholders. The Committee also held public hearings in 25 counties to seek for the views on the Bill.; The NG-CDF (Amendment) Bill No.4 of 2021 on the proposed amendments by the Committee was concluded and awaiting approval by the house; The NG-CDF(Amendment) Bill No.59 by the

Hon. Eseli David propose to divide the fund unequally amongst constituencies but under consideration of various parameters and the NG-CDF (amendment) Bill to reduce the Board's allocation but the committee did not agree on this amendment since it's up to distorting the Board's operations.

The Committee conducted inspection visits to 46 constituencies and has made recommendation on various issues and most has been achieved such as; amending Section 53 of the NG-CDF Act of 2015 to provide for allocation of Constituency Oversight Fund, that does not exceed 1.0% of the total allocation of the Constituency in that Financial Year; Engaged the National Treasury, to resolve the issue of delay in the exchequer releases to the Fund and an amicable solution was reached that funds Ksh.2billion should be released weekly towards the fund .

I note that, despite having made strides in addressing poverty and regional development imbalances, the NG-CDF Fund has been faced with several challenges. Key among them is the Constitutional legal suits which threaten to negatively affect its operations. It is argued that the current NG-CDF Act is unconstitutional as it offends the principles of public finance, division of revenue and the division of functions of the national and county governments. The NGCDF Board with the help of the Committee continues to address these challenges through the laid down legal procedures and framework.

Through the oversight role, the Committee has continued to ensure the Fund plays a significant role in development across the country by focusing on projects that fall under the functions of the National Government as outlined in the Fourth Schedule of the Constitution of Kenya.

While considering the report, the Committee was guided by the existing procedures and modalities of operations of the National Assembly derived from the Constitution of the Republic of Kenya, Acts of Parliament, the National Assembly Standing Orders, conventions, practices and rulings of the Speaker.

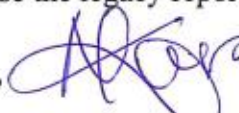

PREFACE

1.1 Establishment of Committee

1. The power of each House of Parliament to establish committees and to make Standing Orders for the orderly conduct of its proceedings, including the proceedings of its committees is provided under Art. 124 of the Constitution of Kenya, 2010.
2. The National Assembly Standing Orders has established various committees of the House with distinct Mandates. These Committees under the Directorate of Audit, Appropriations and Other Select Committees play a pivotal role of facilitating the National Assembly fulfill its constitutional mandate of allocation of national revenue, appropriation of funds and oversight over national revenue, expenditure and State organs.
3. The Committee on National Government Constituencies Development Fund is established pursuant to in accordance with the provisions of section 50 of the NG-CDF Act of 2015.

1.2 Mandate of the Committee

4. The Committee is mandated to:
 - (i) *To oversee the implementation of this Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary, propose any amendments to this Act with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;*
 - (ii) To oversee the policy framework and legislative matters that may arise in relation to the Fund;
 - (iii) To continually review the frame set out for the efficient delivery of development programmes financed through the Fund;
 - (iv) To consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act; and
 - (v) To carry out any other functions relevant to the work of the Fund
5. In discharge of its mandate, the Committee considers matters related to :
 - (i) Proposed amendments to NG-CDF Act, 2015

(ii) Approval of persons specified under the Act.

(iii) Oversee policy frameworks and legislative matters

(iv) To continuously review framework set out for the efficient delivery of programmes financed by the Fund.

BACKGROUND INFORMATION

1.1 Legal framework

9. Art. 93 (1) of the Constitution of Kenya establishes Parliament of Kenya which consists of the National Assembly and the Senate. Further, Art. 95 provides for the role of the National Assembly amongst others to:
 - (i) deliberate on and resolve issues of concern to the people;
 - (ii) enact legislations
 - (iii) determine allocation of national revenue between the two levels of governments the National government and County governments;
 - (iv) appropriate funds for expenditure by the national government and national State organs;
 - (v) exercise oversight over national revenue and its expenditure;
 - (vi) exercise oversight over State organs; and
 - (vii) Review the conduct in the office of the President, Deputy President and other State officers and initiate the process of removal from office.
10. In addition, Art 124 of the Constitution empowers Parliament to establish Committees and to make Standing Orders for orderly conduct of its proceedings including the proceedings of its Committee.
11. The National Assembly Standing Orders has established various Committees of the House with distinct mandates.
12. Section 50 of the NG-CDF Act mandates the Committee to oversee the implementation of Act and in that respect to, after every two years, submit a report to the National Assembly and where necessary, propose any amendments to the Act with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act.
13. Section 51(1) of the Act requires the NG-CDF Board on a quarterly basis to submit a report to the National Assembly Select Committee detailing the following-

- a) A summary of the project proposals received from the constituencies in the preceding quarter and indicating the approval status of such projects;
- b) A summary of the status of disbursements of funds to the constituencies for that preceding quarter;
- c) A summary of the status of disbursements from the Treasury to the National Account; and
- d) Any restriction imposed on a constituency account in accordance with the Act.

15. The Committee completed consideration of the following Bills.

- a. The NG-CDF (Amendment) Bill No.34 of 2021 by the Hon. Tindi Mwale, MP that proposed an increment of percentage from 2.5% to 5% of the National Shareable Revenue, the bill underwent public participation and the Committee consulted with several Ministries and other stakeholders. The Committee also held public hearings in 25 counties to seek for views on the Bill and it was finally the proposal was dropped by the house.
- b. The NG-CDF (Amendment) Bill No.4 of 2021 on the proposed amendments by the Committee that proposes opening of third accounts and other administrative measures for the smooth operation of the Fund which was concluded and awaiting adoption by the house;
- c. The NG-CDF (Amendment) Bill No.59 by the Hon. Eseli David propose to divide the fund unequally amongst constituencies put under consideration of various parameters like population, poverty level for equitable sharing national resources which is awaiting house approval.

- e) The National Government Constituencies Development Fund (Amendment) Bill, Legislative Proposal, 2020 by Hon. Peter Masara, MP and
- f) The National Government Constituencies Development Fund (Amendment) Bill, Legislative Proposal, 2018 by Hon Makali Mulu. MP

3.2 OVERSIGHT

- 17. Oversight of State organs is amongst the roles assigned to the National Assembly under Art. 95 of the Constitution. In fulfillment of this role, the Committee considered the following business.

3.3.3 Public Vetting

- 18. Pursuant to Art 152 and 154, Public Appointments (parliamentary approval) Act, Standing Order 216 (f) and (NGCDF Act & NCIC Act) the Committee considered the following public vetting

a) Appointment and Approval of NG-CDF Board Members and the Chief Executive Officer

- 19. Section 15 of the Act requires the Cabinet Secretary to appoint the Board with the approval of the National Assembly, which shall be composed of: -
 - i. The principal secretary in the Ministry for the time being responsible for matters relating to national economic policy and planning or a designated alternate, not being below the level of Director of Planning;
 - ii. the principal secretary in the Ministry for the time being responsible for matters relating to finance or a designated alternate not being below the level of Deputy

Director of Budget;

- iii. the Attorney-General or a designated alternate not being below the level of Senior State Counsel;
 - iv. the principal secretary in the Ministry responsible for matters relating to education or a designated alternate not being below the level of Director;
 - v. seven other persons, three of whom shall be of the opposite gender and at least one shall be a person with disability, qualified in matters relating to finance, accounting, engineering, economics, community development, public affairs, project management, education, security or law appointed by the Cabinet Secretary with the approval of the National Assembly ; and
 - vi. The Chief Executive Officer who shall be an *ex officio* member without a right to vote.
20. In nominating or approving the appointment of a person as a member of the Board pursuant to paragraph (v) above, the Cabinet Secretary and the National Assembly are required by law to take into account gender equity and the regional diversities of the people of Kenya. Further, the Cabinet Secretary is required to appoint the chairperson of the Board from amongst the seven persons appointed in accordance with paragraph (v) above.
21. Based on the above, the Cabinet Secretary for the National Treasury and Planning nominated the following persons for appointment as Board of Directors of the National Government Constituencies Development Fund and forwarded their names to the National Assembly for approval.
22. The Committee undertook the exercise on Thursday 7th March, 2019, in compliance with the Constitution, the Public Appointments (Parliamentary Approval) Act, 2011 and the National Assembly Standing Orders and recommended all the nominees for appointment as Directors of the National Government Constituencies Development Fund Board. The National Assembly approved the nomination of the following persons as members of the NG-CDF Board.:

(i) Mr. Robert Nyariki Momanyi Masese

- (ii) Ms. Irene C. Masit
- (iii) Mr. Abdiaziz Bulle Yarrow
- (iv) Ms. Isabel Nyambura Waiyaki
- (v) Ms. Maria Lekoloto
- (vi) Mr. George Kasatua Ole Meshuko
- (vii) Hon. Peter Edick Omondi Anyanga

The following persons were appointed to represent the various Government agencies in i-iv above, namely:

- d) Mr. Paul Kibet

The Chief Executive Officer is an ex-officio member.

b) Recruitment of the Chief Executive Officer of the Board

23. The procedure for recruitment of the Chief Executive Officer of the NGC-DF Board is provided for under the Section 20 (1) of the NG-CDF Act. It states-
There shall be a chief executive officer of the Board who shall be recruited by the Board through a competitive process and recommendations made to the Cabinet Secretary for appointment, with the approval of the National Assembly.
24. The Board during this period recruited Mr. Yusuf Mbuno through a competitive process. The appointment of Mr. Yusuf Mbuno was made by the Cabinet Secretary, National Treasury after the approval by the National Assembly on 29th April 2020.

3.2.2 Oversight Milestones (Policy, Structural and Administrative)

IMPLEMENTATION OF THE NG-CDF ACT, 2015

25. To oversee the implementation of the Act, the Committee undertook various activities. These activities are discussed below-

(1) Engagement between the Committee and the NG-CDF Board

26. The Committee has had continuous engagements with the Board for the sole purpose of ensuring the successful implementation of the Act. These activities include the following-

a) Receipt of quarterly reports from the NGCDF Board

27. Based on the above quarterly reports which were tabled by the Committee with recommendations, the National Assembly adopted the following for implementation by the NGCDF Board. The status of the implementation of the recommendations from the National Assembly are detailed in the table below-

	Recommendation by the National Assembly	Status of implementation/achievement
1	The NG-CDF Board should fast-track and submit to the National Assembly a comprehensive list of all incomplete projects countrywide, clearly indicating their status of implementation, categorizing whether active or stalled. b) Status on allocation of funds in each Financial Year

i) Financial Year 2021/2022

28. The National Government Constituencies Development Fund (NG-CDF) was allocated a total of **Kshs.41.7148 Billion** in the 2021/2022 financial year. Section 39. (2) Of the NG-CDF Act 2015 as amended in 2016 requires that disbursements should be effected quarterly at the beginning of each quarter.
29. Pursuant to the above section, this being the fourth quarter, the Board has received the total allocated funds of **Kshs.41.7148**. Section 40 of the Act further provides that the Board shall ensure that the list of projects forwarded to it by each constituency is, upon approval, funded in accordance with the Act.
30. Based on the foregoing, two hundred one (201) constituencies have received full allocation amounting to **Kshs.27,554,864,679** while eighty nine (89) Constituencies have received between 69% and 99.6% of the funds allocated amounting to **Kshs.11,132,966,048** leaving a balance of

Kshs.1,067,944,183. The eighty nine (89) Constituencies have not received their balances due to non-clearance of outstanding projects issues raised by the Board on some of their proposed projects for 2021/22 Financial Year. The Constituencies are therefore required to clear all the outstanding projects issues to enable them access their funds. *See Annex I for the 89 constituencies with outstanding balances.*

1. Receipt and disbursement of the Kshs.4.9 billion allocated through the Supplementary estimate 1

31. The Fund was allocated **Kshs.4.9 billion** under financial year 2021/22 supplementary estimate 1 out of which **Kshs.2 billion** was received on 19th May 2022 leaving a balance of **Kshs.2.9 billion**.
32. The funds received were used to pay outstanding constituencies' arrears for 2020/21 to 2010/2011 Financial Years. *See Annex II for details*
33. The Constituencies listed in *Annex III* have cleared all their outstanding projects issues hence eligible for funding once the arrears of **Kshs.2.9 billion** have been received.
34. However, the Constituencies listed in *Annex IV* have outstanding projects issues. The Constituencies are therefore required to the issues to enable them access their outstanding balances once the arrears of **Kshs.2.9 billion** have been received.
35. In Financial Year 2021/2022, the Board was allocated **Ksh 41,714,800,000**. This comprised of **Ksh 39,755,775,000** being allocation for disbursement to the constituencies and **Ksh 1,959,025,000** being allocation to the Board Secretariat for administrative purposes. Subsequent to the approval of the Constituencies budget ceilings for 2021/2022 Financial Year by the National Assembly Select Committee on NG-CDF, the NG-CDFCs submitted their project proposals to the Board for approval.
36. The NG-CDF Board received project proposals from all the two hundred and ninety (290) Constituencies. Project proposals that were consistent with the Act were approved for funding. The Board has received the total allocated funds of **Kshs 41,714,800,000**.

ii) Financial Year 2020/2021

37. In Financial Year 2020/2021, the Board was allocated **Ksh 41,714,800,000**. This comprised of **Ksh 39,755,775,000** being allocation for disbursement to the constituencies and **Ksh**

1,959,025,000 being allocation to the Board Secretariat for administrative purposes. Subsequent to the approval of the Constituencies budget ceilings for 2020/2021 Financial Year by the National Assembly Select Committee on NG-CDF, the NG-CDFCs submitted their project proposals to the Board for approval.

38. The NG-CDF Board received project proposals from all the two hundred and ninety (290) Constituencies. Project proposals that were consistent with the Act were approved for funding
39. As at 30th June 2021, the Board had received the total allocated funds of Kshs 41,714,800,000. The funds were disbursed to the constituencies and the secretariat as follows:
 - i. Twenty eight (28) constituencies received full allocation amounting to Kshs 3,838,488,620
 - ii. Two hundred sixty two (262) constituencies received between 76% and 99% of the allocation amounting to Kshs 32,655,057,906 leaving a balance of Kshs 3,262,228,472
 - iii. Kshs 1,959,025,000 was disbursed to the Board Secretariat.
 - iv. Kshs 3,262,228,472 was disbursed to Constituencies with respect to balances for previous financial years
 - v. The outstanding balance of Kshs 3,262,228,472 will be cleared once the Board received Kshs 4,900,000,000 approved in the 2021/2022 supplementary budget.

iii) Financial Year 2019/2020

40. In Financial Year 2019/2020, the Board was allocated **Ksh 41,714,800,000**. This comprised of **Ksh 39,836,640,000** being allocation for disbursement to the constituencies and **Ksh 1,878,160,000** being allocation to the Board Secretariat for administrative purposes. Subsequent to the approval of the Constituencies budget ceilings for 2019/2020 Financial Year by the National Assembly Select Committee on NG-CDF, the NG-CDFCs submitted their project proposals to the Board for approval.
41. The NG-CDF Board received project proposals from all the two hundred and ninety (290) Constituencies. Project proposals that were consistent with the Act were approved for funding

42. As at 30th June 2019, the Board had received a total of **Kshs 26,000,000,000** leaving a balance of Kshs 15,714,800,000. The funds were disbursed to the constituencies and the secretariat as follows:

- vi. Thirteen(13) constituencies received full allocation amounting to Kshs 1,785,780,413
- vii. Two hundred sixty one(261) constituencies received between 45% and 99% of the allocation amounting to Kshs 18,626,081,592 leaving a balance of Kshs 17,226,894,408
- viii. Sixteen constituencies have received between 32% and 44% of the allocation amounting to Kshs 849,000,000 leaving a balance of Kshs 1,348,883,586
- ix. Kshs 1,337,000,000 was disbursed to the Board Secretariat.

43. The outstanding receipt of Kshs 15,714,800,000 at the end of the financial year was however received in the subsequent financial year 2020/2021 and disbursed to the constituencies. The current status of disbursements with respect to the funds allocated in financial year 2019/2020 is as follows:

- i. Two hundred twenty five (225) constituencies have received full allocation amounting to Kshs 30,907,737,931
- ii. Sixty five(65) constituencies have received between 50% and 99% of the allocation amounting to Kshs 8,338,224,917 leaving a balance of Kshs 590,677,151
- iii. Kshs 1,337,000,000 disbursed to the Board Secretariat for administrative purposes.

iv) Financial Year 2018/2019

44. In Financial Year 2018/2019, the Board was allocated **Ksh 33,286,162,000**. This comprised of **Ksh 31,621,853,900** being allocation for disbursement to the constituencies and **Ksh 1,664,308,100** being allocation to the Board Secretariat for administrative purposes. Subsequent to the approval of the Constituencies budget ceilings for 2018/2019 Financial Year by the National Assembly Select Committee on NG-CDF, the NG-CDFCs submitted their project proposals to the Board for approval.

45. The NG-CDF Board received project proposals from all the two hundred and ninety (290) Constituencies. Project proposals that were consistent with the Act were approved for funding

46. As at 30th June 2019, the Board had received a total of **Kshs 28,000,000,000** out of the allocation of **Kshs 33,286,162,000** leaving a balance of **Kshs 5,286,162,000**. The funds were disbursed to the constituencies and the secretariat as follows:
- i. Forty eight (48) constituencies had received full allocation amounting to **Kshs 5,233,962,024**
 - ii. Forty one (41) constituencies had received more than 50% of the allocation amounting to Kshs 4,105,574,290 leaving a balance of **Kshs 365,101,606**.
 - iii. One hundred eighty eight(188) constituencies received 50% of the allocation amounting to Kshs 10,154,215,000 leaving a balance of Kshs 10,345,469,619
 - iv. Thirteen (13) constituencies received less than 50% of the allocation amounting to Kshs 511,000,000 leaving a balance of Kshs 906,531,382
 - v. Kshs 1,547,930,000 was disbursed to the Board secretariat for administrative purposes.
47. The pending receipt of Kshs 5,286,162,000 at the close of the financial year was however received in the subsequent financial year 2019/2020 and disbursed to the constituencies. The current status of disbursement to the constituencies and the Board with respect to funds allocated in financial year 2018/2019 is as follows:
- i. Two hundred twenty nine (229) constituencies have received full allocation amounting to **Kshs 24,970,360,495**
 - ii. Sixty one (61) constituencies between 82% and 99.9% of the funds allocated amounting to Kshs 6,394,320,396 leaving a balance of Kshs 257,173,009
 - iii. Kshs 1,547,930,000 was disbursed to the Board secretariat for administrative purposes.

v) Financial Year 2017/2018

41. During the period under review, the Board submitted a total of eight (8) quarterly reports to the Committee. The reports contained the following information-

- a. A total of Ksh. 30,958,596,000 was initially allocated to the Fund in the Annual Development Estimates of 2017/2018 financial year. In line with Sections 6(1) of the NGCDF Act, 2015 (as amended in 2016), the Board with the approval of the Committee determined the budget ceilings for each constituency in accordance with Section 34 but subject to the provisions of Sections 8(1) and 23(1) which translated to Ksh. 101,416,090.34 equal allocation per constituency.
- b. However, in the first Supplementary Development estimates of 2017/2018 financial year, the total allocation to the Fund was reduced to Ksh. 26.5 billion, necessitating the NGCDF Board to revise the budget ceiling for each constituency downwards to Ksh. 86,810,344.83.
- c. In the second Supplementary Development estimates approved by the National Assembly on 3rd May 2018, allocation to the Fund was increased by Ksh. 3.3 billion from Ksh. 26.5 billion to Ksh. 29.8 billion. As a result, the Board with the approval of the Committee revised the budget ceilings for each constituency to Ksh. 98,189,655.17 in line with Section 6(1) of the Act. In light of the foregoing, each National Government Constituency Development Fund Committee (NG-CDFC) was required to prepare and submit project proposals for the additional Kshs.11, 379,310.34 to the Board for approval as per Section 31 of the Act.
- d. As at 30th June, 2018, the NG-CDF Board had approved projects proposals from all the 290 Constituencies under the initial budget of Kshs.26.5 billion.
- e. However, under the Supplementary Development Estimates of Kshs.3.3 Billion, the NG-CDF Board received and approved two hundred and forty eight (248) additional Project Proposals. By June 2018, Forty two (42) Constituencies had not submitted their additional Project Proposals.
- f. As at 30th June, 2018, the NG-CDF Board had received Kshs.21.875 billion from the National Treasury and Ministry for Planning. While disbursing funds to Constituencies, the Board applied the following criteria;
- g. First priority to constituency requisitions with respect to past financial years; and

- h. Second priority to constituencies whose proposals had been approved and therefore qualified for funds for Financial Year 2017-2018.
- i. Therefore disbursement for 2017/18 Financial Year was as follows;
- j. Five (5) Constituencies had received all their funds totaling to Kshs.490,948,275.75;
- k. Eighty seven (87) Constituencies received a total of Kshs.7,376,558,740.30 equivalent to 90% of the total allocation leaving a balance of Kshs.1,165,941,259.42;
- l. One hundred and ninety four (194) Constituencies received a total of Kshs.8,417,895,374.80 equivalent to 40% of the total allocation leaving a balance of Kshs.10,630,897,728.18;
 - i. Three (3) Constituencies received all funds for bursary and administration vote heads totaling to Kshs.91,991,378 leaving a balance of Kshs.202,577,587.31;
 - ii. Changamwe Constituency was the only Constituency that had received part funding for bursary and administration vote heads totalling to Kshs.5,500,000 leaving a balance of Kshs.92,689,655.17;
 - iii. Kshs.1,325,000,000 was set aside for Board Secretariat in adherence to section 23 (1) of the NG-CDF Act, 2015 as amended in 2016;
 - iv. Therefore, as at 30th June, 2018, a total of Kshs.7, 925,641,458.05 remained undisbursed for 2017/18 financial year.

a) Pending receipts from The National Treasury for previous financial years

42. The Fund had pending receipts amounting **Kshs.2.973,196,750 Billion** relating to financial Years 2011/2012, 2013/14 and 2014/15 of which Ksh.2billion has been released by the National Treasury. The Board is in the process of Ksh.2 billion to the Constituencies.

43. Financial year 2021/2022 disbursements are as follows:

- i. One hundred eighty one (181) constituencies have received full allocation amounting to **Kshs 24,813,087,099**
- ii. One hundred nine (109) constituencies have received between 69% and 99.6% of the funds allocated amounting to **Kshs.13,633,116,126.10** leaving a balance of **Kshs 1,309,571,684**
- iii. **Kshs 1,959,025,000** has been disbursed to the Board Secretariat for administrative purposes.

The Board is in the process of disbursing **Kshs 1,309,571,684** available in the Funds bank account at Central Bank of Kenya.

44. During the period under review, no restrictions were imposed on any Constituency account.

c) Constituency Project Monitoring

45. The Select Committee together with the NG-CDF Board continuously monitored the status of the implementation of the NG-CDF projects at the constituencies as part of their oversight function. The objectives of the exercise was to-

1. Assess the progress of implementation of projects and accrued benefits to communities.
2. Determine best practices, successes and challenges realized while implementing projects.
3. Provide guidance for overall management of projects with a view of achieving project objectives, considering the project scope, quality, time and cost elements.
4. Provide for an exchange of ideas, information, challenges, solutions and strategies with project team members, with the aim of developing a good working relationship with all the players.
5. Scrutinize the overall delivery of the projects against resources, time and scope.
6. Make a report to the National Assembly on the findings.

46. During the period under review, some of the constituencies monitored were Limuru, Kiharu, Maragua, Nyali, Kisauni, Changanwe, Kabuchai, Kanduyi and Mt. Elgon, Bahati, Laikipia West and North, Changanwe, Lamu East and Lamu West, Nyali, Kisauni, Taveta Aldai, Narok West,

Nyaribari Chache, Rarieda, Bondo, Embakasi Central, Starehe, Kipipiri ,Gilgil, Naivasha, Olkalou, and Butula constituencies.

47. The following recommendations emerged from the fact finding project monitoring visits undertaken by the Committee and the NG-CDF Board-

- 1) When implementing projects institutions should use innovative ways of cutting cost such as use of locally available resources and labour e.g. baking own bricks within the school for construction of school infrastructure.
- 2) In approving projects, the NGCDF Board should fund the entire project in order to ensure immediate usability of projects. For example, in funding construction of a school, furnishings such as desks or chairs should be taken into account of in total funds disbursed for the project;
- 3) Projects should only be approved where funds available are adequate to cover the whole scope of the projects to avoid stalling of a project due to inadequacy of funds;
- 4) The Board should consider standardized project designs and bill of quantities to ensure that cost variation between projects to be implemented within the same region is minimized. Approval should only be granted only where proposals as detailed in the bill of quantities drawn by the public works officer;
- 5) The construction of more than one floor buildings should take into account the requirement of the law with regard to ease of access by persons with disability;
- 6) The Board should consider the need of continuous capacity building of the NG-CDFCs on a quarterly basis, in order to increase knowledge in matters management, identification of projects and implementation of the Fund.

d) Administrative Meetings with Stakeholders

48. In order to apprise the Committee of the progress of implementation of its mandate the Committee held meetings with its stakeholders during the period under review. Various issues related to the effective and efficient delivery of services by the Board were discussed. This forum

also provided an opportunity for other matters to be raised that affected the smooth operation of the Fund such as delays in release of allocations by the National Treasury, review of laws and other administrative issues.

49. Some of the meetings that took place during this period included the following-

- i. Retreat to discuss emerging issues on the Implementation of NG-CDF Act;
- ii. Retreat to discuss the proposed amendments to the NGCDF Act;
- iii. Retreat to discuss the implementation of Constituencies Digital Innovation Hubs; and
- iv. Periodic meetings to respond to queries or provide information to Committee.
- v. Retreat to deliberate on the Incomplete Projects Report with the council of Governors', State Department for Planning and the NG-CDF Board.
- vi. Retreat with the Fund Managers on implementation of the Fund
- vii. Retreat with the KMTC Board on establishment of new campuses in constituencies

4.0 COMMITTEE'S UNCOMPLETED, PENDING AND LAPSED BUSINESS

The National Government Constituencies Development Fund (Amendment) Bill, (National Assembly Bill, No. 5 of 2022) by Hon. John Mwirigi, M.P. The Bill was referred to the Committee after it was read the first time on Wednesday, March 02, 2022.

The principle objective of the is to amend section 3 of the National Government Constituencies Development Fund, Act, 2015 to provide for the adjustment of the minimum amount of money to be allocated to the National Government Constituencies Development Fund from two and half per centum to three and half per centum of the national Government's share of revenue as divided by the annual Division of Revenue Act enacted pursuant to Article 218 of the constitution.

The Bill does not delegate legislative powers nor does it limit fundamental rights and freedoms.

The Bill does not affect the functions of the County Government and is therefore a Bill concerning counties for purposes of Article 110 of the Constitution and standing orders.

The Bill is a money Bill for Purposes of Article 114 of the Constitution as the enactment of this Bill will occasion additional expenditure.

The Committee delayed in reporting by tabling its report due to the fact that, the Bill needed wider consultation with the relevant stakeholders.

5.0 CHALLENGES AND OPPORTUNITIES

51. Despite the achievements the fund made during this period, it faced the following challenges-

(1) Legal challenges

52. The National Government Constituency Development Fund is facing Constitutional legal suits now at the Supreme Court after two organisations challenged a decision made by the Court of Appeal in November 2017. The Institute for Social Accountability (TISA) and Centre for Enhancing Democracy and Good Governance went to the Supreme Court to challenge the constitutionality of NG-CDF Act, 2015. They argue that the current NG-CDF Act is unconstitutional as it offends the principles of public finance, division of revenue and the division of functions of the national and county governments.

Major constitutional cases facing the Board are as follows:

i. **High Court petition No. 178 of 2016: The Institute for Social Accountability (TISA) and another vs. National Government Constituencies Development Fund Board & others**

53. This petition is challenging the constitutionality of NG-CDF Act no. 30 of 2015. The hearings commenced on 5th October, 2017. It was further presented that the parties would be back to Court on 11th November, 2017 for further hearing. The matter commenced with hearing experts' witnesses, from either side, with view to assisting the court to arrive at a fair conclusion. Unfortunately, before experts' witnesses could finalize their presentations, the presiding judge passed on, in early March, 2018. The matter could not proceed. The matter is awaiting directions, with a possibility of reconstituting the Bench.

54. Other parties sued in this matter include the Attorney General and the National Assembly.

ii. **High Court petition No. 386 of 2017 The Institute for Social Accountability (TISA) and another Vs. National Government Constituencies Development Fund Board and Others**

In this case, the petitioners moved to court challenging the Division of Revenue Act, 2017 and sought to debar disbursements of funds for 2017/2018 financial year. The petitioners' argument has been that the Board had been allocated funds before vertical division of revenue between the two levels of governments (Counties and National governments). The matter is yet to be settled for hearing. In the recent court appearances, (latest being June 04, 2018) the petitioners have not appeared in court.

iii. **Petition Number 01 of 2018**

This is an appeal to the Supreme Court, challenging a decision by the Court of Appeal, which largely overturned the High Court decision that on February 20, 2015, declared the Constituencies Development Fund Act of 2013 unconstitutional. In this case, The Institute for Social Accountability (TISA) and another sued the Board, The National Assembly, The Attorney General and the Senate (didn't participate in the matter) alleging that the entire Act of 2013 was unconstitutional. The High Court agreed with the petitioners and declared the entire Act unconstitutional on the following counts:

- a) Violation of Principles of Public Finance;
- b) Violation of the Principles of division of functions as between the two levels of governments;
- c) Violations of Principles of separation of powers;
- d) Flowed process subsequent amendments of the Act.

55. The Board and the National Assembly, being dissatisfied, challenged the High Court decision at Court of Appeal. The Court of Appeal overturned the High Court decision, safe on separation of powers. The petitioners at High Court, The Institute for Social Accountability (TISA) and another, being dissatisfied with the Court Appeal decision, appealed to Supreme Court. The matter is yet to commence. Parties are still in the process of filing pleadings.

56. Pace in replenishment of the Board's main account

51. The pace of replenishment of Board's account has remained a challenge to project implementation. Section 39 of the NGCDF Act requires that disbursement of funds to the Constituency Fund Account should be effected at the beginning of the first quarter of each financial year. Constituencies are required to receive an equal amount equivalent to twenty – five per of the annual allocation and thereafter three equal installments at the beginning of the second, third and fourth quarters of the financial year.

6.0 COMMITTEE ACHIEVEMENTS

1. In collaboration with the Council of Governors' an amicable solution was reached on the funding of incomplete projects that are under devolved functions, the Council of Governors' should seek for a conditional grant of Ksh. 1.2 billion to complete the said projects;
2. The National Treasury has released Ksh.2.billion towards the arrears of Ksh.4.9 billion for financial years 2011/12, 2012/2013, 2013/2014 and 2014/2015.The remaining amount is Ksh.2.9billion;
3. The Ajira digital platform driven by the Ministry of Information Communication and Technology to empower the youth access job opportunities, this was through a collaboration with the said Ministry and the fund constructed and installed devices in the Digital Innovation Hubs at the constituencies. The project was aimed at introducing young people to online digital work and provide the tools, training and mentorship needed for young people to work online and earn an income with dignity. This has contributed in achieving the Country's objective of a globally competitive knowledge-based middle – income economy in an increasingly digital world;
4. On the construction of new KMTC campus the Kenya Medical Training College has offered policy guidelines for any new campus construction to avoid mushrooming of campuses with no teaching staff and health care facility to train students, in view of the above the NG-CDF Board and KMTC will in future joint consider and approve any funding of any new campus.
5. Engagement with the National Treasury on consistent delay of the release of funds by the National Treasury which had hampered timely disbursement of Funds and implementation of the projects by the NG-CDF Board. The Committee was able to agree with the National Treasury that Ksh.2 billion should be released to the kitty every two weeks in a month. That enabled the Board to receive full allocation for all financial years since 2017 to 2022.
6. On matters legislation the Committee has considered 4 bills that is;
 - i. The NG-CDF (Amendment) Bill No.34 of 2021 by Hon. Tindi Mwale, MP that proposed an increment of percentage from 2.5% to 5% of the National Shareable Revenue, the Bill underwent public participation and the Committee consulted with several Ministries and other stakeholders. The Committee also held public hearings in 25 counties to seek for views on the Bill;
 - ii. The NG-CDF (Amendment) Bill No.4 of 2021 on the proposed amendments by the Committee was concluded and awaiting approval by the house;

- iii. The NG-CDF (Amendment) Bill No.59 by the Hon. Eseli Simiyu which proposed to review the sharing formula to ensure equity/ equitable distribution of three quarters of the funds equally amongst constituencies, while one quarter is shared equitably based on the number of wards in each constituency;
- iv. The Committee ensured that the NG-CDF Board receive authorization on recruitment of critical personnel to fill positions in the Board by asking the public service commission to lift the freeze on recruitment through the cabinet secretary National and Planning and the process of recruitment is currently on-going.

7. The period between the years 2017-2022, the NG-CDF Funds managed to achieve the following:

- (a) Twenty four thousand and twenty (**24,020**) classrooms were constructed which Created extra capacity for one million eighty thousand and nine hundred (**1,080,900**) more students
- (b) Three thousand two hundred and eighty eight (**3,288**) Administration Blocks were newly constructed;
- (c) One hundred and thirty one (**131**) Libraries were newly constructed.
- (d) One thousand three hundred and ninety seven (**1,397**) Laboratories were newly constructed and equipped:
- (e) Nineteen thousand four hundred (**19,400**) toilets were newly constructed:
- (f) Nine hundred sixty one (**961**) School Buses were purchased through Full funding of NG-CDF Funds:
- (g) Eighty hundred thirty three (**833**) dining halls were newly constructed
- (h) Eight hundred seventy six (**876**) staff houses were newly constructed
- (i) One hundred and ninety (**190**) KMTC lecture halls and sixty seven (**67**) administration blocks were constructed.
- (j) Ten (10) administration blocks and (**74**) lecture halls were constructed to completion in tertiary training institutions
- (k) One thousand one hundred and fifty six (**1,156**) dormitories were constructed.
- (l) One hundred ninety six (193) National Government administration offices were constructed
- (m) Two thousand one hundred and two (2102) Chief's/assistant chief's offices and camps were constructed
- (n) One thousand and ninety one (1091) Police posts (camps constructed)
- (o) One thousand and fifty (1050) of rooms of Police houses were constructed.
- (p) Two thousand five hundred (2500) Toilets in security facilities were constructed
- (q) Under Restoration of trees cover six thousand seven hundred seventy three (6773) institutions benefited.
- (r) Under Sanitation and waste disposal one thousand six hundred sixty six (1666) toilets were built.

- (s) Under water conservation four thousand thirty seven (4037) were bought
- (t) Under soil conservation two hundred sixteen (216) sites benefited.
- (u) Under Energy conservation one hundred twenty (120) power lights were erected.
- (v) Other projects (fencing, landscaping) one hundred forty six (146) institutions benefited.
- (w) Nine hundred thirty three (933) Sports tournaments were conducted, one thousand four hundred fifty eight (1458) sports uniform and equipment purchased and construction of twenty nine (29) play grounds, field grading and fencing.

7.0 COMMITTEE OBSERVATIONS

The Committee observed that-

- (1) The National Government has dedicated towards the NG-CDF Fund, a minimum of two and half per cent (2.5%) of its equitable share of annual revenue to fund projects identified by the community at constituency level, within the framework of the Constitution. The National Assembly Select Committee has ensured posterity of the Fund thereby enabling socio-economic development in all 290 constituencies;
- (2) The National Treasury has released Ksh.2.billion towards the arrears of Ksh.4.9 billion for financial years 2011/12, 2012/2013, 2013/2014 and 2014/2015.The remaining amount is Ksh.2.9billion.
- (3) The NG-CDF Board approved only projects that are aligned to the national government functions during the period under review. The key sectors funded by the NG-CDF include education sector (Primary schools, Secondary schools, Tertiary institutions and bursary to needy students in tertiary, secondary and special schools), security, sports and environment. The Fund has enhanced physical infrastructure at the grassroots level through construction and renovation of new and existing schools (both secondary), Medical Training Colleges and Technical Training Institutes. Physical infrastructure included libraries, classrooms, laboratories, dormitories, kitchen, latrines, water tanks, buying of desks and equipping of laboratories. This has resulted in remarkable progress in the Country's education standards.
- (4) The Fund has had tremendous impact towards improving the livelihoods of the citizens across the country. Various sectors have performed well particularly education through provision of bursaries and infrastructure development. It is therefore worth noting that the Fund has gone a long way to supplement government's effort towards access to education through infrastructure development resulting to increase in transition rate from primary to secondary schools. Further, through bursary provision, there has been increased retention rate at secondary and tertiary levels of education;
- (5) The fund has contributed to the attainment of the government's Big four agenda.* Constituencies have been allowed to fund social security programme in 2018/19 financial

year which has scaled up the National Hospital Insurance Fund (NHIF) cover for the old, vulnerable persons and children, thereby, contributing to the government's agenda on universal health coverage. The Committee notes that the new section 15(1B) of the National Health Insurance Fund Act, No. 9 of 1998, provides that, the national government shall be liable as a contributor to the National Health Insurance Fund on behalf of indigent and vulnerable persons as identified by the relevant government body. Further, section 48 of the National Government Constituencies Development Fund Act, No. 30 of 2015 provides that social security programmes shall be considered as development projects for purposes of the Act.

Furthermore, apart from Nairobi Region, all the other regions allocated at least **Kshs.10,000,000** in support of Technical Training Institutes (TTIs) in 2018/19 financial year. This is expected to produce the requisite skills to enable set up cottage industries. Furthermore, some regions allocated part of their total allocations in 2017/18 financial year to the ICT Hubs in support of the manufacturing sector;

- (6) The National Government Constituency Development Fund is facing Constitutional legal suits now at the Supreme Court after two organisations challenged a decision made by the Court of Appeal in November 2017. The Institute for Social Accountability (TISA) and Centre for Enhancing Democracy and Good Governance have gone to Supreme Court to challenge the constitutionality of NG-CDF Act, 2015. They argue that the current NG-CDF Act is unconstitutional as it offends the principles of public finance, division of revenue and the division of functions of the national and county governments;
- (7) The formula for sharing the revenue horizontally amongst the constituencies does not factor in the unique circumstances of each constituency. The sharing is on equal basis despite the differing situations of the constituencies;
- (8) The reporting of project activities at the constituency level by the Fund Account Managers is hampered by lack of skills and competencies necessary to provide accurate and well documented activities reports to the oversight institutions. This is further affected by the frequent requests for transfer of managers. This affects discharge of duty such as preparation of financial statements and response to audit queries;

- (9) In order to improve the visibility of NG-CDF projects at the grass root, the Board undertook various Public and media relation activities among them exhibitions, road shows, media education tours, surveys documentaries, Agricultural Society of Kenya Shows and various infomercials. The Board has also showcased special documentaries with testimonials on how projects have been implemented and how they have impacted lives at the grassroots level; and,
- (10) The eleven Board members of the NG-CDF is fully constituted. The Chief executive Officer of the Fund who is also the Ssecretary to the Board who has served in acting capacity for many years has now been recruited to assume the position on substantive basis.

8.0 RECOMMENDATIONS

The Committee recommends to the National Assembly that-

- (1) The minimum of two and half per cent (2.5%) of its equitable share of annual revenue to fund that is allocated to the fund be increased to a minimum of 5% of the equitable share of the annual revenue. The National Assembly should fast-track the process of passing the NG-CDF (Amendment) Bill No.34 by the Hon. Tindi Mwale, MP that entails increment of the Fund to 5%.**
- (2) The NG-CDF Board should enhance capacity building of Fund Account Managers for preparation of comprehensive project implementation reports, financial statements and other operational reporting that conform to the requirements of the National Assembly and other oversight bodies. Subsequently, specific resources should be set aside by the Board to ensure that this objective is achieved in every Financial Year.**
- (3) The National Treasury should ensure the timely release of funds into the Fund. The National Assembly should consider more stringent measures to ensure that the trend by the National Treasury to inordinately delay release of funds to the Board is minimized.**
- (4) Adequate resources should be allocated and personnel provided to ensure that projects implemented in hardship, marginalized areas with security issues are still over-sighted. Alternatively, independent structures at the grassroots should be put in place to monitor the progress of development projects and put in place strong measures accountability measures.**
- (5) The NG-CDF Committees should enhance Community participation through sensitization of Community in project identification, monitoring and other aspects of the Fund. Further, the Community should be encouraged to provide contributions wherever possible, either in the form of skilled or unskilled labor and materials needed for construction of the projects.**
- (6) The Board should work in consultation with the Ministry of Health and the Departmental Committee on Health in regards to the guidelines on the locations for the setting up of medical training colleges to avoid mushrooming of campuses due to**

the limited teaching staff and health care facilities to train students by using KMTTC guidelines on new campus.

- (7) The NG-CDF Board should ensure that, the implementation of the Constituency Innovation Hubs is optional, and that mechanisms be put in place to allow reallocation of funds set aside for the CIH to other priority projects within the financial year. The Ministry of Information, Communications and Technology should take initiatives of wider consultation with all stakeholders especially National Government Constituencies Development Fund Committees' role in implementing the programme.
- (8) The NG-CDF Board in liaison with key stakeholders should enforce the requirement for strategic planning by the constituencies. Funds should be allocated based on planned programmes.
- (9) The Board should come up with Regulations to align with the amended Act as passed by the House, and to ensure the full operationalization of the Act.

Based on the foregoing, the NG-CDF Board submitted its reports for the first, second, third and fourth quarter of 2017/18 Financial Year.

2017/18 Financial Year

A. Summary of project proposals for 2017/18 financial year received from the constituencies Allocation

Section 4 of the NG-CDF Act, 2015 as amended in 2016 states that *“there is established a fund to be known as the National Government Constituencies Development Fund which shall be a national government fund consisting of monies of an amount of not less than 2.5% of all the National Government’s share of revenue as divided by the annual division of the Revenue Act enacted pursuant to article 218 of the Constitution”*.

The Fund was allocated Kshs.29.8 billion by the National Treasury in the 2017/18 financial year comprising of the initial allocation of Ksh.26.5 Billion and Kshs.3.3 billion under the supplementary budget. This contained Kshs.28.475 Billion being allocation for disbursement to the Constituencies and Kshs.1.325 billion being allocation to the Board Secretariat for administrative purposes in adherence to sections 23 and 34 of the NG-CDF Act, 2015 as amended in 2016. Each Constituency thus received an allocation of Kshs.98, 189,655.17 i.e Kshs. Kshs.86, 810,344.82 in the initial allocation and Kshs.11, 379,310.34 under the supplementary development estimates.

As at 30th June, 2018, the NG-CDF Board management had received projects proposals from all the 290 Constituencies under the initial budget of Kshs.26.5 Billion. However, under the supplementary development estimates of Kshs.3.3 Billion, the Management had received two hundred and forty eight (248) additional Project Proposals out of which seventeen (17) had been deliberated on by the Board in a meeting held on 30th May, 2018 while two hundred and thirty one (231) were awaiting deliberation by the Board in its next meeting. Annex III

Progress report on the implementation of the Constituency Innovation Hubs (CIH) projects

Background

The Constituencies Innovation Hubs (CIH) is a Government of Kenya project implemented through the Ministry of Information and Communication Technology (ICT) aimed at enhancing connectivity in constituencies by providing free internet access to public using the facility to enable access to online jobs and allow the *wananchi* to obtain agribusiness and microfinance information. The Hubs will be equipped with digital devices to enable the youth access tools to innovate and market creative ideas online to enable them earn income.

The Government aims at facilitating the establishment of the innovation hubs in all the 290 constituencies in the country in a bid to transform the country into an information society and prepare citizens for a digital economy.

The programme includes Ajira Digital jobs training to be undertaken by the Government in collaboration with the private sector and development partners for mentorship and to enable the youth to obtain skills and tools for on-line work.

The Ministry of ICT in partnership with the Ministry of Public Service, Youth and Gender Affairs, Ministry of Education, Science and Technology, Ministry of Foreign Affairs and partners of the civil society and private sector have set up the Ajira Digital project to bridge the gap between skills demand and lack of jobs. The project aims to introduce young people to online digital work and provide the tools, training and mentorship needed for young people to work online and earn an income with dignity. This will contribute to achieving the country's objective of a globally competitive knowledge knowledge-based middle – income economy in an increasingly digital world. The Ajira Digital Project further seeks to position Kenya as a choice of labour destination for Multinational Companies as well as encourage

local companies and the Public Sector to create digital work. As a result, this will catapult Kenya onto the global map recognized as a Freelance hub by 2022.

Objectives of the Constituency Innovation Hubs

- i) To establish overall employment status among the youth in the different areas (Labour force composition – including online work status);
- ii) To provide training and mentorship to prepare the youth for online work;
- iii) Provide a platform through which youth can innovate and develop online services to serve communities;
- iv) Provide access to online services offered by the Government such as
 - a. Driving license
 - b. Passport application and renewal
 - c. Registration of Businesses
 - d. I-Tax
 - e. Many others that may be provided online
- v) Establish a platform through which Government will start offering work online e.g. digitization of Government records
- vi) Establish challenges encountered by the beneficiaries and recommendations on how the programme can enhance the skills base for the beneficiaries in the future programmes.

Project scope

The project is implemented in partnership with the Ministry of ICT, the National Government Constituency Development Fund Committee (NG-CDFC) and Telkom Kenya, whereby:

- a) Telkom Kenya supplies, installs, test and commission internet access equipment in each of the participating constituencies countrywide in every identified site. Telkom configures and operationalize internet access bandwidth in the constituencies. Further, the company is responsible for:-
 - i) Ensuring that the equipment supplied, installed, tested and commissioned is fully integrated/compatible with the services.

- ii) Submitting the necessary invoices on the utilization of the internet for settlement by the Ministry of ICT.
- b) The Ministry of ICT is responsible for:-
 - i) Payments of all the recurring monthly charges incurred in the utilization of internet bandwidth in all the participating constituencies.
 - ii) Offer any other information, communication and Technology assistance or policy guidelines/support to ensure efficient delivery of the services.
- c) NG-CDFC is responsible for:-
 - i) Undertaking necessary consultations with the respective constituencies in the supply, installation, testing and commissioning of the equipment and the overall project implementation.
 - ii) Provision of the necessary funds for the supply, installation, testing and commissioning of the equipment;
 - iii) Maintain liaison as may be necessary with other constituencies in the implementation of the project;
 - iv) Facilitating the execution of the resulting framework contracts between the respective committee and Telkom in the supply, installation, testing and commissioning of the project;
 - v) Providing fulltime staff to man the place, have secure places to store the devices and have framework for and policies of operationalization of the hub.

Price and terms of payment

The total price for the four (4) sites is a total of Ksh. 4,677,027.20 (Four million six hundred seventy seven thousand and twenty seven shillings, cents)

Implementation

A pilot study was undertaken by the ICT Ministry in Limuru Constituency through installation of the hub to ascertain its viability. The project proved viable though some challenges were cited. This formed a basis for other Constituencies to allocate funds to the project.

In 2017/18 and 2018/19 financial years, a total of 269 Constituencies allocated funds towards installation of Constituency innovation hubs in 1033 sites each site costing Kshs.1,169,256.80 hence a total of Kshs.1,207,534,497.48 (*See details in annex I*). However, due to various challenges exhibited during implementation, some of the Constituencies reallocated some/whole of its funds to other viable projects. A total of Kshs.708,569,604.79 was reallocated from 606 sites leaving a balance of Kshs.498,964,882.04 in 427 sites remaining for implementation.

It is important to note that in 2019/20 financial year, three Constituencies i.e. Mbooni, Mumias West and Kasarani allocated a total of Kshs.4,677,027.20 towards installation of the hubs (*see details in annex II*). Mumias West and Kasarani had reallocated funds from the project in 2017/18 financial year. This is an indicator that Constituencies are steadily realizing the importance of the CIH projects.

As at now, a total of **58 Constituencies** have **131 operational hubs** while the rest are at different levels of implementation. (*See details in annex III*).

However, during the National Assembly sitting of 12th April, 2018, the Member of National Assembly for Mathare Constituency raised the following concerns regarding the establishment of the CIH project;

- i) 'While the existence of the Ministerial directive to establish CIH projects in constituencies is a noble idea, is it within the provisions of the NGCDF Act, regulations or Constitution?'
- ii) 'Due to the limited resources available to constituencies in 2017/2019 financial year, the Ministry of ICT should consider establishing the hubs and maintaining the infrastructure and budgeting in the 2018/2019 financial year budget estimates while the constituencies provide the physical infrastructure (buildings) to host the project'.

In response, the NASC Chairman outlined the following:

- i) 'Most constituencies had proposed four sites for the hubs, with some proposing between one and three sites while a few had exceeded the minimum of four. He also cited the responsibilities of the various stakeholders';
- ii) 'The CIH is consistent with Section 49 of the NGCDF Act that provides for part – funding of projects;
- iii) 'Parties involved should engage further and consult more regularly with users and other stakeholders'.

In view of (iii) above, the Ministry, NASC and NGCDF Board held a retreat on 26th and 27th May, 2018 to deliberate on the matter. During the retreat, the Ministry made a presentation on the project where the following issues of concern were raised:

- i. Project location
- ii. Ownership of the project and role of the Ministry
- iii. Staffing of the CIHs including who is responsible for remuneration
- iv. Sustenance of the project in terms of operation and maintenance
- v. Awareness creation plans
- vi. Challenges in internet coverage, especially in remote areas
- vii. Electricity connectivity – some areas do not have electricity
- viii. Clarity on the procurement of the equipment
- ix. Existence of a formal agreement between the Ministry of ICT and participating constituencies
- x. Sustainability of the tablets in view of the challenges noted on the ground.

In view of the concerns, the Board was required to review the CIH programme and prepare a report to NASC giving key recommendations on the way forward as follows:-

i) Location

Taking into consideration that the constituencies have been assigned the responsibility of identifying suitable sites for the project, the following options may be considered:

- a. The District Information and Documentation Centres (DIDCs) established through the support of the Ministry could offer additional sites for CIH projects.
- b. NGCDF Committees may consider citing one of the hubs in the NGCDFC office.

- c. Constituencies could consider allocating funds for construction CIH premises where no public facilities are available in suitable market centres.

ii) Ownership and operationalization of the project and role of Ministry of ICT

This being the MoICT's project, the structure of the project should be reviewed so that the Ministry takes a more prominent role other than provision of bandwidth. It is imperative to note that, one of the core mandates of the Ministry of ICT is to provide ICT infrastructure.

The MoICT should train and assist willing constituencies with rollout starting with existing infrastructure such as, the NGCDFC offices, Chiefs' premises among others since commitments have already been done by MoICT & Telkom.

iii) Staffing

The MoICT will provide technical support while the constituencies shall offer administrative support. So far, four hundred (400) Presidential Digital Talent Programme (PDTP's) have been recruited already and they can provide operational support at the hubs.

iv) Sustenance of the project

Since the MoICT will pay the recurring cost for bandwidth, the payment of utility bills, salaries and other support services like sanitation should continue to be handled as they are since the facilities are already in existence. The challenge would only be where a new site is constructed and consultations are ongoing.

v) Awareness creation

The MoICT should take an initiative to create awareness to various stakeholders including members of National Assembly and the community on the project.

The MoICT will collaborate with the Board to undertake awareness creation during the NGCDFC trainings by end of 2018. To this effect, sensitization of the constituency committees was done between June and December, 2018. Further, the MoICT was expected to launch the CIH project in constituencies that have initiated the programme.

vi) Internet coverage

The project will use the satellite internet connectivity which is considered to have 100% coverage. Any challenges faced by individual constituencies will be addressed on a case by case basis.

vii) Electricity connectivity

The MoICT to collaborate with other Agencies for alternative sources of power in areas where there is no electricity such as solar energy. Constituencies are advised that while identifying suitable sites, priority should be given to those that have electricity connections.

viii) Procurement

Competitive bidding was done and Telkom was responsive hence awarded the tender.

ix) Formalization of agreement between the Ministry of ICT and willing constituencies

A formal agreement exists between MoICT and participating constituencies. However, the Ministry was required to review the order and agreement forms to ensure clarity of the contracting parties.

x) Suitability of the tablets

It was argued that since the tablets are only applicable with the sites, they are less prone to theft. The MoICT also committed to monitor their suitability with a view to improvement.

The report was presented to NASC for deliberation and subsequently tabled and adopted by the National Assembly with the following recommendations that were communicated to the NGCDF Board vide letter Ref. No. NA/DLP/RES.14/2018/49 dated 5th December, 2018:-

- i) Implementation of the Constituency Digital Innovation Hubs (CIH) Program should be optional, and the NG-CDF Board should come up with proper mechanism on re-allocations of funds set aside for CIH and other priority projects within Financial Year 2018/19;
- ii) The Ministry of Information, Communications and Technology should take initiatives of wider consultation with all the stakeholders especially National Government Constituency Development Fund Committees' role in implementing the program within FY 2018/19.

The Board in a meeting held on 6th December, 2018 adopted the resolution of the National Assembly.

Strengths

- i. Constituencies like Kamukunji, Limuru and Rongo have already operationalized the project which has become a benchmark for other Constituencies which are slowly realizing the importance of the hubs and hence there is high probability of more installations in the future.
- ii. ICT Ministry has employed ICT officers in the identified Constituencies. This is an indicator of more commitment by the Ministry which led to sustainability of the project.
