CHAIRPERSON'S FORWARD

Standing Order 200A (1) and (2) of the National Assembly Standing Orders provides that "(1) A Committee which is unable to complete its work before the expiry of its term shall table an exit report to the Assembly detailing reasons for such inability; and (2) The report shall be available to the succeeding committee which may consider it in preparing its work plan".

The Committee's Exit Report is an important tool of gauging performance of the Committee in the Twelfth Parliament. It gives details of the business executed by the Committee from November 2017 to June 2022 and offers a starting point for the succeeding Committee as it highlights the business pending before the Committee at the end of the Sixth Session.

The following business was referred to the Departmental Committee on Trade, Industry and Co-operatives in the Twelfth Parliament: thirteen (13) Bills; three (3) Legislative Proposals; four (4) Petitions; seventeen (17) Questions; two (2) inquiries; six (6) Statements; one (1) vetting; and one (1) Agreement; and two (2) Session Papers. The Committee was able to execute most of the work referred to it despite the difficult times that Members had to work under particularly the COVID-19 Pandemic which made it difficult to hold in-person meetings among other challenges that the Committee faced.

Through its work, the Committee was able to positively impact the country in several ways including

- i. Completion of critical projects in the country. The projects that were completed include: Kenya Institute of Business Training Kisumu, and New KCC which were completed and equipped;
- ii. Allocated Kshs. 3 billion for the Coffee Cherry Advance Revolving Fund to be disbursed to coffee farmers by New Kenya Planters Cooperative Union (NEW KPCU) towards reviving the coffee industry;
- iii. Increased allocation to Kenya Industrial Estate (KIE) on the forefront to provide loans to cottage industries to support the Manufacturing pillar of the Big Four Agenda and the Vision 2030;
- iv. Funding for posting of Trade Attaché to various countries to promote trade relations between Kenya and the various countries and also to promote exports;
- v. Revival of the textile industry by reviving RIVATEX and this has promoted His Excellency President Uhuru Kenyatta's 'Buy Kenya, Build Kenya' initiative; and
- vi. Facilitation of Kenya participation in Dubai Expo 2020 which improved Kenya's visibility in international markets and cemented trade relations with other countries such as Oman.

It is therefore my pleasant duty and privilege, on behalf of the Departmental Committee on Trade, Industry and Co-operatives and pursuant to provisions of Standing Order 200A (1) to present to this House the Exit Report of the Departmental Committee on Trade, Industry and Co-operatives.

1 PREFACE

1.1 ESTABLISHMENT OF THE COMMITTEE

 - iv. To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;*
 - v. To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;*
 - vi. To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No. 204 (Committee on appointments);*
 - vii. To examine treaties, agreements and conventions;*
 - viii. To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;*
 - ix. To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and*
 - x. To examine any questions raised by Members on a matter within its mandate.*

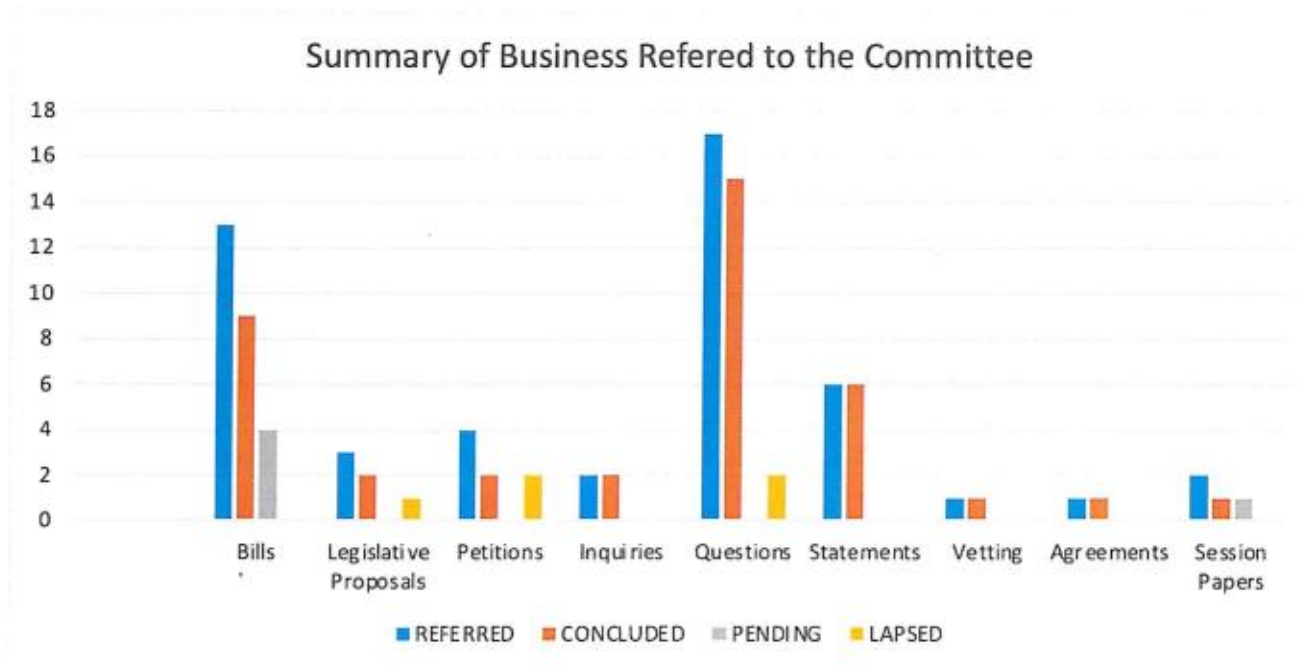

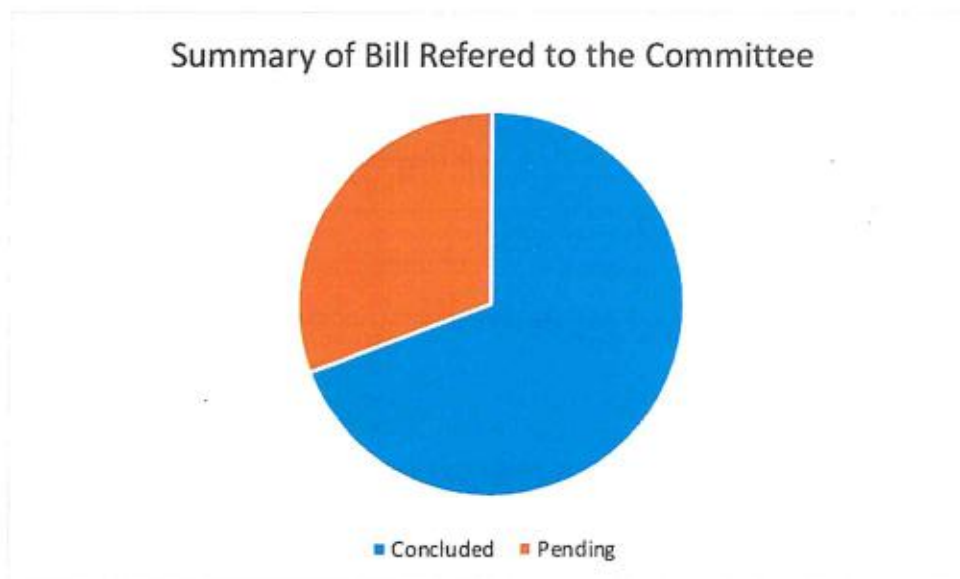

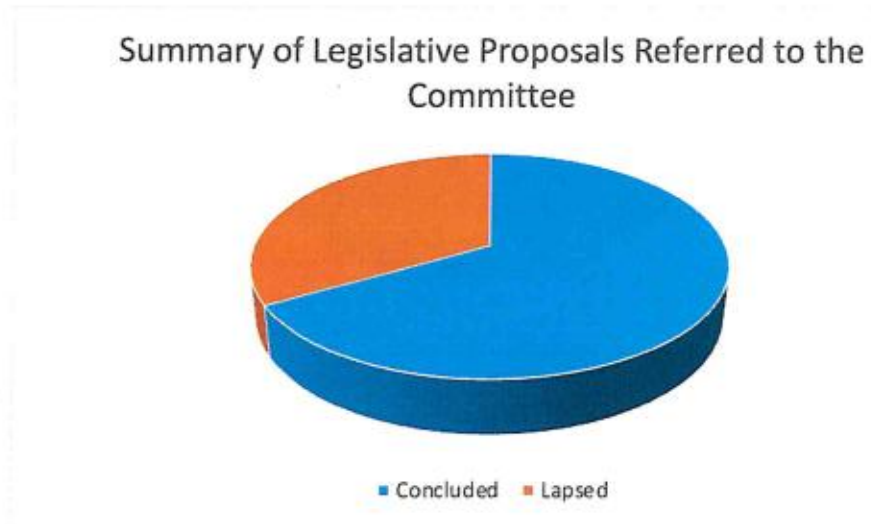

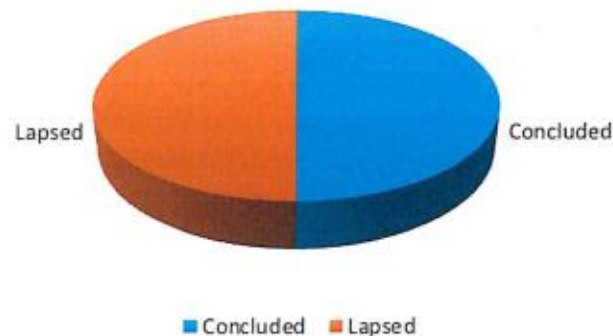

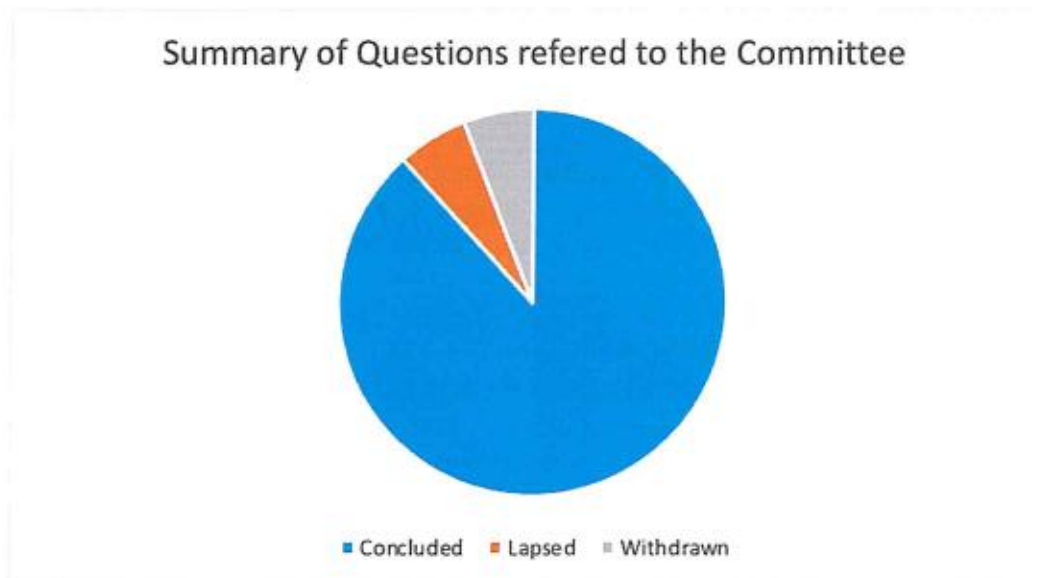
2.4 INQUIRIES

2.7 VETTING

25. The Committee conducted vetting of Amb. Johnson Weru nominee for the positions of Principal Secretary State Department for Trade and Enterprise Development. The Committee approved the appointment of the nominee.

2.8 BUDGETARY REVIEW

26. The Committee in playing its budget making role reviewed budget documents i.e. budget policy statements for 2018, 2019, 2020, 2021 and 2022, budget estimates for FYs 2018/19, 2019/20, 2020/21, 2021/22 and 2022/23 and supplementary estimates that were submitted to the House for consideration during the period.

2.9 AGREEMENTS

27. During the period, the Committee considered the Economic Partnership Agreement (EPA) between Kenya, a member of the EAC, of the other part, and the United Kingdom of Great Britain and Northern Ireland, on the other part. The Agreement provided a legal framework that facilitates **Duty-Free-Quota-Free** access of exports from EAC countries to the UK market.

PART THREE

3 ACHIEVEMENTS FROM THE BUSINESS TRANSACTED BY THE COMMITTEE

Some of the impacts that the Committee's work had to the country include:




30. The Committee allocated funds towards the coffee industry with an aim of reviving Kenyan coffee in the market. The Committee sought to allocate Kshs. 3 billion for the Coffee Cherry Advance Revolving Fund to be disbursed to coffee farmers by New Kenya Planters Cooperative Union (NEW KPCU). Additionally, the Committee allocated funds to digitize and modernize coffee factories and Farmers' Cooperative Societies. The State Department for Cooperatives provided information that they were able to digitize factories across the Country and 325 factories from various counties benefitted.
31. To revive cotton ginneries to produce cotton as a raw material for textile production, the Committee allocated funds for the modernization of ginneries across the country. The modernized ginneries included Luanda Ginnery. The Committee also facilitated the construction of Nyando Apparels and Value Addition Center as a branch of RIVATEX for stitching and tailoring of garments.
32. The Committee also facilitated the revival of the textile industry by reviving RIVATEX and this has promoted His Excellency President Uhuru Kenyatta's 'Buy Kenya, Build Kenya' initiative. The initiative aims at reducing the overreliance on secondhand clothes popularly known as "mitumba". RIVATEX produces clothes, bed sheets, military uniforms, hospital linen, suiting and shirting material.
33. The State Department for Trade and Enterprise Development was implementing only one programme known as Trade Development and Promotion. The Committee proposed four new programmes to be implemented in the State Department and this was implemented in the 2022 Budget Policy Statement. The programmes include: Domestic Trade and Enterprise Development, Fair Trade Practices and Compliance of Standards, International Trade Development and Promotion and General Administration, Planning and Support Services. The introduction of these programmes aimed to improve administration within the State Department and to effectively administer resources to the various priority areas.
34. The Committee also proposed the posting of Trade Attachees/ missions in various countries to promote trade relations between Kenya and the various countries and to promote exports. The trade attachees were posted in the following cities: Kinshasa, Addis Ababa, London, Islamabad, Lusaka, Washington, Kampala, Berlin, Pretoria, Beijing, Juba, Arusha, Cairo, Dubai, Abuja, Windhoek, Accra, New Delhi and Geneva.
35. The Committee was able to allocate funds for completion of critical projects in the country. The projects that were completed include: Kenya Institute of Business Training Kisumu, and New KCC which were completed and equipped.
36. Kenya participated in the Dubai Expo 2020 which was facilitated by the Committee. This expo improved Kenya's visibility in international markets and cemented trade relations with other countries such as relations with Oman.
37. Kenya Industrial Estates which received budgetary allocation by the Committee has been on the forefront to provide loans to cottage industries to support the Manufacturing pillar of the Big Four Agenda and the Vision 2030.

PART FOUR

4 REASONS THE COMMITTEE DID NOT CONCLUDE SOME BUSINESS

The Committee experienced the following challenges which made it difficult for it to optimally discharge its mandate:

1. Inadequate committee meeting rooms and furniture occasionally led to delays in starting meetings and at times cancellation of meetings.
2. The COVID-19 pandemic affected the frequency of meetings and it made it difficult to meet stakeholders to prosecute matters before the Committee. This affected the Committee's efficiency in the execution of its mandate.
3. Unavailability of Government officials when invited for meetings to consider business before the Committee. This made it difficult for the Committee to discharge its mandate effectively.
4. Difficulty in raising quorum because of the 2022 General Elections especially in Sixth Session slowed down activities of the Committee.
