By contrast, typical sessions of Parliament last an entire calendar year.

The new House also faced challenges occasioned by the political stalemate following the General Elections in August 2017 and the Fresh Presidential Elections of October 2017. Hopefully, the aforementioned challenges will not flow into the Sesond Session of the House. In the meantime, however, it is only fair to acknowledge the noble work undertaken by Members during the First Session in view of the twin challenges faced during the time, namely a short period of transacting business and a political stalemate. The achievements include the introduction of fourteen (14) pieces of legislation, sixty five (65) Motions, various Petitions, the tabling of Subsidiary Legislation (Regulations), Sessional Papers, Treaties/ Protocols, approval of CDF Committees, debates on urgent matters of national interest, among other aspects of Parlaimentary work.

In the light of the above achievements, a lot more is hoped and planned for during the Session Session of the National Asembly in the Twelfth Parliament.

God bless the National Assembly, Parliament, the Government, and all citizens of this great nation.

REPORT OF THE FIRST SESSION OF THE NATIONAL ASSEMBLY IN THE 12TH PARLIAMENT

SEPTEMBER – DECEMBER 2017

I. FIRST SITTING OF THE NATIONAL ASSEMBLY

On 8th August 2017, Kenya held its second General Elections under the Constitution of Kenya (2010) and subsequently, and in pursuant to Article 126 (2) of the Constitution, His Excellency the President notified the nation vide Legal Notice No. 219 of 2017 that the first sitting of the National Assembly would be held at the National Assembly Chambers, Main Parliament Buildings, Nairobi, on Thursday, 31st August, 2017 at 9.00 a.m. Additionally, the President set the same date and time for the first sitting of the Senate in the Senate Chamber of the Main Parliament Buildings, Nairobi. The two Houses would comprise the 12th Parliament since Independence.

II. ADMINISTRATION OF OATH

Article 74 of the Constitution places an obligation on all holders of state offices to take or subscribe to the oath or affirmation of office. In order to comply with this provision of the Constitution, the first business of the new House during its first sitting on Thursday, August 31, 2017 was the administration of Oath or Affirmation of Office to Members that was conducted by the Clerk of the National Assembly, Mr. Michael Sialai. The first paper laid in the National Assembly was the List of all Members of Parliament as indicated in the Kenya Gazette Notice No. 8239 of 2017 released by the Independent Electoral and Boundaries Commission (IEBC), which is attached in the Annextures as *Annex I*.

Standing Order 3(2) provides for the administering of oath or affirmation of office to Members of the House in alphabetical order in the following order of precedence: Members with the longest cumulative period of service in the Assembly; Members with the longest cumulative period of service in the National Assembly and the Senate; Longest cumulative period of service in the Senate; and, all other Members. However, for general convenience, priority in administration of oath was accorded to Members having with disabilities.

In the course of the Session, a new Member was sworn in as follows:

Constituency on 7th November 2017 instead of the earlier scheduled date of 8th August 2017 following the death of the Jubilee Party candidate, Mr. Leonard Gwaro Mwamba through a road accident on 14th July 2017. Jubilee Party required time to establish a replacement candidate, and upon consulting its lawyers, IEBC opted to postpone the election. Hon. Onyonka won the election conducted on 7th November 2017, had his victory gazzeted under Gazette Notice No. 11488 of 2017, and was subsequently sworn in by the Speaker of the National Assembly on 29th November 2017.

III. ELECTION OF THE SPEAKER

Article 106(2) (a) provides that the Office of the Speaker becomes vacant when a new House of Parliament first meets after an election. Consequently, and acting under the powers conferred by Standing Order No.5; the Clerk notified the general public of a vacancy in the Office of the Speaker of the National Assembly vide Gazette Notice No. 8376 of 2017 and further invited interested persons to apply and subsequently issued nomination forms for election to the office. The nomination forms were to be collected during the four days of August 25th to 28th 2017.

At the close of the nomination period, six (6) persons had submitted their nomination papers for election as Speaker of the National Assembly, namely:

- a) Jim Boniface Augo
- b) Noah Awinja Migudo
- c) Hon. Justin B.N. Muturi
- d) Gladys Kasiva Ngao
- e) Washingtone Andango Onyango
- f) Isaac Wangengi Wainaina

Upon review by the Office of the Clerk, it was observed that Mr. Jim Boniface Augo, Gladys Kasiva Ngao and Isaac Wangengi Wainaina did not qualify as candidates for election as Speaker of the National Assembly as their nomination papers were not accompanied by names and signatures of twenty (20) Members in support of their candidature pursuant to Standing Order 5(3). On the eve of the election, Mr. Washingtone Andango Onyango wrote to the Clerk communicating his withdrawal from the election, but since the ballot papers had already been printed, the Clerk directed, during the

election day of 31st August 2017, that his name be crossed out of the ballot papers before issuance to Members.

Subsequently, election for the Office of the Speaker was conducted on the remaining two candidates, during which Hon. Justin B.N. Muturi obtained 217 votes against 4 votes obtained by Noah Awinja Migudo. A second poll was necessitated since neither candidate obtained the required two-thirds majority (i.e. minimum of 233 votes) in the first round of voting. In the subsequent voting, Hon. Justin B.N. Muturi obtained 220 votes while Noah Awinja Migudo obtained 1 vote. The Clerk of the National Assembly, who acted as the Presiding and Returning Officer, subsequently declared Hon. Justine B.N. Muturi as the newly elected Speaker of the National Assembly in the Twelfth Parliament in line with the stipulations of the Constitution and the Standing Orders.

IV. ELECTION OF THE DEPUTY SPEAKER

Acting under the powers conferred by Standing Order No.5; the Clerk notified the general public of a vacancy in the Office of the Deputy Speaker of the National Assembly vide Gazette Notice No. 8377 of 2017 and invited interested persons to apply upon obtaining nomination papers from his office. During the nomination period of 25th to 28th August 2017, three (3) persons had collected their nomination papers for election as Deputy Speaker of the National Assembly, namely:

- a) Hon. Moses Kipkemboi Cheboi
- b) Hon. Josephine Naisula Lesuuda
- c) Hon. Martha Wangari Wanjira

At the end of the nomination period, namely at 1700hrs on Monday, 28th August 2017, only Hon. Moses Kipkemboi Cheboi had submitted his nomination papers for election as Deputy Speaker of the National Assembly. The Clerk of the National Assembly therefore invoked Standing Order 11 and duly declared Hon. Moses K. Cheboi as the newly elected Deputy Speaker of the National Assembly in the Twelfth Parliament.

V. OPENING OF THE 12TH PARLIAMENT

The Twelfth Parliament was officially opened on 12th September 2017 at the National Assembly Chamber in Parliament Buildings by H.E. President Uhuru Kenyatta, CGH in a joint sitting of both

Houses presided over by Hon. Justin B.N. Muturi, EGH, MP and Sen. Kenneth Lusaka, CBS, MP. During the occasion, Convocations were made by the two Speakers, followed by the Presidential Address by H.E. the President in line with Article 132 of the Constitution. Debate on the presidential address commenced at the subsequent sitting and was undertaken in a period of four days.

VI. <u>INDUCTION WORKSHOP</u>

The first Induction workshop for the 349 Members of the new House was held at the Hotel Intercontinental from 17th to 22nd September 2017 under the theme of "Setting the Stage for the Twelfth Parliament: Preparing for a Smooth Take-Off". The approach adopted for the Induction Workshop included:-

- a) Making the Workshop fully residential for Members and senior staff;
- b) Using a combination of Plenary and Break-Out Sessions conferencing models of facilitation;
- c) Utilizing both internal and external resource persons;
- d) Having the media as a stakeholder in the induction programme;
- e) Official launch of the National Assembly Factsheets by the Speaker of the National Assembly;
- f) Organizing the participants (Members) into four Break-Out Sessions (Resource Groups), namely:
 - ✓ Understanding the Rules of Procedure of the House –facilitated by the Directorate of Legislative and Procedural Services;
 - ✓ The Committee System –facilitated by the Directorate of Committee Services;
 - ✓ Formulation of Laws –facilitated by the Directorate of Legal Services;
 - ✓ Legislative Budget Oversight –facilitated by the Parliamentary Budget Office.
- g) Coordinating the four Resource Groups in such a way that the facilitators and secretariat moved from room to room whilst Members got trained in the same halls,
- h) A Family Session (Gala Night) for Members and their Spouses; and
- i) Open and consistent communication between Members, Staff and the Secretariat on all aspects of the induction programme.

Members obtained various resources during the Induction Workshop, inclusive of a copy of the Constitution of Kenya (2010), the National Assembly Standing Orders, handouts and pamphlets from various departments and units of Parliament, as well as various Factsheets published by the Procedural Research and Journals Department of the Directorate of Legislative and Procedural Services which the Honourable Speaker officially launched at the Workshop. A List of the Factsheets handed to Members is attached herein as *Annex II*. The Induction Workshop presented an opportunity for Members to seek inquiry and obtain feedback on various aspects of Parliamentary work. The newly-formed Committees of the National Assembly also undertook their individualized, tailor-made induction workshops in January 2018.

VII. <u>LEGISLATIVE CALENDAR</u>

The Legislative Calendar of the First Session of the National Assembly was approved by the House on 27th September 2017. Minor amendments were introduced midstream primarily to hold sittings on specific Thursday mornings, and to accord Members the opportunity to participant in the October 26, 2017 Repeat Presidential Elections. Complete observance of the legislative calendar was hampered by initial temporary non-participation of of the coalitions in House business, but this was gradually settled amicably towards the last two months of the Session. The approved Legislative Calendar is attached herein as *Annex III*.

VIII. HOUSE COMMITTEES

Pursuant to the Standing orders of the National Assembly, Committees of the National Assembly are categorized as either Departmental Committees (having a maximum of 19 Members), Select Committees (such as the Financial Audit & Money-Related Committees) or Ad Hoc Committees. The House Business Committee and the Committee on Selections were constituted on various dates during the Session on account of failure by the NASA Coalition to submit its proposed names to the House, whilst the Departmental Committees were approved on 14th December 2017. The Departmental Committees held their respective first meetings between 19th and 20th December 2017 and elected their chirpersons and vice chairpersons.

Four Committee chairpersons, namely Hon. Alfred Keter (Labour & Social Welfare), Hon. Kangogo Bowen (Environment & Natural Resources), Hon. James Gakuya (Parliamentary Broadcasting & Library) and Hon. Silas Tiren (Agriculture & Livestock) were however dewhipped by the Jubilee Party for vying against preferred candidates under regional balancing considerations. The four sought and obtain court orders in December 2017 temporarily reinstating them as chairpersons. They were nonetheless ousted by their respective Committees through Motions of No Confidence in January 2018.

During the Session, One Ad Hoc Committeee, One Select Committee and one Joint Committee were established to undertake various respective mandate. On 28th September 2017, an Ad-Hoc Committee on the Supplementary Estimates was established to undertake the functions of the Budget and Appropriations Committee as contemplated in the Standing Orders in relation to the

Supplementary Estimates, in particular the Supplementary Estimates for the financial year 2017/2018 and any legislation related to those Estimates. It was composed of:

The House awaited the appointment of six additional Members from the National Super Alliance Coalition, but this did not materialize. On the same day, the Select Committee on the Election Laws, 2017 was established to examine and undertake public participation on the Election Laws (Amendment) Bill, (National Assembly Bill No.39 of 2017) and any other related Bills. Further, on 8th November 2017, a Joint Select Committee consisting of five (5) Members from each of the Houses of Parliament was established to undertake the functions contemplated under the East African Legislative Assembly Elections (Election of Members of the Assembly) Rules, 2017. The subsequent Report of the Joint Committee led to consensus on EALA nomination and election rules that culminated in the election of Kenyan Members to EALA on 14th December 2017. The Committees exercise oversight of government operations, funding and overall policies, identify issues suitable for legislative review, and recommend courses of action to the Executive and the House. The Committee tasked with following up with the Executive on implementation of House decisions is the Committee on Implementation Committee. The List and Membership of Committees of the House is outlined in *Annex IV* herein attached.

IX. MOTIONS

The House considered sixty five (65) Motions during the First Session consisting of substantive, procedural, general, special and other motions. The House adopted fifty four (54) of these Motions, had five (5) Motions undergoing debate at the end of the Session, had three (3) Motions for adjournment of the House to discuss matters of urgent national importance, and deferred debate on one (1) motion.

The Motions to adjourn debate to discuss mattersw of urgent national importance included:

- Adjournment Motion to discuss tribal fighting in Trans Mara along the border of Kilgoris and Emurua Dikirr Constituencies that cost ten people their lives and injured many on September 22, 2017. (Hon. Jahana Ng'eno, MP.)
- 2) Adjournment Motion to discuss the on-going killings of persons in Kimilili Constituency and areas bordering Mount Elgon Constituency in Bungoma County, where close to forty-two people have been brutally been murdered in a span of three months. (Hon Didmus Wekesa Barasa, MP).
- 3) Adjournment Motion to discuss recurrent road accidents in Salgaa and Sachang'wan (Hon. Ferdinard Kevin Wanyonyi, MP)
- 4) Adjournment Motion to discuss discussing urgent issues relating to the outcome of the Presidential Vote in the 2017 general elections and connected matters. (Hon. Aden Duale, EGH, MP).

The List of substantive Motions adopted by the House is attached as Annex V.

X. <u>STATEMENTS/ QUESTIONS BEFORE COMMITTEES</u>

No Questions were forwarded to Cabinet Secretaries for appearance before Departmental Committees.

XI. BILLS

In exercise of its legislative mandate, the National Assembly of the Twelfth Parliament introduced fourteen (14) Bills during the First Session and considered one (1) Senate Bill. This was a noble output considering that the Session lasted only four months as contrasted to other Sessions that last for one calendar year, in addition to the political stalemate brought about by the General Elections and the Fresh Presidential Elections.

Bills that received Presidential Assent into law were:

- 1) The Supplementary Appropriations Bill, 2017
- 2) The Senate County Allocation of Revenue (Amendment) Bill, 2017, and
- 3) The Election Laws (Amendment) Bill, 2017, which was not formally assented to but the lapsing of its due assenssion timeline automatically brought it into force as law.

Bills undergoing various stages of debate at the close of the First Session were:

- 1) The Public Trustee (Amendment) Bill, 2017
- 2) The Copyright (Amendment) Bill, 2017
- 3) The Physical Planning Bill, 2017
- 4) The Building Surveyors Bill, 2017
- 5) The Computer and Cybercrimes Bill, 2017
- 6) The Statute Law (Miscellaneous Amendments)(No.2) Bill, 2017
- 7) The Statute Law (Miscellaneous Amendments)(No.3) Bill, 2017
- 8) The Election Offenses (Amendment) Bill, 2017
- 9) The Nairobi Metropolitan Area Transport Authority Bill, 2017
- 10) The Kenya Roads Bill, 2017

The Petroleum (Exploration, Development, and Production) Bill, 2017 and the Energy Bill, 2017 were withdrawn by the Mover.

XII. PETITIONS

Article 119 of the Constitution accords every person a right to petition Parliament on any matter within its authority including petitioning the House to enact, amend or even repeal legislation. Consequently, Petitions have given citizens opportunities to articulate matters of concern to them, in addition to enabling Members exercise their representation mandate more effectively.

A total of nine (9) Petitions were bebore the House at the end of the First Session. These were as follows:

- 1) Petition on irregular Acquisition of land belonging to the Indigenous People of Vipingo Lands Community in Kilifi County.
- 2) Petition on alleged irregular allocation of Land LR.NO.11379/3 in Mowlem Ward, Embakasi West Constituency.
- 3) Petition on proposed amendment to Section 7 of the Crop Act of 2013 to include Bamboo plant as scheduled crop (cash crop).
- 4) Petition on proposed amendments to Universities (Amendment) Act, 2016.
- 5) Petition on Breach of privilege by a Member of Parliament.
- 6) Petition on Enactment of legislation to provide for prevention of fraud.
- Petition on Implementation of the 2013 2017 collective bargaining agreement for universities' academic staff
- 8) Petition for the Removal of the Auditor-General of the Republic of Kenya from office.(Petition carried over to 12th Parliament pursuant to SO 230(7))
- 9) Petition for the Removal from Office of the Chairperson of the National Land Commission. (Petition carried over to 12th Parliament pursuant to SO 230(7)).

The chief reason behind the pending Petitions was the fact that Departmental Committees were established on the last day of the Session.

XIII. <u>APPROVAL OF SUBSIDARY LEGISLATION/RATIFICATION OF TREATIES</u> /DEPLOYMENT OF MILITARY PERSONNEL

The following subsidiary legislation was tabled in the House during the First Session:

- a) The Capital Markets (Online Foreign Exchange Trading) Regulations, 2017 and the Explanatory Memorandum (pursuant to section 12 of the Capital Markets Act).

XIX. ELECTION OF MEMBERS TO THE EAST AFRICAN LEGISLATIVE ASSEMBLY

The East Africa Legislative Assembly (EALA) is established under Article 9 of the Treaty for the Establishment of the East African Community as one of the key organs and institutions of the Community responsible for the Community's legislative matters. Article 50 of the Treaty provides for the election of Members of EALA by respective Partner States' Legislatures in accordance with their parliamentary procedures for a term of five years, whilst the East African Legislative Assembly Elections Act, 2011 contemplates conclusion of the election of Members of a new Assembly to be within ninety (90) days before the expiry of the term of the subsisting Assembly. The process of electing new Members to the East African Legislative Assembly was commenced by the Eleventh Parliament in April 2017 but could not be concluded by the end of the term of that Parliament on account of disagreement on nomination rules and other issues. As a result, the term of the previous East African Legislative Assembly lapsed on June 4, 2017 without an election having ben conducted in its Kenyan Member-State.

On account of the need to urgently conclude the election process for the East African Legislative Assembly to commence transacting business of the East African Community, and in accordance with the provisions of Rule 9 of the Houses of Parliament (Joint Sittings) Rules, the National Assembly resolved on 8th November 2017 to establish a Joint Select Committee consisting of five (5) Members from each of the Houses of Parliament to undertake the functions contemplated under the East African Legislative Assembly Elections (Election of Members of the Assembly) Rules, 2017, and report to the House within the timelines stipulated in the said Rules. The House further resolved that the Offices of the Clerks of Houses of Parliament provide secretariat services in accordance with the Standing Orders and chose the following members to represent it at the Joint Committee:,

- 1. The Hon. Katoo Ole Metito, M.P.- Co-Chairperson
- 2. The Hon. Jayne Kihara, M.P.

A similar Motion was introduced in and adopted by the Senate, which chose the following Senators as its representatives:

The Joint Select Committee hit the ground running, and within a week released a communication to the public vide Gazette Notice No. 11292 of 2017 inviting members of the public to submit applications for consideration for nomination to EALA. The Gazette Notice stated, among other things, that nine Members would be elected to represent the country in the regional assembly, and further stated that in order to qualify for election as a Member of EALA a person needed to be a citizen of Kenya, qualified to be elected as a Member of Parliament under the Constitution of Kenya, not hold office as a Cabinet Secretary, not be an officer in the Service of the East African Community and with proven experience or interest in consolidating and furthering the aims and objectives of the Community. The Notice also indicated that a person could seek nomination either through a political party or elected independent of a political party, and set Thursday, 23rd November, 2017 as the deadline for submission of applications. By the submission deadline, nominations had been received for the following twenty five (25) persons:

On 7th December 2017, the Report of the Joint Parliamentary Select Committee on its consideration of the nominees for election as Members of the East African Legislative Assembly was tabled in the House and a Motion for its adoption moved. Among other resolutions, the Report sought leave of the House to conduct the EALA election on Thursday, December 14, 2017. Debate on the Motion concluded on 13th December 2017, after which the Motion was approved by the House.

On 14th December 2017, just before voting on the candidates commenced, the Honourable Speaker informed the House that two candidates had written to the Clerk of the National Assembly on 8th December 2017 seeking to withdraw from the election. These were:

- 1) Donya Dorice Aburi (Jubilee Party
- 2) Angela Mueni Munyasia (NASA Coalition)

The Speaker informed Members that under Rule 11(1)(2) the deadline for withdrawal of candidacy had been on Friday, 1st December 2017 at 4.00 p.m, and as such the Office of the Clerk had rejected their intended withdrawal and their names were thus appearing on the ballot papers. After guiding Members on the specific aspects of voting, the Speaker commenced the voting exercise following a ten-minute ringing of the Division Bell.

After a lengthy voting exercise that ended at midnight, the results of the elections were realized as follows:

The nine newly elected Members of the East African Legislative Assembly were congratulated by the Speakers and Members of both Houses, and were subsequently sworn in at the EALA Assembly in Arusha, Tanzania on 18th December 2017. They will be responsible for, among other things,

approving budgets for the region, debating audit reports, performing an oversight function, initiating bills in the Assembly and undertaking other functions that promote the interests of the nation.

XX. EAST AFRICAN SPORTS TOURNAMENT

The 8th Inter-Parliamentary Games took place in Dar es Salaam, Tanzania from 2d to 11th December 2017, with the Kenyan Parliament producing an excellent performance in all fields. being . with tugof-war and athletic disciplines taking off to a competitive start. Among other fetes, Team Kenya Men's Volleyball beat Tanzania 3 sets to 1 in the opening match at the indoor arena, whilst Hon Vincent Musyoka (Mwala) won the 100m race in a time of 11.61 seconds ahead of Hon. Mbwatekamwa Gaffa (Uganda) who managed 12.43 seconds and Hon Nixon Korir (Langata) who was third in 13.05 seconds. In the 200 metres, Hon Dan Wanyama (26.28) led compatriot Hon Charles Njuguna (27.44) while 3rd place went to Hon. Alero Tom Aza (Uganda) (27.68). Hon David Munyaka won the 200m race in 1.00 minutes followed by Sen Moses Kajwang in 1.02 minutes and Uganda's Hon. Mbwatekamwa Gaffa in 1.04 minutes. The 4 x 100 metre relay was also won by Team Kenya comprising Hon Wanyama, Hon Munyaka, Hon Korir and Hon. Musyoka. Laikipia East MP, Patrick Mariru took silver in the 800 metres after clocking 2.29 minutes behind Uganda's Hon. Julius Achon (2.16) and ahead of Tanzania's Hon. Hassan Masala.In Men's Tug-of-War, Tanzania scooped 6 points after recording 2 pulls to nil in similar score over Kenya and Uganda respectively. Uganda scooped 3 points after stopping Kenya 2-0. In the women's category, Kenya and Uganda both scored 4 points after a win and draw a piece. The Kenyan ladies then made 2 pulls to zero over Tanzania before settling to a 1-1 pull with Parliament of Uganda. The objective of tournament is to deepen regional integration and friendship among the partner states.
