MPs to consider new debt management framework

he period preceding June, 6 2022 witnessed a sustained campaign from the Executive for Parliament to raise the public debt ceiling to the current Kshs. 10 trillion shillings.

Former Treasury Cabinet Secretary Ukur Yatani, had at the time sought to amend the Public Finance Management Act to change the upper limit to a percentage of GDP from the current numerical capping.

In 2019 the House had raised the ceiling to Kshs. 9 trillion from Kshs. 6 trillion.

The National Treasury is once again seeking the nod of the House to institute changes to Public Finance Management (PFM) Act 2012 and the attendant regulations, to replace the current numerical debt ceiling of Kshs. 10 trillion with a debt ratio of 55 percent present value of the Gross Domestic Product (GDP).

The House has been scrutinizing the Medium Term Debt Management Strategy to ensure that it is aligned to the Budget Policy Statement. The strategy is meant to guide prudent public debt management.

Last week, the Cabinet Secretary (CS) National Treasury Prof. Njugu- the legislators that with a borrowing na Ndung'u met the Committees on Budget and Appropriations, Public headroom of only Kshs. 610Billion Debt and Privatization, and the Departmental Committee on Finance against a projected fiscal deficit of and National Planning over the matter.

In the forum moderated by the respective chairs; Hon. Ndindi Nyoro, the country has to adopt a practical Hon. Abdi Shurie and Hon. Benjamin Langat (sitting in for Kimani debt management policy. Kuria) the CS told the lawmakers that the forum was geared towards helping them understand the current public debt situation in the country and the proposed new framework.

But even as he made his case, the legislators led by Samuel Atandi (Alego Usonga) and Peter Masara (Suna West) took the CS to task to explain how the Ministry of National Treasury and Economic Planning is managing Kenya's public debt.

During the meeting, the lawmakers further sought to understand the projected impact of the proposed new policy to the economy.

A section of the lawmakers suggested that it were better if the National Treasury were to explore the calculation of the debt ceiling based on the revenue collected.

House team wants Treasury to improve diaspora facilitation to enhance their participation in economic development

he Committee on Diaspora Affairs and Migrant Workers now wants the government to improve facilitation to the Diaspora community to promote their participation in the economic development of the country.

Speaking recently when they met the Cabinet Secretary National Treasury, Prof. Njuguna Ndung'u, the MPs noted that there is need to create incentives to attract Kenyans living in the Diaspora to invest in the country along other foreign investors that the government is inviting to do the same.

Members cited a number of constraints that the community faces in their bid to invest locally ranging from lack of information on investment opportunities and government policies, to difficulties in money transfer.

Others are lack of safeguards that guarantee their investments, diplomatic assistance to replace passports and harassment by customs officials at the airport.

On his part, Prof. Njuguna informed the Com- that the Central Bank conducted Kenya's mittee that his ministry had put in place policies first Diaspora Remittances Survey between and programs to attract diaspora remittances 19th March and 17th May 2021 to collect over the years.

He noted that the ministry had developed wide ranging banking and financial sector reforms to help lower the cost of money transfer. He held that the transformation of the payments ecosystem had been a game changer in enabling Kenyans send money home.

The CS said the M-Pesa service beyond Kenya's borders and the partnership between the Diaspora Association and banks to allow them handle larger volumes of inflows at lower cost and within a much shorter time frame were some of the measures to attract Kenyans living abroad to invest back home.

He revealed that as a result, remittance inflows to Kenya had increased significantly over the past decade reaching a record of USD 4.028 Billion in 2022.

According to the documents tabled before the Committee, the US remains the largest source of remittances into Kenya accounting for 58 percent.

Remittances are an important source of foreign exchange to the country. The inflows have a positive impact on the livelihoods of vulnerable households.

During the meeting, the CS further disclosed

valuable information to improve quality of remittance statistics. He further revealed that the Central Bank had developed a range of financial products targeting the diaspora including successful infrastructure bonds.

The MPs however noted the need to expand focus beyond Kenyans living in the United States to allow more Kenyans living elsewhere across the globe benefit from the facilitation already in place for the diaspo-

The Committee which was established at the beginning of the 13th Parliamentary has in the last few weeks been engaging relevant stakeholders in a bid to brainstorm on legislative interventions required to improve the welfare of Kenyans in the Diaspora and Migrant Worker.

In a bid to brainstorm on legislation interventions crucial to mainstream diaspora and migration issues, the Committee this last weekend engaged Dr. Luchetu Likaka, an expert on matters Labour migration and Diaspora Affairs.

Legislators want Junior Secondary introduced in all Primary Schools

embers of Parliament have backed a proposal requiring the Ministry of Education to establish and operate Junior Secondary Schools (JSS) in every primary school in the country.

This was after Hon. Geoffery Ruku, MP (Mbeere North) moved a motion on the floor of the House seeking the development of a comprehensive policy and funding plan for the establishment of JSS.

Hon. Ruku noted that the recent guidelines by the government that JSS be established in some select primary schools have led to confusion and rendered classrooms that were utilized by pupils of classes seven and eight, redundant.

"This arrangement compels students to travel for longer distance to access institutions where Junior Secondary Schools are Hon .Ruku.

He added: "Communities have over the years continuously established learning institutions within their localities to address the shortage of physical facilities. It is unfair to negate that by having JSS's domiciled in a few schools."

Competency-Based Curriculum (CBC) system of education was rushed.

"JSSs in my constituency and across the country are grappling with challenges of inadequate facilities and acute shortage of teachers. It will be important to come up with a clear policy and funding plan so that our level of education does not deteriorate," said Hon. Yusuf, who also seconded the motion.

Hon Shabbir on his part observed that the new system of education that was rolled out by the government is good, but pointed out that the idea of having JSSs in primary schools was not well-thought out.

"I am shocked by the callous way the stakeholders have been based, which is straining to learners, " said looking at the future of our Education. You cannot have JSS in a primary school. The learners need to be in a secondary school," maintained Hon Shabbir, who also wondered who JSS teachers in primary schools are supposed to report to.

"Should the secondary school teachers report to the Primary school headteacher? We should not have knee-jerk decisions in matters as important as the education of our children," added Hon Shabbir.

Hon Komingoi said it will be important for the policy to address the distance learners need to cover so as to access JSS schools, noting that it is one factor that has the potential of critically affecting students' academic performance.

Committee invites Solicitor General over CBK audit query

he Public Investments Committee on Commercial Affairs and Energy (PIC CA&E) has resolved to invite the office of the Solicitor General to shed more light, on delayed winding up of the Kenya Schools of Monetary Studies, despite an earlier proposal for the same from Central Bank of Kenya (CBK).

The Chair, Hon. David Pkosing (Pokot South) issued the directive, when CBK Governor Dr. Patrick Njoroge appeared before Members to respond to queries raised by the Auditor General on CBK's audited accounts between Financial Years 2018/2019 to 2020/2021.

The Auditor General revealed that the Kenya Schools of Monetary Studies (KSMS), which is a subsidiary of the CBK, had not been wound up despite a proposal from the board for its dissolution in an effort to address concerns regarding governance and internal controls.

Members noted that the Office of the Solicitor General had raised reservations about the proposed winding up of KSMS, and therefore resolved to give him and the school management an audience before the Committee and to later recall the CBK Governor for more clarifications.

Hon. Pkosing said the actual date of the meeting would be announced after the Committee had received all correspondences regarding the issue of the CBK team.

"We will critically examine all these documents, before we meet the Solicitor General and the CBK team. This is very important before we retreat to write the report," said Hon. Pkosing.

Other audit queries raised by the Committee, include the continued running of the CBK without full composition of Non-Executive directors. The Auditor General noted that out of the legally prescribed composition of 8, only 4 non-executive directors were in office during the financial years under review.

Dr. Njoroge, also clarified that a deputy governor for the CBK had been recently hired. This was in relation to a separate query in which the Auditor General had faulted the CBK over a vacuum in the office of one of the two deputy governors.

MPs put Education CS to task over operations of Junior Secondary Schools

he Cabinet Secretary for Education Hon. Ezekiel Machogu has revealed that the government has spent Ksh 7.6 billion to construct 9,721 classrooms in secondary schools across the country.

He says the move aims at reducing congestion in these institutions, which has been a significant challenge in the education sector.

He was responding to a question by Hon. Oku Kaunya(Teso North) Wednesday during Question Time.

The lawmaker had asked the Cabinet Secretary to provide information on the amount of public funds channeled towards the construction of classrooms in junior secondary schools countrywide.

According to Hon. Machogu, the classrooms were built to address a deficit of classrooms in secondary schools which 3,523,428 learners to 3,526,197 from the previous year. stood at 2,633, as at December 2022.

Committee faults KBC over irregular contracts and mismanagement of assets

he Departmental Committee on Communication, Information and Innovation chaired by Dagoretti South MP, Hon. John Kiarie, has faulted the management of the Kenya Broadcasting Corporation (KBC) over alleged assets' mismanagement and irregular contact deals.

The concerns were raised during a two-day consultative forum with KBC, Communication Authority of Kenya (CAK), Postal Corporation of Kenya (PCK), and the National Treasury. In attendance was Prof. Edward Kisiang'ani, the Principal Secretary, State Department for Broadcasting and Telecommunications.

The forum was intended to provide a platform for the agencies to apprise the Committee on their mandate, functions, challenges, and legislative gaps as well as possible turnaround strategies to revive the underperforming agencies. They were also expected to inform the Committee of the measures put in place to settle the existing debts and pending bills.

Among the issues that attracted in-depth deliberations was the Kshs 7 Billion debt KBC owes a United Kingdom Company, after the the broadcaster entered into an irregular contract deal without the involvement of the office of the Attorney General and the National Treasury, who are critical players in any financial deals with foreign companies. and County TV investment.

The CEO noted that a review of the KBC Act CAP 221 (1989) is crucial for enabling the Corporation's operations to be in tandem the current media trend, and sought the Committee's support in attaining this goal.

The Committee highlighted the critical need for a reform agenda of KBC in order to deal with reported historical debts, some of which need to be regularized by Treasury through a sessional paper.

On his part, the Principal Secretary Prof Kisiang'ani emphasized the need for KBC and PCK to have full disclosure on their issues if they need Parliament's intervention in solving their challenges.

In his presentation, the Director General of CAK, Mr. Ezra Chiloba told the lawmakers that the Authority has already aligned itself with the digital transformation agenda, and is keen on rolling out new CA and Universal Service fund strategic plans. He also proposed the formulation of regulatory practices for the future.

Speaking during the forum, Post-Master General Mr. John Tanui shed light on the turnaround strategies that PCK is looking to adopt especially with regard to modernization of logistics and e-commerce, while working on leveraging on technology to improve on its service delivery.

South Mugirango MP decries closure of Nduru Level **Five Hospital by County government**

legislator has decried the indefinite closure of Nduru level 5 hospital in Kisii county over safety concerns, disclosing that the move has subjected the residents to a lot of distress as they cannot access health services.

The closure of the hospital was revealed by Hon. Sylvanus Osoro, MP (South Mugirango), while addressing the National Assembly. He decried to the House that the hospital which was built by the government in partnership with the World Bank had to be shut down due to safety

concerns following an incident that occurred on April 12th, 2023.

The closure was initiated by the County government's attempt to transfer medical equipment from the hospital to another healthcare facility. Unfortunately, the locals protested, resulting in some medical personnel getting injured. This incident forced the hospital's indefinite closure, causing immense suffering to the residents who rely on it for essential healthcare services.

Now the MP is calling on the County government to work closely with the national government to reopen the hospital and ensure the resumption of medical services as soon as possible. Members of Parliament, while making contributions, noted that the hospital's prolonged closure has had severe effects on the residents of Kisii County.

They stressed the need for the county government to prioritize the health of its citizens by taking prompt action to address the hospital's closure.

"This closure underscores the need for stronger measures to protect healthcare facilities and personnel, especially in areas where residents depend on them for essential services. It is hoped that the necessary measures will be taken to ensure that the medical facility is reopened and fully operational to serve the people of Kisii County," held Hon. Caleb Hamisi.
