

Speaker Wetang'ula rules on Admittance of 'Money Bill' Amendments as House considers proposed changes to the Finance Bill, 2023

The Speaker of the National Assembly the Rt. Hon. (Dr.) Moses Wetang'ula, in a Communication to the House on Tuesday; cautioned the House against introducing amendments to Bills which commit the Executive without taking cognizance of the fiscal policy and considerations of the National government.

"Honourable Members, I give this direction with full consciousness that the intention of Article 114 of the Constitution is not to curtail the legislative mandate of the House. The Article merely seeks to ensure that, in as much as this House reserves the power to determine revenue raising revenues, it does not commit the Executive without taking cognizance of the fiscal policy and considerations of the National Government", a part of his Communication read.

The Standing Orders of the National Assembly as well as the

Noting that he had only allowed proposed amendments to the Finance Bill from 21 legislators, the Speaker told the House that when considering any matter that has a financial implication on public funds, the House is bound by the provisions of Article 114(2) of the Constitution.

Wetang'ula Speaker underscored the need for legislators to abide by the Standing Orders when introducing amendments during the Committee of the Whole

Citing an earlier guidance to the House, the speaker stipulated that Departmental committee on Finance chairperson their amendments to the Clerk, but a public hearing on Finance Bill 2023.

Speaker Wetang'ula decrees on the introduction, consideration and passage of the Finance Bill, in line with Standing Order 244C

The Speaker of the ■ National Assembly, the Rt. Hon. (Dr.) Moses Wetang'ula has ruled that the Finance Bill ought to be submitted before 30th April in each year. In a Communication Tuesday last week, the Speaker also told Members that the House is at liberty to prioritize consideration of the Bill before or after the presentation of the Budget Statement by the Cabinet Secretary (CS) for National Treasury and Economic Planning.

The Speaker was invited to issue guidance on the matter, after Rarieda MP, Hon. Otiende Amollo rose on a Point of Order seeking procedural guidance on adherence with Standing Order 244C with regard the introduction, consideration and passage of the Finance Bill, 2023 by the House.

Rising just as the CS National Treasury was preparing to enter the National Assembly Chambers to present Budget Highlights on 15th June, the Hon. Otiende Amollo sought to know whether it was right for the Finance Bill to have been submitted in April, published and considered before the "reading" of the Budget by the CS in the House.

Hon. Amollo argued that Standing Order 244C outlines a particular order requiring the Cabinet Secretary for the National Treasury to make a pronouncement of the Budget Policy Highlights and Revenue raising measures for the National Government and thereafter present a legislative proposal which is published and introduced as a Finance Bill.

According to him, a strict reading of the Standing Orders would indicate that the House had jumped the gun by concluding the Second Reading of the Finance Bill before "reading of the Budget".

However, in his Communication, Speaker Wetang'ula clarified while that may have been the case then, following successful petition filed by Sen. Okiya Omtatah challenging the constitutionality Provisional Collection of Taxes and Duties Act, in July 2019, the 12th Parliament amended the Public Finance Management Act through the Statute Law (Miscellaneous) Act, (2019).

The resultant effect was the introduction of Section 39A into the

The Speaker told the House that following this move, the Cabinet Secretary and the House had forthwith adhered to the Orders of the Court with the Finance Bill being introduced in the House not later than April 30th every year since

"The Cabinet Secretary and the House have consistently adhered to the orders of the Court in Okiya Omtatah Okoiti Cabinet Secretary (CS), National Treasury and 3 others (2018) and Section 39 of the Public Finance Management Act, (2012). This clearly signifies that Section 39A of the Public Finance Management Act, (2012) is the operative provision with regard to the introduction, consideration and passage of a Finance Bill", read a section of the Speaker's Communication.

He pointed out that while the plain reading of Section 40(3) and 40(4) of the Act implies that the CS for National Treasury is required to submit the legislative proposal setting out the revenue raising measures on the same day that he or she makes a pronouncement on the Budget Policy Highlights, the amended Section 39A requiring the CS to submit a Finance Bill not later than 30th April every year is the most recent one and therefore should take precedence.

At the same time, the Speaker has called upon the Procedure and House Rules Committee to address the variance between Standing Order 244C and Section 39A of the Public Finance Management Act.

"I guide that the Procedure and House Rules Committee notes the variance between Standing Order 244C and Section 39A of the PFM Act and include in the Standing Order in the items earmarked for review when it next proposes amendments to the Standing Orders", the Speaker directed.

Trans Nzoia County Member of Parliament urges review of NG- CDF bursary formula and procurement procedures to tackle delayed projects

Trans Nzoia County MP resentative, Hon. Lilian Siyoi, is calling for a review of the formula used to allocate bursaries to deserving and needy students under the NG-CDF (National Government Constituency Development Fund) program.

Hon. Siyoi has also expressed the need to re-evaluate the procurement procedures within the NG-CDF program to expedite the execution of works and contracts.

She highlights the current delay in identifying merchants or contractors for NG-CDF projects, which often leads to projects being awarded long after their intended take-off time.

"When projects are significantly delayed, they may be taken over by other programs. This is an issue that requires our attention. When allocating funds, particularly for bursaries, the NG-CDF program should consider the poverty level of each area," she emphasizes.

She argues that needy students require more substantial bursaries than the current allocation provides

"For instance, if each student is given Kshs 5,000, it may be insufficient considering that school fees can amount to around Ksh40,000." Poses Hon. Siyoi.

She further explains that towards the end of the academic term, students are forced to return home due to their parents' inability to raise the remaining balance.

She expresses concern that the extremely poor, who cannot afford school fees, are not adequately supported, and proposes amending the system to ensure

that schools in dire economic situations receive a greater allocation of bursary funds compared to more financially stable schools. Hon. Lilian Siyoi is also advocating for changes in the NG-CDF program to address the delayed project execution and improve the allocation of bursaries based on the poverty levels of the respective areas.

Public Petitions Committee investigates River Athi Pollution, says urgent action needed to protect Kenyan citizens and Thwake Dam

The Public Petition Committee conducted a fact-finding mission in Mwala Constituency, responding to Hon. Vincent Musyoka's petition regarding the pollution of River Athi. The committee sought to understand the environmental impact and root causes of this pollution

Hon. Musyoka initiated a laudable project in his constituency to generate electricity for pumping clean water from River Athi to residents' homes.

Unfortunately, water testing revealed the presence of harmful substances, rendering it unfit for human consumption.

In response, Hon. Musyoka filed a petition with Parliament to seek intervention in addressing the pollution of River Athi.

He said that adverse effects of industrial waste and residential sewage upstream from the river in Nairobi significantly affect downstream consumers thus necessitating urgent action to address the issue effectively.

The concern arises from the possibility of River Athi which drains in Thwake dam changing it to be a "sewer dam," jeopardizing the nation's well-being.

This situation could undermine the intended benefits of Thwake dam, which aims to alleviate water scarcity.

Under the leadership of Hon. Nimrod Mbai (Kitui East), the Public Petition Committee conducted extensive investigations along River Athi.

They called out contributors of the pollution, such as the Export Processing Zone Authority (EPZA) and Mavoko Water and Sewerage Company (MAVWASCO), urging them to fulfill their responsibilities.

The pollution caused by these entities poses significant risks to Kenyan citizens, with sewage and waste from industrial facilities and residential areas contaminating the river.

The committee recommended swift administrative action against industries releasing effluents into River Athi and those lacking Effluent Treatment Plants (ETPs).

They suggested revoking licenses for non-compliant businesses and emphasized the importance of operational treatment plants in sewerage companies, including addressing the abandonment of MAVWASCO's plant.

The committee also called for the immediate resignation of the NEMA Director due to perceived negligence.

During the site visit, Hon. Mbai called for the immediate step-down of the NEMA Director General, Mr. Mamo Boru Mamo citing lack of dedication in fulfilling the Authority's responsibilities.

To address these concerns, the committee proposed that NEMA exclusively grant licenses to factories with functional ETPs.



Budget and Appropriations Committee Tables 2022/2023 Second Supplementary Estimates, Report adopted by the House

The Committee on Budget and ▲ Appropriations chaired by Kiharu MP Hon Ndindi Nyoro, tabled its report on the Floor of the House in regards to the Second Supplementary Estimates for FY 2022/23 after engagements with Departmental Committee chairpersons in order to align the estimates with actual revenues and expenditure absorption for the year ending 30th June, 2023.

The Budget Committee report seeks to reduce the National Government Expenditure estimates by Ksh. 6.4Billion. This comprises of a reduction of capital expenditure by Ksh. 39.0Billion, an increase in recurrent expenditure by Ksh. security operations related in- Estimates No. 1 with support of 7.6Billion and an increase in Consolidated Funds Services (CFS) by Ksh. 24.8Billion.

While rationalizing the Budget and aligning it with the revised Macro Economic and fiscal framework, the 2nd Supplementary Estimates for 2022/23 also seek to provide additional resources for drought related interventions, Junior Secondary School (JSS) capitation,

Speaking during the Budget and Appropriations Committee meeting with chairpersons of Departmental Committees, Hon Ndindi Nyoro said that the second Supplementary Estimates for FY 2022/23 will bring overspending and underspending of state resources to a close while minimizing the accrual of pending bills.

"The purpose for this 2nd Supplementary Estimates for FY 2022/23 is to entirely align government expenditure and revenue so that we end the year with realistic figures and support the state departments that are in dire need in the public interest before the end of June, 2023," said Hon. Ndindi Nyoro.

Nevertheless, the Supplementary Estimates No. 2 for FY 2022/23 reflect the government's investment on priorities that matter to Kenyans.

Youth MP Hon. Umulkher proposes Bill to have youth representation in public decision-making, development agenda and governance processes

Parliament has a crucial role in advancing and promoting the inclusion promoting the inclusion, equal participation and representation of youths in the decisionmaking processes.

In a significant move towards empowering the youth and promoting their participation in nation building, Umulkher Mohamed (Nominated Youth MP) has sponsored a Bill seeking to amend the County Governments Act, 2012 to include youth representation focusing at the County Public Service Boards.

Hon. Umulkher, while presenting the amendments before Departmental the Committee on Labour highlighted the proposed amendment seeking to give effect to Article 55 of the Constitution which mandates the state to implement measures, including affirmative action programs, to ensure that the youth have

opportunities to participate in various aspects of political, social, and economic decisions.

The session Chair, Hon. Chiforomodo Mangale, (Lunga Lunga), expressed his support for the proposal, saying that in all democracies, youth must play an active part in formulating tomorrow's politics.

The Committee acknowledged that inclusive participation of the youth in politics and development remains a fundamental political and democratic right.

The legislators expressing their support for the proposed amendment saying that it aligns with broader efforts to address the needs and aspirations of the youth, providing them with Hon. Umulkher Mohamed (Nominated) appears equal opportunities to shape the future of their counties.

Botched malaria nets procurement linked to suspicious tender error, National Assembly Health Committee told

The National Assembly departmental committee on Health has discovered a suspicious tender error that may have contributed to the failed procurement of anti-Malaria nets worth Ksh.3.7 billion.

The error in question relates to the inclusion of Preferred Provider Organization combinations, which did not align with the initial tender specifications.

It is suspected that this discrepancy was intentional and aimed at sabotaging the procurement process by the Kenya Medical Supplies Authority (KEMSA).

Dr. Andrew Mulwa, the acting Chief Executive Officer (CEO) of KEMSA and Head of Preventive and Promotive Health Services at the Ministry of Health, informed the committee that the head of the malaria program had alerted his office about the absence of PPO combinations in the insecticide specifications stated in the tender advertisement.

"I advised the head of the malaria program to send me a memo on this issue. He indeed prepared the memo, but unfortunately, it did not reach my office," explained Dr. Mulwa.

He added: "Instead, it was acted upon by

Dr. Josephine Mburu, the Principal Secretary of the State Department for Public Health and Professional Standards, leading to the extension of the tender,"

During the committee hearing, Dr. Mulwa faced questioning from Endebess MP Robert Pukose, who chairs the Health Committee. Hon. Dr. Robert Pukose raised concerns about the contradictory statements made by Dr. Mulwa regarding the origin of the request to amend the tender specifications.

"Are you suggesting to this committee that the request to amend the tender specifications originated from your office, yet you claim to be unaware? But at the same time, didn't you instruct him to write the memo?" asked Hon. Pukose.

Dr. Mulwa responded, "Yes, he came to my office and informed me that the advertisement was missing the PPO part. I verified that it was indeed missing and asked him to write a memo if he believed it was necessary."

Dr. Mulwa admitted that the head of the malaria program had informed him about the missing PPO requirement but claimed he was unaware of the subsequent actions taken.

Dr. Mulwa emphasized that his office had no visibility of the communication between the national treasury, KEMSA, and the Global Fund concerning the color and dimensions specifications. He revealed that although they had specified blue-green or blue as the color, the treasury, KEMSA, and the Global Fund agreed on a rectangular shape and a blue collar.

Similarly, the choice between Pyrethrins or PPO for the insecticide was decided by the Global Fund and Treasury, without his knowl-

Trade Committee investigates release of Unsafe Sugar

The Trade, Industry, and Cooperatives L Committee chaired by Hon. James Gakuya (Embakasi North) convened a follow up meeting with the Acting Managing Director of the Kenya Bureau of Standards (KEBS) on 21st June, 2023 to address concerns regarding the unauthorized release of condemned sugar into the Kenyan market.

The Trade Committee had an earlier sitting with Ms. Esther Ngari on 8th June, 2023. To adequately prepare responses for the Committee's concerns, she had requested for a time frame of 2 weeks.

The Lawmakers were deeply troubled by the incident and are determined to uncover the reasons behind this lapse and the actions taken by KEBS to address the issue. The occurrence highlights the urgent need for strict regulations and effective oversight to ensure product safety and quality in Kenya.

The Committee sought to understand the factors that contributed to this breach and its potential impact on public health. Members of the Committee posed a series of inquiries to the Ag. Managing Director for KEBS, to ascertain the entire process that allowed condemned sugar to reach consumers.

During the questioning, Ms. Ngari, failed to provide satisfactory answers, leading many legislators to perceive her responses as evasive. When asked about KEBS' knowledge regarding the disappearance of the sugar, the acting MD replied, "I have no information on when and how the sugar disappeared." She also stated that KEBS had no response regarding the significant delay of nearly six years in taking action against the condemned sugar.

In their pursuit of the truth behind this alarming issue, the Committee plans to meet with other relevant agencies

involved, such as Kenya Revenue Authority and the companies involved in the storage and transportation of the condemned sugar. They are devoted to thoroughly investigate the matter and present a comprehensive report that reveals the full extent of what transpired.

"We will leave no stone unturned until we have a complete understanding. It appears that this was a carefully orchestrated event. The Committee will diligently uncover the truth and provide a final report detailing the sequence of events," stated Hon. Gakuya, the Chairperson.

The Public Debt and Privatization Committee receives Stakeholders' submissions on the Public Finance Management (Amendment) Bill, 2023

The Public Debt and Privati-L zation Committee held consultative meetings with different stakeholders in regards to the Public Finance Management (PFM) (Amendment) Bill, 2023. The PFM Amendment Bill seeks to amend the PFM Act No. 18 of 2012, by adjusting the framework for monitoring public debt and borrowing, and to align the Act with the provisions of the Constitution relating to definition of public debt, financial obligations and amending the debt limit.

While appearing before the Committee, the Principal Secretary (PS), National Treasury and Economic Planning Dr. Chris K. Kiptoo notified Members that the available borrowing space as at the end of April 2023 was Kshs. 400 billion, against a fiscal deficit of Kshs. 718 billion, indicating the inability within the law to finance the Financial Year 2023/24 budget.

"We are just getting the flexibility in the sense that you may have a choke with the economy if the shilling moves in an uncontrollable manner and affects your debt of stock without even thinking of borrowing, hence the amendment will allow such adjustment." Explained Dr. Kiptoo. Committee Members raised a concern on the proposed insertion of an additional provision to Section 50(2): - "Cabinet Secretary to submit a report to Parliament in the event there is a breach on the threshold indicating a remedial plan to be undertaken."

The PS assured the MPs that there is no budget will be effected without Parliamentary approval, and as such the National Treasury will always engage Parliament on financial matters.

The National Treasury also proposed the substitution of section 15(2)(d) to enable the Public Debt Management Office to advise Parliament and the Cabinet Secretary on the sustainable levels of public stock of debt as they set the public debt threshold.

Other stakeholders that presented their submissions include the Institute of Economic Affairs (IEA), who raised an issue with the amendment of Section 6 (b) that seeks to delete section 31 (6) of the PFM Act for the Cabinet Secretary for Finance to charge debt costs to any other fund apart from the Consolidated Fund.

Digital bursary system garners praise as model of transparency, accessibility and disbursement of NG-CDF bursaries

The use of a digital system to roll out bursaries by the Uriri constituency office in Migori County is an initiative worth emulation by other constituencies. This, is an observation made by the National Assembly's Select Committee on National Government Constituency Development Fund (NG-CDF), in its tour of regional NG-CDF funded projects in Uriri.

The committee chaired by Eldama Ravine legislator Hon Musa Sirma acknowledged that the use of an online system does not only provide faster accessibility of bursary services by the befitting students, but also ensures transparency and accountability in the use of government resources.

"The digital route will eradicate corruption in the distribution of the NG-CDF funds and also gives easy access to services by students, many of whom live in rural set ups and far from the constituency offices," said Hon. Sirma, who commended area MP Hon Eng. Mark Nyamita for the great stride. he NG-CDF Committee inspected the Uriri Technical Training Institute (TTI), Rapogi Mixed Primary School, a laboratory at Nyamasaria Secondary School, and the Kajulu Sub-Chief offices in West Kanyamkago ward.

The Committee was accompanied on the tour by officials from the NG-CDF Board led by Mr. George Olemeshuko, Director of Human Resource. Hon. Sirma emphasized that the role of the oversight board is to ensure proper utilization of the funds allocated to the Constituency for Development, and praised legislators who have met these expectations.

Banning the growing of eucalyptus trees in the country

THAT. that, the eucalypaware cies are popular tus tree speamong large scale and commercial tree farmers in ing that, these Kenya; notare grown in tree species most ecological zones in the country and in particular in Central Rift Val-Western, ley, Central Kenya, parts of Eastern and the Coastal Regions of the country; acknowledging farming of the eucalyptus trees has been on the rise due to their fast growth, good economic returns and diverse commercial uses such as transmission poles, fuelwood, timber, plywood, pulp, fencing posts and building materials among others; concerned that, eucalyptus trees species are majorly cited as high water depleting agents through high consumption, transpiration and evaporation thus causing the drying up of streams, rivers and depletion of groundwater water sources; deeply concerned that, the high depletion of water by the said trees has caused adverse negative effects on soil fertility, land degradation and are a serious threat to the biodiversity; recognizing that, due to the serious threats paused by the Eucalyptus trees to the biodiversity, there is need therefore for their removal and replacement with other types of trees to improve conservation of water sources and the ecosystem; this House resolves that the National Government through the Ministry of Environment, Climate Change and Forestry - (i) orders absolute banning of planting eucalyptus trees and encourages planting of indigenous species across the country; (ii) orders the uprooting of all eucalyptus trees and replacement with other varieties of trees particularly, indigenous species to ensure conservation of water sources and preserve the ecosystem; and (iii) initiates the process of putting in place punitive measures against persons who defy the above orders.

Establishment of strategic grain storage reserves and silos in close proximity to smallholder farmers

THAT, aware that, agriculture is the backbone of the Kenya's economy contributing approximately 33% of the G D P and employing more than 40 percent the total population and 70 percent of the rural population; noting that the sector's performance has been declining as a result of


Scouts Union President Calls on the Speaker ahead of the Kenya World Scout Parliamentary Union, Africa Assembly 2023, in Nyeri
