5. <u>NOTICE OF MOTION</u>

The following Notice of Motion was given: -

Development of a framework to mitigate flood hazards

THAT, aware that the Constitution recognizes the people's respect for the environment and the determination to sustain it for the benefit of future generations; further aware that the country has been experiencing some of its worst flood events during the rainy season in recent years; concerned that the effects of climate change will exacerbate the frequency and intensity of these extreme flood events; further concerned that floods pose a direct threat to the safety and security of Kenyans causing significant loss of life and mass displacement which leads to severe economic setbacks; recognizing that there is need to take proactive measures by developing an actionable framework to implement strategic water harvesting techniques to mitigate against perennial flooding; acknowledging that rainwater harvesting would not only alleviate the destructive impacts of excessive runoff rainwater but also contribute to long-term water availability; now therefore, this House urges the national government through the Ministry of Environment, Climate Change and Forestry to develop a national framework providing for, among other things, the prevention and control of flooding in flood-prone areas in the country, emergency response coordination and evacuation, and long-term rainwater management systems through harvesting and storage.

6. QUESTIONS

- a) The following Questions were <u>asked</u> and responded to by the Cabinet Secretary for Water, Sanitation and Irrigation in plenary –
 - (i) Question No. 235 of 2023 by the Member for Gatundu North (Hon. Elijah Njoroge, MP) regarding details of the *Ndaragu* 2 dam project in Gatundu North Constituency, including the targeted beneficiaries, project contractors, and lack of public participation within the area of the intended project.
 - (ii) Question No. 237 of 2023 by the Member for Taveta (Hon. John Bwire, MP) regarding information on the state of distillation of existing irrigation canals and construction of new irrigation canals by the National Irrigation Authority in *Mboghoni* ward in Taveta Constituency which has resulted in perennial floods several villages and measures taken by the Ministry to fix the flooding.
 - (iii) **Question No. 238 of 2023** by the Member for Manyatta (Hon. Gitonga Mukunji, MP) regarding management of water upstream and downstream in irrigation schemes and water abstraction activities in rivers within Manyatta Constituency; re-directing of water from the River *Rupingazi* to Mbeere South Irrigation Schemes and steps the Ministry has put in place to ensure that the infrastructural development of *Nginda* Irrigation Scheme is up to par with the increase in farming activities within the Scheme.
 - (iv) **Question No. 240 of 2023 by the Member for Bura (Hon. Adow Yakub, MP)** regarding the plans the Ministry has instituted towards supporting water trucking initiatives in *Bangale* Ward, Bura Constituency specifically by providing water boozers and fuel.

- (v) Question No. 332 of 2023 by the Member for Marakwet West (Hon. Timothy Kipchumba, MP) regarding amount of money that the Ministry allocated to *Chebara Boys Secondary School, Chebara Girls Secondary School, AIC Chebara and Kaptomut Primary School* for their relocation to pave way for construction of *Chebara Dam*, how the money allocated to each institution was utilized and when the stalled projects in the institutions will be completed.
- (vi) Question No. 336 of 2023 by the Member for Mandera County (Hon. Umul Ker Kassim, MP) regarding the status of the implementation of Mandera Water Supply Project and Mandera Sewerage Project both funded by the African Development Bank in conjunction with the National Government under the Kenya Towns Sustainable Water Supply Sanitation Program, which were awarded in 2018, but have since stalled, including project details.

 - (i) Question No. 239 of 2023 by the Member for Maragwa (Hon. Mary Wamaua, MP) regarding reasons why Murang'a South Water and Sanitation Company (MUWASCO) is the sole authorized distributor of water three constituencies namely, Maragwa, Kigumo and Kandara Constituencies but has insufficient capacity; basis upon which the Water Services Regulatory Board (WASREB) permits Murang'a South Water and Sanitation Company (MUWASCO) to collect revenue from landlords who provide borehole water to their tenants; entities that audit water service providers; and provision of the audit reports for MUWASCO for the financial years 2020/2021 and 2021/2022.
 - (ii) **Question No. 337 of 2023** by the Member for Bondo (Hon. (Dr.) Gideon Ochanda, MP) regarding the state of land reclamation works on the Yala Swamp, and indicate the timelines within which the Yala Swamp reclamation will begin and the expected completion dates.

Various Members also raised Supplementary Questions which were responded to by the Cabinet Secretary within the allotted time.
