#### 7. QUESTIONS AND STATEMENTS

#### **STATEMENTS**

## a) Pursuant to Standing Order 52(1)

i.) Nominated Senator (Sen. Esther Okenyuri, MP) made a statement concerning the recovery of the tourism sector in Kenya, post COVID – 19 Pandemic.

In the Statement, the Senator highlighted the importance of the tourism sector in the country. She pointed out that tourism was a significant contributor to the country's Gross Domestic Product (GDP), with the sector contributing 10.4%. The Senator appreciated and congratulated the Ministry of Tourism and other relevant government agencies for their efforts towards reviving the tourism industry.

However, the Senator pointed out that despite the growth trend over the past two years, the growth falls below the pre – COVID -19 pandemic period of 30% of GDP. She pointed out that this called for new approaches and deepening strategies by tourism sector players in order to bring the sector back to the pre COVID 19 levels.

In highlighting one of the new approaches to spurring growth in the tourism sector, the Senator urged fellow Senators to sensitize their constituents on the need protect the environment and wildlife as Kenya's treasured natural heritage. She also called upon the national and county governments to support indigenous efforts by various communities aimed at promotion of tourism, in the context of climate change.

ii.) The Senator for Narok County (Sen. Ledama Olekina, MP) made a statement regarding the Public Service Superannuation Scheme Act, 2012 (PSSS Act), the Public Service Superannuation Guideline / Handbook published by the National Treasury and Economic Planning, and the Human Resource Policies and Procedure Manual for Public Service of May 2016.

Thereupon, the Senator informed the Senate that the Public Service Superannuation Scheme Act No. 8 of 2012, which was operationalized on 1<sup>st</sup> January 2021, is geared toward provision of retirement benefit to persons employed in the public service, while the Human Resource Policies and Procedure Manual provides guidelines in the management and development of human resource capacity.

The Senator pointed out that Section (f) of the Manual defines work environment health and safety of public servants, with the responsibility of provision of the benefits being bestowed upon the government. The Senator pointed out that teachers, who form bulk of the public service, have never been provided with the benefits as highlighted in the Manual.

The Senator highlighted that over 4,094 teachers have died since 2016 and that over 30,000 had recorded occupational illnesses and injuries. He noted that the estimated value of compensation that is legally due to teachers is in excess of Kshs. 25 billion.

In conclusion, the Senator called upon the government through the Ministry of Public Service, Gender and Affirmative Action and the National Treasury and Economic Planning, to enforce compliance with the PSSS Act No. 8 of 2012 and the Human Resource and Procedure Manual of May 2016, to address the ballooning compensation dues.

iii.) Nominated Senator (Sen. Abdullahi Miraj, MP) made a statement concerning the indignity and challenges suffered by women and girls during menstruation.

Thereupon, the Senator underscored the existing societal taboos and shame surrounding menstruation in certain communities. She noted that lack of open dialogue on this matter among certain communities often leads to insufficient information for menstruating girls, which subjects them to teasing and stigma.

She emphasized the urgent need for better access to information, safe menstrual materials, and proper facilities for menstrual hygiene management, observing that many adolescent girls and women struggle to afford sanitary pads. The Senator expressed concern that this vulnerability leads to some engaging in risky behaviour such as sex for money, in order to afford sanitary products.

The Senator also drew the attention of the Senate to the fact that most school-going girls of menstrual age were often absent from school during menstruation due to lack of adequate sanitary materials. She pointed out that this situation disadvantages them over their male counterparts.

The Senator called upon other Senators to support initiatives that provide crucial support, empowerment, and dignity to menstruating girls. She observed that such interventions addressing the challenges that women and girls face and promote sustainable solutions for improved menstrual hygiene, which in turn reduced school dropout rates.

"special service providers" means any person providing specialized, supplementary and related services to learners with special education needs and includes braille readers and technicians, sign language instructors and interpreters, orientation and mobility specialists, physiotherapists, occupational therapists, speech and language pathologists and therapists, counsellors, behaviour specialists, sensory integration therapists, psychologists, nutritionists, social workers and learner support assistants.
