4. COMMUNICATIONS FROM THE CHAIR

The Speaker issued the following Communications -

(a) Prioritization of Bills before Committees

Honourable Members, as you will recall, on Tuesday, 25th July 2023, I did notify the House on the status of business, especially legislative proposals and Bills published and awaiting consideration by Committees and the House. In my notification, I indicated that at least forty (40) Bills by individual Members had been published for consideration by the House. In addition, there are two hundred and sixty-eight (268) legislative proposals that have been sponsored by Members of this House, of which sixty-five (65) are undergoing pre-publication scrutiny by various Committees.

Honourable Members, the House Business Committee took cognizant, that under C, Committees are expected to prioritize the consideration of Bills and legislative proposals. To this end, I urge all Committees to prioritize the consideration of Bills and legislative proposals undergoing prepublication scrutiny. For greater certainty, may I remind Committees that Standing Order 114(7) requires a committee to which a legislative proposal is committed to submit a report within thirty (30) days.

Honourable Members, should it be brought to my attention that any Committee has inordinately delayed undertaking pre-publication scrutiny of legislative proposals before them, I will cause the House Business Committee, which I chair, to follow the precedent set in 2019 to have such proposals published as Bills without any further recourse to the relevant Committees.

To this end, **Honourable Members**, I now direct all Committees to consider and conclude on all legislative proposals before them and to submit their reports as soon as possible, given that the timelines for considering the Bills lapsed a long time ago. Going forward, may I remind Committee Chairpersons that Committees are under obligation to adhere to the thirty (30) day timeline without fail.

Further, all Committees that have Bills pending public participation are directed to expedite the process of consideration and table reports on the respective Bills within the timelines spelt out in Standing Order 127(4), in order to facilitate prioritization of the Bills for Second Reading.

Honourable Members, as the House creates time for individual Member Bills, the onus is on the Members to avail themselves in the House and prosecute their respective businesses once scheduled.

I hasten to state that, whenever a sponsor of a Bill or other business, listed in the Order Paper is absent from the House without permission of the Speaker when the business is scheduled, such business shall stand deferred and will not be prioritized again.

The House is accordingly guided. I thank you.

(b) Guidance on the consideration of the Anti-Money Laundering and Combating of Terrorism Financing Laws (Amendment) Bill (National Assembly Bill No. 35 of 2023)

Honourable Members, as you are aware, the Anti-Money Laundering and Combating of Terrorism Financing Laws (Amendment) Bill (National Assembly Bill No. 35 of 2023) was read a First Time on 26th July 2023. The Bill was thereafter committed to the relevant Committees for publication participation in accordance with the requirements of Article 118 of the Constitution and Standing Order 127. Subsequently, the Clerk of the National Assembly placed an advertisement in print media inviting the public and stakeholders to submit memoranda on the Bill in accordance with the requirements for public participation.

Honourable Members, the Anti-Money Laundering and Combating of Terrorism Financing Laws (Amendment) Bill, 2023 seeks to amend various Acts of Parliament relating to anti-money laundering and combating of terrorism financing and financing of proliferation of weapons.

Honourable Members, in particular, the Bill seeks to amend seventeen (17) Acts of Parliament. In this regard, I wish to notify the House that the proposed amendments to the following Acts of Parliament as contained in the Bill have since been referred to the Departmental Committee on Justice and Legal Affairs for consideration –

- (i) The Extradition (Contiguous and Foreign Countries) Act (Cap 76);
- (ii) The Extradition (Commonwealth Countries) Act (Cap. 77);
- (iii) The State Corporations Act (Cap. 446);
- (iv) The Anti-Corruption and Economic Crimes Act (No. 3 of 2003);
- (v) The Proceeds of Crime and Anti-Money Laundering Act, 2009 (No. 9 of 2009);
- (vi) The National Police Service Act, 2011 (No.11A of 2011);
- (vii) The Ethics and Anti-Corruption Commission Act, 2011 (No. 22 of 2011);
- (viii) The Mutual Legal Assistance Act, 2011 (No. 36 of 2011);
- (ix) The Prevention of Terrorism Act, 2012 (No. 30 of 2012); and
- (x) The Companies Act, 2015 (No. 17 of 2015).

Further, the proposed amendments to the following Acts of Parliament as contained in the Bill have also since been referred to the Departmental Committee on Finance and National Planning for consideration -

- (i) The Capital Markets Act (Cap. 485A);
- (ii) The Insurance Act (Cap 487);
- (iii) The Banking Act (Cap. 488);
- (iv) The Central Bank of Kenya Act (Cap. 491);
- (v) The Microfinance Act, 2006 (No. 19 of 2006);
- (vi) The National Payment System Act, 2011 (No. 39 of 2011); and
- (vii) The Limited Liability Partnership Act (No.42 of 2011).

Honourable Members, from the foregoing, the Departmental Committee on Justice and Legal Affairs shall be the lead Committee for purposes of conducting public participation. In this regard, the Departmental Committee on Finance and National Planning is required to conduct public participation process and submit its Report to the Departmental Committee on Justice and Legal Affairs, for consolidation.

Honourable Members, as you are aware, the Anti-Money Laundering and Combating of Terrorism Financing Laws (Amendment) Bill, 2023 contains proposed amendments seeking to provide for disclosure of information to help in combating money laundering, terrorism financing and financing of proliferation of weapons activities. In considering the Bill, the Committees bear in mind the requirements of Article 24 of the Constitution on the limitation of rights and the various court decisions that have outlined the manner of application of the Bill of Rights.

Honourable Members, may I implore the two Committees to prioritize consideration of the Bill and report to the House, soonest. Given that the Bill is also informed by various international obligations, which require the country to have in place a robust legal framework to combat money laundering, financing of terrorism and proliferation of weapons. The House is accordingly guided. I thank you.

6. NOTICES OF MOTION

(i) Review of the scope of education bursary scheme under NG-CDF and capitation for learners in Primary and Junior Secondary Schools

THAT, aware that Article 43(1)(f) of the Constitution as read together with Article 53(1)(b) entitles every child to free quality and compulsory basic education; cognizant of the fact that, access to funding for education immensely contributes to the realization of universal access to basic education in the country; appreciating that, section 48 of the National Government Constituency Development Fund (NG-CDF) Act, 2015 establishes education bursary schemes for every constituency towards access to basic education; noting that section 48A of the NG-CDF Act further allows for affirmative action mechanisms of allocating additional funds to cater for education bursary schemes and other teaching and learning related activities; concerned that, the NG-CDF Act caps allocation to bursary schemes under the Fund at not more than 35% of total Constituency allocation in a financial year, thereby limiting the number of cases that may be supported to access basic education; further concerned that, the NG-CDF Board has only been approving bursary support for secondary and tertiary education and not primary schools and the recently created Junior Secondary Schools; cognizant of the fact that, the failing to extend bursaries to primary and Junior Secondary Schools on the assumption that the two levels of education are 'free' is a misnomer since the Government's capitation per pupil is inadequate to cater for the mandatory materials required for Competency Based Curriculum (CBC), thereby affecting pupils whose parents are unable to meet the attendant costs; deeply concerned that, continued exclusion of allocation of bursary to Primary and Junior Secondary Schools violates the provisions of Article 27

of the Constitution and slows down attainment of universal basic education in Kenya; now therefore, this House resolves that –

- (i) the education bursary schemes under section 48 of the National Government Constituency Development Fund (NG-CDF) Act, 2015 be extended to support learners in Primary and Junior Secondary Schools to cater for Competency Based Curriculum requirements;
- (ii) pursuant to section 48A of National Government Constituency Development Fund Act, 2015, the NG-CDF Board in each Constituency approves additional allocation to the education bursary scheme in order to Support for teaching and learning related activities associated with the CBC education including School Feeding Programmes; and
- (iii) the Government revises the capitation per student in primary schools from the current Kshs. 1,420 per year to at least Kshs. 7,760, being the minimum optimal capitation factoring the new CBC education system and the prevailing high cost of living.

Reuben Kiborek)** regarding plans by the Government to allocate seed money for establishment of a Revolving Fund for purchase of hides and skins for processing by the Ewaso Nyiro South Development Authority and if the Ministry could consider building the capacity of the County Government of Baringo to realize value addition of the skins and hides.
 - (iii) Question No. 156 of 2023 by the Member for Manyatta (Hon. Gitonga Mukunji) regarding steps by the Ministry to protect Macadamia farmers from poor pricing and also improve market prices for macadamia nuts in the country.
