7. QUESTIONS AND STATEMENTS

STATEMENTS

a) Pursuant to Standing Order 52(1)

i.) Nominated Senator (Sen. Karen Nyamu, MP) made a statement regarding World Breast Cancer Awareness Month, the state of cancer disease in Kenya and the challenges facing victims of Breast Cancer.

Thereupon, the Senator pointed out that the month of October is a very important month in the global calendar of health and wellness as it is the month dedicated to sensitizing and creating awareness to the people about Breast Cancer as well as other classes of Cancer.

The Senator, thereafter shared some shocking statistics about the state of cancer in Kenya indicating the high costs related to treating the disease.

The Senator also applauded the Senate on the passage of the Primary Health Care Bill(Senate Bills No. 44 of 2023), which sought to address the health challenges in the country and urged every Kenyan to be champions of the war against cancer, by ensuring timely screening and early treatment of the disease.

ii.) The Senator for Turkana County (Sen. James Lomenen, MP) made a statement concerning the effects of climate change and the mitigation strategies in Turkana County.

Thereupon, the Senator drew the attention of the House to the severe impact of climate change that has befallen the Turkana community inflicting profound suffering upon the community, majority of whom rely on pastoralism for their livelihoods.

The Senator informed the Senate that this has caused loss of lives due to devastating floods, decimated livestock through famine and drought, and brought about numerous other hardships.

The Senator also pointed out that Turkana County, being situated in an arid and semi-arid region, relies heavily on agriculture as its primary source of livelihood, making the community particularly vulnerable to the adverse impacts of climate change and variability. He called upon the Senate Standing Committee on Agriculture, Livestock and Fisheries to engage the National Government in regards to the adverse effects of climate change.

iii.) The Senator for Kakamega County (Sen. Dr. Boni Khalwale, MP) made a statement regarding the temporary suspension, by the High Court in Eldoret, of all official sittings, meetings and deliberations by Members of the Uasin Gishu County Assembly pending the hearing and determination of a Petition challenging the composition of the County Assembly.

Thereupon, the Senator informed the House that the suspension arose from the filing of a Petition in the High Court by a civil society activist challenging the composition of the County Assembly, specifically that the Assembly lacks adequate representation of women and marginalized groups following the revocation, by the Courts, of the nomination of nine (9) United Democratic Alliance (UDA) Members of County Assembly (MCAs).

The Senator urged the House to take note of these developments and their potential impact on our democratic processes as it raises critical questions about the state of our democratic institutions and argued that, by dint of Section 7A (2) and Section 14 of the County Governments Act, the County Assembly is duly constituted and that such a suspension unnecessarily disrupts the normal functioning of the County Assembly.

The Senator called for the vacation of the Court orders and subsequent speedy resolution of the matter.

- vi.) The Senator for Turkana County (Sen. James Lomenen, MP) sought a Statement from the Standing Committee on Roads, Transportation and Housing concerning the status of construction of the Lodwar court building in Turkana County.
- vii.) The Senator for Turkana County (Sen. James Lomenen, MP) sought a Statement from the Standing Committee on Education concerning the burning of schools in Turkana County by suspected armed bandits.
- viii.) The Senator for Kakamega County (Sen. Dr. Boni Khalwale, MP) sought a Statement from the Standing Committee on Labour and Social Welfare regarding the hosting of the 2027 Africa Cup of Nations (AFCON) by Kenya, Uganda and Tanzania.
