#### 6. **QUESTIONS AND STATEMENTS**

#### **STATEMENTS**

#### a) Pursuant to Standing Order 52 (1)

i.) The Senator for Turkana County (Sen. James Lomenen, MP) made a statement concerning the disparities in service delivery to refugee communities in Kakuma and Kalobeyei camps in Turkana County.

Thereupon, the Senator informed the Senate that both Camps were home to over 196,666 refugees as of July 2020 and that this situation had presented challenges for the Turkana community. He informed the Senate that despite the Kalobeyei Integrated Socio-Economic Development Program (KISDBP) aiming for equal services for refugees and the local community, discrimination persisted in various aspects such as, scholarships, healthcare, training programs, access to water, and job opportunities at the UNHCR for the Turkana.

The Senator emphasized on the need to ensure fair access to scholarships, more educational facilities, equitable healthcare, cultural respect, expanded gender-based violence services, enhanced security, tailored livelihood programs, additional water points, qualified job opportunities, community engagement, and conflict resolution in order to address the challenges.

ii.) The Senator for Nandi County (Sen. Samson Cherarkey, MP) made a statement concerning the stunning performance by Kenyan athletes at the World Road Running Championships in Riga, Latvia.

Thereupon, the Senator congratulated the Kenyan athletes who participated at the World Athletics Road Running Championship in Riga, Latvia. The Senator highlighted the sterling performance that the athletes demonstrated in the half-marathon and securing gold medals for Team Kenya, led by Sebastian Sawe and Peres Jepchirchir.

In addition, the Senator recognized Ms. Beatrice Chebet who claimed victory in the women's 5 kilometers and Mr. Daniel Simiyu Ebenyo and Samwel Nyamai Mailu who enabled the Kenyan male team in securing their 17<sup>th</sup> title. This, he said, was a remarkable performance.

In conclusion, the Senator called upon the Ministry of Sports, Athletics Kenya (AK) and the National Olympics Committee of Kenya (NOCK) to partner with the Ministry of Tourism and utilize the fame and good name of the Kenyan athletes to market Kenya as a tourist destination by making them Brand Kenya ambassadors.
