The Deputy Speaker conveyed the following Message from the National Assembly:-

“Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 46 (3) and (4), I received the following Message from the Speaker of the National Assembly with respect to the National Assembly’s Resolution on the Extension of the Mandate of the National Dialogue Committee passed on Tuesday, 17th October, 2023.

The Message, which is dated Wednesday, 18th October, 2023, was received on Wednesday, 18th October 2023, in the Office of the Clerk of the Senate.

Pursuant to the said Standing Order, I now report the Message-

“PURSUANT to the provisions of Standing Order 41(1) of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly-

WHEREAS, the National Assembly and the Senate considered and passed a resolution on the Establishment of a National Dialogue Committee on 16th August 2023 and 29th August 2023, respectively;

AND WHEREAS, the National Dialogue Committee (NADCO) was mandated to, amongst other roles, facilitate dialogue, build consensus, and recommend appropriate constitutional, legal, and policy reforms on issues of concern to the people of Kenya and to report to the Leadership of the Kenya Kwanza and Azimio Coalitions, and to Parliament within sixty (60) days from 29th August 2023;

FURTHER WHEREAS, on Tuesday, 17th October 2023 following a request from NADCO, the National Assembly considered and passed a Resolution on the Extension of the Mandate of the National Dialogue Committee by a further thirty (30) days from 28th October 2023;

NOW THEREFORE, in accordance with the provisions of Standing Order 41(1) of the National Assembly Standing Orders, I hereby convey the said Resolution of the National Assembly to the Senate for consideration.”

7. **NOTICE OF MOTION - REPORT OF THE AD-HOC COMMITTEE TO INVESTIGATE THE PROLIFERATION OF RELIGIOUS ORGANISATIONS AND CIRCUMSTANCES LEADING TO THE DEATHS OF MORE THAN 95 PEOPLE IN SHAKAHOLA, KILIFI COUNTY**

THAT, the Senate adopts the Report of the Ad-Hoc Committee to Investigate the Proliferation of Religious Organisations and Circumstances Leading to Deaths of more than 95 people in Shakahola, Kilifi County laid on the Table of the Senate on Thursday, 19th October, 2023.

8. **QUESTIONS AND STATEMENTS**

STATEMENTS

a) **Pursuant to Standing Order 52(1)**

- i) The Senator for Nandi County (Sen. Samson Cherarkey, MP) made a statement concerning the remarkable achievement by Mr. James Muhia and Mr. Cheruiyot Kirui in climbing Mt. Manaslu in Nepal.

The Senator highlighted that Mr. James Muhia and Mr. Cheruiyot Kirui made history by becoming the first Africans and Kenyans in particular, to successfully climb Mt. Manaslu in Nepal. The Senator observed that the two compatriots reaching a height of 8,163 metres above sea level and noted that the achievement was notable because it was accomplished without the use of supplemental oxygen or Sherpa support that showcased their mountaineering skills, physical endurance and mental fortitude.

The Senator stated that the success of Mr. Muhia and Mr. Kirui served as an inspiration to aspiring mountaineers and highlighted the importance of perseverance and dedication in the face of adversity. The Senator commended Mr. Muhia and Mr. Kirui for their historic accomplishment and the positive image they had brought to Kenya in the international stage.

- ii) Nominated Senator (Sen. Crystal Asige, MP) made a statement commemorating World Sight Day, which is observed annually on the second Thursday of October.

In the Statement, the Senator highlighted the importance of raising awareness about vision impairment, blindness, and the necessity of comprehensive eye care. She pointed out that out of the 7.5 million Kenyans suffering from severe visual impairment or blindness, 90% of the cases could have been prevented. The Senator therefore emphasized the importance of protecting one's eyesight, and called upon policymakers to lead and support initiatives that highlight issues of eyesight.

The Senator further noted the connection between eye health and economic advancement, citing studies that show a significant increase in productivity and income following successful eye treatments like cataract surgery and the use of spectacles. She also underscored the need for employers to prioritize eye health of employees, especially in workplaces where eye injuries were a potential hazard.

In conclusion, the Senator called upon Senators to take advantage of regular eye screenings and to encourage testing and screening for eye issues within their families and communities. She also emphasized on the obligation of employers to provide for the eye health of their employees and fostering a workplace culture that champions the well-being of employees.
