5. QUESTIONS AND STATEMENTS

STATEMENTS

a) Pursuant to Standing Order 52 (1)

i.) The Senator for Bungoma County (Sen. David Wafula Wakoli, MP) made a statement concerning the plight of Kenyans who are stranded in Malaysia.

The Senator expressed concerns about the dire situation that three individuals were facing after traveling to Malaysia in search of better opportunities but fell victim to human trafficking. The three Kenyans found themselves living in deplorable conditions, having been duped by an agency named Elite Job Hub21 Agency.

The Senator informed the Senate that the victims were initially taken to Malaysia by Elite Job Hub21 Agency who had organized their travel, where they were made to work without proper contracts, adequate meals, or shelter. They endured harsh conditions for two months before being told they were essentially slaves who had been bought at an exorbitant price. When they demanded payment for their labor, they were dismissed without compensation.

The Senator observed that the stranded Kenyans sought help from the Kenyan Embassy in Malaysia but received no response. The Senator called for an inquiry by the Standing Committee on Labour and Social Welfare, to address the human trafficking issue and provide assistance to the affected Kenyans.

ii.) Nominated Senator (Sen. Betty Montet, MP) on behalf of Nominated Senator (Sen. Catherine Mumma, MP) made a statement concerning the sustainable exploitation of natural resources in Turkana County.

The Senator highlighted the constitutional obligations to ensure the sustainable management of the environment and the equitable distribution of benefits. The Senator observed that Turkana County, with its vast arable land and abundant natural resources, held immense potential for development if managed sustainably.

However, security issues, both internal and external, had hindered the exploitation of these resources, affecting activities like fishing, pastoralism, and mining. The Senator emphasized the need for affirmative measures to increase investment in resource management and urged for greater community engagement in decision-making processes to protect the interests of the local population.

She called upon the Senate to engage with relevant government bodies to assess existing affirmative actions, outline security measures for Turkana County, explore international cooperation to address cross-border issues, and evaluate community participation in resource exploitation decisions. The Senator concluded by stating that without these steps, Turkana County would continue to be marginalized, missing out on the development opportunities its abundant resources could offer to its residents and the nation at large.
