- 8. MOTION DECLARATION OF CATTLE RUSTLING AND BANDITRY AS A NATIONAL DISASTER AND ESTABLISHMENT OF A SPECIAL FUND FOR VICTIMS

(Sen. William Cheptumo, MP)

THAT AWARE THAT, cattle rustling/banditry is a major menace and security threat in the South and North Rift regions and some other regions of the country;

CONCERNED THAT, the menace has since left irreparable and negative socioeconomic impact which include but are not limited to increased number of widows, widowers, orphaned children, poverty, displacement of people leading to Internally Displaced Persons (IDPS), disruption of educational health programs and other economic activities owing to the destruction and/or closure of educational, health and other institutions;

FURTHER CONCERNED THAT, the people living in the affected regions have been denied the enjoyment of their social, economic and political rights as guaranteed to them under the Bill of Rights as enshrined in Chapter Four of the Constitution;

NOW THEREFORE, the Senate resolves that the National Government through the Ministry of Interior and National Administration and in collaboration with the Council of Governors:

- 1. Declares cattle rustling a National Disaster;
- 2. Establish a National Task force on cattle rustling/banditry to:
 - (i) Investigate the causes of the rampant cattle rustling and banditry in the said region and the Country at large;
 - (ii) Establishes the extent of suffering, loss and damage the cattle rustling/banditry has occasioned to the communities in all the affected Counties;
- 3. Create a Special Fund for mitigating the losses suffered by and in compensating all victims of cattle rustling/banditry and settle all internally displaced persons occasioned by the menace.

9. MOTION - ESTABLISHING OF A MONTHLY CAR FREE DAY AND COUNTY CAR FREE ZONES

(Sen. Crystal Asige, MP)

THAT, AWARE THAT Kenyans have a right to a clean and healthy environment pursuant to Article 42 of the Constitution;

NOTING THAT the National Climate Change Action Plan identifies transportation as the fourth largest contributor to greenhouse gas emissions, which if uncontrolled, will result to negative impact of climate change with adverse effect to millions of Kenyans;

CONCERNED THAT the number of private vehicles has significantly grown, leading to increased road accidents, carbon emission and vehicle congestion, costs of which are in excess of Kshs. 100 billion in GDP per year;

NOW THEREFORE the Senate urges the Ministry of Roads and Transport, Ministry of Environment, Climate Change and Forestry, in collaboration with the Council of Governors and the National Climate Change Council to –

- i.) identify, publicize and execute suitable monthly car-free days and County car-free zones in urban areas across the country;
- ii.) Identify and develop County car-free zones, also known as "pedestrians' precincts", in urbanized areas, where its infrastructure and activities are restricted to pedestrians alone;

- iii.) provide affordable, safe and universally designed public transport access to and around these car-free zones, including, but not limited to, development of Bus Rapid Transport (BRT) in the urban areas;
- iv.) design inclusive mobility infrastructure that supports non motorized transport facilities, such as pedestrian spaces, bicycle lanes and green spaces, within the Central Business District of every County; and
- v.) ensure inter-modal connectivity among the various transport modes.

QUESTIONS

Question No. 008

The Senator for Kirinyaga County (Sen. James Murango, MP) to ask the Cabinet Secretary for Lands, Public Works, Housing and Urban Development:

- a) Could the Cabinet Secretary provide a status report on the issuance of title deeds to public schools, particularly in Kirinyaga County?
- b) What measures have been put in place to expedite the issuance of title deeds to public schools in Kirinyaga County that are yet to receive them?

Question No. 017

The Senator for Marsabit County (Sen. Mohamed Chute, MP) to ask the Cabinet Secretary for Lands, Public Works, Housing and Urban Development: -

- a) Could the Cabinet Secretary indicate the respective value of each parcel of Government-owned land that has been designated for the Affordable Housing Project in Nairobi, Mombasa, Nakuru and Kisumu counties, and indicate how many of the said parcels are currently being or have been developed since 2017?
- b) What is the value of parcels of land assigned to respective developers for the construction of affordable housing, and could the Cabinet Secretary indicate the projected cost, per square meter, of each housing unit as well as the interest rate to be charged to buyers of the units?
- c) How many of the houses under the project are under Public-Private Partnership (PPP) arrangement, and could the Cabinet Secretary state the respective percentage contribution of the government vis-a-vis the developers?
- d) Could the Cabinet Secretary halt all transactions involving public land until a mutually beneficial formula to both the Government and developers is agreed upon?

- b) Could the Cabinet Secretary explain the circumstances under which the parcel of land came into the custody of a private developer, who has already commenced construction works?
- c) What measures has the Ministry put in place to reclaim public land that has been illegally acquired or encroached upon as well as generally forestall land grabbing?

- d) What measures has the Government put in place to safeguard dependents and property left behind by deportees, and could the Cabinet Secretary also explain the initiatives taken by the Government to facilitate the reintegration process for the deportees?
