Senators want Kenya Power monopoly upended due to high cost of electricity

enators have expressed their dissatisfaction with the management of Kenya Power and called for its reorganisation to make it efficient and competitive.

In particular, the lawmakers say the only way to boost efficiency in the national power distribution space is by ending the monopoly enjoyed by the utility company which has made it inefficient.

In a debate this week, Senators argued that in its current set up, Kenya Power management cannot innovate arguing the monopoly has led to the deeply entrenched inefficiency.

"There is no more thinking in Kenya Power because whether they are efficient or not, they will still sell electricity, they determine the tariffs. They will increase the rates as and when they wish. They will make us pay for loans for projects that have not succeeded," said Senator Jackson Mandago, as he called for the opening up of the sector for competition.

The lawmakers poured out their frus-

trations on the matter during debate on the Report of the Committee on Energy on its inquiry into the high cost of electricity in the country.

The House adopted the report.

While undertaking the inquiry, the Committee looked at the distribution, generation and consumption of electricity in Kenya.

The report was tabled in the Senate on Wednesday, September 17, 2023.

"We cannot have a nation that is not certain of its power simply because we have an institution that is a monopoly and has used this opportunity to be inefficient. Experience in this country has shown that there will be innovation if you open up to competition," added Senator Mandago.

Data at the Kenya Bureau of Standards (KeBS) and Economic Survey of 2023, indicate that about 87.5 per cent of all electricity generated in Kenya country is from a renewable source.

The Kenya Electricity Generating Company (KenGen) generates about 70 per cent of the energy consumed in Kenya, whereas the private power producers produce about 30 per cent.

However, the 30 per cent takes about 70 per cent of the cost that Kenyans pay for power production, the reason being that most of independent power producers were conceived at a time when the country needed to breach the gap between demand and supply.

Engaging Independent Power Producers (IPPs) was done to the disadvantage of the consumers. The Committee established that they were engaged through an arrangement that is famously known as the take or pay, which leaves Kenyans in a disadvantaged because even in the absence of generation or consumption, Kenyans still end up paying.

The Committee observed that the country lacks redundant power lines, a lapse that has contributed to the chal-

lenges related to ever present blackouts.

The Report proposes that the Government should invest in multiple distribution lines so that power can be dispatched. Overreliance on one substation in Suswa has become a major impediment and the Committee is proposing that the distribution of power should be relooked into.

The Committee further recommends that Kenya Electricity Transmission Company (KETRACO) and Kenya Power must be disengaged so that one will have the responsibility of supplying power while the other one will have the responsibility of having administrative control.

On the question of the existing licences entered with the independent power producers' the committee established that some of the agreements cannot be changed, hence disadvantaging the consumers.

It proposes that the agreements

should be renegotiated so that they can reduce the cost of power.

The report questions the management, accountability, transparency and governance of most of the state departments that are responsible for the distribution and generation of power, pointing out that they are wanting.

The report says there is need to start looking at how the procurement of these institutions is undertaken because it is imperative to put systems in place to increase transparency and accountability.

"This is one of the major impediments to the cost of power. We lose a lot of money through transmission losses and forex adjustments. Most of these are things that can be associated with accountability and governance issues," said Senator Wahome Wamatinga, the chair of the Committee on Energy, while moving the motion on the report.

Senator Mandago argued the only way to ensure that every Kenyan has access to power is by ending the Kenya Power monopoly.

"In the northern part of Kenya where we have no dams, we shall have people willing to invest in solar energy and supply electricity to citizens. Those in Moyale and Marsabit, where we have a lot of wind, will get energy through wind power," he submitted.

Senator Richard Onyonka said there is a cartel capture between KenGen, Kenya Power and Geothermal Development Company (GDC) and called for thorough investigation on the affairs of the Kenya Power.

"I plead with this House to disband Kenya Power and allow private companies to supply power. Let us test set the operational structures of these companies so that we can reduce the cost of power," argued the Senator.

While arguing that all Kenyans are tied to Kenya Power, whether in the office or at home, Senator Gloria Orwoba said it was time to discuss how to bring healthy competition in the industry.

"We can audit the IPPs and the operations, but the question remains, do we want to be held hostage? Do we want to stay in this situation where if KP wakes up today and they decide they want to play some shoddy business, we will all be stuck to it? No," she argued.

The Senator urged the House to go further and develop mechanisms to open up the sector for competition market.

"Competition is what we need when it comes to power producers and distributors. As much as we are contributing to this Report, it would be imperative that one of us actually comes up with a Bill. We need to perhaps legislate and ensure that we have competition in that space."

Senator Tabitha Mutinda also raised concern over KP's continued monopoly. "Any moment there is a monopoly, there is more disadvantage to the beneficiaries or the end user of the commodity, " she told the House.

"With different power suppliers, there will be innovation there will be more job opportunities that will be created. Where we are with KP is like a status quo. Nothing is new or exciting. There is nothing more in the market that is different."

Trade Committee wants funding for County Integrated and Industrial Parks Programme

The Committee on Trade, Industrialisation and Tourism has resolved to push the Government to avail funds for the County Integrated and Industrial Parks Programme which will provide the business community traders with the perfect environment to do business.

The National Government through the Ministry of Investment, Trade and Industry and County Governments in partnership with private sector, development partners have agreed to establish County Aggregation and Industrial Park (CAIP) in each County.

The development and implementation of the project is to be jointly accomplished between the National Government, Council of Governors and County Governments

"We have developed the Industrial Park Bill which are pushing as a committee. The Bill will go a long way in facilitating the management of the County Integrated and Industrial Park Programme," said Senator Crystal Asige

after the Committee adopted the report on its consideration of the 2024/25 Budget Policy Statement (BPS)

The committee vowed to follow up on the operations of the Hustler, Uwezo and Kenya Youth Employment Opportunities Programme (KYEOP) Funds to ensure they work efficiently for the benefit of the intended groups.

The Committee, which is chaired by Senator Seki ole Kanar, has been engaging state departments under its jurisdiction as it considered the 2024 Budget Policy Statement.

The state departments include the State Department of Cooperatives, the State Department of Trade, the State Department for Industry, the State Department of Micro, Small and Medium Enterprises Development, the State Department of Investment Promotion and the State Department for Tourism.

In its report, which was submitted to the Committee on Finance and Budget, the Committee urged the Ministry of Trade, Investments and Industry and

the Ministry of Tourism and Wildlife to prioritise its recommendations to ensure Kenyans benefit from the Government

"Over the years, we have been making good recommendations but min-

istries do not take them into account. The ministries involved should implement the recommendations so that we can help our people," said Senator Steve Lelegwe, a member of the committee.

Western Kenya Cane farmers support Sugar Bill

Fisheries Committee has started public participation to gather views on the Sugar Bill, 2022 currently before the House.

The Committee was in the Sugarcane growing areas of Kakamega and Bungoma where it engaged cane farmers on their views on the Bill.

Sponsored by Navakholo MP Emmanuel Wangwe, the Bill seeks to reinstate the Sugar Act which was repealed through the enactment of the Crops Act,

Among other proposals, the Bill seeks to restore the roles of the Kenya Sugar Board currently undertaken by the Sugar Directorate of the Agriculture and Food Authority (AFA).

The Bill further provides for the development, regulation and promotion of the sugar industry, to provide for the establishment, powers and functions of the Kenya Sugar Board.

Cane farmers from Western Kenya have supported the reinstatement of the Kenya Sugar Board to regulate the sector directly instead of operating through

Stakeholders in the sugar sector said

The Agriculture, Livestock and the Sugar Directorate lacks the autonomy to address challenges in the industry. The farmers also want the Kenya Sugar Board head office moved from Nairobi to western Kenya region in order to serve farmers better.

> Speaking at the forum, the Secretary-General of Kenya National Federation of Sugar Cane Farmers Kilion Osur Anyango said farmers should be free to supply their cane to whichever mill they preferred, as long as they did not have a contract with another mill.

> "Independent farmers should have 3-4 sugar mills within a region from which they will have freedom to supply their cane instead of being zoned to a particular mill," he explained.

> The stakeholders told the Committee that sugar reforms should include strict guidelines on importation of sugar into the country.

> His sentiments were supported by farmers who said the same has been left to cartels who have flooded the local market with cheap sugar.

> The chair of the committee Senator Murango, Senator David Wakoli and Nominated Senator Beth Syengo resolved to consider the farmers' views.

Housing Committee directs Governor Sakaja to submit details of rent collected in County houses

overnor Johnson Sakaja has told a Committee of the Senate that the County Government of Nairobi is not in possession of agreement between the Israel Government and the Government of Kenya for the construction of the estates through a Tenant Purchase Scheme Tenants of Jericho Estate in Nairobi have claimed that they were to take ownership of the Houses after 25 years of tenancy.

The tenants have not availed the said agreements.

"Nairobi City County Government has earmarked all the estates for redevelopment to provide additional housing for rental purpose and home ownership. This is in line with the Government's affordable housing agenda," said the Governor.

The governor made the comments when he appeared before the Committee on Roads, Transportation and Housing to discuss the issue of Nairobi urban regeneration and renewal programme.

He told the committee, chaired by Senator Karungo Thang'wa that the original plan for the estates were for the development of the social housing to cater for the low income earners.

But the new proposed redevelopment comprises 70 per cent affordable housing for low income earners and 30 per cent for high income earners due to the shortfall experienced in the high and middle income bracket as well.

The County Government of Nairobi has awarded seven contracts for regeneration and renewal of old estates, however the titles deeds of the estates estimated to be 4000 acres are still under processing.

The Governor said the City County is not giving free houses but the rent paid since occupation of the housing units will be used to get the tenants houses.

"All concerns should be dispensed with before the regeneration projects are launched." Said Nairobi Senator Edwin Sifuna.

The Governor was given two weeks to furnish the committee with statement of rent collected by the County Government of Nairobi since 1985 for Ofafa Jericho, 1988 for Jericho Lumumba and 1990 for Ofafa Maringo Estates.

PSC satisfied with academic progress at CPST, promises to raise the bar higher

he Board of the Centre of Parliamentary Studies and Training (CPST) has expressed satisfaction with the success the institution has achieved in the 13 years of its existence, promising to raise the bar higher, sustain the achievements and make the institution a centre of global excellence.

"This should not be the end for you," she told the graduands drawn from the different departments of the three services of the PSC – Senate, National Assembly and Parliamentary Joint Services.

"Open up your mind so that your brain can function. Be like a parachute which functions well when it is unfurled."

The event was attended by other Commissioners Joyce Korir (Vice chair), who represented PSC chairman, Dr Moses Wetangula, the Speaker of the National Assembly, Patrick Makau and Mishi Mboko.

Commissioner Korir reminded the graduands though they have acquired the new skills, there is room for them to continue advancing themselves through regular trainings

"Let me commend you all for stepping up to take this course," she said, even as she acknowledged the sdacrifice they had made to go back to acquire the skills

"It is all about commitment. Take the initiative and increase your knowledge. Knowledge acquisition is a continuous process and it should not end here."

"We have different reports and Bills that we will be considering in our sessions here in the country which mainly involve oversight of different partner states," said Speaker Joseph Ntakirutimana when he addressed journalists at Parliament Buildings, Nairobi.

The Assembly has lined up six Bills and will also consider five reports aimed at addressing several challenges affecting the member states.

The session marks the Assembly's return to Nairobi following its last sitting more than five years ago, in 2018.

Apart from five bills, there are motions, oversight reports to be considered, petitions and questions to be responded to by the EAC Council of Ministers.

The five Bills lined up for debate besides seven oversight reports and six motions that are slated for resolutions.

The Bills are East African Statistics Bureau Bill, 2017, The East African Community Surveillance, Compliance and Enforcement Commission Bill, 2022 and The East African Community Financial Services Commission Bill, 2022 which are sponsored by the EAC Council of Ministers.

There is also the EAC Creative and Cultural Industries Bill, 2015 and East African Community Pharmaceuticals Bill, 2019, both which are sponsored by.....

The Council of Ministers is expected to respond to questions regarding the implementation of the East African Community (EAC) Treaty.

The highlight of the session will be the official address to the Assembly by President William Ruto on Tuesday, March 5, 2023.

As a member of the EAC Summit of Heads of State, a President's address are influential in providing policy direction to the Assembly and its committees.

Rotational sittings offer a unique chance for the Assembly to be addressed by Heads of State of a member country and provides valuable insights and direction from the Summit, a key EAC decision-making organ.

The session will foster collaboration between the Assembly and Kenya Parliament in line with Article 65 of the EAC Treaty. Members of Kenya's National Assembly and Senate, along with members of diplomatic corps from other EAC Partner States have been invited to attend.

The session will provide EALA the platform to directly connect with the Kenyan public, raise awareness about its work and increase its visibility.

A dispatch from the Assembly notes that Nairobi serves as a strategic anchor

for the East African Community (EAC) and the session is not merely a procedural matter; it holds symbolic and practical importance to the EAC integration.

"The EALA's plenary session in Nairobi serves as a timely reminder of the city's pivotal role in driving East African integration forward. It provides an opportunity to increase visibility, strengthen bonds with Kenyan institutions, and receive direct guidance from regional leaders," reads the dispatch from the Assembly which sits in Arusha, Tanzania.

Government to construct 100 dams under PPP, CS Njeru tells Senate

The Government has promised to construct 100 dams in the next five years under the Public-Private Partnership (PPP) programme.

The Water, Sanitation and Irrigation Cabinet Secretary Zachariah Njeru told the Senate on Wednesday that aim of the project is ensure stability in the supply of safe drinking water.

"We are still receiving proposals. We will go through all the proposals. I want to assure this House that something is happening as far as the 100 dams are concerned," said CS Njeru on the floor of the House.

The CS revealed that his Ministry has submitted a proposal concerning Kamumu Dam to the United Kingdom Accreditation Forum (UKAF) for review.

"We are hopeful that these dams will be implemented after they go through the initial stage of the proposal. We have 100 dams that are on course and which we will implement. We are looking for people who we can partner with to make sure that we realise the implementation."

The CS was responding to Questions raised by Senator James Murango who wanted the Ministry to provide details of all water projects budgeted for by the National Government in Kirinyaga County in the 2023/24 financial year.

The lawmaker also wanted to know whether the government has plans to supply water to residents of Muratiri area in Gichugu Constituency through the Kerugoya-Kutus Water Supply Project by installing additional water distribution pipes.

CS Njeru told the House the national Government has allocated Sh135 million for the construction of Ngariama-Njuki-ini water supply in the 2023/24 financial year.

The project is being implemented by the Tana Water Works Development Agency (TWWDA).

The Project is located in Ngariama

and Njukiini wards of Gichugu Constituency and upon completion, it will benefit the same wards with clean and portable water.

The targeted beneficiaries are approximately 14,000 households including major learning institutions in the supply area.

The project commenced in March 2023, with a contract duration of 18 months and will be completed in September, 2024.

"Works are currently ongoing. However, the project has experienced challenges which has contributed to the slow progress of work."

The Ministry has already received an allocation for the first quota, amounting to Sh4 billion to be disbursed to the Water Works Development Agencies (WWDAs) to help improve water supply across the country.

Agriculture Ministry developing rules to streamline management of sugar weighbridges, CS Linturi tells House

The Ministry of Agriculture is in the process of making regulations to provide for the management of weighbridges, Cabinet Secretary Mithika Linturi has said.

This, he said, will ensure fairness and efficiency in the sugarcane production.

The CS told the Senate that his Ministry is not aware of the existence of syndicates engaged in theft of cane at weighbridges and buying centers.

"If issues of theft have been detected, it is prudent to report to the relevant authorities for necessary actions to be taken," the CS told the House.

The CS was responding to questions by Senator Tom Ojienda who wanted to know what the Ministry is doing to deal with the syndicates involved in the theft of cane at weighbridges while in transit to sugar factories.

Senator Ojienda says the theft has a huge impact on sugarcane farmers.

He challenged the CS to explain if there are plans by the Cabinet Secretary to compensate sugarcane farmers and hold accountable the persons involved.

Mr Linturi told the House that he had directed the Agriculture and Food Authority (AFA) and specifically the Sugar Directorate, to investigate the allegation of cane theft and make recommendations for implementation if malpractices are detected.

"I ask farmers whose cane has been stolen to report to the various law enforcement agencies because theft is criminal. The culprits will be dealt with properly within the criminal justice system for the farmers to get justice," said the CS.

Deputy Minority Leader Enoch Wambua challenged the CS to explain the progress the government had made in securing and protecting farmers from predatory cartels.

"We are getting crops out of our farms now but we have been invaded by cartels. What protection are we getting from the Government? What is the Government doing to ensure that farmers do not continue to suffer at the hands of

these cartels?" asked Senator Wambua.

Citing the Presidential directive, which mandates government agencies do what is practically possible to ensure the interests of farmers are safeguarded from exploitation, the CS told the Ministry is addressing the issue.

"There is no quick fix. We are progressively getting there," he said even as enumerated areas where the state has moved into kick out cartels.

Through the Strategic Food Reserve Regulations, the Ministry has classified food crops that are to be identified as strategic food reserves. Besides cereals like maize, beans and pulses, milk has also been included.

"We were doing this because we want

to make sure that as we prepare or maintain our food balance sheet and stocks, we can off-take from farmers what is produced in excess. That way, we can easily provide the budgets to buy them as food strategic reserves for a rainy day.

The Ministry is also implementing the warehouse receipt system. Under this system, when farmers harvest and they do not want to sell immediately, the government intervenes by ensuring that the harvest is properly stored.

Farmers can deposit their harvest for storage in NCPB and get a receipt which will allow them to sell at the appropriate time

"These are some of the immediate measures we have put in place to ensure that our farmers are not exploited."

Representation: Senators raise concern on issues concerning their constituents

s part of their representative role, a number of Senators took to the floor of the House this week to request for answers from the government Ministries on weighty issues affecting their constituents and the country at large.

The issues of concern to the legislators range from health care, education, land and the environment.

Senator Joe Nyutu has sought a statement from the Committee on Health regarding the status of medical equipment supplied by Mega Scope to Level Five Hospitals across the country.

Specifically, the Senators wants the Committee on Health to provide details on the CT-Scan and X-Ray machines.

The lawmaker wants the Committee to clarify the reasons behind the breakdown of the machines and the status of their repair.

He wants the Committee to explain plan laid out to address the breakdown of this critical diagnostic equipment which have severely hampered healthcare services and the measures taken to expedite the repair and ensure that they are operational.

The Senator further wants the State Department for Medical Services to explain how it will ensure that such incidents affecting service delivery in hospitals do not reoccur.

Senator Fatuma Dullo wants information related to the state of the morgue at the Isiolo County Referral Hospital.

The legislator says in the last one year, four machines in the morgue have broken down, leaving 32 bodies unrefrigerated which has caused severe health hazard.

The Senator says there is a crisis at the Hospital and wants the Health Committee, which is chaired by Senator Jackson Mandago, to explain the action being taken to resolve the crisis at the morgue.

She wants to know why the morgue has not been operational for the last one year despite Isiolo County Health Department receiving the highest budget allocation.

"The Committee should outline steps the county is taking to ensure the

facility is efficient in service delivery and its capacity improved," said Senator Dullo when she sought the statement on the floor of the House.

She wants morgue closed immediately as the county seeks a lasting solution to the challenges it is facing.

The renewed wave of banditry attacks along the Meru-Isiolo Border has caught the attention of **Senator Kathuri Murungi**, who is also the Deputy Speaker.

At least 50 people lost their lives in the latest attacks that happened earlier in the week, a total of 6,000 heads of cattle were stolen besides destruction of property and disruption of normal activities for the people living in the areas.

Senator Murungi is now calling upon the Committee on National Security, Defence and Foreign Relations to explain the security lapses that may have led to the attacks.

The Committee is also expected to outline interventions the Government has made to compensate families that have lost their loved ones, livestock and property, giving timelines within which compensation shall be granted.

The committee will also state measures being taken to reinforce security, restore sanity and peace in the affected areas and the long-term plans being taken to end the attacks in the affected areas.

Senator Johnes Mwaruma is seeking a statement on the boundary dispute between residents of Marungu Village and Oza Group Ranch, in Taita-Taveta County.

The lawmaker wants the Committee on Land, Environment and Natural Resources to provide the House with requisite ownership documents for all parcels of land owned by Oza Group Ranch, in Wundanyi Subcounty, stating the total acreage of the land.

Other documents he wants tabled in the House include survey maps of parcels of land owned by residents of Marungu Village in the subcounty and Oza Group Ranch, indicating the geographical boundaries of each parcel.

He also wants the committee to pro-

vide steps taken by the government to resolve the land boundary dispute between the residents of Marungu Village and Oza Group Ranch.

Senator Agnes Muthama is seeking information on the release of capitation funds to universities in the country.

The Senator wants the Committee on Education to explain circumstances that led to the delay in the release of the funds to universities countrywide, providing remedial interventions aimed at addressing the delays.

She wants a detailed report on capitation funds received by each university since 2019/20 financial year submitted to the House, detailing the total outstanding capitation and pending bills covering the said financial year for all the universities nationally.

"The Committee should indicate the number of government-sponsored students admitted by the Scott Christian University and capitation fund grant received by the university since 2019/20 financial year," said the Senator in her request for the statement.

The committee should show any balance owed to the University by the Government and the strategies and measures taken by the Ministry of Education to ensure that both public and private universities admitting Government sponsored students, receive capitation funds and grants to ensure uninterrupted learning.

Senator Tabitha Mutinda wants the House to be furnished with details of infrastructure at Mwiki primary School in Githurai, Nairobi, which holds over 4,000 learners.

She wants details of the total number of learners relative to the land on which the school stands.

The Senator wants the Committee on Education to outline any protocols implemented by the Ministry of Education to address the safety and health risks associated with overcrowding at the school, stating government intervention meant to step up the construction of classrooms and other essential infrastructure such as boarding and sanitation facilities to match the increasing number

of learners.

In particular, the Senator wants the Committee to explain measures put in place by the Government to mitigate against over enrollment in public schools which strains existing facilities and exposes learners to safety and health risks.

She also wants the committee to highlight measures put in place to ensure strict enforcement of the Ministry of Education's safety and health guidelines in all schools.

Senator Ledama ole Kina wants the House furnished with details of the status of tourism and the lease agreements entered into by proprietors in the greater Maasai Mara, the Mara Triangle and the County Government of Narok.

The Minority Whip wants the Committee on Trade, Industrialisation and Tourism to provide a list of all lodges and camps operating within the Triangle, their locations and accommodation capacity.

He also wants the House given the lease agreements between the County Government of Narok and the proprietors of the lodges and camps within the area, detailing specific obligation placed on the proprietors to Narok residents who reside within the environs of the park.

"The Committee should provide details of the lease agreement between the County Government of Narok and MGM Methu Hotels to manage and operate Keekorok Lodge," he said.

He also wants the Committee to provide details of the shareholders and shareholding structures of the company, stating whether there are any loans guaranteed by the County Government and indicate whether the company is registered in Kenya.

The Senator also wants the ownership documents for Keekorok Lodge in Maasai Mara provided. This should include the title deed and the list of all the revenue streams and the value generated from the lodges and the camps for the past two years. This should include bed night fees, royalties and lease ground fees.
