#### 5. **MESSAGES**

The Speaker conveyed the following Messages: -

### i) From the National Assembly on the adoption, by the National Assembly, of the report of the National Dialogue Committee

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 46 (3) and (4), I received the following Message from the Speaker of the National Assembly with respect to the Resolution of the National Assembly on the Report of the National Dialogue Committee.

The Message, which is dated 29<sup>th</sup> February, 2024 was received on Wednesday, 5<sup>th</sup> March, 2024 in the Office of the Clerk of the Senate.

Pursuant to the said Standing Order, I now report the Message-

"PURSUANT to the provisions of Standing Order 41(1) of the National Assembly Standing Orders, I hereby convey the following Message from the National Assembly-

WHEREAS, the National Assembly and the Senate, on Wednesday, 16<sup>th</sup> August 2023 and Tuesday, 29<sup>th</sup> August 2023, respectively, considered and passed a resolution on the establishment of a National Dialogue Committee, which was mandated to facilitate dialogue and consensus building and recommend appropriate constitutional, legal and policy reforms on issues of concern to the people of Kenya, to be framed by the Committee;

AND WHEREAS, the National Assembly and Senate, by resolutions passed on Tuesday, 17<sup>th</sup> October 2023 and Wednesday, 18<sup>th</sup> October 2023, respectively, extended the mandate of the National Dialogue Committee by a further thirty (30) days from 28<sup>th</sup> October 2023 consequent to which, the Committee would report to the leadership of Kenya Kwanza and Azimio Coalitions on or before 26<sup>th</sup> November 2023 and thereafter submit its Report to Parliament;

FURTHER WHEREAS, the National Assembly, by a resolution passed on Thursday,  $22^{nd}$  February 2024, adopted the Report of the National Dialogue

Committee, laid on the table of the National Assembly on Thursday, 7<sup>th</sup> December 2023;

NOW THEREFORE, in accordance with the provisions of Standing Orders 41(1) of the National Assembly Standing Orders, I hereby convey the said Resolution of the National Assembly to the Senate for consideration."

Honourable Senators,

As you may be aware, the Senate, by a resolution passed on Wednesday, 21<sup>st</sup> February 2024 (afternoon sitting), also adopted the Report of the National Dialogue Committee laid on the Table of the Senate on Wednesday, 14<sup>th</sup> February, 2024.

This decision was communicated to the National Assembly vide a Message dated 23<sup>rd</sup> February, 2024.

## ii) From the County Assembly of Kisii on the approval of a Motion on the proposed removal from office, by Impeachment, of H.E Hon. (Dr.) Robert Onsare Monda, the Deputy Governor of Kisii County

"Honourable Senators,

I wish to report to the Senate that I have, pursuant to Standing Order 48 (4), received a Message from the Speaker of the County Assembly of Kisii regarding the removal from office, by way of impeachment, of H.E Hon (Dr.) Robert Onsare Monda, the Deputy Governor of Kisii County.

The Message was conveyed to the Senate via a letter dated Friday, 1st March 2024 signed by the Speaker of the County Assembly of Kisii and received in my Office on Saturday, 2nd March 2024 indicated that the County Assembly had passed the resolution to remove the Deputy Governor from office, pursuant to Article 181 (1) (a) & (c) of the Constitution as read together with Section 33 of the County Governments Act and Standing Orders 60 and 61 of the Kisii County Assembly Standing Orders, by a majority of 53 votes out of 70 on the following grounds:-

1. Gross Violation of the Constitution or any other law

The particulars of this allegation are that the Deputy Governor –

- (i) Violated Articles 10, 73, 75, and 232 of the Constitution of Kenya by soliciting and receiving a bribe to influence the recruitment process at the Gusii Water and Sanitation Company (GWASCO); and
- (ii) Breached the Leadership and Integrity Act sections 8, 9, 10, 11, 24, 32, 34 and Public Officer Ethics Act sections 9, 11(1), 11(2)(a)(i), (c)

by compromising the integrity of a public recruitment institution for personal gain.

- 2. Abuse of Office
- 3.

The particulars of this allegation are that the Deputy Governor -

- (i) Used his position to solicit Kenya shillings eight hundred thousand (Kshs. 800,000) thereby, conferring a financial benefit upon himself and attempting to influence GWASCO's hiring decision by sending Kenya shillings one hundred thousand (Kshs. 100,000) to its Managing Director, violating Articles 10, 27, 73 (2) (b), 75 and 232 of the Constitution, sections 8, 9, 10, 11, 13, 24, 32, and 34 of the Leadership & Integrity Act, section 11(1), (2)(a)(i), (c) of the Public Officers & Ethics Act and section 6(1)(a), (c), (2) (3) of the Bribery Act; and
- (ii) Unlawfully diverted county enforcement officers to work on his farm and misused executive power to target his relative.

#### 4. Gross Misconduct

The particulars of this allegation are that the Deputy Governor contravened Article 75 of the Constitution by attempting to influence the appointment process for the position of Commercial Manager at GWASCO by offering a bribe to its Managing Director, Ms. Lucy Wahito Wachira.

#### 5. Crimes Under National Law

The particulars of this allegation are that the Deputy Governor breached the Bribery Act section 6(1)(a), (c), (2) (3) by soliciting and receiving bribes of Kenya shillings eight hundred thousand (Kshs 800,000) and sending Kenya shillings one hundred thousand (Kshs 100,000) to the managing director of GWASCO so as to influence the award of a contract of employment to a preferred interviewee.

The letter further stated that the Hansard recordings of the Assembly proceedings of 29<sup>th</sup> February, 2024 would be submitted to the Senate on Friday, 8<sup>th</sup> March, 2024.

Honourable Senators,

In terms of Article 181 of the Constitution, Section 33(3)(a) of the County Governments Act, 2012 and Standing Order 80(1)(a) of the Senate Standing Orders, the Speaker of the Senate is required "within seven days after receiving notice of a resolution from the Speaker of a County Assembly to convene a meeting of the Senate to hear charges against the Governor."

Pursuant to Section 33(3)(b) of the County Governments Act and Standing Order 80(1)(a) of the Senate Standing Orders, I hereby proceed to read the charges against the Deputy Governor of Kisii County, as contained in the Motion of Impeachment by the County Assembly of Kisii.

1. Charge 1: Gross Violation of the Constitution or any other law

The particulars of this allegation are that the Deputy Governor -

- (i) Violated Articles 10, 73, 75, and 232 of the Constitution of Kenya by soliciting and receiving a bribe to influence the recruitment process at the Gusii Water and Sanitation Company (GWASCO); and
- (ii) Breached the Leadership and Integrity Act sections 8, 9, 10, 11, 24, 32, 34 and Public Officer Ethics Act sections 9, 11(1), 11(2)(a)(i), (c)by compromising the integrity of a public recruitment institution for personal gain.

#### 2. Charge 2: Abuse of Office

The particulars of this allegation are that the Deputy Governor –

- (i) Used his position to solicit Kenya shillings eight hundred thousand (Kshs. 800,000) thereby, conferring a financial benefit upon himself and attempting to influence GWASCO's hiring decision by sending Kenya shillings one hundred thousand (Kshs. 100,000) to its Managing Director, violating Articles 10, 27, 73 (2) (b), 75 and 232 of the Constitution, sections 8, 9, 10, 11, 13, 24, 32, and 34 of the Leadership & Integrity Act, section 11(1), (2)(a)(i), (c) of the Public Officers & Ethics Act and section 6(1)(a), (c), (2) (3) of the Bribery Act.
- (ii) Unlawfully diverted county enforcement officers to work on his farm and misused executive power to target his relative.

#### 3. Charge 3: Gross Misconduct

The particulars of this allegation are that the Deputy Governor contravened Article 75 of the Constitution by attempting to influence the appointment process for the position of Commercial Manager at GWASCO by offering a bribe to its Managing Director, Ms. Lucy Wahito Wachira.

#### 4. Charge 4: Crimes Under National Law

The particulars of this allegation are that the Deputy Governor breached the Bribery Act Section 6(1)(a), (c), (2) (3) by soliciting and receiving bribes of Kenya shillings eight hundred thousand (Kshs 800,000) and sending Kenya shillings one hundred thousand (Kshs 100,000) to the Managing Director of GWASCO so as to influence the award of a contract of employment to a preferred interviewee.

Honourable Senators,

In terms of the way forward following the reading of the charges against the Deputy Governor, Standing Order 80(1)(b) of the Senate Standing Orders, as read together with Section 33(3)(b) of the County Governments Act, gives the Senate two options on how to proceed with the matter.

"The Senate may –

- (a) by Resolution, appoint a Special Committee comprising eleven of its members to investigate the matter; or
- (b) investigate the matter in plenary."

The Senate Majority Leader will, at an appointed time during this sitting, give a Notice of Motion for the establishment of a Special Committee. Should this Motion be carried, the Special Committee will be required, under Section 33(4) of the County Governments Act and Standing Order 80(2) of the

Senate, to investigate the matter and to report to the Senate on whether it finds the particulars of the allegations against the Governor to have been substantiated.

In the event that the Motion for the establishment of a Special Committee does not pass, the fall-back position is that the Senate shall proceed to investigate and consider the matter in Plenary. In this event, I will appoint the dates on which the Senate will sit in Plenary to hear and determine the charges against the Governor.

#### Honourable Senators,

It is noteworthy, and I wish to emphasize to all Honourable Senators, that when we come to the debate on the Motion for the establishment of the Special Committee, debate on the Motion shall be limited to the substance of the Motion, principally, whether or not to establish the Special Committee. It will not be a debate on the substance of the impeachment or its merits, propriety, prudence or even the constitutionality or the legality of the processes that have preceded the submission of this matter to the Senate. It is, therefore, not permissible to deviate to any issues other than the Motion before the Senate.

In the meantime, and during the pendency of the Impeachment process in the Senate, I wish to caution Honourable Senators to desist from publicly commenting on the merits or demerits of the impeachment Motion before the Senate. Doing so would amount to anticipation of debate, which is an infringement of Standing Order 99. Therefore, it shall be out of order, within the meaning of Standing Order 122, for any Senator to make comments, whether written or spoken, in relation to the conduct of the Deputy Governor or the impeachment process, outside the confines of the impeachment proceedings as such comments may prejudice the just outcome of the process.

#### Honourable Senators,

This is the fourth impeachment hearing in the 13<sup>th</sup> Parliament, and the second one involving a Deputy Governor. In undertaking this mandate, the Senate will be sitting as a quasi-judicial body and will conduct investigations into the alleged infractions of the Constitution and the law, and thereafter make its determination on the matter.

As such, this is a reminder that the impeachment hearing is not just a procedural formality but a fundamental process that plays a crucial role in upholding the principles of democracy and good governance. This hearing is one of the most crucial oversight tools and roles of the Senate.

I conclude by urging all Honourable Senators to exercise the highest level of responsibility on this matter.

#### 10. QUESTIONS AND STATEMENTS

#### Statements made pursuant to Standing Order 52(1)

i) The Senator for Nandi County (Sen. Samson Cherarkey, MP) made a Statement on a matter of general topical concern and national importance on the outstanding performance of the Kenyan team at the Tokyo Marathon 2024, which took place on Sunday, 3<sup>rd</sup> March, 2024.

The Senator highlighted the athletes' dominant performance, notably Benson Kipruto's outstanding victory, which set a new course and Japanese all-comers record with an incredible time of 2:02:16. Timothy Kiplagat followed closely in second place, with Vincent Kipkemboi Ngetich completing the Kenyan sweep by securing third place. The Senator emphasized that the victory not only showcased Kenya's preeminence in long-distance running but also built upon Kipruto's prior achievements, including his win at the Chicago Marathon in 2022 and his second-place finish in 2023, highlighting the continuing excellence and global competitiveness of Kenyan athletes.

Moreover, the Senator took the opportunity to extend his warm congratulations to Rosemary Wanjiru for her impressive second-place finish in the women's race.

Acknowledging the significance of these remarkable achievements, the Senator urged the Senate to facilitate a session where the athletes could address the legislative body, ensuring their efforts and successes are aptly acknowledged and celebrated.

Additionally, he urged relevant sports authorities to uphold transparency and integrity in team selection and management, particularly as they prepare for the upcoming Olympics in Paris and to remain vigilant against doping and other unethical practices that tarnish the reputation of the athletes and the nation as a whole.

ii) Nominated Senator (Sen. Veronica Maina, MP) made a Statement on a matter of general topical concern, on advancing and protecting the rights and status of women in Kenya in light of the upcoming International Women's Day.

The Senator underscored the significance of the Two-Thirds Gender Rule as a pivotal element in the quest for gender equality in leadership positions. She noted that, despite significant progress, Kenya still faces challenges in fully implementing this key principle. She paid tribute to the invaluable contributions of Kenyan women to the country's development, recognizing their roles across various sectors, from vibrant marketplaces and corporate boardrooms to productive farmlands, underscoring women as the backbone of Kenya's socio-economic structure.

Reiterating her dedication to enhancing women's participation at all levels of governance, Sen. Maina called for the removal of systemic obstacles that limit

women's opportunities and achievements. She stressed the importance of valuing the diverse perspectives and experiences of Kenyan women to promote a more inclusive society.

The Senator, while emphasizing the critical role of education for girls, advocated for it as essential for enhancing Kenya's resilience and economic growth. She urged for concerted efforts to make the Two-Thirds Gender Rule a tangible reality in the Senate.

Additionally, Sen. Maina addressed the severe issue of violence against women, with a particular focus on femicide. She outlined plans to forge a safer world where women are free from fear and violence, aiming to eradicate femicide. Through awareness, advocacy, and investment in a safer future, she envisioned creating a society where every woman feels secure and esteemed.

iii) Nominated Senator (Sen. Hamida Kibwana, MP) made a Statement on a matter of general topical concern on celebrating the achievements and contributions of women from all walks of life, with a special focus on the women leaders in Kenya Women Senators Association (KEWOSA), on the occasion of the International Day of Women.

The Senator highlighted the indomitable resilience, leadership and achievements of Kenyan women in promoting gender equality and empowering women and girls. She said that despite facing historical and ongoing challenges such as systemic obstacles, the disproportionate effects of climate change and gender-based violence, women in Kenya had shown remarkable strength and unity.

The Senator gave special commendation to the leadership shown by women in KEWOSA, noting their substantial legislative efforts during the Thirteenth Parliament. She recognized them for their active roles in sponsoring legislative business aimed at enhancing the well-being of women and girls nationwide. The transformative leadership of women governors was also acknowledged, with specific acknowledgement of Governor Gladys Wanga of Homa Bay County for her initiatives in spurring economic growth and fostering international cooperation.

Additionally, the Senator celebrated the accomplishments of Kenyan women on the international stage, including those holding prestigious roles such as the Senior Presidential Producer at the White House and the Chief of Staff in the Office of the Secretary-General of the Organisation of African, Caribbean, and Pacific States (OACPS).
