**APPOINTMENT OF SENATORS TO THE MEDIATION COMMITTEE ON  
THE DIVISION OF REVENUE BILL (NATIONAL ASSEMBLY BILL NO.  
14 OF 2024)**

**WHEREAS**, the National Assembly passed the Division of Revenue Bill (National Assembly Bill No. 14 of 2024) and referred it to the Senate for consideration in accordance with Article 110 of the Constitution;

**AND WHEREAS**, on 2<sup>nd</sup> May 2024, the Senate considered and passed the Bill **with amendments**, which were subsequently rejected by the National Assembly on 13<sup>th</sup> May 2024, thereby committing the Bill to mediation in accordance with Article 112 of the Constitution;

**FURTHER WHEREAS**, on 13<sup>th</sup> May 2024, in accordance with the provisions of Article 113 of the Constitution and Standing Order 149, I nominated nine (9) Members of the National Assembly to the Mediation Committee to consider the Bill;

**RECALLING THAT**, by a Resolution passed on 14<sup>th</sup> February 2024 and further pursuant to the provisions of Standing Order 41, the House ordered that during the Short and Long Recesses of the Third Session, upon receipt of any Message from the Senate, the Speaker **shall forthwith cause the Message to be transmitted to every Member** and report such fact to the House upon resumption;

**NOW THEREFORE, IT IS NOTIFIED** to all Members of the National Assembly and the general public—

**1. THAT,** the Speaker of the Senate has nominated the following Senators to the Mediation Committee on the Division of Revenue Bill (National Assembly Bill No. 14 of 2024)—

- 1) Sen. Kathuri Murungi, MGH, MP;
- 2) Sen. (Dr.) Boni Khalwale, CBS, MP;
- 3) Sen. Fatuma Dullo, CBS, MP;
- 4) Sen. Jackson Mandago, EGH, MP;
- 5) Sen. Mohamed Chute, MP;
- 6) Sen. Edwin Sifuna, MP;
- 7) Sen. Moses Kajwang', MP;
- 8) Sen. Agnes Muthama, MP; and
- 9) Sen. Eddy Oketch, MP.

**2. THAT,** pursuant to the provisions of Standing Order 41(6) and the Resolution of the House of 14<sup>th</sup> February 2024, the Mediation Committee is urged to expeditiously commence the mediation process and report to the Houses of Parliament within the constitutional timelines; and

**3. THAT,** the Clerk is directed to—

- a) circulate this Notification to all Members of the National Assembly and accordingly facilitate the Mediation Committee to undertake the exercise; and
- b) prepare the necessary Message for formal conveyance to the House upon its resumption on 4<sup>th</sup> June 2024.
