6. QUESTIONS AND STATEMENTS

a) Statements pursuant to Standing Order 52 (1)

i.) Nominated Senator (Sen. Hamida Kibwana, MP) made a Statement concerning the historic appointment of Major General Fatuma Ahmed as the first female Service Commander of the Kenya Airforce.

The Senator highlighted that the appointment of Maj. Gen. Fatuma Ahmed was a milestone achievement that not only marked a significant moment in the annals of the country's military history, but also stood as a beacon of inspiration for women across the nation. As the Chairperson of the Kenya Women Senators Association (KEWOSA), the Senator expressed immense pride in Maj. Gen. Fatuma Ahmed's accomplishment, noting that her appointment reflected the growing recognition of women's capabilities in a traditionally male-dominated sector and underscored the strides being made towards gender equality and women's empowerment in Kenya.

The Senator celebrated Maj. Gen. Fatuma Ahmed's accomplishments as a win not just for her but for all Kenyan women striving for excellence and equality in every sphere of society. She concluded by calling upon other Senators to join her in congratulating Maj. Gen. Fatuma Ahmed for a well-deserved appointment.

ii.) The Senator for Tana River County (Sen. Danson Mungatana, MP) made a Statement concerning the Mental Health Awareness Month which is observed worldwide in May.

In the Statement, the Senator informed the House that the initiative aims to educate the public about mental illnesses, raise awareness about research and treatments, reduce stigma, understand the impact of mental health issues on individuals, families and society as well as celebrate recovery. The Senator highlighted that in Kenya, mental health was increasingly being acknowledged as a crucial aspect of well-being, though awareness and education on the topic remain insufficient. Factors such as stigma, lack of awareness of mental health symptoms, and limited resources often prevent people from seeking medical assistance.

The Senator pointed out that during the designated Mental Health Awareness Week from 13th to 19th May, 2024, the theme "Movement: Moving more for our mental health" was highlighted. The Senator encouraged Kenyans to incorporate physical activity into their daily routines, suggesting simple activities like walking, dancing, or chair exercises. The Senator stressed that regular movement was essential for mental health, boosting mood, self-esteem, reducing stress and anxiety, and improving sleep.

The Senator concluded by encouraging everyone to find joy in movement and to make social connections through active engagements. The Senator urged Kenyans to be mindful of how movement affects their mental and physical well-being, and to use the awareness month to learn more about mental health, build coping mechanisms, and advocate for better mental health practices within their communities.
