### 8. QUESTIONS AND STATEMENTS

a) Statement pursuant to Standing Order 52(1)

Nominated Senator (Sen. Hamida Kibwana, MP) made a Statement on the International Day to end Obstetric Fistula and Mental Health Awareness Month.

The Senator informed the House that the International Day to End Obstetric Fistula was observed on May 23<sup>rd</sup> with the theme "Breaking the Cycle: Preventing Fistula Worldwide," and that the Mental Health Awareness Month was being observed in the month of May, with the theme "Mental Health is a Universal Human Right."

In the Statement, the Senator highlighted the physical and mental health challenges faced by women suffering from obstetric fistula, stressing the need for comprehensive maternal healthcare and psychological support. She pointed out the existence of stigma and discrimination surrounding fistula and mental health, which leads to social exclusion and barriers to seeking help.

The Senator proposed a multifaceted approach to address the issue, which includes enhancing access to skilled birth attendants, emergency obstetric care and timely surgical interventions to prevent fistula, along with providing reconstructive surgery and post-operative care for affected women. Additionally, she suggested integrating mental health support into maternal healthcare programs and emphasized the importance of raising awareness about obstetric fistula and mental health within communities, to foster a supportive environment and challenge misconceptions.

In conclusion, the Senator urged the Senate to participate in initiatives that raise awareness about the issue, reaffirming the commitment to health as a universal human right. She also urged for the promotion of comprehensive healthcare for both physical and mental well-being for a more inclusive and equitable society.
