5. <u>MESSAGE FROM THE NATIONAL ASSEMBLY – DECISION OF THE</u> <u>NATIONAL ASSEMBLY ON THE SENATE AMENDMENTS TO THE NATIONAL</u> <u>RATING BILL (NATIONAL ASSEMBLY BILLS NO. 55 OF 2022)</u>

I wish to report to the Senate that I have, pursuant to Standing Order 46(3), received the following Message from the Speaker of the National Assembly regarding the decision of the National Assembly on the Senate Amendments to the National Rating Bill (National Assembly Bills No. 55 of 2022).

The Message, dated Wednesday, 24th July, 2024, was received in the Office of the Clerk of the Senate on the same date.

Pursuant to Standing Order 46(4), I now report the Message -

"PURSUANT to the provisions of Standing Order 41(1) and 148(b), I hereby convey the following Message from the National Assembly –

WHEREAS, on 11th October, 2023, the National Assembly passed the National Rating Bill (National Assembly Bills No. 55 of 2022) with amendments, and thereafter referred it to the Senate for consideration in accordance with Article 110(4) of the Constitution;

AND WHEREAS, on 9th May, 2024, the Senate considered and passed the said Bill with further amendments and referred it back to the National Assembly for consideration;

FURTHER WHEREAS, on 12th June, 2024, the National Assembly considered and rejected the Senate's amendments to the Bill, the effect of which the Bill is referred to a mediation committee in accordance with the provisions of Article 112(2)(b) of the Constitution;

NOW THEREFORE, in accordance with the provisions of Article 112 of the Constitution and Standing Orders 41(1) and 148(b), I hereby convey the said decision of the National Assembly to the Senate and seek the appointment of nine (9) Senators to a Mediation Committee to consider the Bill in accordance with Article 113 of the Constitution."

NOTICE OF MOTION - EXTENSION OF TIME FOR CONSIDERATION OF THE VALUERS (FORMS AND FEES) (AMENDMENT) RULES, 2024 (LEGAL NOTICE NO. 69 OF 2024, THE SURVEY (AMENDMENT) REGULATIONS, 2024 (LEGAL NOTICE NO. 71 OF 2024) AND THE LAND ADJUDICATION (AMENDMENT) REGULATIONS, 2024 (LEGAL NOTICE NO. 76 OF 2024) (The Chairperson, Committee on Delegated Legislation)

THAT, WHEREAS the Committee on Delegated Legislation is established under standing order 195(1) of the Senate Standing Orders and is mandated to scrutinize statutory instruments laid before the Senate;

RECALLING that on 2nd May, 2024, the Valuers (Forms and Fees) (Amendment) Rules, 2024 (Legal Notice No. 69 of 2024), the Survey (Amendment) Regulations, 2024 (Legal Notice No. 71 of 2024) and the Land Adjudication (Amendment) Regulations, 2024 (Legal Notice No. 76 of 2024) were laid in the Senate and referred to the Committee on Delegated Legislation for consideration and scrutiny, pursuant to section 12(1) of the Statutory Instruments Act, Cap. 2A and standing order 195(3) of the Senate Standing Orders;

NOTING that these statutory instruments seek to amend the Valuers (Forms and Fees) Rules, 1987, the Survey Regulations, 1994 and the Land Adjudication Regulations, 1970, respectively, which, pursuant to section 21(1) of the Statutory Instruments Act, expired;

FURTHER NOTING that in course of considering the statutory instruments, the Committee was informed that an order had been issued by the High Court in <u>Machakos Petition No. E002 of 2024 Innocent Musumbi Kimanthi vs the Attorney</u> <u>General and the National Assembly</u> suspending the expiry of the statutory instruments contained in the Statutory Instruments (Exemption from Expiry) Regulations, 2022 (Legal Notice No. 218 of 2022) and further suspending the operation of section 21(1) of the Statutory Instruments Act, Cap. 2A;

APPRECIATING that under section 15(2) of the Statutory Instruments Act, Cap. 2A, the Committee is required to make a report on the statutory instruments within twenty-eight sitting days after the date of referral of the instruments by the Senate and that with regard to the three statutory instruments, the time lapses on 30th July, 2024;

FURTHER APPRECIATING that in light of the court order issued by the High Court in Machakos, the Committee requires additional time in order to conclusively interrogate the matter and to scrutinize the statutory instruments; NOW THEREFORE, pursuant to section 15(3) of the Statutory Instruments Act, Cap. 2A, the Senate resolves to extend the timeline for consideration of the Valuers (Forms and Fees) (Amendment) Rules, 2024 (Legal Notice No. 69 of 2024), the Survey (Amendment) Regulations, 2024 (Legal Notice No. 71 of 2024) and the Land Adjudication (Amendment) Regulations, 2024 (Legal Notice No. 76 of 2024) by twenty-one days in order to enable the Committee to conclusively consider and scrutinize the statutory instruments.

9. **QUESTIONS AND STATEMENTS**

a) Statements pursuant to Standing Order 52(1)

i) The Senator for Turkana County (Sen. James Lomenen, MP) made a statement regarding the need for affirmative action to increase the representation of marginalized and underrepresented communities in the Public Service.

Thereupon, the Senator noted that, despite the efforts by the Public Service Commission to improve inclusivity and proportional representation to ensure that marginalized groups have access to employment opportunities, marginalized communities including the Konso, Dahalo, Makonde, Aweer, Wayuu, Elmolo, Ogaden, Suba, Dorobo, Njemps, Taveta, Burji, Borana, Gabbra, Rendille, Garreh, Daasanach, Somali, Sakuye, Maasai, Turkana, Samburu, and Pokot remained significantly underrepresented in the Public Service.

The Senator called for urgent corrective measures including the review of employment policies, establishment of clear affirmative action targets, promotion of the active participation of individuals from marginalized and underrepresented communities and the development of robust mechanisms for monitoring and reporting on the progress of affirmative action initiatives to maintain transparency and accountability

ii) The Senator for Turkana County (Sen. James Lomenen, MP) made a statement regarding the need to recruit additional National Police Reservists (NPRs) in the banditry-prone areas of Turkana County.

Thereupon, the Senator noted that the areas have, regrettably, been overrun by lawless bandits who orchestrate numerous tragic raids against residents and commit heinous killings, forcing residents to flee their homesteads for safer areas.

The Senator stated that, despite commendable efforts and decisive action by the Ministry of Interior and National Administration, a critical inadequacy of NPRS persisted in Turkana County, particularly along the international borders and the internal borders with Samburu, Baringo and West Pokot counties. The Senator concluded by calling for the recruitment of additional NPRs and the implementation of other strategic measures to effectively and permanently address the menace of banditry in the region.
