## **1.0 INTRODUCTION**

**Mr. Speaker Sir,**

In accordance with the provisions of Articles 49 (2) and 132 of the Treaty for the Establishment of the East African Community and Rules 74 and 75 of the Assembly Rules of Procedure, the Chairperson Council of Ministers laid on table the Annual Budget Estimates of Revenue and Expenditure of the East African Community for the FY 2024/2025 on 30<sup>th</sup> April 2024. Accordingly, the Rt, Hon. Speaker referred the Annual Estimates of Revenue and Expenditure of the East African Community for the FY 2024/2025 to the Committee on General Purpose for consideration.

Pursuant to the provisions of Articles 49(2) and 132 of the Treaty, and as further amplified by Rule 81 (c), (e), and (g) Annex 5 (f) of the Rules of Procedure of the Assembly, the Committee on General Purpose proceeded to consider the Annual Estimates of Revenue of Revenue and Expenditure FY 2024/2025. The Committee hereby presents its report.

## **2.0 METHODOLOGY**

During the consideration of the Budget Estimates, the Committee:

- a) Held meetings in Arusha and interfaced with the Chairperson, Council of Ministers, the Secretary General, Heads of Organs and Institutions and other relevant officers of the Community.
- b) Scrutinized and considered the following documents:
  - (i) The Policy Statement by the Secretary General on the EAC Budget for FY 2024/2025.
  - (ii) The EAC Budget Summaries for FY 2024/2025.
  - (iii) The EAC Summary of activities – MTEF for FY 2024/2025.
  - (iv) The EAC Annex to the Budget for FY 2024/2025 (Detailed MTEF).
  - (v) The EAC Budget Performance for July 2023 – June 2024.
  - (vi) The EAC Project Financial Statement for the FY 2024/2025.
  - (vii) The EAC Annual Operational Plan for FY 2024/2025.
  - (viii) The Pre Budget Conference Report for FY 2024/2025.
  - (ix) The Progress Report for July 2023 – June 2024.
  - (x) Extract of the 53<sup>rd</sup> Extra Ordinary Meeting of Council of Ministers Report.

The Committee also made reference the Treaty, the EAC Budget Act, the EALA Rules of Procure and the other relevant leagal instruments of the Community.

### **3.0 ACHIEVEMENTS DURING THE FY 2023/2024**

According to the Budget Speech by the Chair Council, and the Policy Statement by the Secretary General, during the year 2023/2024, the Community achieved the following:

- a. Strengthening of regional governance, political commitment, accountability, and inclusivity to improve peace and security in the build up to an EAC Political Confederation.
    - o The Federal Republic of Somalia deposited the instruments of accession to the East African Community.
  - b. Increased visibility, knowledge, awareness and participation of the Private Sector, citizens and other stakeholders in the EAC integration process.
  - c. Effective implementation of the EAC Customs Union and Common Market Protocols to increase EAC Intra- Trade and enhance freedoms and rights under the Common Market Protocol.
    - i) The Community harmonized 172 standards in accordance with the Standardisation Quality Assurance Metrology and Testing (SQMT) Act, 2006 and reviewed the Regional Standardisation Plan with specific consideration to national and regional priorities and the AfCFTA.
  - d. Improvement of productivity, value addition, promotion of regional supply chains, local content and domestication of regional commitments to improve socio-economic welfare of East Africans.
- e. Leveraging on new technologies to support the migration of production and service delivery to digital platforms and enhance e-business opportunities.**
- (i) The Community established an EAC E-commerce Engagement Platform (EEP) to strengthen collaboration and coordination in the e-commerce ecosystem; and
  - (ii) The EAC Secretariat mobilized USD 15 million from the World Bank for the implementation of the Eastern African Regional Digital Integration Project.
- f. Strengthening of the Global Health Agenda for the EAC Region**
- i) Developed and launched the digital version of the Zanzibar scorecard for tracking the progress of Reproductive, Maternal, New born, Child and Adolescent Health (RMNCAH).
  - ii) Trained 150 young researchers under the Young East African Research Scientists (YEARS) in research ecosystem skills.
- g. Implementation of the Road Map for the attainment of the EAC Monetary Union**
- i) Under ongoing implementation of the revised Roadmap for the East African Monetary Union, the EAC Monetary Policy Communication Strategy and the framework for monitoring the implementation of the EAMU Roadmap were developed; and

- ii) Eight (8) regional guidelines for the compilation of specific statistics domains were approved and the development of the compatible software for the compilation of the Consumer Price Index (CPI) was completed.
- h. Improvement of quality multi- sectoral strategic infrastructure and related services to support and accelerate sustainable regional integration and competitiveness.**
- i) Detailed designs of the Multi-national Tanzania/Burundi: Luhafe – Uvinza (132 km); Uvinza – Kanyani (60 km); Kumsenga – Kifura (25 km); Mabamba – Kumsenga (19.5 km); Gitega – Makebuko (25 km); Cankuzo -Gahumo (50 km) roads that link Tanzania and Burundi were completed;
  - ii) Funding amounting to USD1.7 million was secured for detailed designs on the multinational Burundi/Rwanda which is Kanyaru/Akanyaru Belt Roads: Ngozi (Mwumbe) – Nyamurenza – Ntega – Kirundo (66 km)/ Akanyaru Bas – Nyaruteja – Kibirizi – Gisagara – Nyamiyaga (110 km).
- i. Strengthening the Capacity of All EAC Organs and Institutions to effectively execute their mandates**
- i) The Community mobilized funding amounting to USD44 million to support the implementation of various EAC projects and programmes;
  - ii) The East African Legislative Assembly passed the East African Community Supplementary Appropriation Bill, 2023; the East African Community Supplementary (No. 2) Bill, 2023; and the East African Community Appropriation Bill, 2023; and
  - iii) Construction of the Regional Maritime Rescue Coordination Center commenced in December 2023.

### **3.1 Key Challenges Faced During the financial year**

Despite the progress that has been made in the implementation of the Community's projects and programmes, a number of challenges still persist:

- i) Delays in disbursement of Partner States' contributions to the EAC Budget which results in delayed implementation of regional commitments;
- ii) Delays in backfilling of vacant positions in EAC Organs and Institutions;
- iii) Lags in implementation of the Common Market Protocol (CMP) by Partner States mainly due to lengthy procedures for amending national policies, laws and regulations to conform to Protocol and inadequacy of resources to support implementation of the CMP; and
- iv) Lack of an effective mechanism for enforcement of the Community's decisions and directives.

### 3.2 Strategies for mitigating the above challenges

The Community will implement the following strategies to mitigate the effects of the above challenges:-

- i) Adherence to the schedule of disbursement of contributions to the EAC Budget by Partner States as stipulated in the EAC Financial Rules and Regulations (2012);
- ii) Expedited implementation of the approved Financial Mechanism for the Community;
- iii) Expedited finalization and implementation of Institutional Review recommendations, especially filling of the vacant positions; and
- iv) Comprehensive review of the EAC Treaty to enhance its robustness, align it to the current realities in the eight Partner States and include an enforcement mechanism.

### 4.0 STATUS OF CONTRIBUTION BY PARTNER STATES

## 5.1 Priority Areas and Programmes for the Budget 2024/2025

The Budget for the Financial Year 2024/25 has been prepared in line with the Global/Sector - specific priority areas and targets agreed upon by the Pre-budget Conference held from 23<sup>rd</sup> – 24<sup>th</sup> October 2023 and adopted by the 53<sup>rd</sup> Extra Ordinary Meeting of the Council of Ministers, as well as directives and decisions of the Council and Summit.

In FY 2024/25, the Community will focus on the following key priority areas:

- i) Strengthening of regional peace, security, political and governance mechanisms to maintain stability in the Community;

- ii) Enhancement of intra-regional trade and investment through an enabling business environment;
- iii) Establishment of the requisite institutions and acceleration of harmonization of fiscal and monetary policies towards attaining prerequisites for the East African Monetary Union;
- iv) Development of multi-sectoral infrastructure to improve connectivity in the region's transport and ICT to facilitate timely services;
- v) Enhancement of the social and productive sectors to increase productivity and raise the standards of living for East Africans; and
- vi) Enhancement of capabilities of all EAC Organs and Institutions to fulfill their mandates and raise awareness of the EAC integration process.

## 5.2 Budget allocation to the EAC Global Priorities for FY 2024/2025

The proposed budget for the FY 2024/2025 is allocated to the EAC Global priorities adopted by the Council as follows:

The above table summarises the budget estimates allocated to the global priority areas aimed at advancing the East African Community's goals and objectives. In total, the budget estimates allocated to the six global priority areas amount to USD112,984,442. This allocation reflects the importance placed on various aspects such as peace and security, economic and social

integration, infrastructure development, and institutional capacity building within the East African Community.

### **5.3 Expected Outcomes in the Financial Year 2024/2025**

It is expected that the implementation of the above priority programs will result into the following outcomes:

- i) strengthened peace and security leading to improved inter-state relations and stability in the region;
- ii) increased intra-trade and enhanced access to the international export markets;
- iii) accelerated implementation of the road map for the attainment of the EAC Monetary Union;
- iv) Improved quality infrastructure and increased level of e-business opportunities leading to enhanced service delivery and competitiveness;
- v) Increased efficiency in the production and distribution of products and services and improved social welfare of EAC citizens; and
- vi) Effective implementation of EAC Projects and Programmes and increased awareness of EAC integration leading to a greater sense of ownership and inclusiveness of the East African citizenry.

## **6.0 PROPOSED BUDGET ALLOCATION AND PLANNED ACTIVITIES/OUTPUTS IN FY 2024/2025**

### **6.1 EAC-SECRETARIAT**

The EAC-Secretariat requests the approval of USD 51,677,120 for the FY 2024/2025.

### **6.2 EAST AFRICAN LEGISLATIVE ASSEMBLY (EALA)**

The Council proposes the approval of USD 20,469,040 for the Assembly to implement among others, the following key programmes/activities in 2024/2025:

- i. Enactment of the remaining Bills that are pre-requisite for the establishment of the third Pillar of Integration (the Monetary Union);
- ii. Enhance its oversight function to ensure that the people of East Africa benefit fully from the implementation of the Common Market rights and freedoms;
- iii. Strengthen its collaboration with National Legislatures of the EAC Partner States to improve popular participation of people in the integration process through their elected representatives;
- iv. Audit the implementation of Assembly Resolutions and recommendations;
- v. Audit the status of Bills un-assented to;
- vi. Develop its 4<sup>th</sup> Strategic Plan (2024 – 2029);
- vii. Build capacity for the Members of the 5<sup>th</sup> Assembly and staff to effectively and efficiently discharge its cardinal mandate of legislation, oversight and representation;
- viii. Organize the 18<sup>th</sup> EAC Bureau of Speakers;
- ix. Organize the 14<sup>th</sup> EAC Inter-Parliamentary Games in Mombasa, Kenya.

### **6.3 EAST AFRICAN COURT OF JUSTICE (EACJ)**

The Organ requests the approval of USD 4,858,553 for FY 2024/2025 to implement among others, the following key programmes/activities:

- i. To hold sessions of the Appellate Division of the EACJ to adjudicate on matters filed before the Court by Partner States, EAC citizens, Institutions and Staff of the Community.
- ii. To hold sessions of the First Instance Division of the EACJ to adjudicate on matters filed before the Court by Partner States, Institutions and Staff of the Community.
- iii. To represent EACJ in key events within Partner States aimed at deepening integration.
- iv. To facilitate Commonwealth Magistrates and Judges Association (CMJA) Annual Conference on the role of Regional Courts in upholding the rule of law, engendering public confidence and dispensing justice.
- v. To present on topical issues in East African Magistrates and Judges Association (EAMJA) annual conference on "One Court mixed systems: the East African Court of Justice as a Court that encompasses the Common Law and Civil Law systems.
- vi. To attend all the budget related meetings including F & A meetings and EAC Planning Committee meetings.
- vii. To represent the Court in the Annual Report writing Committee Meeting on annual activities.
- viii. To facilitate ten (10) court clerks to attend staff exchange programmes at EACJ and its sub registries.
- ix. To attend statutory meetings of the EAC Audit and Risk Committee to respond to findings on the EACJ.
- x. To participate in the International Regional and National exhibitions and knowledge forum.
- xi. To establish Court sub registry in the Democratic Republic of Congo to facilitate access to Court by EAC citizens.
- xii. Formulation of EACJ Strategic Plan for the period 2024/4 – 2028/9.

### **6.4 LAKE VICTORIA BASIN COMMISSION (LVBC)**

The Commission requests the approval of USD 7,787,519 for FY 2024/2025 to implement the following key programmes/activities. The Budget FY 2024/2025 was prepared in line with the global priority areas approved by the Council of Ministers and informed by the LVBC 4<sup>th</sup> LVBC Strategic Plan (2021-2026), Decisions and Directives of the LVBC Sectoral Council of Ministers and recommendations of the LVBC management meetings. In view of the foregoing, during the FY 2024/2025, the LVBC will focus on the following key priority programs:

- i. Enhancing Maritime Communication network coverage on Lake Victoria to improve SAR services and trade;
- ii. Developing one Search and Rescue framework on Lake Victoria to reduce accident and rescue lead-time ;
- iii. Support the preparation and implementation of Integrated water resources management investments (including water supply and sanitation)

- iv. Promote sustainable agriculture and land use management practices in critical transboundary watersheds & ecosystems/landscapes
- v. Implement the Climate Change mitigation and adaptation Strategies and interventions
- vi. Coordinate and Facilitate basin-wide data and information generation and dissemination including monitoring of water quantity and quality, flood prediction and lake water level monitoring.
- vii. Hold community awareness campaigns on the importance of the LVB resources and importance of conservation. Embrace and integrate indigenous knowledge and practices of targeted communities in ecosystem conservation and management including policy, programming, and on-ground interventions.
- viii. Strengthen the institutional framework for cooperative management in the transboundary water and shared ecosystems in the LVB
- ix. Strengthen the Resource mobilization to increase LVBC resource base
- x. Strengthen the Institutional capacity to improve the commission Fiduciary systems, Monitoring and evaluation, Legal framework, Human resources capacity, communication and public relations.
- xi. Complete and equip the LVBC Headquarters.

#### **6.5 INTER- UNIVERSITY COUNCIL FOR EAST AFRICA (IUCEA)**

The Institution requests the approval of USD17,287,618 for the FY 2024/2025 to implement among others, the following key programmes/activities:

- i. Capacity Building for Regional Flagship Technical Institutions and National Project coordination Unit in leadership M&E, Finance, Procurement, communication ,Grievance Redress Mechanisms and environmental.
- ii. Capacity Building of Reginal Faciltation Unit(RFU) Staff.
- iii. Facilitate IUCEA and Project Staff in skills development in Project management.
- iv. Facilitation of technical assistance in research and training.
- v. Facilitation of trainings and mentorship events.
- vi. Facilitate scholarships to 60 students.
- vii. Conduct an annual beneficiary satisfaction survey for East African skills for transformation and Regional Intergration-EASTRIP Stakeholders.
- viii. Facilitate 4th cohort of EASTRIP-China Scholarship for 20 TVET Trainers from 16 EASTRIP RFTIs-Regional Flagship Technical Institutions.
- ix. Facilitate mobility of regional students among East African skills for transformation and Regional Intergration Project (EASTRIP) Regional Flagship Technical Institutions.
- x. Preparation of concept notes and/or proposal for establishment of networks, training, and mentorship.
- xi. Organise Quarterly Regional TVET Qualification Framework (RTQF) Implementation Advisory Group (IAG) meetings to oversee smooth implementation of RTQF and harmonized occupational standards.
- xii. Organize Capacity building activities related to implementation of Quarterly Regional TVET Qualification Framework to Support the process of curriculum & assessment tool development based on harmonized Occupational Standards.
- xiii. Maintenance and updates of M&E EASTRIP Project Portal.



- xiv. Facilitation of business incubation and acceleration including linkages with private sector and investors.
- xv. Engagement with other potential funders/development partners for Resource mobilisation and sustainability of EASTRIP.
- xvi. Advocacy and branding of EASTRIP project activities.
- xvii. Conduct quarterly engagements meeting with Development Partners to support new initiatives within IUCEA Strategic plan.

## **6.6 LAKE VICTORIA FISHERIES ORGANIZATION (LVFO)**

The Organisation requests the approval of USD3,109,586 to implement among others, the following key activities/programmes in FY 2024/2025:

- i. Convene a workshop of key stakeholders in Fisheries and aquaculture to prepare robust proposals for Research and development;
- ii. Upgrade the Data Centre software suite (Adobe software bundles, Navicat Premium Software, Team Viewer, Microsoft Visual Studio);
- iii. Finalize and rollout e-Fisher application in Lake Victoria basin;
- iv. Undertake sensitization mission to fishing communities to enlighten them on emerging issues;
- v. Conduct one regional enforcement operation on Lake Victoria;
- vi. Conduct sensitization meetings for fisheries stakeholders in the Lake Victoria region through multi-stakeholder meetings;
- vii. Mark and protect 3 critical fish breeding and nursery areas in each of the Lake Victoria riparian Partner State;
- viii. Convene workshop for capacity building of beneficiaries in solar technologies;
- ix. Train women and youth associations in developing innovative small fish products for enhanced market penetration;
- x. Conduct short training to technical staff from Republic of Burundi on analysis of basic fisheries and limnological parameters to enhance their capacity;
- xi. Conduct hydroacoustic survey to estimate the amount of fish in the Lake Victoria to guide sustainable management of its fisheries;
- xii. Conduct a study on the role of gender in small fish value chains, from catching to processing and marketing, and identify opportunities for women's economic empowerment;
- xiii. Conduct a study to provide the empirical data for testing the potential of a price subsidy intervention as a policy for the management of the dagaa fishery in Lake Victoria;
- xiv. Conduct fieldwork to provide empirical data to construct the perceived consequences, conservation, and adaptation to Nile perch stock tipping points across stakeholders in Kenya, Uganda and Tanzania, using a Mental Model approach;
- xv. Conduct study on baited hook fishery to determine hook selectivity in relation to bait types and sizes;
- xvi. Conduct study to provide empirical data to test the desirability and willingness to pay for cultivated bait among longline fishers in Lake Victoria;

- xvii. Convene stakeholders' workshops to discuss the policy implications of MultiTip-ER results in Lake Victoria;

## **6.7 EAST AFRICA SCIENCE AND TECHNOLOGY COMMISSION (EASTECO)**

The Commission requests the approval of USD 2,177,192 for the FY 2024/2025 to implement among others, the following key programmes/activities:

- i. Develop EAC Regional Commercialization strategy to strengthen the commercialization of STI products and services.
- ii. Develop EAC Regional Geospatial (Space) Information Management Network (EAGIN) framework to strengthen the coherence and coordination of Geospatial Information Management across the EAC Region.
- iii. Develop EAC Regional biotechnology and biosafety Strategy.
- iv. Conduct one online training on entrepreneurship skills development for graduate and post-graduate students and faculty to enhance creativity and job creation.
- v. Conduct online training on scientific and grant proposal writing for scientists and faculty to enhance knowledge and skills.
- vi. Publish issues of the East African Journal of science technology and Innovation to enhance the dissemination of STI products and services.
- vii. Develop and maintain a database for indigenous knowledge and technology systems for increased access and utilization.
- viii. Convene EAC Regional eHealth and telemedicine conference to enhance knowledge dissemination, Networking, and collaboration.
- ix. Convene Youth Innovation Forum to enhance scientific and technological solutions for societal needs.
- x. Convene quarterly working sessions of Research and Development sub-committees to enhance resource mobilization, grant management and science communication.
- xi. Establish an Information and Communication Technology development working group to enhance coordination.
- xii. Fund multi-disciplinary and collaborative Science, innovation, and technology projects for increased knowledge and innovation development.
- xiii. Identify and support the development and applications of Artificial intelligence for real-time monitoring and control of manufacturing processes.
- xiv. Identify and support the development and applications of the Internet of Things (IoT) in eHealth and telemedicine for enhanced delivery of healthcare services.
- xv. Support the development of remote sensing applications in climate information dissemination to farmers for evidence-based decision-making in farm operations.
- xvi. Development of STI Indicators data support system to enhance continuous data generation and updates for strategic decisions.
- xvii. Establish and operationalize coordination unit for RTOs, academia, industry and the private sector to support export-oriented industrial development and trade.
- xviii. Convene Donor roundtable meeting to showcase EASTECO projects and programs for support by development partners.
- xix. Undertake Resource mobilization missions to seek support from development partners to enhance the sustainability of EASTECO.

- xx. Participate in Regional and International STI events to foster partnerships and collaborations.

#### **6.8 EAST AFRICA KISWAHILI COMMISSION (EAKC)**

The Commission requests the approval of USD 1,641,445 to fund the implementation of the following programmes/activities in FY 2024/2025:

- i. Participation in stakeholders' meetings in media, Academia, Culture and languages;
- ii. To coordinate and represent EAKC in high-level international meetings.
- iii. To coordinate annual visits to Ministries responsible for Culture/ Kiswahili in all Partner States to assess the status of implementation of activities for the development and use of Kiswahili;
- iv. To undertake Resource mobilization to raise support from Development Partners to enhance sustainability of EAKC activities;
- v. Capacity building for key Kiswahili Stakeholders on the mandate and progress made by EAKC towards development and popularization of Kiswahili in (EAC);
- vi. Hold the 2nd EAKC International Kiswahili Conference;
- vii. Hold a meeting of experts to review articles/manuscripts for publication in a special issue of Kiswahili Journal;
- viii. Hold a national meeting of DRC Kiswahili stakeholders for awareness creation and onboarding of DRC onto EAKC programs and Activities;
- ix. Hold the 3rd EAC World Kiswahili Language Day Celebrations;
- x. Implementation of the Mobility Program for Kiswahili Stakeholders for capacity building and creation of awareness in all Partner States for enhanced Kiswahili language usage;
- xi. Recruitment of key staff for the commission.

#### **6.9 EAST AFRICAN HEALTH RESEARCH COMMISSION (EAHRC)**

The Commission requests the approval of USD 2,451,157 for the implementation of among others, the following programmes/activities in FY 2024/2025:

- i. Publishing the health research findings of the region through the EAHRC journals,
- ii. resource mobilization to implement the health programs of the Digital Regional East African Community Health (REACH) initiative.
- iii. Get the architectural design and bill of quantities for the construction of the EAHRC permanent headquarters, and secure the EAHRC Permanent HQ Land by erecting a boundary wall.
- iv. Operationalization of the EAHRC in the Federal Republic of Somalia.
- v. To initiate implementation of the establishment of Telemedicine in the Centers of Excellence.
- vi. To develop digital health programmes to train health professionals from EAC partner states by June 2025
- vii. To continue building the capacity of the Young East African Research Scientists 2nd cohort to build their capacity in mentorship and research ecosystem skills
- viii. To train the national ethics review bodies to enhance their capacity in reviewing research proposals in line with developed programmes

- ix. Convening of the 10<sup>th</sup> East African Health and Scientific Conference in March 2025 in Juba, Republic of South Sudan.

#### **6.10 EAST AFRICAN COMPETITION AUTHORITY (EACA)**

The Authority requests for the approval of USD 1,525,212 to fund the implementation of the following programmes/activities FY 2024/2025:

- i. Enforcement of the EAC Competition Authority Competition Act, 2006 through:
  - a) Investigations, analysis and determination of cross border mergers and acquisitions notified with the Authority.
  - b) Investigations and assessment of consumer protection complaints with cross border effects in the community.
  - c) Investigations and assessment of anti-competitive practices (unilateral, concerted practice and abuse of dominance) with cross border effects in the community
- ii. Screening of economic sectors prone to anticompetitive practices.
- iii. Building capacity of Partner States stakeholders to entrench the culture of competition through:
  - a. Sensitization and awareness creation.
  - b. Technical assistance to Partner States without competition institutions and laws and agencies at nascent stages of establishment.
- iv. Support Partner States in TFTA and AfCFTA competition policy negotiations and implementation of activities.
- v. Development and Review of Enforcement toolkits – guidelines, frameworks.

#### **7.0 OBSERVATIONS AND RECOMMENDATIONS**

1. According to the Budget Estimates for the FY 2024/25, out of the initial total budget of USD 112,984,442, a sum of USD 62,824,573 will be contributions from Partner States which represents 55.6% of the total budget. Other sources of funds will be: Development Partners USD 43,936,292; General Reserve Fund USD 1,262,631; IUCEA Arrears Fund USD 2,932,841; Member Universities of IUCEA USD 506,680; Road Agencies from Partner States USD 107,660 and Miscellaneous Income USD 1,413,765.
2. Whereas the budget of the Community may seem to have increased from USD 103,842,880 in FY 2023/24 to USD 112,984,442 in FY 2024/25, it should be noted that this increase is largely attributed to the contribution of USD 7,853,071 from the Federal Republic of Somalia, a new Partner State of the EAC. The joining of the Federal Republic of Somalia places additional responsibilities and obligations to the EAC Organs and Institutions.
3. The Committee reviewed the programs and projects of the Organs and Institutions and noted the following:
  - i. A substantial number of the programs/activities are not linked to the four pillars of the EAC integration.
  - ii. There is duplication of some programs/activities.
  - iii. Some programs/activities are not aligned to the core mandates of the Organs and Institutions.

- iv. The cost of most of the planned programs/activities is on DSAs, tickets, hire of conference facilities and ushers.
  - v. Some Organs and Institutions deliberately split their programs into micro activities for the officers to earn DSAs, yet these activities will not have any impact on our integration process. These institutions/departments include EASTECO, LVFO, and the Virtual Office of Polical Federation.
4. Arising from the above, and in line with Article 132(5) of the Treaty, and Section 4(3) and Section 5 of the EAC Budget Act 2009, the Committee, in consultation with the Heads of Organs and Institutions made some reallocations and reprioritisation of some programs and projects within some Organs and Institutions as indicated in **Annex1** of this report.

***The Committee recommends to the Assembly to approve the reallocations and reprioritised programs and projects as provided in Annex 1, and accordingly appropriate funds for their implementation.***

5. During the consideration of the EAC Supplementary budget for 2023/24, the Assembly deferred the appropriation of USD 1,441,400 for a number of programs and projects under the EAC Secretariat which could not be implemented in the course of the financial year due to time constraints (**Annex 2**). The Assembly agreed with the Council that the funds for these programs and projects be included in the budget for financial year 2024/25.

***The Committee recommends that the Assembly appropriates an additional sum of USD 1,441,400 to Vote 001 -EAC Secretariat to cater for the implementation of programs and projects indicated in the corrigendum, and in Annex 2.***

6. Page 10 of the Secretary General's Policy Statement highlights the allocation of the EAC Budget in 2024/25 along the six global priority areas whereby USD 66,292,413 is allocated for enhancing capabilities of all the EAC Organs and institutions to fulfil their mandates and raise awareness on the EAC integration process. However, the Committee noted that the Council did not approve EALA's request for USD 810,000 for public outreach and sensitisation which is a core mandate of the Assembly.

***The Committee recommends that the Assembly urges the Council to approve EALA's request for USD 810,000 for public outreach and sensitisation to enhance the visibility of the Community. This funding should be accommodated in the supplementary budget for FY 2024/25.***

7. Whereas the Assembly has severally urged the Council to approve the appointment and remuneration of Aides to Members with disabilities, this request has been ignored. The late Hon. Kasamba Mathias (Uganda) and Hon. Bahati Alex (Rwanda) were elected to the 4<sup>th</sup> Assembly (2017 -2022). In the same vein Hon. Alex Bahati (Rwanda) and Hon. David Ole Sankok (Kenya) were elected to the 5<sup>th</sup> Assembly (2022 – 2027) on the PWDs ticket. The Treaty, the UN Conventions, African Charters and other labour laws recognise the rights of PWDs, besides warranting affirmative action to PWDs. In 2008, the Council appointed an Aide to Hon. Dr. Ndahiro – a Member of EALA then.

However, the Council has not accorded the same treatment to the aforementioned Members of the 4<sup>th</sup> and 5<sup>th</sup> Assembly.

***The Committee recommends that the Assembly urges the Council to:***

- i. Approve the retrospective appointment of the Aides to the late Hon. Mathias Kasamba, and Hon. Alex Bahati and Hon. Ole David Sankok.***
- ii. approve the outstanding arrears of emoluments of these Aides and an extra budgetary requirement of emoluments for the Aides of the two Members in a supplementary budget for FY 2024/25.***

8. It was noted that within some Organs and Institutions, there were some programs/activities that were either erroneously or deliberately placed in cost centres that do not relate to their mandates. In consultation with the relevant officers, these programs/activities were realigned to the mandates of the appropriate departments.
9. The Committee registers its displeasure over the deliberate refusal by some of the relevant officers of the EAC Secretariat to appear before the Committee to defend their budgets despite the invitations and numerous reminders extended to them. The officers who did not show up were from the Directorate of Productive Sector, the Directorate of Infrastructure, Internal Audit, and the Head of Political Federation. The actions of these officers tantamount to contempt of the Assembly.

***The Committee urges the Assembly to resolve that in the event that a responsible officer of the Community refuses to appear before the Committee during the consideration of the budget, the Assembly should stay the approval of the budgets for their respective departments.***

10. It was noted that some Organs and Institutions had budgeted for some activities for the integration of the Federal Republic of Somalia into the Community. Whereas the Committee appreciates the need to expeditiously integrate the Federal Republic of Somalia in the EAC, the Organs and Institutions are doing it in a disjointed manner, without a comprehensive roadmap to guide the process. It was noted that the Republic of South Sudan and the Democratic Republic of Congo that joined the Community before the Federal republic of Somalia are not yet fully integrated in the Community.

- i. The Committee recommends to the Assembly to urge the Council of Ministers to develop a comprehensive roadmap for the full integration of the Republic of South Sudan, the Democratic Republic of Congo and the Federal Republic of Somalia.***
- ii. The Committee further recommends that the Assembly resolves that the implementation of this roadmap shall be subject the concerned Partner States honouring their financial contributions to the Community.***

11. It was noted that every financial year, the Council of Ministers presents a supplementary budget for the consideration and approval of the Assembly. However, there is no budget line for the consideration of the same by the Assembly. The Assembly has always had to plead with the Council and the EAC Secretariat to avail funds for this activity. This explains why at times it takes long for the Assembly long to convene meetings to consider supplementary budgets.

***The Committee recommends that the Assembly to urge the Council of Ministers to always provide funds to the Assembly in time for the consideration of the supplementary budgets.***

12. During the 3<sup>rd</sup> Plenary Session of the Assembly held in March 2024, the Council Supplementary budget to reconsider Council Bills returned the following Bills for reconsideration: The East African Community Statistics Bureau Bill; The East African Community Financial Service Bill; and The East African Community Surveillance Compliance and Enforcement Bill. However, no funds have been provided for the consideration of these Bills.

***The Committee recommends to the Assembly to urge the Council of Ministers to provide USD 376,000 in a supplementary in FY 2024/25 to enable the assembly process the aforementioned Bills.***

13. It was noted that the Assembly convened the ongoing 4<sup>th</sup> Plenary from 23<sup>rd</sup> June 2024 for nine days, yet the Assembly made a request of USD 753,600 this sitting to the Council, but was not approved. Instead, EALA and the Secretariat were requested to effect internal reallocations within their respective budgets to cater for only 9 Plenary days. However, there were no budget lines from which these funds could be reallocated.

***The Committee recommends to the Assembly to urge the Council of Ministers to provide USD 574,000 in a supplementary in FY 2024/25 to enable the defray the expenses for the 4<sup>th</sup> Session held in June 2024.***

14. It was noted that in February 2021, the Summit of the EAC Heads of State approved Kiswahili and French as additional official languages of the Community. In November 2023, the Summit also approved a model for the sustainable financing mechanism of the Community. On both occasions, the Summit directed the Council to expedite the operationalisation of these decisions. The Committee noted that there has been minimal progress in the amendment of the Treaty.

***The Committee recommends that the Assembly urges the Council of Ministers to prioritise and expedite the process of amending the Treaty to give effect to the above Summit decisions and directives in FY 2024/25.***

15. It was noted that the Office of the Counsel to the Community has not been able to process a number of Bills due to underfunding. This Office requires a sum of USD 112,500 to process six Bills in financial year 2024/25. The inability by the Office of the CTC to process Bills due to underfunding, negatively impacts on the legislative mandate of the Assembly.

***The Committee recommends to the Assembly to urge the Council of Ministers to provide a sum of USD 112,500 to the Office of the CTC through a supplementary budget in FY 2024/25.***

16. Article 49 (2)(a) and 65 of the Treaty obligates the Assembly to establish functional relations with national parliaments of the EAC Partner States. To achieve this, the Assembly devised the annual Nanyuki series and inter-parliamentary liaison committees as well as the East African Parliamentary Institute, the annual EAC parliamentary games and the bi-annual EAC Speakers Forum. This serves as an opportunity for EALA to interact with national parliaments to deepen the EAC integration agenda and to further entrench the EAC at Partner State levels. A budget of USD 291,000 is therefore required for the Assembly to undertake this activity in four days.

***The Committee recommends that the Assembly urges the Council of Ministers to provide a sum of USD 291, 000 in a supplementary budget in FY 2024/25 to enable the Assembly convene the Annual EAC/EALA Inter-Parliamentary Relations Seminar (Nanyuki Series).***

17. Section 4(3) of the Budget requires that the Committee of the Assembly that is charged with the consideration and review of the EAC Budget to present its report to the Assembly not later than the 30<sup>th</sup> day of May in each financial year. However, due to liquidity challenges this statutory obligation has not always been complied with by the Assembly.

***The Committee recommends to the Assembly to direct the the Secretary General to always ring-fence the funds for the consideration of the budget to enable the Committee on General Purpose comply with this statutory obligation.***

18. Clause 6.4 of the Operational Manual for the Implementation of the Quota System in Recruitment of staff in the EAC enjoins the Secretary General to make proposals to review and amend the guidelines therein at least once every three years. However, this requirement has never been fulfilled since the manual came into effect in 2012.

***The Committee recommends to the Assembly to direct the Secretary General to comply with the provisions of clause 6.4 of the Operational manual for the implementation of the quota system in financial year 2024/25.***

19. The Committee also recommends that the Assembly directs the Secretary General to:

- (i) make appropriate adjustments in the EAC Budget Management System to accommodate the rationalisation/reallocations as approved by the august House in the budget.
- (ii) submit and lay before the Assembly the final signed copy of the approved budget at the first sitting of the of the Assembly in FY 2024/24.

20. The Assembly adopts the Committee report and passes the EAC Appropriation Bill, 2024 to provide for a total sum of USD 114,425,842 to the various Organs and Institutions of the Community for the implementation of various programs and activities in the financial year 2023/24 as indicated below:
